Mr. Yung is therefore deemed to be interested in 47,456,396 shares of the Company (the "**Shares**") held by Lotus Atlantic which is an indirect wholly-owned subsidiary of Shell Holdings for the purpose of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) ("**SFO**").
2. These Shares represent the interest held by Louts Atlantic which is a controlled corporation of Mr. Yung. Ms. Vivian Hsu ("**Mrs. Yung**") is the spouse of Mr. Yung.
