UPDATE ON WINDING UP PETITIONS

References are made to the announcements of the Company dated 2 February 2021, 15 March 2021, 19 March 2021, 26 March 2021, 9 April 2021 and 22 April 2021 (the “**Announcements**”) regarding several winding up petitions received by the Company on 10 November 2020, 15 December 2020, 20 January 2021, 27 January 2021 and 1 February 2021, respectively (collectively the “**Petitions**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as defined in the Announcements.

The Company would like to provide update on the status of the Petitions as follow:

- (a) as disclosed in the Announcements, the hearing of Petition A was adjourned to 25 May 2021 and the High Court of the Supreme Court of the Republic of Singapore has ordered the hearing for Petition A be further adjourned to 10 June 2021;

- (b) as disclosed in the Announcements, the hearing of Petition D was adjourned to 25 May 2021 and the High Court of the Supreme Court of the Republic of Singapore has ordered the hearing for Petition D be further adjourned to 10 June 2021; and
- (c) as disclosed in the Announcements, the hearing of Petition E was adjourned to 25 May 2021 and the High Court of the Supreme Court of the Republic of Singapore has ordered the hearing for Petition E be further adjourned to 10 June 2021.

The Company will make further announcements to update the shareholders of the Company (the “**Shareholders**”) and potential investors on the development of the Petitions as and when appropriate.

UPDATE ON APPLICATION FOR MORATORIUM UNDER SECTION 64 OF THE INSOLVENCY, RESTRUCTURING AND DISSOLUTION ACT 2018 (THE “IRDA”)

References are made to the announcements of the Company dated 19 April 2021, 22 April 2021 and 30 April 2021 regarding the application made by Hon Industries Pte. Ltd., an indirectly wholly owned subsidiary of the Company, to the High Court of the Republic of Singapore under Section 64 of the IRDA (the “**Application**”). The Board wishes to announce that, on 18 May 2021, the High Court of the Supreme Court of the Republic of Singapore has dismissed the Application.

As of the date of this announcement, the Company and its subsidiaries are still carrying out their day-to-day operations under the management of the board of the directors of the Company.
