FURTHER EXTENSION OF TIME OF RELEVANT WRITTEN SUBMISSION

References are made to the announcements (the “**Announcements**”) of the Company dated 27 May 2021 in relation to extension of time of relevant written submission, dated 4 May 2021 in relation to the application for a review by the GEM Listing Review Committee, dated 26 April 2021 in relation to the decision of GEM Listing Committee, dated 10 February 2021 in relation to extension of time of review hearing and relevant written submission, dated 21 December 2020 in relation to request to review decision of the Stock Exchange on GEM Rule 17.26 and dated 14 December 2020 in relation to the decision of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) that the Company has failed to maintain a sufficient level of operations as required under Rule 17.26 of the GEM Listing Rules to warrant the continued listing of its shares, and that, subject to the Company’s right of review, the trading in the Company’s shares will be suspended under Rule 9.04(3) of the GEM Listing Rules (the “**LD Decision**”). Unless otherwise defined, capitalised terms in this announcement shall have the same meanings as those defined in the Announcements.

FURTHER EXTENSION OF TIME OF RELEVANT WRITTEN SUBMISSION

The Company has made an application to the Stock Exchange for an extended time to provide written submission. On 7 June 2021, the Company confirmed from the Stock Exchange that the Listing Review Committee has agreed to allow the Company to further extend its written submission by 11 June 2021. Pending the Review, the trading of the Company’s shares will continue.

Shareholders and potential investors are reminded that the outcome of the Review is uncertain. Should the GEM Listing Review Committee of the Stock Exchange uphold the Decision after the Review, the trading in the Company's shares may be suspended under Rule 9.04(3) of the GEM Listing Rules.

Further announcement(s) will be made by the Company regarding any material developments on the Review as and when appropriate and in accordance with the requirements of the GEM Listing Rules. Shareholders and potential investors of the Company who have any queries about the implications of the Decision are advised to seek professional advice as they may consider appropriate.

Transfer of Shares may be restricted as the deposits of the Shares into CCASS may be suspended due to the Petition. Shareholders and potential investors of the Company should exercise caution when dealing in the Shares, and if they are in any doubt about their position, they should consult their professional adviser(s).
