# Chairman's Statement

## 主席報告

Dear Shareholders,

On behalf of the board of Directors (the “**Board**”) of the Company and its subsidiaries (collectively the “**Group**”), I am pleased to present the annual results of the Group for year ended 31 March 2021.

The Group's revenue for the year ended 31 March 2021 slightly increased by approximately HK\$0.6 million, or approximately 0.3% from approximately HK\$224.2 million for the year ended 31 March 2020 to approximately HK\$224.8 million for the year ended 31 March 2021. The Group recorded a gross profit of approximately HK\$64.2 million for the year ended 31 March 2021, representing a decrease of approximately 10.0% as compared with approximately HK\$71.3 million for the year ended 31 March 2020. The project performance was hampered due to the precautionary measures implemented both by the Hong Kong society as a whole and by our internal arrangement. However, with the government subsidy and better cost control, improvement of our net profit this year was achieved. Net profit of the Group increased to approximately HK\$32.0 million for the year ended 31 March 2021 as compared with approximately HK\$21.6 million for the year ended 31 March 2020.

In March 2021, the Group was awarded a new contract on the replacement of smoke curtains at East Rail Line (ERL) and West Rail Line (WRL) with contract value of approximately HK\$61.8 million. The preceding contract was awarded to the Group in September 2018 on the replacement and modification of smoke curtains at the Airport Express Line (AEL) and Tung Chung Line (TCL) with contract value at approximately HK\$70.0 million and will be substantially completed at the second half of year 2021. We are delighted that our customer is satisfied with our performance in the Airport Express Line and Tung Chung Line and confident to award us another contract of similar kind at other railway lines.

Meanwhile, the project of implementation of quick access code (“**QR Code**”) for Travel on the MTR was substantially completed during the year. The 3-year maintenance contract on the automatic fare collection (“**AFC**”) equipment awarded at year 2015, and subsequently extended for another 3 years will be completed during the financial year ending 2022. The Group is keen and confident to pursue the continuance of this maintenance contract and expect that the revenue generated from our maintenance contracts will maintain a steady growth.

While continuing to work on our electrical and mechanical (“**E&M**”) engineering and maintenance projects, the Group has been putting more efforts further promoting our technical capabilities such as devoting resources on the implementation of building information modelling (“**BIM**”) and started applying virtual reality (VR), augmented reality (AR) and mixed reality (MR) technologies in providing training and real time on-line supports to our frontline maintenance staff. By bringing the advanced technologies to our daily operation, we expect that our competitive strengths will be enhanced and operation efficiency will be improved. In addition, the Group continues to put more efforts in research and development (“**R&D**”) including (i) to develop software-based solution to broadcast the expected arrival time of ferries at ferry terminals; (ii) to apply robotic technology to transport the cash and banknote vault from ticket vending machines to the station audit rooms in order to reduce the human efforts to handle weighty objects; and (iii) to study the feasibility of producing a kiosk to handle ePayment transactions which could accept various ePayment methods including Octopus, various mobile and online payment methods and EMV cards. We expect that our efforts in R&D could on the one hand to catch up with the market demand and create more business opportunities, while to increase the efficiency and effectiveness of some of our working procedures.

致各位股東：

本人謹代表本公司及其附屬公司(統稱「**本集團**」)董事會(「**董事會**」)欣然呈報本集團截至二零二一年三月三十一日止年度的年度業績。

截至二零二一年三月三十一日止年度，本集團收益由截至二零二零年三月三十一日止年度約224.2百萬港元輕微增加約0.6百萬港元或約0.3%至截至二零二一年三月三十一日止年度約224.8百萬港元。本集團於截至二零二一年三月三十一日止年度錄得毛利約64.2百萬港元，較截至二零二零年三月三十一日止年度約71.3百萬港元減少約10.0%。由於香港社會整體上及我們內部安排採取預防措施，項目表現受到阻礙。然而，在政府補助及更好的成本控制下，本年度純利得到改善。截至二零二一年三月三十一日止年度，本集團純利增加至約32.0百萬港元，而截至二零二零年三月三十一日止年度約為21.6百萬港元。

於二零二一年三月，本集團獲授有關更換東鐵線車站及西鐵線車站的隔煙幕系統的新合約，合約價值約為61.8百萬港元。本集團於二零一八年九月獲授前述合約，有關更換及改動機場快線及東涌線的隔煙幕系統，合約價值約為70.0百萬港元並將於二零二一年下半年基本完成。我們很高興客戶對我們在機場快線及東涌線的表現感到滿意，並有信心再次授予我們其他線路的同類型合約。

與此同時，於港鐵出行實施快速響應碼(「**二維碼**」)項目於年內基本完成。與二零一五年，我們獲授為期三年的自動收費系統(「**自動收費**」)設備保養合約，及後獲延續三年，將於二零二二年財政年度內完成。本集團渴望及有信心延續該保養合約，並預期保養合約產生的收益將保持穩定增長。

在繼續開展機電(「**機電**」)工程及保養項目的同時，本集團加大力度進一步提升技術能力，例如投入資源實施建築信息模擬(「**BIM**」)，並開始應用虛擬現實(VR)、增強現實(AR)及混合現實(MR)技術為前線維護員工提供實時在線支持培訓。通過將先進技術引入我們的日常運營，預計將增強競爭優勢並提高運營效率。此外，本集團將繼續加大研發(「**研發**」)力度，包括(i)開發軟件解決方案，以在渡輪碼頭廣播渡輪預計抵達時間；(ii)應用機器人技術將現金和鈔票錢箱從自動售票機運送到車站審計室，以減少處理重物的人力；及(iii)研究製作處理電子支付交易的信息亭的可行性，其可接受各種電子支付方式，包括八達通、各種移動及在線支付方式以及EMV卡。我們預期，在研發上的努力一方面可迎合市場需求並創造更多商機，另一方面亦可提高若干工作程序的效率及有效性。

Apart from these, the Group has actively participated in campaigns organised by different governmental bodies. KML Engineering Limited ("**KML Engineering**"), a principal subsidiary of our Company, has been awarded the Gold Certificate of the inaugural Privacy-Friendly Awards and Equal Opportunity Employer for Gender Equality and Family Status Equality by the Privacy Commissioner for Personal Data Hong Kong and Equal Opportunities Commission Hong Kong respectively. The Group has been and will continue to be a socially responsible employer.

Year 2020 was a challenging year. Under the midst of worldwide pandemic of coronavirus disease 2019 (COVID-19), global economy has gone through a tough and challenging period. As the Group has taken timely and effective prevention and control measures to minimise the chance of our employees being infected and operation being suspended, COVID-19 pandemic has not caused material financial impacts to the Group up to the date of this report. Revenue of the Group for the year ended 31 March 2021 amounted to approximately Hong Kong dollars (“**HK\$**”) 224.8 million (2020: approximately HK\$224.2 million).

Gross profit of the Group for the year ended 31 March 2021 amounted to approximately HK\$64.2 million, representing a decrease of approximately HK\$7.1 million or approximately 10.0% as compared with approximately HK\$71.3 million for the year ended 31 March 2020.

The net profit of the Group for the year ended 31 March 2021 amounted to approximately HK\$32.0 million (2020: approximately HK\$21.6 million).

The Board recommends the payment of a final dividend of HK2.73 cents per ordinary share for the year ended 31 March 2021 (2020: HK2.0 cents).

### BUSINESS REVIEW

The Group has been providing E&M engineering solutions and services in Hong Kong for over 40 years. Our principal business is the provision of E&M engineering works, and comprises (i) E&M engineering solutions and services on Transportation Mission Critical Systems Solutions and other E&M engineering solutions and services; (ii) E&M engineering design and fabrication services; (iii) E&M engineering maintenance services; and (iv) sales of parts and components. Depending on our customers' needs and requirements, we provide a full spectrum of solutions and services covering design, equipment assembly, supply, installation, fabrication, testing, and commissioning and maintenance support with a focus on Hong Kong Transportation Mission Critical System Solutions.

The following table sets forth the details of our Group's revenue by type of projects and services we undertook for the years ended 31 March 2021 and 2020:

### 業務回顧

本集團於香港提供機電工程解決方案和服務逾四十年。我們的主要業務為提供機電工程作業，包括(i)交通關鍵系統解決方案的機電工程解決方案及服務和其他機電工程解決方案及服務；(ii)機電工程設計及裝配服務；(iii)機電工程保養服務；及(iv)銷售零件及部件。視乎客戶的需求及要求，我們提供涵蓋設計、設備裝置、供應、安裝、裝配、測試及調試以及維護支援的全面解決方案及服務，主要專注香港交通關鍵系統解決方案。

# Management Discussion and Analysis

## 管理層討論及分析

E&M Engineering Solutions and Services segment accounts for the largest business segment of our Group's business. Approximately 79.4% of the revenue was attributable to this segment for the year ended 31 March 2021. Some major projects of this segment include (i) replacement and upgrading of AFC gates and ticket issuing machines; (ii) replacement and modification of smoke curtains at the Airport Express Line (AEL) and Tung Chung Line (TCL); and (iii) application of QR Code for Travel on the MTR. The second largest segment is E&M Engineering Maintenance Services. Revenue from this segment increased by approximately 6.4% from approximately HK\$34.4 million for the year ended 31 March 2020 to approximately HK\$36.6 million for the year ended 31 March 2021. Major maintenance projects include maintenance services for AFC and access control system (ACS) equipment, maintenance services for AFC equipment at Shatin Central Link (SCL) and maintenance services for signalling equipment for Express Rail Link (XRL). The 3-year maintenance contract on the AFC equipment awarded to us at year 2015, and subsequently extended for another 3 years will be completed during the financial year ending 2022. This 3+3 maintenance contract generated the Group with a revenue over HK\$70 million. The Group is keen and confident to pursue the continuance of this maintenance contract and expect that the revenue generated from our maintenance contracts will maintain a steady growth.

During the year ended 31 March 2021, the Group has submitted 339 tenders and quotations to our customers (2020: 325 tenders and quotations) with 135 contracts being awarded (2020: 165 contracts) including (i) supply of AFC equipment for a new station at the Taoyuan Airport MRT; (ii) supply and installation charging facilities for electric vehicles in a public carpark; (iii) provision of electrical supervision work for part of a new Integrated Waste Management Facilities Project in Hong Kong; and (iv) replacement of smoke curtains at East Rail Line (ERL) and West Rail Line (WRL) Stations.

In respect of promoting social responsibility, our Group participated various campaign and activities during the year. For example, (i) KML Engineering was recognised as a "Construction Industry Caring Organisation" by the Construction Industry Council ("CIC"); (ii) KML Engineering participated the "Life First" campaign organised by the CIC; and (iii) KML Engineering signed the "Mental Health Workplace Charter" jointly organised by the Department of Health, the Labour Department and the Occupational Safety and Health Council, and was commended as a "Mental Health Friendly Supreme Organisation".

In response to the outbreak of COVID-19, a working group has been set up to regularly review the pandemic condition, coordinate and arrange various provision of services including supply of sufficient masks and hand sanitiser to our employees, ensured strict observance of personal and environmental hygiene and daily body temperature checks for employees and visitors entering into our premises. Besides, we have engaged specialist contractors to conduct a thorough cleaning and a long-acting antibacterial coating spraying at our premises. All these efforts aimed to ensure the health and safety of our employees and facilitate the prevention the outbreak in our premises.

機電工程解決方案及服務分部為本集團的最大業務分部。截至二零二一年三月三十一日止年度，約79.4%的收益來自該分部。該分部若干主要項目包括(i)更換及更新自動收費設備(閘機及售票機)；(ii)更換及改動機場快線及東涌線的隔煙幕系統；及(iii)於港鐵出行應用二維碼。第二大分部為機電工程保養服務。該分部的收益由截至二零二零年三月三十一日止年度約34.4百萬港元增加約6.4%至截至二零二一年三月三十一日止年度約36.6百萬港元。主要保養項目包括自動收費及出入控制系統(ACS)設備保養服務、沙田至中環線自動收費設備保養服務及高鐵信號設備保養服務。我們於二零一五年獲授為期三年的自動收費設備保養合約，及後獲延續三年，將於二零二二年財政年度內完成。3+3保養合約為本集團帶來的收益超過70百萬港元。本集團渴望及有信心延續該保養合約，並預期保養合約產生的收益將保持穩定增長。

截至二零二一年三月三十一日止年度，本集團已向客戶提交339項投標及報價(二零二零年：325項投標及報價)，獲授135份合約(二零二零年：165份合約)，包括(i)為桃園機場捷運一個新車站提供自動收費系統設備；(ii)為一個公共停車場提供及安裝電動汽車充電設施；(iii)為香港一個新綜合廢物管理設施項目提供部分電力監督工作；及(iv)更換東鐵線車站及西鐵線車站的隔煙幕系統。

就推動社會責任而言，本集團於年內參與多項活動。例如，(i)高明科技工程獲建造業議會(「建造業議會」)肯定為「建造業關愛機構」；(ii)高明科技工程參加建造業議會舉行的「生命第一」安全推廣活動；及(iii)高明科技工程簽署由衛生署、勞工處及職業安全健康局合辦的「精神健康職場約章」，並被評定為「精神健康友善卓越機構」。

為應對爆發COVID-19，本公司成立了一個工作組，定期審查疫情情況，協調及安排各種服務，包括向僱員提供足夠的口罩和洗手液，確保嚴格遵守個人及環境衛生，並對進入物業的僱員及訪客進行日常體溫檢查。此外，本公司已委聘專業承包商對場地進行徹底清潔及長效抗菌塗層噴塗。所有該等措施旨在確保僱員健康及安全，及有效預防本公司物業爆發疫情。

### OUTLOOK

The Group has been putting much effort to deepen our penetration in the E&M engineering industry and diversify our exposure at various E&M sectors. At the new financial year, the Group continues to benefit from the renovation and replacement of E&M, communication and AFC assets projects from our customers, we foresee a steady growth of revenue to be generated from this sector. At the first two months for the year ended 31 March 2022, two major projects were awarded to the Group which include : (i) refurbishment and replacement of air handling units (AHU) and primary air units (PAU) in Tsuen Wan Line (TWL), Kwun Tong Line (KTL), Island Line (ISL), Air Express Line (AEL), Tung Chung Line (TCL), Disneyland Resort Line (DRL), Tseung Kwan O Line (TKL) and East Rail Line (ERL) and (ii) revamp of trackside advertising panels along West Rail Line (WRL). These two projects amounted to approximately HK\$50.0 million. In addition, in order to prepare Hong Kong with the required charging infrastructure to support the wider use of electric private cars (“e-PCs”), the Government of the Hong Kong Special Administrative Region (“HKSAR”) is forward-looking and has been encouraging, among other initiatives, the installation of electric vehicle (“EV”) charging-enabling infrastructure (“EVCEI”) in private car parks. A HK\$2 billion pilot subsidy scheme was launched to promote installation of EVCEI in car parks of existing private residential buildings. The scheme, namely the “EV-charging at Home Subsidy Scheme” (“EHSS”), is to help car parks of existing private residential buildings with multiple ownership resolve technical and financial difficulties that are encountered frequently when retrofitting EVCEI and further facilitate car park owners to install EV chargers (or EV supply equipment) of their choice in the future in a simple and easy manner. The Group by utilising our experience and expertise is pursuing business opportunities in this area.

Besides, a new subsidiary will be set up this year targeting to the ePayment business. By making use of the knowledge and experience we gained when carrying out the project at the Taoyuan MRT on the integration of mobile payment application with QR Code and various contactless payment method, the Group has lined up with various business partners including bank and digital payment providers with a planning to take up broader roles in the ePayment business arena such as becoming a facilitator.

### FINANCIAL REVIEW

#### Revenue

Revenue of the Group for the year ended 31 March 2021 amounted to approximately HK\$224.8 million, representing more or less the same level as compared with approximately HK\$224.2 million for the year ended 31 March 2020.

#### Cost of Sales and Gross Profit

The majority of the Group’s cost of sales comprised (i) material and equipment; (ii) direct labour; and (iii) sub-contracting cost. The cost of sales increased by approximately 5.1% from approximately HK\$152.9 million for the year ended 31 March 2020 to approximately HK\$160.7 million for the year ended 31 March 2021. The increase in cost of sales was mainly due to a decrease of efficiency when carrying out our projects during the COVID-19 pandemic. The gross profit of the Group decreased by approximately 10.0% from approximately HK\$71.3 million for the year ended 31 March 2020 to approximately HK\$64.2 million for the year ended 31 March 2021. The decrease in gross profit was mainly due to (i) the increase of cost of sales as discussed above; and (ii) a decrease of gross profit margin for project during the period.

### 前景

本集團一直致力於加深對機電工程行業的滲透率及擴展我們於不同機電領域的業務。於新財政年度，本集團繼續自機電、通信及自動收費系統資產的翻新及更新項目獲益，我們預期產生自該領域的收益將平穩增長。於截至二零二二年三月三十一日止年度首兩個月，本集團獲授兩個主要項目，包括：(i)翻新及更換荃灣線、觀塘線、港島線、機場快線、東涌線、迪士尼線、將軍澳線及東鐵線的風櫃及(ii)翻新西鐵線沿線軌道旁廣告牌。該兩個項目約為50.0百萬港元。此外，為支持廣泛使用電動私家車（「**電動私家車**」），香港特別行政區（「**香港特區**」）政府一直推出各項前瞻性措施，如鼓勵私人停車場安裝電動車（「**電動車**」）充電基礎設施（「**電動車充電基礎設施**」）等，令香港可以在電動車充電基礎設施方面作好準備。一個20億港元先導資助計劃，推動在現有私人住宅樓宇停車場安裝電動車充電基礎設施。該先導資助計劃，即「**EV屋苑充電易資助計劃**」，旨在協助由不同業權人共有的現有私人住宅樓宇及屋苑停車場解決在加裝電動車充電基礎設施時經常遇到的技術和財政困難，方便停車場業主日後可簡易地安裝他們選擇的充電器。本集團正利用其經驗及專長致力掌握商機。

此外，本年度將成立一家新附屬公司，專注於電子支付業務。利用在桃園捷運項目中將二維碼與各種免觸支付方式相結合所獲得的知識及經驗，本集團已與不同業務夥伴（包括銀行及電子支付供應商）結盟，計劃在電子支付業務領域扮演更廣泛的角色（例如成為服務商）。

### 財務回顧

#### 收益

本集團截至二零二一年三月三十一日止年度的收益約為224.8百萬港元，較截至二零二零年三月三十一日止年度的約224.2百萬港元維持差不多的水平。

#### 銷售成本及毛利

本集團的主要銷售成本包括(i)物料及設備；(ii)直接勞工；及(iii)分包成本。銷售成本由截至二零二零年三月三十一日止年度約152.9百萬港元增加約5.1%至截至二零二一年三月三十一日止年度約160.7百萬港元。銷售成本增加主要由於COVID-19疫情期間項目開展的效率降低。本集團毛利由截至二零二零年三月三十一日止年度約71.3百萬港元減少約10.0%至截至二零二一年三月三十一日止年度約64.2百萬港元。毛利減少主要由於(i)上文所討論銷售成本增加；及(ii)期內工程的毛利率下跌。

### Administrative Expenses

The Group's administrative expenses decreased by approximately 11.9% from approximately HK\$46.1 million for the year ended 31 March 2020 to approximately HK\$40.6 million for the year ended 31 March 2021. Such decrease was mainly due to (i) a decrease of professional and legal fees incurred as compared with the year ended 31 March 2020; (ii) better cost control measures implemented; and (iii) a decrease of staff cost in relation to reduced staff gathering events due to the various measures of social distancing and requirements to reduce gatherings.

### Profit attributable to the owners of the Company

The Group recorded net profit attributable to the owners of the Company of approximately HK\$32.0 million for the year ended 31 March 2021 (2020: net profit of approximately HK\$21.6 million). The increase in net profit is mainly due to (i) financial support received from the Government of the HKSAR in response to the novel coronavirus epidemic; (ii) a decrease of administrative expenses; and (iii) receipt of a long outstanding payment from a customer.

## FINANCIAL POSITION

### Liquidity, Financial Resources and Capital Structure

Historically, the Group has met the liquidity and capital requirements primarily through operating cash flows and capital contribution from its Shareholders.

The Group requires cash primarily for working capital needs. As at 31 March 2021, the Group had approximately HK\$113.9 million in (i) bank balances and cash; and (ii) time deposits with original maturity over three months (2020: approximately HK\$83.0 million), representing an increase of approximately HK\$30.9 million as compared to that as at 31 March 2020.

There are 2,500,000 shares (“**Share(s)**”) issued on 2 March 2021 pursuant to exercise of share options granted under the share option scheme adopted on 20 September 2017.

Save as disclosed above, there has been no change on the capital structure of the Group for the year ended 31 March 2021 and up to the date of this report (i.e. 17 June 2021) (the “**Date of this Report**”). The share capital of the Company only comprises of ordinary shares.

As at 31 March 2021, the issued share capital of the Company was HK\$4,025,000 divided into 402,500,000 Shares of HK\$0.01 each.

### Capital Expenditure

The Group purchased property, plant and equipment amounting to approximately HK\$1.9 million for the year ended 31 March 2021 which comprised acquisition of furniture, fixtures and office equipment (2020: approximately HK\$4.8 million).

### Final Dividend

The Board recommends the payment of a final dividend of HK2.73 cents per Share for the year ended 31 March 2021 (2020: HK2.0 cents).

### 行政開支

本集團行政開支由截至二零二零年三月三十一日止年度約46.1百萬港元減少約11.9%至截至二零二一年三月三十一日止年度約40.6百萬港元。有關減少主要由於(i)所產生專業及法律費用較截至二零二零年三月三十一日止年度減少；(ii)實施更好的成本控制措施；及(iii)由於各種保持社交距離措施及員工聚集活動減少令員工成本降低。

### 本公司擁有人應佔溢利

截至二零二一年三月三十一日止年度，本集團錄得本公司擁有人應佔純利約32.0百萬港元(二零二零年：純利約21.6百萬港元)。純利增加主要由於(i)香港特區政府為應對新型冠狀病毒疫情而提供的財政支持；(ii)行政開支下降；及(iii)收到來自一名客戶的長期未清償款項的付款。

### 財務狀況

#### 流動資金、財務資源及資本架構

過往，本集團主要透過經營現金流量及股東注資滿足其流動資金及資本需求。

本集團主要需要現金應付營運資金需要。於二零二一年三月三十一日，本集團有(i)銀行結餘及現金；及(ii)原到期日超過三個月的定期存款合共約113.9百萬港元(二零二零年：約83.0百萬港元)，較於二零二零年三月三十一日增加約30.9百萬港元。

於二零二一年三月二日，2,500,000股股份(「**股份**」)因行使根據於二零一七年九月二十日採納的購股權計劃所授予的購股權而發行。

除上文所披露者外，於截至二零二一年三月三十一日止年度及直至本報告日期(即二零二一年六月十七日)(「**本報告日期**」)，本集團股本架構並無任何變動。本公司股本僅包括普通股。

於二零二一年三月三十一日，本公司已發行股本為4,025,000港元，分為402,500,000股每股0.01港元的股份。

#### 資本開支

截至二零二一年三月三十一日止年度，本公司購買金額約1.9百萬港元的物業、廠房及設備，當中包括購買傢俱、裝置及辦公室設備(二零二零年：約4.8百萬港元)。

#### 末期股息

董事會建議派付截至二零二一年三月三十一日止年度的末期股息每股2.73港仙(二零二零年：2.0港仙)。

### Employees and Remuneration Policies

As at 31 March 2021, the Group employed 203 employees (2020: 199 employees). The Group's remuneration policies are in line with the prevailing market practice and are determined on the basis of performance, qualification and experience of individual employee. On top of basic salaries, bonus may be paid with reference to the Group's performance as well as individual's performance. Other staff benefits include provision of retirement benefits, medical and life insurance benefits. Share options and/or share awards may also be granted to eligible employees by reference to the Group's performance as well as the individual contribution.

### Comparison of Business Objectives with Actual Business Progress

An analysis comparing the business objectives as set out in the Company's prospectus dated 29 September 2017 (the "Prospectus") with the Group's actual business progress for the period from 16 October 2017 (the "Listing Date") to 31 March 2021 is set out below:

#### Business strategy

Expand and enhance our E&M engineering technical capabilities

#### Actual business progress up to 31 March 2021

The Group has purchased several fibre cable testing related equipment in order to maintain our competitiveness in the railway sector as the Group anticipates that E&M engineering systems in the railways will rely increasingly on optical fibre networks to transfer relevant system data in the future.

The Group has purchased additional equipment for material handling and field services for carrying out high level works. It helps to maintain our competitiveness and operational flexibility as well as work safety.

The Group has arranged specific trainings for employees on BIM and is in the processing of procurement of additional hardware and software in order to fulfill upcoming contract requirement, promote productivity and uplift quality of our work.

The Group has rented and continued the rental of additional space and storage facilities to cater for space required for operation and to accommodate the new machineries and equipment purchased.

The Group has purchased four vehicles to increase our travelling efficiency and allow our project teams to transport additional spare parts and equipment for use in our operations.

The Group has continued to enhance our insurance coverage and employee remuneration packages, including (i) upgrading of employees' medical insurance plan; (ii) purchasing of the Group's professional indemnity insurance plan; (iii) purchasing of the Group's product liability insurance plan; and (iv) providing funds for the employees' performance bonus scheme and share award scheme as one of the measures for retaining talents and risk mitigation.

### Use of Proceeds from the Listing

On 16 October 2017, the Shares were listed on GEM by way of Share Offer (“Listing”). The Group intends to apply the proceeds from the Listing in accordance with the proposed applications set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

After deduction of all related Listing expenses and commissions, the net proceeds from Listing amounted to approximately HK\$36.0 million. The Board resolved on 10 July 2019 to change the intended use of part of the net proceeds from Listing. For further details, please refer to the announcement of the Company dated 10 July 2019.

The net proceeds have been utilised in a manner consistent with the disclosures set out in the Prospectus and the said announcement of the Company dated 10 July 2019. An analysis of the planned usage of net proceeds, the actual utilisation of the net proceeds from the Listing Date up to 31 March 2021, the revised use of net proceeds and the expected time line for utilising the remaining unused net proceeds are set out as below:

### GEARING RATIO

The ratio was not applicable for the year ended 31 March 2021 as no borrowing was incurred (2020: Nil).

### FOREIGN EXCHANGE EXPOSURE

We conducted business with customers, suppliers and subcontractors located in Hong Kong, the People's Republic of China (the "PRC") and overseas. The Group's exposure to the currency risk mainly arises from the fluctuation of Renminbi ("RMB"), Euro ("EUR") or United States dollars ("USD"). The Group currently does not have any hedging policy in place for its foreign currency exposure. The management will consider hedging significant currency exposure should the need arise.

### TREASURY POLICIES

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the year ended 31 March 2021. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

### SIGNIFICANT INVESTMENTS AND FUTURE PLANS FOR MATERIAL INVESTMENTS AND CAPITAL ASSETS

The Group did not hold any significant investments in equity interest in any other companies as at 31 March 2021. # Management Discussion and Analysis

## 管理層討論及分析

### PRINCIPAL RISKS AND UNCERTAINTIES

For the year ended 31 March 2021, the following principal risks of the Group were identified:

- (i) If the Group is unable to effectively monitor and implement work safety measures at project sites, in the event of serious injuries and casualties, the Group could suffer heavy penalties and its reputation could be adversely affected.
- (ii) the Group relies on a few numbers of key customers which may result in over-reliance on these particular customers. The loss of one customer or downsizing of these customers could potentially have a significant impact to the Group's revenue.
- (iii) the Group is facing challenges in identifying competent candidates with the right qualification, experience and background as successors of senior management positions. If the Group is unable to develop, attract and retain employees with capabilities and commitment needed, achievement of long run objectives may be jeopardised.
- (iv) technologies are rapidly changing. If the Group fails to keep up with technological advancement, it could jeopardise our competitiveness in the industry.
- (v) if the pandemic is not under control, and the travel restrictions and compulsory quarantine requirements continue, collaboration with overseas business partners as well as supply chain may be adversely affected which may result in project delay or reduced efficiency. Besides, if there is a confirmed or suspected case(s) of COVID-19 at the workplace, the workplace may need to be closed and may eventually lead to business interruption and/or project delay.

#### Our Risk Control Mechanism

The Group has adopted a three-tier risk management approach to identify, assess, mitigate and handle risks. At the first line of defence, operating units are responsible for identifying and monitoring risks associated with each business. The management, as the second line of defence, defines rules and models, provides technical support, develops new systems and oversees portfolio management. It ensures that risks are within acceptable range and that the first line of defence is effective. As the final line of defence, the risk management committee of the Company (the "Risk Management Committee"), with the professional and independent advice from the internal audit function ensures the first and second line of defence are effective through constant inspection and monitoring.

The Group maintains a risk register to keep track of all identified major risks of the Group. The risk register provides the Board, the Risk Management Committee and management with a profile of its major risks and records management's action taken to mitigate the relevant risks. The risk register will be reviewed and monitored at least annually. The review process ensures that the Group proactively manages the risks faced by it.

### 主要風險及不確定性

- (ii) 本集團依賴少數主要客戶，可能導致過度依賴該等特定客戶。失去其中一位客戶或該等客戶規模縮減可能會對本集團收益產生重大影響。
- (iii) 本集團於識別具有合適資格、經驗及背景的可勝任候選人擔任高級管理層職務的繼任人時面臨挑戰。倘本集團未能發展、吸引及挽留具有所需能力及承擔的僱員，長期目標的實現可能受到損害。
- (iv) 技術發展瞬息萬變。倘本集團未能緊跟技術提升，則可能損害我們於行業中的競爭力。
- (v) 倘疫情未得到控制，旅遊限制及強制隔離的要求持續，則與海外業務夥伴的合作以及供應鏈可能受到不利影響，從而導致項目延遲或效率降低。此外，倘工作場所出現COVID-19確診或疑似病例，工作場所可能需要關閉，並最終可能導致業務中斷及／或項目延遲。

#### 風險控制機制

本集團已採納三層風險管理方法以識別、評估及降低及應對風險。在第一道防線，營運組別負責識別及監察與各項業務相關的風險。管理層（作為第二道防線）界定規則及模式、提供技術支援、開發新系統及監督投資組合管理。其確保風險處於可接受範圍內及第一道防線為有效。作為最後一道防線，本公司的風險管理委員會（「風險管理委員會」），加上來自內部審計職能的專業及獨立意見，透過不斷視察及監控而確保第一道及第二道防線有效。

本集團設立風險登記冊以跟踪本集團所有已識別主要風險。風險登記冊為董事會、風險管理委員會及管理層提供其主要風險情況，並記錄管理層為降低相關風險所採取的行動。每年至少檢討及監察風險管理冊一次。此檢討程序可確保本集團主動管理其所面臨的風險。

He is admitted a member and registered as a Chartered Electrical Engineer by The Institution of Electrical Engineers (currently known as the Institution of Engineering and Technology), the United Kingdom, and a Chartered Engineer by the Council of Engineering Institutions, the United Kingdom. He is also admitted as a member of the Hong Kong Institution of Electrical Engineers, a member of Institution of Railway Signal Engineers, and a member of Hong Kong Association of Energy Engineers. He was nominated as the Country Vice President of Institution of Railway Signal Engineers for Hong Kong, China in March 2011.

Mr. KM Luk is the father of Mr. Luk Kwai Lung (“**Mr. KL Luk**”) and Mr. Luk Yin Cheung (“**Mr. YC Luk**”), both our Executive Directors. Mr. KM Luk is also the spouse of Ms. Leung Kwok Yee (“**Madam Leung**”), our controlling Shareholder, and the father-in-law of Ms. Woo Siu Wai (“**Madam Woo**”), our company secretary.

**Mr. Chan Chak Lun Philip (陳澤麟)**, aged 59, is an Executive Director and our chief executive officer. Mr. Chan is responsible for overseeing the daily operations and overall general management of our Group. Mr. Chan is also a member of the Risk Management Committee.

Mr. Chan has more than 30 years of experience in E&M engineering. He joined KML Engineering in October 1987. Since then, he has served our Group in various capacities including engineer, general manager of advanced products department, the operation director and the managing director of KML Engineering.

Mr. Chan has been a director of KML Engineering since June 1991. He is a technical director and one of the authorised signatories appointed by KML Engineering for its qualification as a Registered Minor Works Contractor for Type A and Type C of Class II & III under the Buildings Ordinance.

Mr. Chan obtained a degree of Bachelor of Engineering with first class honours in mechanical engineering from the Newcastle University (formerly known as “University of Newcastle upon Tyne”), the United Kingdom and a degree of Master of Science in Engineering from The University of Hong Kong, Hong Kong. As at 31 March 2021, the Group employed 203 employees. We maintained a good working relationship with our employees and we did not experience any labour disputes during the year ended 31 March 2021. Recruitment in the E&M engineering service industry is highly competitive, especially with respect to the recruitment of qualified engineering staff. We believe we are hiring high-quality employees in the market by offering competitive wages and benefits and comprehensive training opportunities. We have facilitated the recruitment through a variety of channels, such as newspapers, internet websites, recruitment agencies, career talks and internal referrals. We believe our continuous efforts will help us attract suitable personnel.

#### Customers

Our customers mainly comprise transportation companies and other engineering companies in Hong Kong and Taiwan and also various departments of the Hong Kong Government. We maintain business relationship with our largest customer since year 1978. We usually enter into agreements with our customers on project basis and the majority of such contracts have term over one year. Most of our project contracts are fixed price contracts. The lump sum price is usually determined based on factors including project requirements and estimated cost of materials, labour and time required for completion of the projects.

#### Suppliers

The Group sources equipment, parts and components from our suppliers. The principal materials and equipment used by our E&M engineering business include steel and copper parts, switchboards, and various mechanical equipment. Most of these materials and equipment are sourced from local suppliers or imported mainly from Germany, Taiwan and the PRC.

### FINANCIAL SUMMARY

A summary of the Group's results, assets and liabilities for the last five financial years is set out on page 128 of this Report. This summary does not form part of the audited consolidated financial statements.

### SHARE OPTION SCHEME

In order to recognise and acknowledge the contributions that the directors and employees of the Group have made or may make to the Group, the Company approved and adopted the share option scheme pursuant to the written resolutions of the Shareholders passed on 20 September 2017 (the "Share Option Scheme"). The principal terms of the Share Option Scheme are summarised below:

- (i) the Board may, at its absolute discretion and on such terms as it may think fit, grant an option to subscribe any director or employee of the Group, from time to time on the basis of his/her contribution or potential contribution to the development and growth of the Group;

Any further grant of options in excess of such limit must be separately approved by Shareholders in general meeting with such grantee and his/her close associates abstaining from voting;

The value of the Options is subject to certain fundamental limitations, including the subjective nature of and uncertainty relating to a number of assumptions of the expected future performance input to the model, and certain inherent limitations of the model itself. The expected volatility was determined with reference to the historical daily volatilities of the Share price of the Company. Pursuant to the deed of non-competition dated 20 September 2017 (the "**Deed of Non-competition**") entered into by the Group and Mr. KM Luk, Madam Leung, Mr. KL Luk, Mr. YC Luk and KML Holdings (collectively, the "**Controlling Shareholders**") and as covenators (collectively, the "**Covenators**"), each of the Covenators has irrevocably and unconditionally undertaken to and covenanted with the Company (for itself and as trustee for its subsidiaries) that, subject to the exceptions as described in the Prospectus, during the period that the Deed of Non-Competition remains effective, he/she/it shall not, and shall procure that his/her/its associates (other than any members of the Group) will not, during the term of the Deed of Non-Competition, directly or indirectly, either for his/her/its own account or in conjunction with or on behalf of or for any other person, firm or company, whether for profit, reward or otherwise, (i) carry on, participate in, be interested or engaged in, or acquire or hold any right or interest (in each case whether as a shareholder, partner, agent, consultant, employee or otherwise) directly or indirectly in any business which is or likely to be in competition with the business currently from time to time engaged by the Group (the "**Restricted Business**") in Hong Kong, Taiwan and any other country or jurisdiction which any member of the Group provides such services and/or in which any member of the Group carries on its business currently and from time to time (the "**Territory**"); (ii) solicit, interfere with or endeavour to entice away from any member of the Group any person, firm, company or organisation who to his/her/its knowledge is now or has been a customer, supplier, subcontractor or employee of any member of the Group in the past twelve months before such proposed engagement or employment; or (iii) without prior written consent of the Company, make use of any information pertaining to the business, which have or may have come to his/her/its knowledge in his/her/its capacity as a Controlling Shareholder and/or Director for any purpose of his/her/its capacity as a Controlling Shareholder and/or Director for any purpose of his/her/its engaging, investing or participating in any Restricted Business in the Territory. For details of the above, please refer to the Prospectus.

The Company has received confirmations from the Controlling Shareholders confirming their compliance with the Deed of Non-competition respectively during the Reporting Period for disclosure in this Report.

The independent non-executive Directors have reviewed the Deed of Non-competition during the Reporting Period and based on the information and confirmation provided by or obtained from the Controlling Shareholders and they were satisfied that the Controlling Shareholders have duly complied with the Deed of Non-competition during the Reporting Period.

#### Tenancy Agreement

KML Engineering, a wholly-owned subsidiary of the Company, as tenant entered into a tenancy agreement on 30 March 2020 (the **"Tenancy Agreement"**) with K M L Limited as landlord in respect of Workshop 12 on G/F of Block B, Workshop 5 on 1/F with Flat Roof of Block B, Workshops 7, 9, 10 and 11 on 1/F of Block B, Workshop 7 on 3/F with Flat Roof of Block B and Car Parking Spaces numbered V20, V25, L33, L37 and L39, Shatin Industrial Centre, Nos. 5-7 Yuen Shun Circuit, Shatin, New Territories, Hong Kong (the **"Premises"**) for a term of 18 months from 1 April 2020 to 30 September 2021 (both days inclusive). As the applicable percentage ratios in respect the Tenancy Agreement exceed 5% but are less than 25% and the value of the right-of-use of the Premises is less than HK\$10,000,000, the transaction contemplated under the Tenancy Agreement constitutes a connected transaction of the Company and is subject to the reporting and announcement requirements under Chapter 20 of the GEM Listing Rules but exempt from the circular (including independent financial advice) and Shareholders' approval requirements under the GEM Listing Rules.

K M L Limited is a company incorporated in Hong Kong and owned as to 78.2% by Golden Sail International Limited (**"Golden Sail"**), which is wholly-owned by a trustee for a family trust where the beneficiaries include Mr. KM Luk and Madam Leung. Therefore, K M L Limited is an associate of each of Mr. KM Luk and Madam Leung, and hence is a connected person of the Company.

The Group has been leasing the Premises from K M L Limited as its head office and workshops in Hong Kong for more than 20 years. The Company considers that it would be beneficial to lease the Premises as it will enable the Group to secure its stable operation at the Premises without incurring additional costs and expenses in identifying, renovating and relocating to alternative premises and ensure that there will be no disruption to the operations, business and growth of the Group.

Save as disclosed in this Report, during the Reporting Period, the Company had no connected transactions or continuing connected transactions which fell to be disclosed in accordance with the provisions under Chapter 20 of the GEM Listing Rules in relation to the disclosure of connected transactions and continuing connected transactions.

The related party transactions as disclosed in note 27 to the consolidated financial statements constituted as connected transactions or continuing connected transactions as defined in Chapter 20 of the GEM Listing Rules and in compliance with the disclosure requirements under Chapter 20 of the GEM Listing Rules.

### TERMS OF APPOINTMENT AND RE-ELECTION OF DIRECTORS

Each of the executive Directors has signed a service agreement with the Company for a term of three years and will continue thereafter until terminated in accordance with terms of the agreement.

Each of the independent non-executive Directors has renewed the letter of appointment with the Company for a term of three years, which may be renewable subject to both parties' agreement.

None of the Directors has a service agreement / letter of appointment which is not determinable by the Group within one year without payment of compensation (other than statutory compensation).

The procedures and process of appointment, re-election and removal of Directors are set out in the Articles of Association. The Nomination Committee is responsible for reviewing the Board composition and making recommendations to the Board on the appointment or re-election of Directors and succession planning for Directors.

### COMPLIANCE WITH THE REQUIRED STANDARD OF DEALINGS IN SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the required standard of dealings set out in Rules 5.48 to 5.67 of the GEM Listing Rules as its own code of conduct regarding Directors' securities transactions in the securities of the Company.

The Company has made specific enquiries to all Directors about their compliance with the required standard of dealings from the Listing Date and up to 31 March 2021, without noticing any violation of the required standard.

### DELEGATION BY THE BOARD

The Board reserves for its decision on all major matters of the Company, including approval and monitoring of all policy matters, overall strategies and budgets, risk management and internal control systems, material transactions (in particular those that may involve conflict of interests), financial information, appointment of Directors and other significant financial and operational matters. Directors are provided with sufficient resources to seek independent professional advice in performing their duties at the Company's expense and are encouraged to access and to consult with the Company's senior management independently.

The daily management, administration and operation of the Group are delegated to the senior management. The delegated functions and responsibilities are periodically reviewed by the Board. Approval has to be obtained from the Board prior to any significant transactions entered into by the management.

### CORPORATE GOVERNANCE FUNCTION

The Board recognises that corporate governance should be the collective responsibility of the Directors which includes:

- (i) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements;

- (iii) to develop, review and monitor the codes of conduct and compliance manuals applicable to employees and the Directors;
- (iv) to develop and review the Company's policies and practices on corporate governance and make recommendations to the Board on such matters;
- (v) to review the Company's compliance with the CG Code and disclosure in the corporate governance report; and
- (vi) to review and monitor the Company's compliance with the Company's whistleblowing policy.

### BOARD MEETINGS

The Company adopts the practice of holding Board meetings regularly, at least four times a year, and at approximately quarterly intervals. Notices of not less than 14 days are given for all regular Board meetings to provide all Directors with an opportunity to attend and include matters in the agenda for a regular meeting.

For other Board and Board Committee meetings, reasonable notice is generally given. The agenda and accompanying board papers are despatched to the Directors or Board Committees members at least three days before the meetings to ensure that they have sufficient time to review the papers and are adequately prepared for the meetings. When Directors or Board Committee members are unable to attend a meeting, they will be advised of the matters to be discussed and given an opportunity to make their views known to the chairman of the Board or the relevant Board Committees prior to the meeting. Minutes of the meetings are kept by the company secretary with copies circulated to all Directors to the relevant Board Committees members for information and records.

Minutes of the Board meetings and Board Committees meetings are recorded in sufficient details about the matters considered by the Board and the Board Committees and the decisions reached, including any concerns raised by the Directors or the Board Committees members. Draft minutes of each Board meeting and Board Committee meeting are sent to the Directors or the Board Committees members for comments within a reasonable time after the date on which the meeting is held. Minutes of the Board meetings and the Board Committees are open for inspection by Directors.

### Policy on Directors Nomination

The Company has adopted a nomination policy stating the process and criteria to select and recommend candidates for directorship during the Reporting Period. In identifying suitable candidate qualified to become Board members, the Nomination Committee shall consider the attributes complementary to the Board, business experience and Board Expertise and skills, availability, motivation, integrity and independence of candidates.

The Nomination Committee had one meeting during the Reporting Period to assess the independence of independent non-executive Directors and consider the re-appointments of the retiring Directors.

### Board Diversity Policy

The Board has adopted a board diversity policy, a summary of which is set out below:

- (i) with a view to achieving a sustainable and balanced development, the Company sees increasing diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development;
- (ii) in designing the Board's composition, Board diversity has been considered from a number of aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service;
- (iii) all Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board;
- (iv) selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board;

The Risk Management Committee comprises five members, namely Mr. LAW Wing Chi Stephen (chairman), Mr. CHAN Chak Lun Philip, Mr. LAU On Kwok, Mr. LUK Kwai Lung and Mr. LUK Yin Cheung.

The principal duties of the Risk Management Committee include the following:

- (i) to review the Group's risk management system, including risk, capital and liquidity management framework, the Group's risk tolerance capability, its risk policies and standards, and relevant risk limits, including the parameters used and the methodology adopted, and the processes used for identifying and assessing risks;
- (ii) to approve risk policies and standards, referring any new material policies/standards or material changes to existing policies/standards/limits to the Board for approval;
- (iii) to discuss the risk management system with the management and ensure that the management has performed its duties to establish an effective system. The contents to be discussed include the Company's resources for risk management, adequacy of qualifications and experiences of the employees, as well as adequacy of training courses and relevant budgets available to the employees;
- (iv) to review material risk exposures of the Group, including market, credit, insurance, operational, liquidity, and economic and regulatory capital risks against the Group's risk measurement methodologies and management actions to monitor and control such exposures;
- (v) to review annually the changes, since the last annual review, in the nature and extent of significant risks, and the issuer's ability to respond to changes in its business and the external environment; and
- (vi) to review annually the effectiveness of the issuer's processes for financial reporting and compliance of the Listing Rules.

### RISK MANAGEMENT AND INTERNAL CONTROL

The Board acknowledges that it is its responsibility to ensure that the Company establishes and maintains sound risk management and internal control systems within the Group and to review the effectiveness of the systems. Such systems are designed to manage and mitigate risks inherent in the Group's business faced by the Group to an acceptable level, but not eliminating the risk of failure to achieve business objectives, and can only provide reasonable assurance against material misstatement, loss or fraud.

The Board has entrusted the Risk Management Committee with the responsibility to oversee the risk management and internal control systems of the Group on an on-going basis and to review the effectiveness of the systems annually. The annual review covered all material controls, including financial, operational and compliance controls.

Under the Company's risk management and internal control structure, the management is responsible for the design, implementation and maintenance of risk management and internal control systems to ensure, amongst others, (i) appropriate policies and control procedures have been designed and established to safeguard the Group's assets against improper use or disposal; (ii) relevant laws, rules and regulations are adhered to and complied with; and (iii) that reliable financial and accounting records are maintained in accordance with relevant accounting standards and regulatory reporting requirements.

No significant control failings or weaknesses were identified during the Reporting Period.

The main features of risk management and internal control structure of the Company is as follows:

- (i) heads of each operation unit or department manage major risks affecting the Group's businesses and operations through the processes of risk identification, risk assessment and implementation of risk mitigation measures in accordance with the internal guidelines approved by the Board and the Risk Management Committee;
- (ii) the management ensures appropriate actions are taken on major risks affecting the Group's businesses and operations; and
- (iii) internal auditors provide independent assurance to the Board, the Risk Management Committee and the management concerning the effectiveness of risk management and internal control systems.

During the year ended 31 March 2021, major works performed by the management in relation to risk management and internal control include the following:

- (i) reviewed the progress of the implementation of the mitigation plan for the major risks identified for the year ended 31 March 2020;
- (ii) identified new risks at corporate level for year ended 31 March 2021; and incorporated them into risk register for risk assessment;

Based on the findings of the internal audit and the comments of the Risk Management Committee, the Board considered that the risk management and internal control systems are effective and adequate.

### INSIDE INFORMATION DISCLOSURE POLICY

The Company has established a policy on the handling and dissemination of inside information (“**Inside Information**”). The inside information policy concerns the handling and the dissemination of the Inside Information as follows:

- (i) subject to the availability of a safe harbor exception, Inside Information must be disclosed to public as soon as reasonably practicable;
- (ii) executive Directors and senior management should identify events and/or developments which may constitute Inside Information and report to the Board to consider whether they may constitute Inside Information requiring disclosure;
- (iii) until an announcement in relation to the Inside Information is made, the Company shall ensure the Inside Information is kept strictly confidential; and
- (iv) If the Company believes that the necessary degree of confidentiality cannot be maintained or that confidentiality may have been breached, an announcement shall be made as soon as reasonably practicable.

Inside Information is announced on the websites of the Stock Exchange and the Company.

### DIVIDEND POLICY

The Company has adopted a dividend policy facilitating the Shareholders and investors to make informed investment decisions relating to the Company during the Reporting Period. In considering whether to propose a dividend and in determining the dividend amount, the Board shall consider the following factors before declaring or recommending dividends:

- (i) the Company’s actual and expected financial performance;
- (ii) retained earnings and distributable reserves of the Company and each of the members of the Group;
- (iii) the Groups’ working capital requirements, capital expenditure requirements and future expansion plans;
- (iv) the Group’s liquidity position;
- (v) business conditions and strategies;

#### OPINION

We are independent of the Group in accordance with the HKICPA's *Code of Ethics for Professional Accountants* (the “**Code**”), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. For each matter below, our description of how our audit addressed the matter is provided in that context.

#### **Contract revenue and contract costs from engineering solutions and services** 來自工程解決方案及服務的合約收益及合約成本

For the year ended 31 March 2021, the Group's revenue and costs recognised for electrical and mechanical ("E&M") engineering solutions and services contracts amounted to HK\$178,656,000 and HK\$130,146,000, respectively.

Revenue from E&M engineering solutions and services is recognised over time and the input method is adopted to measure progress towards complete satisfaction of services. The input method recognises revenue based on the proportion of actual costs incurred relative to budget contract costs for satisfaction of the E&M engineering solutions and services.

The budget contract costs are prepared based on management's estimate, such as estimation of direct labour costs to be incurred and quotations provided by the major contractors, suppliers or vendors involved.

Significant estimation uncertainty is involved in determining the budget contract costs recognised for contract works.

Related disclosures are included in notes 3, 4 and 5 to the consolidated financial statements.

### 2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“**HKFRSs**”) (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards (“**HKASs**”) and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants (the “**HKICPA**”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention, except for financial assets at fair value through profit or loss which have been measured at fair value. These financial statements are presented in Hong Kong dollars (“**HK\$**”) and all values are rounded to the nearest thousand except when otherwise indicated.

#### Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries for the year ended 31 March 2021. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Company and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

### 2.1 編製基準

本財務報表乃根據香港會計師公會(「香港會計師公會」)頒佈的香港財務報告準則(「香港財務報告準則」)(包括所有香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋)、香港公認會計原則及香港公司條例的披露規定編製。除按公允值計入損益的金融資產已按公允值計量外，本財務報表乃根據歷史成本慣例編製。本財務報表乃以港元(「港元」)呈報，除另有指明外，所有金額均調整至最接近的千元。

#### 綜合基準

綜合財務報表包括本公司及其附屬公司截至二零二一年三月三十一日止年度之財務報表。附屬公司為本公司直接或間接控制的實體(包括結構實體)。本集團因參與投資對象而可以或有權獲得不定回報，且可透過對投資對象行使權力影響回報(即本集團運用既有權利現時可以左右投資對象有關業務)時，則屬擁有控制權。

如本公司直接或間接擁有投資對象投票權或類似權利不過半數，本集團評估是否對投資對象有權力時，會考慮所有相關事實及情況，包括：

- (a) 投資對象其他投票權持有人的合約安排；
- (b) 其他合約安排產生的權利；及
- (c) 本集團的投票權及潛在投票權。

附屬公司使用與本公司一致的會計政策編製同一報告期間的財務報表。附屬公司的業績自本集團取得控制權之日起綜合入賬，並持續綜合入賬至有關控制權終止當日為止。

損益及其他全面收益的各組成部分會歸屬於本公司母公司擁有人及非控股權益，儘管這會導致非控股權益結餘錄得虧絀。有關本集團成員公司間交易的所有集團內資產及負債、權益、收入、開支以及現金流量於綜合入賬時悉數對銷。

#### Basis of consolidation (continued)

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to profit or loss or accumulated profits, as appropriate, on the same basis as would be required if the Group has directly disposed of the related assets or liabilities.

### 2.2 CHANGES IN ACCOUNTING POLICIES AND DISCLOSURES

The Group has adopted the *Conceptual Framework for Financial Reporting 2018* (the “**Conceptual Framework**”) and the following revised HKFRSs for the first time for the current year's financial statements:

The nature and the impact of the Conceptual Framework and the revised HKFRSs are described below:

- (a) The Conceptual Framework sets out a comprehensive set of concepts for financial reporting and standard setting, and provides guidance for preparers of financial statements in developing consistent accounting policies and assistance to all parties to understand and interpret the standards. The Conceptual Framework includes new chapters on measurement and reporting financial performance, new guidance on the derecognition of assets and liabilities, and updated definitions and recognition criteria for assets and liabilities. It also clarifies the roles of stewardship, prudence and measurement uncertainty in financial reporting. The Conceptual Framework is not a standard, and none of the concepts contained therein override the concepts or requirements in any standard. The Conceptual Framework did not have any significant impact on the financial position and performance of the Group.

- (b) Amendments to HKFRS 3 clarify and provide additional guidance on the definition of a business. The amendments clarify that for an integrated set of activities and assets to be considered a business, it must include, at a minimum, an input and a substantive process that together significantly contribute to the ability to create output. A business can exist without including all of the inputs and processes needed to create outputs. The amendments remove the assessment of whether market participants are capable of acquiring the business and continue to produce outputs. Instead, the focus is on whether acquired inputs and acquired substantive processes together significantly contribute to the ability to create outputs. The amendments have also narrowed the definition of outputs to focus on goods or services provided to customers, investment income or other income from ordinary activities. Furthermore, the amendments provide guidance to assess whether an acquired process is substantive and introduce an optional fair value concentration test to permit a simplified assessment of whether an acquired set of activities and assets is not a business. The Group has applied the amendments prospectively to transactions or other events that occurred on or after 1 April 2020. The amendments did not have any impact on the financial position and performance of the Group.
- (c) Amendments to HKFRS 9, HKAS 39 and HKFRS 7 address issues affecting financial reporting in the period before the replacement of an existing interest rate benchmark with an alternative risk-free rate (“RFR”). The amendments provide temporary reliefs which enable hedge accounting to continue during the period of uncertainty before the introduction of the alternative RFR. In addition, the amendments require companies to provide additional information to investors about their hedging relationships which are directly affected by these uncertainties. The amendments did not have any impact on the financial position and performance of the Group as the Group does not have any interest rate hedging relationships.
- (d) Amendments to HKAS 1 and HKAS 8 provide a new definition of material. The new definition states that information is material if omitting, misstating or obscuring it could reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. The amendments clarify that materiality will depend on the nature or magnitude of information, or both. The amendments did not have any significant impact on the financial position and performance of the Group.

- (b) 香港財務報告準則第3號(修訂本)澄清業務的定義，並提供有關業務定義的額外指引。該等修訂本明確說明，就可視為業務的一組整合活動及資產而言，其必須至少包括一項投入及一項重要過程，而兩者必須對創造產出的能力有重大貢獻。業務的存在毋須包括創造產出所需的所有投入及過程。該等修訂本取消了評估市場參與者是否有能力收購業務並持續獲得產出的規定。反之，轉為重點關注所獲得的投入及所取得的重要過程是否共同對創造產出的能力有重大貢獻。該等修訂本亦已收窄產出的定義，重點關注向客戶提供的貨物或服務、投資收入或日常活動產生的其他收入。此外，該等修訂本提供有關評估所取得過程是否重大的指引，並引入選擇性的公允價值集中度測試，允許對所取得的一組活動及資產是否不屬於業務進行簡化評估。本集團已按前瞻性基準將該等修訂本應用於二零二零年四月一日或之後發生的交易或其他事件。該等修訂本並無對本集團的財務狀況及表現造成任何影響。
- (c) 香港財務報告準則第9號、香港會計準則第39號及香港財務報告準則第7號(修訂本)旨在解決對以另一種無風險利率(「無風險利率」)取代現有利率基準前期間財務申報之影響。該等修訂本提供在推出另一無風險利率之前之不確定期限內繼續進行對沖會計處理之暫時性補救措施。此外，該等修訂本規定公司須向投資者提供有關直接受該等不確定因素影響之對沖關係的額外資料。由於本集團並無任何利率對沖關係，故該等修訂本並無對本集團的財務狀況及表現造成任何影響。

Further information about those HKFRSs that are expected to be applicable to the Group is described below:

Amendments to HKFRS 3 are intended to replace a reference to the previous *Framework for the Preparation and Presentation of Financial Statements* with a reference to the Conceptual Framework issued in June 2018 without significantly changing its requirements. The amendments also add to HKFRS 3 an exception to its recognition principle for an entity to refer to the Conceptual Framework to determine what constitutes an asset or a liability. The exception specifies that, for liabilities and contingent liabilities that would be within the scope of HKAS 37 or HK(IFRIC)-Int 21 if they were incurred separately rather than assumed in a business combination, an entity applying HKFRS 3 should refer to HKAS 37 or HK(IFRIC)-Int 21 respectively instead of the Conceptual Framework. Furthermore, the amendments clarify that contingent assets do not qualify for recognition at the acquisition date. The Group expects to adopt the amendments prospectively from 1 January 2022. Since the amendments apply prospectively to business combinations for which the acquisition date is on or after the date of first application, the Group will not be affected by these amendments on the date of transition.

Amendments to HKFRS 9, HKAS 39, HKFRS 7, HKFRS 4 and HKFRS 16 address issues not dealt with in the previous amendments which affect financial reporting when an existing interest rate benchmark is replaced with an alternative RFR. The Phase 2 amendments provide a practical expedient to allow the effective interest rate to be updated without adjusting the carrying amount when accounting for changes in the basis for determining the contractual cash flows of financial assets and liabilities, if the change is a direct consequence of the interest rate benchmark reform and the new basis for determining the contractual cash flows is economically equivalent to the previous basis immediately preceding the change. In addition, the amendments permit changes required by the interest rate benchmark reform to be made to hedge designations and hedge documentation without the hedging relationship being discontinued. Any gains or losses that could arise on transition are dealt with through the normal requirements of HKFRS 9 to measure and recognise hedge ineffectiveness. The amendments also provide a temporary relief to entities from having to meet the separately identifiable requirement when an RFR is designated as a risk component. The relief allows an entity, upon designation of the hedge, to assume that the separately identifiable requirement is met, provided the entity reasonably expects the RFR risk component to become separately identifiable within the next 24 months. Furthermore, the amendments require an entity to disclose additional information to enable users of financial statements to understand the effect of interest rate benchmark reform on an entity's financial instruments and risk management strategy. The amendments are effective for annual periods beginning on or after 1 January 2021 and shall be applied retrospectively, but entities are not required to restate the comparative information. The amendments are not expected to have any significant impact on the Group's financial statements.

### 2.3 已頒佈但尚未生效之香港財務報告準則(續)

預期將適用於本集團之該等香港財務報告準則之進一步資料於下文載述。

香港財務報告準則第3號(修訂本)旨在以二零一八年六月頒佈的概念框架之提述取代先前財務報表編製及呈列框架之提述，而毋須大幅更改其規定。該等修訂本亦對香港財務報告準則第3號有關實體參考概念框架以釐定資產或負債之構成之確認原則加入一項例外情況。該例外情況規定，對於屬香港會計準則第37號或香港(國際財務報告詮釋委員會)－詮釋第21號範圍內的負債及或然負債而言，倘該等負債屬單獨產生而非於業務合併中產生，則應用香港財務報告準則第3號的實體應分別參考香港會計準則第37號或香港(國際財務報告詮釋委員會)－詮釋第21號而非概念框架。此外，該等修訂本澄清或然資產於收購日期不符合確認條件。本集團預計自二零二二年一月一日起前瞻性採納該等修訂本。由於該等修訂本前瞻性應用於收購日期為首次應用日期或之後的業務合併，因此本集團於過渡日期將不會受該等修訂本的影響。

香港財務報告準則第9號、香港會計準則第39號、香港財務報告準則第7號、香港財務報告準則第4號及香港財務報告準則第16號(修訂本)於現有利率基準被可替代無風險利率替換時解決先前修訂本中未處理但影響財務報告之問題。第二階段之修訂本提供一項實際可行權宜方法，允許對釐定金融資產及負債之合約現金流量之基準變動進行會計處理時更新實際利率而無需調整賬面值，前提是有關變動為利率基準改革之直接後果且釐定合約現金流量的新基準於經濟上等同於緊接變動前的先前基準。此外，該等修訂本允許就對沖指定項目及對沖文件作出利率基準改革所要求的變動，而不會終止對沖關係。過渡期間可能產生的任何收益或虧損均通過香港財務報告準則第9號的正常規定進行處理，以衡量及確認對沖無效性。該等修訂本亦為實體提供暫時寬免，於無風險利率被指定為風險成份時毋須滿足可單獨識別之規定。該寬免允許實體於指定對沖後假定已滿足可單獨識別之規定，惟實體須合理預期無風險利率風險成份於未來24個月內將可單獨識別。此外，該等修訂本要求實體須披露額外資料，以使財務報表的使用者能夠瞭解利率基準改革對實體的金融工具及風險管理策略的影響。該等修訂本於二零二一年一月一日或之後開始的年度期間生效，並應追溯應用，但實體毋須重列比較資料。該等修訂本預期不會對本集團的財務報表產生任何重大影響。

Amendments to HKFRS 10 and HKAS 28 (2011) address an inconsistency between the requirements in HKFRS 10 and in HKAS 28 (2011) in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to HKFRS 10 and HKAS 28 (2011) was removed by the HKICPA in January 2016 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

Amendments to HKAS 1 clarify the requirements for classifying liabilities as current or non-current. The amendments specify that if an entity's right to defer settlement of a liability is subject to the entity complying with specified conditions, the entity has a right to defer settlement of the liability at the end of the reporting period if it complies with those conditions at that date. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement of the liability. The amendments also clarify the situations that are considered a settlement of a liability. The amendments are effective for annual periods beginning on or after 1 January 2023 and shall be applied retrospectively. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

In April 2021, the HKICPA issued amendments to HKAS 1 *Presentation of Financial Statements* in which it provides guidance and examples to help entities to apply materiality judgements to accounting policy disclosures. The Board also issued amendments to HKFRS Practice Statement 2 *Making Materiality Judgements* to support the amendments in HKAS 1 by explaining and demonstrating the application of the "four-step materiality process" to accounting policy disclosures. The amendments aim to help entities provide accounting policy disclosures that are more useful by:

Replacing the requirement for entities to disclose their "significant" accounting policies with a requirement to disclose their "material" accounting policies; and

Adding guidance on how entities apply the concept of materiality in making decisions about accounting policy disclosures.

The amendments are effective for annual reporting periods beginning on or after 1 January 2023. The Group is currently assessing the impact of the amendments upon adoption.

香港財務報告準則第10號及香港會計準則第28號(二零一一年)(修訂本)解決香港財務報告準則第10號與香港會計準則第28號(二零一一年)之間有關處理投資者與其聯營公司或合營企業之間的資產出售或注資的規定的不一致情況。該等修訂本規定，倘投資者與其聯營公司或合營企業之間的資產出售或注資構成一項業務，則須悉數確認收益或虧損。倘交易涉及不構成一項業務的資產，則該交易產生的收益或虧損於投資者的損益內確認，惟以不相關投資者於該聯營公司或合營企業的權益為限。該等修訂本將予以前瞻性應用。香港會計師公會於二零一六年一月剔除香港財務報告準則第10號及香港會計準則第28號(二零一一年)(修訂本)的以往強制生效日期，而新的強制生效日期將於對聯營公司及合營企業的會計處理完成更廣泛的審閱後釐定。然而，該等修訂本目前可供採納。

香港會計準則第1號(修訂本)澄清將負債分類為流動或非流動的規定。該等修訂本指明，倘實體延遲償還負債的權利受限於該實體須符合特定條件，則倘該實體符合當日之有關條件，其有權於報告期末延遲償還負債。負債的分類不受該實體行使權利延遲償還負債的可能性所影響。該等修訂本亦澄清被視為償還負債的情況。該等修訂於二零二三年一月一日或之後開始的年度期間生效，並應追溯應用。允許提早應用。該等修訂預期不會對本集團的財務報表產生任何重大影響。

於二零二一年四月，香港會計師公會發佈對香港會計準則第1號*財務報表之呈列之修訂本*，該等修訂本提供了以助實體將重要性判斷應用於會計政策披露之指引及解釋。香港會計準則委員會亦發佈香港財務報告準則實務聲明2*作出重要性判斷之修訂本*，通過解釋及證明將「四步重要性過程」應用於會計政策披露以支持香港會計準則第1號(修訂本)。尤其是，該等修訂本旨在幫助實體提供更加有用的會計政策披露：

將實體披露其「重大」會計政策的要求替換為披露其「重要」會計政策的要求；及

增加關於實體如何在會計政策披露的決策中應用重要性概念的指引。

該等修訂本將於二零二三年一月一日起或之後開始的年度期間生效。本集團正評估於採納後該等修訂本的影響。

In April 2021, the HKICPA issued amendments to HKAS 8 *Accounting Policies, Changes in Accounting Estimates and Errors*, in which it introduces a new definition of “accounting estimates”. The amendments are designed to clarify the distinction between changes in accounting estimates and changes in accounting policies and the correction of errors. Distinguishing between a change in accounting policy and a change in accounting estimates is, in some cases, quite challenging. To provide additional guidance, the amended standard clarifies that the effects on an accounting estimate of a change in an input or a change in a measurement technique are changes in accounting estimates if they do not result from the correction of prior period errors.

The amendments are effective for annual reporting periods beginning on or after 1 January 2023. The amendments are not expected to have any significant impact on the financial position and performance of the Group.

Amendments to HKAS 16 prohibit an entity from deducting from the cost of an item of property, plant and equipment any proceeds from selling items produced while bringing that asset to the location and condition necessary for it to be capable of operating in the manner intended by management. Instead, an entity recognises the proceeds from selling any such items, and the cost of those items, in profit or loss. The amendments are effective for annual periods beginning on or after 1 January 2022 and shall be applied retrospectively only to items of property, plant and equipment made available for use on or after the beginning of the earliest period presented in the financial statements in which the entity first applies the amendments. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

於二零二一年四月，香港會計師公會發佈對香港會計準則第8號(修訂本)會計政策、會計估計變更及錯誤，該等修訂本引進「會計估計」的新定義。該修訂本旨在澄清會計估計變更及會計政策變更及錯誤更正的區別。在某些情況下，區分會計政策變更及會計估計變更是相當具有挑戰性的。為提供額外指引，修訂後準則澄清若非前期錯誤更正所致，輸入變更或計量方法變更對會計估計的影響乃會計估計之變更。

該等修訂本自二零二三年一月一日起或之後開始的年度報告期生效。預期該等修訂本不會對本集團的財務狀況及業績產生任何重大影響。

香港會計準則第16號(修訂本)禁止實體從物業、廠房及設備項目的成本中扣除使資產達到管理層擬定之營運狀態所需位置與條件過程中產生的項目銷售之任何所得款項。相反，實體須於損益中確認銷售任何有關項目之所得款項及該等項目之成本。該等修訂本於二零二二年一月一日起或之後開始的年度期間生效，並僅追溯應用於實體首次應用該等修訂本的財務報表中所呈列的最早期間開始或之後可供使用的物業、廠房及設備項目。允許提早應用。該等修訂本預期不會對本集團的財務報表產生任何重大影響。

Amendments to HKAS 37 clarify that for the purpose of assessing whether a contract is onerous under HKAS 37, the cost of fulfilling the contract comprises the costs that relate directly to the contract. Costs that relate directly to a contract include both the incremental costs of fulfilling that contract (e.g., direct labour and materials) and an allocation of other costs that relate directly to fulfilling that contract (e.g., an allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract as well as contract management and supervision costs). General and administrative costs do not relate directly to a contract and are excluded unless they are explicitly chargeable to the counterparty under the contract. The amendments are effective for annual periods beginning on or after 1 January 2022 and shall be applied to contracts for which an entity has not yet fulfilled all its obligations at the beginning of the annual reporting period in which it first applies the amendments. Earlier application is permitted. Any cumulative effect of initially applying the amendments shall be recognised as an adjustment to the opening equity at the date of initial application without restating the comparative information. The amendments are not expected to have any significant impact on the Group's financial statements.

*Annual Improvements to HKFRSs 2018-2020* sets out amendments to HKFRS 1, HKFRS 9, Illustrative Examples accompanying HKFRS 16, and HKAS 41. Details of the amendments that are expected to be applicable to the Group are as follows:

- HKFRS 9 *Financial Instruments*: clarifies the fees that an entity includes when assessing whether the terms of a new or modified financial liability are substantially different from the terms of the original financial liability. These fees include only those paid or received between the borrower and the lender, including fees paid or received by either the borrower or lender on the other's behalf. An entity applies the amendment to financial liabilities that are modified or exchanged on or after the beginning of the annual reporting period in which the entity first applies the amendment. The amendment is effective for annual periods beginning on or after 1 January 2022. Earlier application is permitted. The amendment is not expected to have a significant impact on the Group's financial statements.
- HKFRS 16 *Leases*: removes the illustration of payments from the lessor relating to leasehold improvements in Illustrative Example 13 accompanying HKFRS 16. This removes potential confusion regarding the treatment of lease incentives when applying HKFRS 16.

香港會計準則第37號(修訂本)澄清，就根據香港會計準則第37號評估合約是否屬虧損性而言，履行合約的成本包括與合約直接相關的成本。與合約直接相關的成本包括履行該合約的增量成本(例如直接勞工及材料)及與履行合約直接相關的其他成本分配(例如分配履行合約所用物業、廠房及設備項目的折舊費用以及合約管理及監管成本)。一般及行政成本與合約並無直接關連，除非根據合約明確向對手方收取，否則不包括在內。該等修訂本於二零二二年一月一日或之後開始的年度期間生效，並將應用於實體於其首次應用該等修訂本的年度報告期間開始尚未履行其所有責任的合約。允許提早應用。初步應用該等修訂的任何累計影響將確認為對首次應用日期之期初權益的調整，而毋須重列比較資料。該等修訂本預期不會對本集團的財務報表產生任何重大影響。

香港財務報告準則二零一八年至二零二零年週期之年度改進載列香港財務報告準則第1號、香港財務報告準則第9號、香港財務報告準則第16號隨附之說明性示例及香港會計準則第41號修訂。預期將適用於本集團之該等修訂本詳情如下：

- 香港財務報告準則第9號金融工具：澄清實體於評估一項新訂或經修訂金融負債之條款是否實質上不同於原金融負債之條款時所計入之費用。該等費用僅包括借入人與貸款人之間已付或已收之費用，其中包括借入人或貸款人代表另一方支付或收取之費用。實體對於該實體首次採用修訂的年度報告期間開始或之後經修訂或交換之金融負債應用該修訂。該修訂本於二零二二年一月一日或之後開始的年度期間生效。允許提早應用。該修訂預期不會對本集團的財務報表產生重大影響。
- 香港財務報告準則第16號租賃：於香港財務報告準則第16號隨附之第13項說明性示例中移除出租人就租賃物業裝修作出之付款說明。此舉消除了應用香港財務報告準則第16號時對租賃優惠進行處理之潛在混淆。

### 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Interests in joint operations

A joint operation is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the assets, and obligations for the liabilities, relating to the arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group recognises in relation to its interest in a joint operation:

- its assets, including its share of any assets held jointly;
- its liabilities, including its share of any liabilities incurred jointly;
- its revenue from the sale of its share of the output arising from the joint operation;
- its share of the revenue from the sale of the output by the joint operation; and
- its expenses, including its share of any expenses incurred jointly.

The assets, liabilities, revenues and expenses relating to the Group's interest in a joint operation are accounted for in accordance with the HKFRSs applicable to the particular assets, liabilities, revenues and expenses.

#### Fair value measurement

The Group measures its financial assets at fair value through profit or loss at fair value at the end of each reporting period. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

### 3. 重大會計政策概要

#### 合營業務權益

合營業務指擁有共同控制權的各方享有與該安排相關的資產權利及負債責任的一種合營安排。共同控制指按照合約協定對一項安排所共有之控制權，共同控制僅在有關活動要求享有控制權之訂約方作出一致同意之決定時存在。

本集團於合營業務權益確認以下各項：

- 其資產，包括其應佔任何共同持有之資產；
- 其負債，包括其應佔任何共同承擔之負債；
- 其銷售應佔合營業務產量之收益；
- 其來自銷售合營業務產量之應佔收益；及
- 其開支，包括其應佔任何共同承擔之開支。

本集團於合營業務中之權益所涉的資產、負債、收益及開支乃根據適用於該特定資產、負債、收益及開支的香港財務報告準則入賬。

#### 公允值計量

本集團於各報告期末以公允值計量其按公允值計入損益的金融資產。公允值乃在市場參與者於計量日期進行之有序交易中出售資產所收取或轉讓負債所支付之價格。公允值計量乃基於出售資產或轉讓負債之交易發生在該資產或負債之主要市場或(如無主要市場)就該資產或負債而言最有利之市場的假設。該主要市場或最有利市場必須為本集團可進入之市場。資產或負債之公允值採用市場參與者為資產或負債定價所採用的假設進行計量(假設市場參與者依照彼等的最佳經濟利益行事)。

非金融資產的公允值計量計及市場參與者通過使用其資產的最大及最佳用途或將有關資產出售予將使用其最大及最佳用途的另一市場參與者而產生經濟利益的能力。

本集團採用適用於有關情況並可獲得充足數據的估值技術來計量公允值，盡量使用相關可觀察輸入數據而盡量避免使用不可觀察輸入數據。

#### Fair value measurement (continued)

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

- Level 1 – based on quoted prices (unadjusted) in active markets for identical assets or liabilities
- Level 2 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly
- Level 3 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

#### Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, contract assets and financial assets), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to profit or loss in the period in which it arises.

#### 公允值計量(續)

所有於財務報表內按公允值計量或披露的資產及負債乃基於對公允值計量整體而言屬重大的最低層級輸入數據按以下公允值層級分類：

- 第一級 – 基於相同資產或負債在活躍市場上的報價(未經調整)
- 第二級 – 基於對公允值計量而言屬重大的最低層級輸入數據為可觀察(直接或間接)數據的估值技術
- 第三級 – 基於對公允值計量而言屬重大的最低層級輸入數據為不可觀察數據的估值技術

就按經常性基準於財務報表確認的資產及負債而言，本集團透過於各報告期末重新評估分類(基於對公允值計量整體而言屬重大的最低層級輸入數據)確定是否發生不同層級轉移。

#### 非金融資產之減值

倘存在減值跡象，或當資產須作出年度減值測試(存貨、合約資產及金融資產除外)，會估計資產之可收回金額。資產之可收回金額乃按該資產或現金產生單位之使用價值與其公允值減出售成本之較高者計算，並就個別資產作出釐定，除非該資產並不產生很大程度上獨立於其他資產或資產組別之現金流入，則在此情況下，可收回金額乃就該資產所屬現金產生單位予以釐定。

減值虧損僅於資產賬面值超過其可收回金額時確認。於評估使用價值時，估計未來現金流量乃採用反映現時市場對該資產之貨幣時間價值及特定風險評估之稅前貼現率，貼現至其現值。減值虧損於其產生期間在損益中在與減值資產功能一致的相關開支類別內扣除。

於各報告期末將評估有否跡象顯示以往確認之減值虧損可能不再存在或可能已減少。如存在有關跡象，則會估計可收回金額。以往確認之商譽以外之資產減值虧損，僅於用作釐定該資產可收回金額之估計出現變動時撥回，然而，不得撥回至高於假設過往年度並無確認資產減值虧損而下釐定之賬面值(扣除任何折舊/攤銷)之金額。有關減值虧損撥回於產生期間計入損益。

#### Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in profit or loss in the year the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

#### Research and development costs

All research costs are charged to profit or loss as incurred.

Expenditure incurred on projects to develop new projects is capitalised and deferred only when the Group can demonstrate the technical feasibility of completing the intangible asset so that it will be available for use or sale, its intention to complete and its ability to use or sell the asset, how the asset will generate future economic benefits, the availability of resources to complete the project and the ability to measure reliably the expenditure during the development. Project development expenditure which does not meet these criteria is expensed when incurred.

物業、廠房及設備按成本減累計折舊及任何減值虧損列賬。物業、廠房及設備項目成本包括其購買價及任何使資產達致可使用狀態及運抵使用地點作擬定用途之直接應計成本。

物業、廠房及設備項目投入運作後產生之開支(如維修及保養費用)一般於產生期間自損益扣除。在符合確認標準之情況下,主要檢修費用將予以資本化,作為一項置換列入資產之賬面值。倘物業、廠房及設備之重要部分須定期更換,本集團會將該等部分確認為擁有特定可使用年期之獨立資產,並計算相應折舊。

折舊按每個物業、廠房及設備項目之估計可使用年期以直線法基準計算,以撇銷其成本至其剩餘價值。就此而言,所用之主要年率如下:

物業、廠房及設備項目(包括任何已首次確認之重要部分)於出售或預期不會自其使用或出售產生未來經濟利益時終止確認。於該資產終止確認之年度在損益確認之出售或報廢所產生之任何收益或虧損,為出售所得款項淨額與有關資產賬面值間之差額。

#### 研發成本

所有研究成本於產生時自損益扣除。

新項目開發項目產生之開支僅於本集團證明於技術上能夠完成無形資產供使用或出售、有意完成及有能力使用或出售該資產、該資產將帶來未來經濟利益之方法、具有完成項目所需之資源且能夠可靠地計量開發期間之開支時,方會撥充資本並以遞延方式入賬。未能符合該等標準之項目開發開支概於產生時支銷。

#### Leases

The Group assesses at contract inception whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

#### Group as a lessee

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

#### (a) Right-of-use assets

Right-of-use assets are recognised at the commencement date of the lease (that is the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease terms and the estimated useful lives of the assets as follows:

If ownership of the leased asset transfers to the Group by the end of the lease term or the cost reflects the exercise of a purchase option, depreciation is calculated using the estimated useful life of the asset.

#### (b) Lease liabilities

Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

本集團於合約開始時評估合約是否為租賃或包含租賃。倘合約為換取代價而給予在一段時間內控制已識別資產使用的權利，則該合約為租賃或包含租賃。

#### 本集團作為承租人

本集團對所有租賃(惟短期租賃及低價值資產租賃除外)採取單一確認及計量方法。本集團確認租賃負債以作出租賃付款，而使用權資產指使用相關資產的權利。

#### (a) 使用權資產

使用權資產於租賃開始日期(即有關資產可供使用的日期)確認。使用權資產按成本減任何累計折舊及任何減值虧損計量，並就租賃負債之任何重新計量作出調整。使用權資產之成本包括已確認租賃負債金額、已發生初始直接成本及於開始日期或之前支付之租賃付款減已收取之任何租賃優惠。使用權資產於租期及資產估計使用年期(以較短者為準)內以直線法折舊如下：

##### (b) Lease liabilities (continued)

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

The Group's lease liabilities are separately disclosed in the consolidated statement of financial position.

##### (c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases of containers (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to the containers that are considered to be of low value.

Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee are accounted for as finance leases.

#### Investments and other financial assets

##### Initial recognition and measurement

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

##### (b) 租賃負債(續)

於計算租賃付款現值時，由於租賃中所隱含之利率不易釐定，本集團則於租賃開始日期使用其增量借貸利率。於開始日期後，租賃負債金額會增加，以反映利息增加及就所付租賃付款作出調減。此外，倘出現修改、租期變動、租賃付款變動(如指數或比率變動所產生之未來租賃付款變動)購買相關資產之選擇權評估變更，租賃負債的賬面值將予重新計量。

本集團的租賃負債於綜合財務狀況表內單獨披露。

##### (c) 短期租賃及低價值資產租賃

本集團將短期租賃確認豁免應用於集裝箱的短期租賃(即自開始日期起計租期為12個月或以下，並且不包含購買選擇權的租賃)。低價值資產租賃確認豁免亦應用於被視為低價值的集裝箱租賃。

短期租賃的租賃付款及低價值資產租賃於租期內按直線法確認為開支。

將相關資產絕大部份之風險及回報擁有權轉移至承租人的租賃入賬列為融資租賃。

#### 投資及其他金融資產

##### 初步確認及計量

金融資產於初步確認時分類，其後按攤銷成本及按公允值計入損益計量。

初步確認時的金融資產分類取決於金融資產的合約現金流量特徵以及本集團管理彼等的業務模式。除並不包含重大融資成分或本集團已採用不調整重大融資成分影響之切實可行權宜方法之貿易應收款項外，本集團初始按公允值加上(倘金融資產並非按公允值計入損益)交易成本計量金融資產。並不包含重大融資成分或本集團已採用切實可行權宜方法之貿易應收款項，乃根據下文「收益確認」所載政策按照香港財務報告準則第15號釐定之交易價格計量。

##### Initial recognition and measurement (continued)

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest ("SPPI") on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

##### Subsequent measurement

The subsequent measurement of financial assets depends on their classification as follows:

##### Financial assets at amortised cost (debt instruments)

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in profit or loss when the asset is derecognised, modified or impaired.

##### Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with net changes in fair value recognised in profit or loss.

This category includes derivative instruments and equity investments which the Group had not irrevocably elected to classify at fair value through other comprehensive income. Dividends on equity investments classified as financial assets at fair value through profit or loss are also recognised as other income in profit or loss when the right of payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

##### 初步確認及計量(續)

為使金融資產按攤銷成本或按公允值計入其他全面收益進行分類及計量，需產生純粹為支付本金及未償還本金利息（「純粹支付本金及利息」）的現金流量。現金流量並非純粹支付本金及利息的金融資產，不論其業務模式如何，均按公允值計入損益分類及計量。

本集團管理金融資產的業務模式指其如何管理其金融資產以產生現金流量。業務模式確定現金流量是否來自收取合約現金流量、出售金融資產，或兩者兼有。而按攤銷成本分類及計量的金融資產於旨在持有金融資產以收取合約現金流量的業務模式中持有，而按公允值計入其他全面收益分類及計量的金融資產於旨在收取合約現金流量以及出售的業務模式中持有。並非於上述業務模式中持有的金融資產按公允值計入損益分類及計量。

所有正常購買及銷售之金融資產，於交易日確認，即本集團承諾購買或出售資產當日。正常購買或銷售是指按照市場既有規定或慣例須在一段期限內交付資產之金融資產買賣。

##### 後續計量

金融資產的後續計量取決於其以下的分類情況：

##### 按攤銷成本列賬的金融資產(債務工具)

按攤銷成本列賬之金融資產其後使用實際利率法計量，並可能受減值影響。當資產終止確認、修訂或減值時，收益及虧損於損益內確認。

##### 按公允值計入損益的金融資產

按公允值計入損益的金融資產於財務狀況表按公允值列賬，而公允值變動淨額則於損益內確認。

該類別包括本集團並無不可撤回地選擇按公允值計入其他全面收益進行分類的衍生工具及股權投資。在支付權確立、與股息相關的經濟利益很可能流入本集團，且股息金額能夠可靠計量時，分類為按公允值計入損益的金融資產的股權投資的股息亦於損益確認為其他收入。

#### Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e., removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if, and to what extent, it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Continuing involvement that takes the form of a guarantee over the transferred asset is measured at the lower of the original carrying amount of the asset and the maximum amount of consideration that the Group could be required to repay.

#### Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

金融資產(或,倘適用,一項金融資產的一部份或一組同類金融資產部份)在下列情況中終止確認(如自本集團綜合財務報表中移除):

- 收取該項資產所得現金流量的權利經已屆滿;或
- 本集團已轉讓其收取該項資產所得現金流量的權利,或已承擔一項責任,在未有嚴重拖延之情況下,根據一項「轉付」安排向第三方全數支付已收取之現金流量;以及(a)本集團已轉讓該項資產之絕大部份風險及回報,或(b)本集團並無轉讓或保留該項資產絕大部份風險及回報,但已轉讓該項資產之控制權。

倘若本集團已轉讓其收取資產所得現金流量之權利,或已訂立轉付安排,其將評估其是否保留該項資產之擁有權的風險及回報以及保留之程度。當其並無轉讓亦無保留該項資產之絕大部份風險及回報,亦無轉讓該項資產的控制權,則該項資產將於本集團繼續按其持續參與程度確認該已轉讓資產。在此情況下,本集團同時確認相關負債。已轉讓資產及相關負債按反映本集團所保留權利及責任之基準計量。

以擔保方式繼續參與已轉讓資產之程度,乃按資產原有賬面值與本集團可被要求償還的最高代價金額兩者的較低者計量。

#### 金融資產減值

##### General approach

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset to be in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables and contract assets which apply the simplified approach as detailed below.

- Stage 1 – Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs
- Stage 2 – Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs
- Stage 3 – Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

##### 一般方法

預期信貸虧損分兩個階段進行確認。就自初步確認起未有顯著增加的信貸風險而言，會為未來12個月內可能發生違約事件而導致的信貸虧損(12個月預期信貸虧損)計提預期信貸虧損撥備。就自初步確認起已顯著增加的信貸風險而言，不論何時發生違約，須就於餘下風險年限內的預期信貸虧損計提虧損撥備(存續期預期信貸虧損)。

本集團於各報告日期評估金融工具的信貸風險是否自初步確認以來顯著增加。在進行該評估時，本集團將於報告日期就金融工具發生之違約風險與初步確認日期起金融工具發生之違約風險進行比較，並會認為無須付出過多成本或努力即可獲得的合理及有佐證的資料(包括過往及前瞻性資料)。

倘合約付款已逾期90日，則本集團將相關金融資產視為違約。然而，在若干情況下，倘內部或外部資料反映，在計及任何本集團之信貸提升措施前，本集團不大可能悉數收到未償還合約款項，則本集團亦可將金融資產視為違約。倘無合理預期可收回合約現金流量，則對金融資產進行撇銷。

除採用下述簡化方法的貿易應收款項及合約資產以外，按攤銷成本計量的金融資產，均須按一般方法進行減值，並於下列各階段內分類，計量預期信貸虧損：

- 第一階段 – 自初步確認以來信貸風險並無顯著增加及虧損撥備以相當於12個月預期信貸虧損金額計量的金融工具
- 第二階段 – 自初步確認以來信貸風險顯著增加但並非信貸減值的金融資產及其虧損撥備以相當於存續期預期信貸虧損金額計量的金融工具
- 第三階段 – 於報告日期為信貸減值(但並非購買或原始信貸減值)且其虧損撥備以相當於存續期預期信貸虧損金額計量的金融資產。

##### *Simplified approach*

For trade receivables and contract assets that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date.

#### Financial liabilities

##### *Initial recognition and measurement*

Financial liabilities are classified, at initial recognition, as financial liabilities at fair value through profit or loss, loans and borrowings or payables, as appropriate.

These financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and retention payables and other payables and accruals.

##### *Subsequent measurement*

The subsequent measurement of financial liabilities depends on their classification as follows:

##### *Financial liabilities at amortised cost (loans and borrowings)*

After initial recognition, interest-bearing loans and borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in profit or loss.

就並無包含重大融資成分或本集團已應用可行權宜方法不調整重要融資成分影響的貿易應收款項及合約資產而言，本集團採用簡化的方法計算預期信貸虧損。根據該簡化方法，本集團並無追溯信貸風險變動，而是於各報告日期就存續期預期信貸虧損確認虧損撥備。

#### 金融負債

##### *初步確認及計量*

金融負債於初步確認時分類為按公允值計入損益的金融負債、貸款及借貸或應付款項(倘適用)。

該等金融負債初步按公允值確認，而貸款及借貸以及應付款項則須扣減直接應佔交易成本。

本集團的金融負債包括貿易應付款項及應付保留金及其他應付款項及應計費用。

##### *後續計量*

金融負債其後按其分類計量如下：

##### *按攤銷成本計量的金融負債(貸款及借貸)*

於初步確認後，計息貸款及借貸其後採用實際利率法按攤銷成本計量，惟除非貼現的影響不大，於該情況下則會按成本列賬。終止確認負債及按實際利率攤銷過程中產生的損益在損益內確認。

於計算攤銷成本時考慮任何收購折讓或溢價以及作為實際利率一部分的費用或成本。實際利率攤銷於損益內列為融資成本。

#### Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in profit or loss.

#### Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

#### Treasury shares

Own equity instruments which are reacquired and held by the Company or the Group (treasury shares) are recognised directly in equity at cost. No gain or loss is recognised in profit or loss on the purchase, sale, issue or cancellation of the Group's own equity instruments.

#### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the weighted average basis. Net realisable value is based on estimated selling prices less any estimated costs to disposal.

#### Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, and are subject to an insignificant risk of changes in value and less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, and assets similar in nature to cash, which are not restricted as to use.

倘金融負債下的義務被解除、取消或到期，則本集團會終止確認金融負債。

當現有金融負債被來自同一放款人的另一項條款迥異的金融負債替換，或現有負債的條款大部分被修訂時，該項替換或修訂會被視作終止確認原有負債及確認新負債，相關各賬面價值之差額於損益內確認。

#### 抵銷金融工具

倘現時存在一項可強制執行法定權利，可抵銷已確認金額，且擬以淨額結算或同時變現資產及清算債務，則金融資產與金融負債可予抵銷，並以淨額在財務狀況表呈報。

#### 庫存股份

本公司或本集團持有及重新購入的自身股本工具(庫存股份)按成本直接於權益中確認。就購買、銷售、發行或註銷本集團自身的股本工具而言，毋須於損益內確認損益。

#### 存貨

存貨按成本與可變現淨值兩者中的較低者列賬。成本按加權平均法釐定。可變現淨值乃基於估計售價減任何在出售時產生的估計成本作出。

#### 現金及現金等價物

就綜合現金流量表而言，現金及現金等價物包括手頭現金及活期存款，以及可隨時兌換為已知數額現金且價值波動風險輕微的短期高流通性投資，減須按要求償還的銀行透支，構成本集團現金管理的整體部分。

就綜合財務狀況表而言，現金及現金等價物包括用途不受限制的手頭現金及存放於銀行的現金(包括定期存款)以及與現金性質類似的資產。

#### Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included as finance costs in profit or loss.

The Group provides for warranties in relation to the provision of E&M engineering services and sales of parts and components for general repairs of defects occurring during the warranty period. Provisions for these assurance-type warranties granted by the Group are recognised based on past experience of the level of repairs and returns, discounted to their present values as appropriate.

#### Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries, associates and joint ventures, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

若由於過往事項產生現有法定或推斷責任，而履行責任可能需要未來資源流出，且該責任的數額能可靠估計，則會確認撥備。

當貼現影響重大時，已確認的撥備數額為預期履行責任所需的未來支出於報告期末的現值。隨時間流逝而產生的貼現現值增加將計入損益的融資成本。

本集團就提供之機電工程服務及銷售零件及部件於保修期內發生缺陷之一般維修提供保證。本集團授予該等保證型保證撥備乃根據維修及退貨水平之過往經驗確認，並貼現至適當之現值。

#### 所得稅

所得稅包括當期及遞延稅項。未確認損益的項目相關的所得稅不計入損益，應在其他全面收益確認或直接在權益中確認。

當期稅項資產及負債按根據於報告期末已經頒佈或實質上已頒佈的稅率(及稅法)及考慮本集團營運所在國家通行的詮釋及慣例預期獲退回或已付予稅務當局的數額計量。

遞延稅項使用負債法，於報告期末就資產與負債的稅基與其作財務申報用途的賬面值之間所有暫時差額作出撥備。

所有應納稅暫時性差額均確認為遞延稅項負債，除非：

- 遞延稅項負債是由初始確認非業務合併交易的商譽或資產及負債所產生，而在交易時既不影響會計溢利亦不影響應課稅溢利或虧損；及
- 應課稅暫時性差額與附屬公司、聯營公司及合營公司的投資相關，而本集團能夠控制暫時性差額撥回的時間，並且在可見未來應不會撥回暫時性差額。

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries, associates and joint ventures, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if and only if the Group has a legally enforceable right to set off current tax assets and current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

所有可抵扣的暫時性差額、結轉未利用的稅項抵免及任何未利用的稅務損失確認為遞延稅項資產，但以很有可能具有足夠的應課稅溢利抵銷可抵扣的暫時性差額、以及結轉未利用的稅項抵免及未利用的稅務損失為限，除非：

- 與可抵扣暫時性差額相關的遞延稅項資產，由初始確認非業務合併交易的資產或負債所產生，而在交易時既不影響會計溢利亦不影響應課稅溢利或損失；及

遞延稅項資產及負債按變現資產或償還負債期間預計適用稅率計量，而預計的適用稅率乃按報告期末已頒佈或實質上已頒佈的稅率(及稅法)釐定。

當且僅當本集團擁有可依法強制執行之權利對銷即期稅項資產及即期稅項負債，且遞延稅項資產及遞延稅項負債與同一稅務當局對同一應課稅實體或於各未來期間預期有大額遞延稅項負債或資產需要結算或清償時，擬按淨額基準結算即期稅項負債及資產或同時變現資產及結算負債之不同應課稅實體徵收之所得稅相關，則遞延稅項資產及遞延稅項負債可予對銷。

#### Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

Where the grant relates to an asset, the fair value is credited to a deferred income account and is released to profit or loss over the expected useful life of the relevant asset by equal annual instalments or deducted from the carrying amount of the asset and released to profit or loss by way of a reduced depreciation charge.

#### Revenue recognition

##### Revenue from contracts with customers

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

#### (a) Provision of E&M engineering solutions and services

Revenue from the provision of E&M engineering solutions and services is generated from the design, supply and installation of systems and implementation of E&M engineering solutions and services and design and fabrication services for the fabrication of made-to-order products for the customers, where applicable.

#### 政府補助

倘有合理保證可取得政府補助，並符合所有附帶條件，則會按其公允值確認政府補助。倘有關補助乃與一項開支項目有關，則按有系統的基準於支銷擬作補償的成本期間確認。

當政府補助與某個資產項目相關聯時，公允值計入遞延收入賬，並根據相關資產之預期可使用年期以年限平均法調撥至損益，或者從資產的賬面值中減去並通過減少折舊費用的方式計入損益。

#### 收益確認

##### 來自客戶合約的收益

來自客戶合約的收益於貨品或服務的控制權轉移至客戶時確認，其金額反映本集團預期就交換該等貨品或服務有權獲得的代價。

當合約的代價包括可變金額，代價金額估算為本集團向客戶轉移貨品或服務而有權換取的代價。可變代價於合約開始時估計並受到約束，直至其後消除可變代價的相關不確定因素，使已確認累計收益金額的重大收益撥回不大可能發生。

當合約包含融資成分並向客戶提供超過一年為轉移貨品或服務進行融資的重大利益時，收益於合約開始時按應收金額現值計量，並使用貼現率貼現，有關貼現率將於本集團與客戶之間之獨立融資交易中反映。當合約包含融資成分並向本集團提供超過一年的重大財務利益時，根據合約確認的收益包括按照實際利率法對合約負債累計的利息開支。就客戶付款與轉移所承諾貨品或服務間之期間為一年或以內的合約，交易價使用香港財務報告準則第15號可行權宜方法，不會就重大融資成分的影響予以調整。

#### (a) 提供機電工程解決方案及服務

提供機電工程解決方案及服務之收益來自系統設計、供應及安裝及執行機電工程解決方案及服務，並為客戶裝配按訂單製造的產品的設計及裝配服務(如適用)。

###### (a) Provision of E&M engineering solutions and services (continued)

Revenue is recognised over time, using an input method to measure progress towards complete satisfaction of the service, because the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced. The input method recognises revenue based on the proportion of the actual costs incurred relative to the estimated total costs for satisfaction of the construction services.

Claims to customers are amounts that the Group seeks to collect from the customers as reimbursement of costs and margins for scope of works not included in the original construction contract. Claims are accounted for as variable consideration and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved. The Group uses the expected value method to estimate the amounts of claims because this method best predicts the amount of variable consideration to which the Group will be entitled.

Under the terms of contracts, the Group's performance creates and/or enhances the assets which the customers control during the course of work by the Group. Revenue from the provision of contracting services is therefore recognised based on the stage of completion of contracts over time using the input method. The Group normally receives progress payment from customers on a monthly basis with reference to the contract terms. The Group requires certain customers to provide upfront deposits at rates ranging from 5% to 20% of total contract sum. When the Group receives a deposit before the project commences, this will give rise to contract liabilities at the start of a contract until the full amount of deposits is deducted proportionately from monthly progress payment.

A contract asset, net of contract liability related to the same contract, is recognised over the period in which the E&M engineering solutions and services are performed and represents the Group's right to consideration for the services performed and not billed because the rights are conditional on the Group's future performance accepted by the customers. The contract assets are transferred to trade receivables when the rights become unconditional. The Group typically transfers its contract assets to trade receivables when progress certificate/invoice is issued.

Retention receivables, prior to the expiration of the maintenance period which usually ranges from one to three years from the date of the practical completion of the project, are classified as contract assets. The relevant amount of contract assets is reclassified to trade receivables when the maintenance period expires, and/or the maintenance/payment certificate is issued, and/or the final account is issued.

##### 來自客戶合約的收益(續)

###### (a) 提供機電工程解決方案及服務(續)

由於本集團之履約行為創造或改良了客戶在資產被創造或改良時已控制的資產，因此本集團隨時間轉移確認收益，並採用輸入法計量完全達成合約的進度。輸入法按已實際產生的成本佔完成建造服務所需估計總成本的比例而確認收益。

向客戶索償為本集團尋求向客戶收取成本補償及原有承建合約並未載列的工程範疇的利潤之款項。索償入賬列作可變代價並受到限制，直至與可變代價相關的不明因素在往後解決時，已確認的累計收益金額很可能不會回撥大額收益。本集團使用預期價值法估計索償金額，因為該方法最能預測本集團將有權收取的可變代價金額。

根據合約的條款，本集團的表現創造及／或增強客戶在本集團作業過程中控制的資產。因此，提供合約服務的收益使用輸入法隨著時間根據完成合約的階段確認。本集團通常參考工程合約條款每月從客戶處收取進度付款。本集團要求若干客戶提供介乎按總合約金額5%至20%利率計算的事先按金。本集團在項目開始前收到按金，這將造成於合約開始時的合約負債，直至按金的全部金額按比例每月從進度付款中扣減。

合約資產，扣除與相同合約相關的合約負債，於實施機電工程解決方案及服務的期間確認，代表本集團有權就已實施但尚未開票的服務收取代價，因為該等權利乃取決於客戶接納本集團未來表現。當權利變為無條件時，合約資產轉撥至貿易應收款項。本集團通常在發出進度證書／發票時將其合約資產轉撥至貿易應收款項。

於保修期屆滿前，應收保留金分類為合約資產，通常介乎自項目實際完成日期起一至三年。合約資產的相關金額在保修期屆滿，及／或保修／付款證書已發出，及／或最終賬戶已發行時重新分類至貿易應收款項。

##### Revenue from contracts with customers (continued)

(b) *Provision of E&M engineering maintenance services*

Revenue from the provision of E&M engineering maintenance services to the customers' facilities is recognised over time when services are rendered during the contract period. The services are billed based on the services performed.

(c) *Provision of E&M engineering design and fabrication services*

Revenue from the provision of E&M engineering design and fabrication services is generated from design and fabrication services for the fabrication of made-to-order products for the customers, such as control room consoles, public access kiosks and terminals, relay racks, test rigs, control room technical furniture and industrial enclosures and instrument cabinets without supply, installation of systems and implementation of E&M engineering solutions and services.

Revenue is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the goods to specific locations and customers obtaining control of the goods.

(d) *Sales of parts and components*

Revenue from the sale of parts and components is recognised at the point in time when control of the asset is transferred to the customer, generally on delivery of the goods to specific locations and customers obtaining control of the materials.

#### Other income

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

#### Contract assets

A contract asset is the right to consideration in exchange for goods or services transferred to the customer. If the Group performs by transferring goods or services to a customer before the customer pays consideration or before payment is due, a contract asset is recognised for the earned consideration that is conditional. Contract assets are subject to impairment assessment, details of which are included in the accounting policies for impairment of financial assets.

#### Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

(b) *提供機電工程保養服務*

向客戶的設施提供機電工程保養服務產生收益於合約期內服務提供的時間確認。服務乃根據所履行的服務計費。

(c) *提供機電工程設計及裝配服務*

提供機電工程設計及裝配服務產生的收益來自為客戶裝配按訂單製造的產品(例如控制室控制台、公用關卡及終端、繼電器機架、試驗台,以及控制室技術傢俬及工業外殼及儀器櫃)的設計及裝配服務(並無供應、安裝系統及執行機電工程解決方案及服務)。

該收益於資產控制權轉移至客戶、貨品通常交付至指定位置及客戶獲得貨品控制權時的時間點確認。

(d) *銷售零件及部件*

銷售零件及部件的收益於資產控制權轉移至客戶、貨品通常交付至指定位置及客戶獲得材料控制權時的時間點確認。

#### 其他收入

利息收入按應計基準使用實際利息法確認,當中採用將金融工具預期年期或更短期間(如適用)內的估計未來現金收入準確貼現至金融資產賬面淨額的利率。

#### 合約資產

合約資產乃就換取已向客戶轉移的貨品或服務而收取代價之權利。倘本集團於客戶支付代價前或到期付款前將貨品或服務轉移予客戶,則就附帶條件賺取的代價確認合約資產。合約資產有待進行減值評估,其詳情載於金融資產減值之會計政策。

#### 合約負債

合約負債於本集團將相關貨品或服務轉移前向客戶作出收款或到期付款時(以較早者為準)確認。合約負債於本集團履行合約(即向客戶轉移相關貨品或服務的控制權)時確認為收益。

#### Contract costs

Other than the costs which are capitalised as inventories and property, plant and equipment, costs incurred to fulfil a contract with a customer are capitalised as an asset if all of the following criteria are met:

- (a) The costs relate directly to a contract or to an anticipated contract that the entity can specifically identify.
- (b) The costs generate or enhance resources of the entity that will be used in satisfying (or in continuing to satisfy) performance obligations in the future.
- (c) The costs are expected to be recovered.

The capitalised contract costs are amortised and charged to profit or loss on a systematic basis that is consistent with the transfer to the customer of the goods or services to which the asset relates. Other contract costs are expensed as incurred.

#### Share-based payments

##### Share option scheme

The Company operates a share option scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees for grants after 7 November 2002 is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external valuer using a binomial model, further details of which are given in note 35 to the consolidated financial statements.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

#### 合約成本

除撥充存貨以及物業、廠房及設備資本之成本外，倘符合以下全部條件，則因履行客戶合約而產生之成本亦撥充資產資本：

- (a) 成本與合約或實體能具體識別的預計合約直接有關。
- (b) 成本為實體產生或提升資源而該資源將於日後用於履行(或持續履行)履約責任。
- (c) 成本預期可予收回。

撥充資本的合約成本按向客戶轉讓與資產相關的貨品或服務一致的系統化基準攤銷及於損益扣除。其他合約成本於產生時列為開支。

#### 以股份為基礎付款

##### 購股權計劃

本公司實施購股權計劃，旨在為對本集團業務成功作出貢獻之合資格參與者提供激勵與獎勵。本集團僱員(包括董事)以股份為基礎付款之方式收取報酬，而僱員提供服務作為收取股本工具之代價(「權益結算之交易」)。

於二零二零年十一月七日之後之與僱員進行權益結算之交易之成本，乃參照授出日期之公允值而計量。公允值乃由外聘估值師採用二項式模型釐定，進一步詳情載於綜合財務報表附註35。

權益結算之交易的成本，連同在表現及／或服務條件得到履行的期間內相應增加的權益在僱員福利開支中確認。於歸屬日期前的各報告期末，權益結算之交易所確認的累計開支，反映了歸屬期屆滿的程度及本集團對於最終將歸屬的股本工具數量的最佳估計。期內於損益扣除或計入的金額，指該期初及期末所確認的累計開支的變動。

釐定獎勵的授出日期公允值時，不會計及服務及非市場表現條件，但會評估達成該等條件的可能性，作為本集團對最終將歸屬的股本工具數量的最佳估計的一部分。市場表現條件反映於授出日期公允值內。獎勵所附帶但並無相關服務要求的任何其他條件視為非歸屬條件。除非有另外的服務及／或表現條件，否則非歸屬條件反映於獎勵的公允值內，並將即時支銷獎勵。

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilutive effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

#### Shares held under the share award scheme

Where shares of the Company are gifted or purchased from the open market for the share award scheme, the fair value at the date of gifting or consideration paid, including any directly attributable incremental costs, respectively, is presented as "Shares held under the share award scheme" and deducted from equity. No gain or loss is recognised in profit or loss on the purchase, sale, issue or cancellation of the Group's own equity instruments.

#### Other employee benefits

##### Retirement benefit schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme, except for the Group's employer voluntary contributions, which are refunded to the Group when the employee leaves employment prior to the contributions vesting fully, in accordance with the rules of the MPF Scheme.

基於未能達成非市場表現及/或服務條件而最終並無歸屬的獎勵不會確認開支。倘獎勵包括市場或非歸屬條件，交易視為歸屬，而不論市場或非歸屬條件是否達成，惟所有其他表現及/或服務條件須已達成。

倘若以權益結算獎勵的條款有所更改，則在達致獎勵原定條款的情況下，所確認的開支最少須達到猶如條款並無任何更改的水平。此外，倘若按更改日期計量，任何更改導致以股份基礎支付的總公允價值有所增加，或對僱員帶來其他利益，則應該等更改確認開支。

倘若註銷以權益結算獎勵，應被視為已於註銷日期歸屬，任何尚未確認獎勵的開支，均應立刻確認，包括在本集團或其僱員控制下的非歸屬條件並未達成的任何獎勵。然而，若授予新獎勵代替已註銷的獎勵，並於授出日期指定為替代獎勵，則已註銷的獎勵及新報獎勵，誠如前段所述，均應被視為原獎勵的更改。

尚未行使購股權的攤薄影響於計算每股盈利時反映為額外股份攤薄。

#### 根據股份獎勵計劃持有的股份

倘本公司股份為贖贈或就股份獎勵計劃從公開市場購買，於贖贈或支付代價日期的公允價值包括任何直接應佔增加成本，呈列為「根據股份獎勵計劃持有的股份」及自權益扣除。概無收益或虧損於購買、出售、發行或註銷本公司自身股本工具時於損益內確認。

#### 其他僱員福利

##### 退休福利計劃

根據強制性公積金計劃條例，本集團為合資格參與強積金計劃之僱員設立定額供款之強制性公積金退休福利計劃(「強積金計劃」)。供款乃按該等僱員之基本薪金之某一百分比作出，並按強積金計劃之規則於應付供款時自損益扣除。強積金計劃之資產由本集團以外之獨立管理基金持有。向強積金計劃作出供款時，本集團的僱主供款將全數歸屬僱員擁有，惟本集團僱主的自願供款則除外，根據強積金計劃的規則，當僱員在供款全數歸屬彼等前離職，則僱主的自願供款將退還予本集團。

The Group also operates a Mandatory Provident Fund Exempted ORSO retirement benefit scheme (the “**ORSO Scheme**”) for those employees who are eligible to participate in the ORSO Scheme. The ORSO Scheme operates in a way similar to the MPF Scheme, except that when an employee leaves the scheme prior to his/her interest in the Group’s employer contributions vesting fully, the ongoing contributions payable by the Group are reduced by the relevant amount of the employer’s forfeited contributions.

#### Dividend

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting. Proposed final dividends are disclosed in the notes to the consolidated financial statements.

#### Foreign currencies

These financial statements are presented in HK\$, which is the Company’s functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

##### 退休福利計劃(續)

本集團另外為合資格參與之僱員設有強制性公積金豁免之職業退休計劃(「**職業退休計劃**」)。職業退休計劃之運作形式與強積金計劃相似，惟當僱員在符合資格獲得本集團全部僱主供款前退出該計劃，則僱主之沒收供款之有關數額乃用以扣減本集團持續應繳之供款。

#### 股息

當末期股息於股東週年大會上獲股東批准時，末期股息獲確認為負債。擬派末期股息於綜合財務報表附註內披露。

#### 外幣

本財務報表均以港元呈列，而港元乃本公司的功能貨幣。本集團旗下各實體自行決定功能貨幣，而各實體財務報表中包含的項目以該功能貨幣計量。本集團實體記錄的外幣交易按交易日期適用的各自功能貨幣匯率初步入賬。以外幣計值的貨幣資產及負債以報告期末適用的功能貨幣匯率重新換算。所有產生自結算或換算貨幣項目的差額一律於損益確認。

以歷史成本按外幣計量的非貨幣項目按初步交易日的匯率換算。以外幣按公允值計量的非貨幣項目會使用計量公允值當日的匯率換算。換算按公允值計量的非貨幣項目而產生的收益或虧損，按確認該項目的公允值變動的收益或虧損一致的方法處理(即公允值收益或虧損於其他全面收益或損益內確認的項目，其換算差額亦分別於其他全面收益或損益內確認)。

於釐定相關資產於初步確認，終止確認與預付代價有關的非貨幣資產或非貨幣負債產生的開支或收入的匯率時，初步交易日為本集團初步確認因預付代價而產生非貨幣資產或非貨幣負債的日期。倘多次預先支付或收取款項，本集團會就每次支付或收取預付代價釐定交易日。

### 4. SIGNIFICANT ACCOUNTING JUDGEMENTS AND ESTIMATES

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and their accompanying disclosures, and the disclosure of contingent liabilities. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

The major judgements, estimates and assumptions, that have the most significant effect on the amounts recognised in the financial statements and have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are set out below:

#### ***Contract revenue and contract costs from E&M engineering solutions and services***

The Group reviews and revises the estimates of contract revenue, contract costs, variation orders and contract claims prepared for each E&M engineering solutions and services contract as the contract progresses. Budgeted engineering service costs are prepared by management on the basis of estimation of direct labour costs to incur and quotations from time to time provided by the major contractors, suppliers or vendors involved and the experience of management. In order to keep the budget accurate and up-to-date, management conducts periodic reviews of the budgets of contracts by comparing the budgeted amounts to the actual amounts incurred. Such significant estimate may have impact on the revenue recognised in each period with adjustments made on a prospective basis.

Recognised amounts of E&M engineering solutions and services contracts revenue and related receivables reflect management's best estimate of each contract's outcome and stage of completion, which are determined on the basis of a number of estimates. This includes the assessment of the profitability of on-going E&M engineering solutions and services contracts.

For more complex contracts in particular, costs to complete and contract profitability are subject to significant estimation uncertainty. The actual outcomes in terms of total cost or revenue may be higher or lower than estimated at the end of the reporting period, which would affect the revenue and profit recognised in future years as an adjustment to the amounts recorded to date with adjustments made on a prospective basis.

### 4. 重大會計判斷及估計

本集團財務報表的編製需要由管理層作出影響收益、開支、資產及負債的呈報金額及其相關披露及或然負債披露的判斷、估計及假設。該等假設及估計的不明朗因素，可能導致須就日後受影響的資產或負債的賬面值作出重大調整。

對於財務報表內確認的金額具有最重大影響且具有導致下個財政年度的資產及負債賬面值出現大幅調整的重大風險的主要判斷、估計及假設載列如下：

#### ***來自機電工程解決方案及服務的合約收益及合約成本***

隨著合約工程進度，本集團檢討及修訂就每一份機電工程解決方案及服務合約編製的合約收益、合約成本、更改工程指令及合約索償估計。工程服務成本預算由管理層以所涉及的主要承包商、供應商或賣方不時提供的估計產生的直接勞工成本及報價及管理層的經驗為基礎而編製。為確保預算準確及更新，管理層通過比較預算金額與所產生實際金額，定期對合約預算進行檢討。有關重大估計或會對各期間所確認的收益造成影響，按預期基準作出調整。

機電工程解決方案及服務合約收益及相關應收款項的已確認金額反映管理層對各合約的結果及完成階段的最佳估計，乃基於若干估計釐定。這包括評估持續經營之機電工程解決方案及服務合約的盈利能力。

特別對較複雜的合約而言，完成成本及合約盈利能力受限於重大估計不明朗因素。總成本或總收益之實際結果可能高於或低於報告期末作出之估計，從而將影響未來年度作為迄今記錄金額的調整而確認之收益及溢利，按預期基準作出調整。

#### *Provision for ECLs on trade receivables and contract assets*

The Group calculates ECLs for the trade receivables and contract assets. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by customer type and rating). At every reporting date, the credit ratings are reassessed. In addition, trade receivables and contract assets with significant balances and that are credit impaired are assessed for ECLs individually.

The provision for ECLs is sensitive to changes in estimates. The information about the Group's trade receivables, contract assets and ECLs is disclosed in notes 16, 18 and 31 to the consolidated financial statements, respectively.

Accordingly, the Group has only one single operating segment and no separate analysis of this single segment is presented other than entity-wide disclosure.

The above unlisted investments at 31 March 2021 were the deposits paid for life insurance products issued by financial institutions in Hong Kong. They were classified as financial assets at fair value through profit or loss as their contractual cash flows are not solely payments of principal and interest.

The life insurance products were entered by the Group's subsidiaries with financial institutions on certain senior management of the Group, including Mr. Chan Chak Lun Philip and Mr. Luk Yin Cheung, directors of the Company. Under the life insurance policies, the beneficiary and policy holders are subsidiaries of the Group. The Group's subsidiaries are required to pay a single premium or annual premium for the policies and may request a partial surrender or full surrender of the policies at any time and receive cash back based on the value of the policies at the date of surrender, which is determined by the account value net of any surrender charge (the "Cash Values"). The policy premium expense, insurance charges and surrender charges are recognised in profit or loss. The life insurance policies have guaranteed value or carry guaranteed interest of 4.25% per annum at first year, and a minimum guaranteed interest of 2.00% per annum at the second year and onwards.

The Group rebutted the presumption of default under the expected credit loss model for trade receivables past due over 90 days assuming no significant change in credit quality after having an understanding of those customers' background as well as the good payment records and continuous business relationship with those customers. Further, such long outstanding balances were primarily due to overdue payment which was a common practice in E&M engineering solutions and services. The Group did not hold any collateral over these balances.

Details of impairment of trade receivables for the year ended 31 March 2021 were set out in note 31 to the consolidated financial statements. The ECLs for trade receivables as at 31 March 2021 and 31 March 2020 were HK\$282,000 and HK\$317,000, respectively.

A contract asset, net of contract liability related to the same contract, is recognised over the period in which the engineering services are performed, representing the Group's right to consideration for the services performed and not billed because the rights are conditional on the Group's future performance accepted by the customers. The contract assets are transferred to trade receivables when the rights become unconditional. The Group typically transfers its contract assets to trade receivables when progress certificate/invoice is issued. The Group generally provides their customers with maintenance period of one to three years from the date of the practical completion of the project. Upon the expiration of the maintenance period, the customers will provide a maintenance certificate and pay the retentions within the term specified in the contract. The increase in contract assets in 2021 and 2020 was the result of the increase in the provision of engineering services at the end of each of the years.

The Group requires certain customers under engineering service contracts to provide upfront deposits at rates ranging from 5% to 20% of the total contract sum. When the Group receives a deposit before the project commences, this will give rise to contract liabilities at the start of a contract until the full amount of the deposit is deducted proportionately from progress payment. The increase in contract liabilities in 2021 and 2020 was mainly due to the increase in short-term advances received from customers in relation to the provision of engineering services at the end of the years.

The total expense is recognised on a straight-line basis over the relevant vesting periods (or on the grant date if the shares vest immediately), with a corresponding credit to the share-based payment reserves under equity. Upon vesting, the related costs of the vested shares under the share award scheme are credited to shares under the share award scheme, with a corresponding decrease in the share-based payment reserves.

### 28. RETIREMENT BENEFIT SCHEMES

The Group participates in defined contribution schemes which are registered under the ORSO Scheme and the MPF Scheme established under the Mandatory Provident Fund Ordinance in December 2000. The assets of the schemes are held separately from those of the Group, in funds under the control of trustees. Employees who were members of the ORSO Scheme prior to the establishment of the MPF Scheme were offered a choice of staying with the ORSO Scheme or switching to the MPF Scheme, whereas all new employees joining the Group on or after 1 December 2000 are required to join the MPF Scheme.

For members of the MPF Scheme, except for the Group's voluntary contributions, the Group contributes 5% of relevant payroll costs to the MPF Scheme, subject to a cap of monthly relevant income of HK\$30,000, which matches contribution of the employee.

The ORSO Scheme is funded by monthly contributions from both employees and the Group at rates ranging from 5% to 8% of the employee's basic salary, depending on the length of service with the Group.

The total expense recognised in profit or loss of HK\$3,062,000 (2020: HK\$2,929,000) during the year ended 31 March 2021 represents contributions paid and payable to these plans by the Group at rates specified in the rules of the plans.

### 29. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to owners through the optimisation of the debt and equity balance.

The capital structure of the Group consists of debt and equity of the Group, comprising issued share capital and accumulated profits.

The management of the Group reviews the capital structure regularly taking into account the cost of capital and the risk associated with the capital. The Group will balance its overall capital structure through the issuance of new shares and the raise of borrowings.

### 30. FAIR VALUE AND FAIR VALUE HIERARCHY OF FINANCIAL INSTRUMENTS

Management has assessed that the fair values of financial assets and liabilities which are due to be received or settled within one year approximate to their carrying amounts largely due to the short term maturities of these instruments.

The fair values of the financial assets and liabilities are included at the amounts at which the instrument could be exchanged in a current transaction between willing parties, other than in a forced or liquidation sale.

#### Financial risk management objectives and policies

The Group's principal financial instruments include trade receivables, other receivables and deposits, pledged bank deposits, time deposits with original maturity over three months, bank balances and cash, trade and retention payables, other payables and accruals and lease liabilities. Details of the major financial instruments and the Group's relevant accounting policies are disclosed in note 3 to the consolidated financial statements.

The main risks arising from the Group's financial instruments are currency risk, interest rate risk, credit risk and liquidity risk. The Directors review and agree policies for managing each of these risks and they are summarised below.

#### Currency risk

Financial assets at fair value through profit or loss, certain bank balances and cash, time deposits with original maturity over three months, trade receivables and trade payables of the Group are denominated in foreign currencies, i.e. RMB, EUR, USD, New Taiwan dollars ("NTD") and Singapore dollars ("SGD"). The Group currently does not have a foreign currency hedging policy. However, the directors of the Company monitor foreign exchange exposure and will consider hedging significant foreign currency exposure should the need arise.

Since the exchange rate of HK\$ is pegged with USD, the Group does not expect any significant movements in the USD/HK\$ exchange rates. Thus, there is no sensitivity analysis on USD denominated financial assets.

##### Interest rate risk

The Group was exposed to cash flow interest rate risk in bank balances and cash and pledged bank deposits as at 31 March 2021 and 2020.

As at 31 March 2021 and 2020, the Group was also exposed to fair value interest rate risk in relation to fixed rate time deposits with original maturity over three months.

The Group has not used any interest rate swaps to mitigate its exposure associated with interest rate risk. However, the management of the Group monitors interest rate exposure and will consider hedging significant interest rate exposure should the need arise.

##### Sensitivity analysis

In the opinion of the management of the Group, the expected change in interest rate will not have a significant impact on the interest income or expenses on payments for bank balances and pledged bank deposits, hence sensitivity analysis is not presented.

##### Credit risk and impairment assessment

The Group's maximum exposure to credit risk which will cause a financial loss to the Group due to the failure to discharge the obligations by counterparties arises from the carrying amount of the respective recognised financial assets as stated in the consolidated statements of financial position at the end of the reporting period. The Group's credit risk is primarily attributable to financial assets at fair value through profit or loss, trade receivables, contract assets, financial assets included in other receivables, deposits and prepayments, pledged bank deposits, time deposits with original maturity over three months and bank balances and cash.

*Trade receivables and contract assets arising from contracts with customers*

In order to minimise the credit risk, the management of the Group has delegated a team responsible for the determination of credit limits and credit approvals. Before accepting any new customer, the Group uses an internal credit scoring system to assess the potential customer's credit quality and define credit limits by customer. The level of credit granted must not exceed a predetermined level set by management. Limits and scoring attributed to customers are reviewed once a year. Other monitoring procedures are in place to ensure that follow-up action is taken to recover overdue debts. In addition, the Group performs impairment assessment under the ECL model on trade receivables and contract assets individually. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The Group has concentration of credit risk on trade receivables and contract assets in terms of geographical location, as these receivables and assets which accounted for 99.3% (2020: 97.0%) of the total trade receivables and 97.6% (2020: 99.8%) of the total contract assets as at 31 March 2021, were mainly in Hong Kong.

The Group has concentration of credit risks on trade receivables and contract assets with exposure limited to certain customers. Receivables from the five largest customers amounting to HK\$37,205,000 (2020: HK\$37,498,000) comprised approximately 91.3% (2020: 82.1%) of the Group's trade receivables and 81.0% (2020: 88.2%) of the Group's total contract assets as at 31 March 2021. As at 31 March 2021, 65.6% (2020: 63.8%) of the Group's trade receivables were due from the Group's largest customer.

##### *Pledged bank deposits, time deposits with original maturity over three months and bank balances and cash*

The Group has a concentration of credit risk on pledged bank deposits, time deposits with original maturity over three months and bank balances deposited with a few major banks. The credit risk on these balances is limited because the counterparties are banks with good reputation and with high credit ratings assigned by international credit-rating agencies.

##### *Financial assets included in other receivables, deposits and prepayments*

The management of the Group regularly reviews and assesses the credit quality of the counterparties. The Group uses 12-month ECLs to assess the loss allowance for financial assets included in other receivables, deposits and prepayments since these receivables are not past due and there has not been a significant increase in credit risk since initial recognition. Based on internal credit assessment, the directors of the Company consider that these assets are low credit risk financial assets due to the short-term nature and the probability of default is negligible. Hence, no loss allowance was recognised during the year ended 31 March 2021 (2020: Nil).

Other than the concentration risk as disclosed above, the Group does not have any other significant concentration of credit risk.

*貿易應收款項及來自客戶合約的合約資產*

為盡量減低信貸風險，本集團管理層已委派一小組，負責釐定信貸限額及信貸批核。接納任何新客戶前，本集團採用內部信貸評分系統評估潛在客戶的信貸質素及按客戶界定的信貸額度。所授出信貸水平不得超過管理層預先設定的水平。每年一次審閱對客戶的額度及評分。進行其他監察程序，以確保已採取跟進措施，收回逾期債項。此外，本集團亦對貿易應收款項及合約資產根據預期信貸虧損模式單獨進行減值評估。就此而言，本公司董事認為本集團之信貸風險已大幅減低。

本集團貿易應收款項及合約資產按地理位置劃分的信貸風險集中主要在香港，由於該等貿易應收款項及合約資產於二零二一年三月三十一日佔總貿易應收款項的99.3%(二零二零年：97.0%)及總合約資產的97.6%(二零二零年：99.8%)。

本集團面臨僅限於若干客戶的貿易應收款項及合約資產集中信貸風險。於二零二一年三月三十一日，應收五大客戶款項為37,205,000港元(二零二零年：37,498,000港元)佔本集團貿易應收款項約91.3%(二零二零年：82.1%)及本集團總合約資產81.0%(二零二零年：88.2%)。於二零二一年三月三十一日，本集團貿易應收款項中65.6%(二零二零年：63.8%)為應收本集團最大客戶款項。

##### *已抵押銀行存款、原到期日超過三個月的定期存款以及銀行結餘及現金*

本集團有關於已抵押銀行存款、原到期日超過三個月的定期存款及與一些主要銀行的銀行結餘的集中信貸風險。該等結餘的信貸風險有限，因為交易對手方為聲譽良好及由國際信貸評級機構評定的高信貸等級之銀行。

##### *計入其他應收款項、按金及預付款項之金融資產*

本集團管理層定期審閱及評估交易對手方的信貸質素。本集團使用12個月預期信貸虧損評估計入其他應收款項、按金及預付款項之金融資產的虧損撥備，因為該等應收款項並無逾期及自初次確認起其信貸風險並無重大增加。根據內部信貸評估，本公司董事認為由於短期性質及違約可能性可忽略，該等資產為低信貸風險資產。因此，於截至二零二一年三月三十一日止年度並無確認虧損撥備(二零二零年：零)。

除上文所披露集中性風險外，本集團並無任何其他重大集中信貸風險。

The estimated loss rates and risk level are estimated based on historical observed default rates over the expected life of the debtors and are adjusted for forward-looking information that is available without undue cost or effort. The grouping is regularly reviewed by management to ensure relevant information about specific debtors is updated.

The Group writes off a trade receivable when there is information indicating that the debtor is in severe financial difficulty and there is no realistic prospect of recovery, e.g. when the debtor has been placed under liquidation or has entered into bankruptcy proceedings, or when the trade receivables are over two years past due, whichever occurs earlier. Trade receivables of HK\$650,000 were written off by the Group during the year ended 31 March 2020.

During the year ended 31 March 2021, the Group reversed provision of impairment allowance of HK\$35,000 and made provision of HK\$179,000 (2020: provision of HK\$200,000 and reversal of HK\$87,000) for trade receivables and contract assets, respectively. ### 32. PERFORMANCE GUARANTEES

As at 31 March 2021, performance guarantees of approximately HK\$5,424,000 (2020: HK\$5,424,000) were given by a bank in favour of the Group's customer as security for the due performance and observance of the Group's obligations under the contracts entered into between the Group and its customer. If the Group failed to provide satisfactory performance to its customer to whom the performance guarantees had been given, such customer may demand the bank to pay to the customer the sum or sum stipulated in such demand. The Group would become liable to compensate such bank accordingly. The performance guarantees would be released upon completion of the contract works. ### 35. SHARE OPTION SCHEME

Upon passing an ordinary resolution on 20 September 2017, the Company adopted a share option scheme (the “**Share Option Scheme**”) which will remain valid for a period of 10 years commencing on 16 October 2017. The major terms of the Share Option Scheme are set out below:

- (i) The purpose of the Share Option Scheme is to recognise and acknowledge the contributions that the directors and employees of the Group have made or may make to the Group.
- (ii) The participants included any director or employee of the Group which, in the opinion of the Company's board of directors, has contribution or potential contribution to the development and growth of the Group.
- (iii) The maximum number of shares in respect of which options might be granted under the Share Option Scheme must not exceed 30% of the issued share capital of the Company from time to time. The number of shares issued and to be issued in respect of which options granted and may be granted to any individual in any 12-month period is not permitted to exceed 1% of the shares of the Company in issue at any point in time, without prior approval from the Company's shareholders. Options granted to a substantial shareholder or an independent non-executive director in excess of 0.1% of the Company's share capital or with a value in excess of HK\$5 million must be approved in advance by the Company's shareholders.
- (iv) In relation to each grantee of the options granted under the Share Option Scheme, the right of the grantee to exercise the option shall be in accordance with the terms of the Share Option Scheme and the period to be notified by the board of directors of the Company to each grantee which shall not exceed 10 years from the date upon which the options are deemed to be granted and accepted.
- (v) The exercise price of an option will be determined by the board of directors of the Company and will not be less than the highest of:
  - the closing price of the share on the date of grant;
  - the average closing price of the share for the five business days immediately preceding the date of grant; and
  - the nominal value of the share.
- (vi) A consideration of HK\$10 per grant is payable on acceptance of the offer of grant of options.

Eligible persons of the Share Award Scheme include any employee of the Group; any executive or non-executive director (including any independent non-executive director) of the Company, any of its subsidiaries, customers, suppliers, any person or entity that provides research, development or other technological support, shareholders of any member of the Group or any invested entities, any person or entity which has contributed to the Group or its business; and any other person selected by the board of directors, and if applicable, including its executive committee at its sole discretion, provided that the eligible persons for participation in the Share Award Scheme (the **"Selected Participants"**) remain at all times after the date of grant and on the relevant vesting date being eligible person of the Group.

The maximum number of shares currently permitted to be granted under the Share Award Scheme is limited to 10% of the total number of issued shares as at the date on which the Share Award Scheme is adopted by the board of directors. The maximum number of shares which may be awarded to each eligible person in the Share Award Scheme in any 12-month period is limited to 1% of the total number of shares in issue of the Company in any 12-month period from time to time.

Selected Participants are selected and the number of shares to be awarded under the Share Award Scheme is determined by the board of directors. The shares to be awarded under the Share Award Scheme are purchased by a trustee (the **"Trustee"**) from the open market out of cash contributed by the Group or by way of gift and be held on trust for the Selected Participant until such shares are vested with the Selected Participants in accordance with the provisions of the Share Award Scheme.
