**RESULT OF REVIEW HEARING
AND
JUDICIAL REVIEW**

Reference is made to the announcements of **China Trends Holdings Limited** (the “**Company**”) dated 10 June 2019, 14 June 2019, 4 July 2019, 23 August 2019, 14 November 2019, 21 November 2019, 4 December 2019 and 10 March 2020 in relation to, inter alia, the decision of the Stock Exchange to suspend trading in the shares of the Company under Rule 9.04 of the GEM Listing Rules, the announcement of the Company dated 5 May 2020 in relation to the resumption guidance, the announcement of the Company dated 17 May 2020, 6 October 2020, 8 December 2020, 31 December 2020, 9 July 2021 and 29 July 2021 in relation to the application for leave to judicial review, and the announcements of the Company dated 10 June 2020, 12 June 2020, 10 September 2020, 10 December 2020, 10 March 2021 and 10 June 2021 in relation to the quarterly update of the Company (collectively, the “**Announcements**”). Unless otherwise defined, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcements.

On 10 August 2021, the GEM Listing Review Committee notified the Company that it decided to uphold the GEM Listing Committee's Delisting Decision (the “**LRC Decision**”).

The Company disagrees with the LRC Decision and will file an application for leave to apply for judicial review against the LRC Decision in the High Court of Hong Kong.

CONTINUED SUSPENSION OF TRADING

At the request of the Company, trading in the shares of the Company have been suspended since 9:00 a.m. on 11 March 2020 and will remain suspended until the Company fulfills the Resumption Guidance.
