This announcement is made by Hon Corporation Limited (the “**Company**”) in accordance with Rules 17.10 and 17.27 of the Rule Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provision (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinances (Chapter 571) of the Laws of Hong Kong.

WINDING UP APPLICATION DATED 23 JULY 2021

On 30 July 2021, Hon Industries Pte. Ltd. (“**HIPL**”), the indirectly wholly owned subsidiary of the Company, has received an originating summons issued by the High Court of the Supreme Court of the Republic of Singapore (the “**Court**”) in relation to a winding application (the “**Application**”) dated 23 July 2021 filed against HIPL under Sections 125(1)(e) and 125(2)(a) of the Insolvency, Restructuring and Dissolution Act (Act 40 of 2018) for its alleged failure to pay the applicant, Maybank Singapore Limited, in full the outstanding amount of S\$3,893,314.75 (including interests accrued up till 15 July 2021).

A hearing for the Application was conducted through video conference on 13 August 2021 and the Court has ordered the hearing for the Application be adjourned to 18 October 2021.

UPDATE ON WINDING UP PETITIONS

References are made to the announcements of the Company dated 2 February 2021, 15 March 2021, 19 March 2021, 26 March 2021, 9 April 2021, 22 April 2021, 28 May 2021, 22 June 2021 and 7 July 2021 (the “**Announcements**”) regarding several winding up petitions received by the Company on 10 November 2020, 15 December 2020, 20 January 2021, 27 January 2021 and 1 February 2021, respectively (collectively the “**Petitions**”). Unless otherwise defined, capitalised terms used herein shall have the same meanings as defined in the Announcements.

The Company would like to provide update on the status of the Petitions as follow:

- (a) as disclosed in the Announcements, the hearing of Petition A was adjourned to 27 September 2021 and the Court has ordered the hearing for Petition A be further adjourned to 18 October 2021;
- (b) as disclosed in the Announcements, the hearing of Petition C was adjourned to 20 August 2021 and the Court has ordered the hearing for Petition C be further adjourned to 18 October 2021;
- (c) as disclosed in the Announcements, the hearing of Petition D was adjourned to 27 September 2021 and the Court has ordered the hearing for Petition D be further adjourned to 18 October 2021; and
- (d) as disclosed in the Announcements, the hearing of Petition E was adjourned to 27 September 2021 and the Court has ordered the hearing for Petition E be further adjourned to 18 October 2021.

The Company will make further announcements to update the Shareholders and potential investors on the development of the Petitions as and when appropriate. As of the date of this announcement, the Company and its subsidiaries are still carrying out their day-to-day operations under the management of the board of the directors of the Company.

CONTINUED SUSPENSION OF TRADING

Trading in the shares of the Company on the Stock Exchange has been suspended with effect from 9:00 a.m. on 31 March 2021, and will remain suspended until further notice pending, among other matters, the finalisation of the 2020 Annual Results of the Company.
