## **PROFIT WARNING**

This announcement is made by Kwong Man Kee Group Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on a preliminary review of the Group’s unaudited consolidated management accounts for the six months ended 30 September 2021, the Group is expected to record a substantial decrease in profit not less than 60% for the six months ended 30 September 2021 as compared with profit for corresponding period of 2020. Such decline was mainly attributable to (1) the decrease of revenue due to delay in commencement of certain contracts caused by change of schedule of relevant main contractors and property developers; (2) fewer projects with higher profit margin as compared with the corresponding period of 2020; (3) the higher staff costs due to the increased staff number; and (4) the discontinuance of financial support to employers provided by the Government of Hong Kong Special Administrative Region through its “Employment Support Scheme” during the six months ended 30 September 2021.

The Company is still in the process of finalising its unaudited consolidated management accounts for the six months ended 30 September 2021. The information contained in this announcement is only based on the preliminary assessment by the Board on the unaudited consolidated management accounts of the Group for the six months ended 30 September 2021 and the information available for the time being, which have been neither reviewed by the audit committee of the Company nor audited by the Company’s auditors, and is subject to possible adjustment. Shareholders and potential investors are advised to read carefully the interim results announcement of the Group for the six months ended 30 September 2021, which is expected to be released on 5 November 2021.

**Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.**
