EXPECTED DECREASE IN LOSS

This announcement is made pursuant to Rule 17.10 of the GEM Listing Rules and the Inside Information Provisions under Part XIVA of the SFO.

The Board wishes to inform the Shareholders and potential investors of the Company that, based on a preliminary assessment on the Management Accounts, the Group is expected to record a decrease of consolidated net loss to not more than HK\$6 million and an increase of consolidated revenue to approximately HK\$9 million to HK\$10 million. The improvement was mainly attributable to the increase in revenue which was primarily due to there were less suspension of robotics classes due to the precautionary measures imposed by the government authority in current year.

The information in this announcement is only based on the preliminary assessment by the Board on the Management Accounts which have not been confirmed or audited by the Company's auditors, and therefore may be subject to changes.

Shareholders and potential investors of the Company should exercise caution when dealing in the shares of the Company.

This announcement is made by Shentong Robot Education Group Company Limited (the “**Company**” together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the GEM (the “**GEM Listing Rules**”) of The Stock Exchange of Hong Kong Limited and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong) (the “**SFO**”).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors of the Company that, based on a preliminary assessment on the consolidated management accounts of the Group for the six months ended 30 September 2021 (the “**Management Accounts**”), the Group is expected to record a decrease of consolidated net loss to not more than HK\$6 million and increase of consolidated revenue to approximately HK\$9 million to HK\$10 million. The improvement was mainly attributable to the increase in revenue which was primarily due to there were less suspension of robotics classes due to the precautionary measures imposed by the government authority in current year.

The Company is still in the process of finalising the Group’s results for the six months ended 30 September 2021. The information in this announcement is only based on the preliminary assessment by the Board on the Management Accounts which have not been confirmed or audited by the Company’s auditors, and therefore may be subject to changes.
