PROFIT WARNING ANTICIPATION OF A DECREASE IN NET LOSS

This announcement is made by Merdeka Financial Group Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Director(s)**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that the Group is expected to record a net loss of approximately HK\$20 million for the nine months ended 30 September 2021 (the “**2021 Q3**”) as compared to the net loss of approximately HK\$84 million for the nine months ended 30 September 2020 (the “**2020 Q3**”). The decrease in net loss was mainly attributable to the net off effect of (i) the absence of reversal of impairment loss on other receivables of approximately HK\$9 million; (ii) the absence of impairment loss on finance lease receivables of approximately HK\$78 million; and (iii) the loss on deconsolidation of subsidiaries of approximately HK\$4 million.

Should the reversal of impairment loss on other receivables and impairment loss on finance lease receivables be excluded, the net loss of the Group for the 2020 Q3 would be approximately HK\$15 million, the net loss of the Group for the 2021 Q3 would be approximately HK\$20 million represented a slightly increase as compared to the net loss of approximately HK\$15 million for the 2020 Q3.

The information contained in this announcement represents only a preliminary assessment by the Board based on information currently available including the unaudited consolidated management accounts of the Group for the 2021 Q3, which have not been reviewed by the audit committee of the Company. As at the date of this announcement, the Company is in the process of finalising the financial results of the Group for the 2021 Q3, and such results are subject to necessary adjustments.

Shareholders and potential investors are advised to read carefully the Company's announcement of the 2021 Q3 which is expected to be published on or around 11 November 2021.
