POSITIVE PROFIT ALERT

This announcement is made by KOALA Financial Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company and potential investors that, based on a preliminary assessment of the latest available unaudited consolidated management accounts of the Group and information currently available to the Board, it is expected that the Group will record a profit of approximately HK\$95.7 million for the nine months ended 30 September 2021 as compared with a profit of approximately HK\$4.2 million for the corresponding period in 2020. Based on the relevant information currently available to the Board, the Board considers such expected increase in profit for the period of 2021 is mainly attributable to, among other things, an unrealised gain (after tax) from the investment in Hong Kong Aerospace Technology Group Limited (formerly known as Eternity Technology Holdings Limited) (stock code: 1725) of approximately HK\$79.6 million.

As the Group is still in the course of finalising its financial results for the nine months ended 30 September 2021, the information contained in this announcement is only based on the preliminary assessment by the Board of the information currently available to it including but not limited to the unaudited draft consolidated management accounts of the Group, which has not been audited by the auditors of the Company nor reviewed by the audit committee of the Board as at the date of this announcement and is subject to possible adjustments upon further review.

Shareholders and potential investors are advised to read carefully the Group's results announcement for the nine months ended 30 September 2021, which is expected to be published on 9 November 2021.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares and securities of the Company.
