POSITIVE PROFIT ALERT THIRD QUARTERLY RESULTS FOR THE NINE MONTHS ENDED 31 DECEMBER 2021

This announcement is made by Taste · Gourmet Group Limited (the “**Company**”, together with its subsidiaries as the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the GEM (the “**GEM Listing Rules**”) of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**” or “**Directors**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on a preliminary review of the unaudited consolidated management accounts of the Company for the nine months ended 31 December 2021 (the “**Current Period**”), the Group is expected to record a substantial growth in: (1) revenue of more than 73% as compared to the nine months ended 31 December 2020 (the “**Corresponding Period**”); and (2) the net profit and net profit attributable to owners of the Company:

<u>Adjustments relating to the Corresponding Period</u>	<u>More than</u>
Unadjusted	145%
After government subsidies deducted and listing expenses added back	395%
After listing expenses added back only	25%

The reasons for the increase are mainly due to: (1) more restaurants opened during the Current Period and restaurants that opened last year contributing full nine months of operations during the Current Period; (2) increase in the average spending per customer; (3) a change in dining habits of customers by taking dinners earlier due to the restrictive social distancing measures imposed by the Hong Kong Government; and (4) during the Corresponding Period, no dine-ins after 6 p.m. was enforced from the second half of July 2020 until the end of August 2020 and from early December 2020 until early February 2021.

As at the date of this announcement, the information contained in this announcement is only based on a preliminary assessment by the Board based on the unaudited consolidated management accounts of the Group for the Current Period, which have not been reviewed or audited by the auditor of the Company nor confirmed by the audit committee of the Company. Therefore, the actual results of the Group for the Current Period may differ from the information contained in this announcement. Shareholders and potential investors should refer to the third quarterly results announcement of the Company for the nine months ended 31 December 2021, which is expected to be published on 8 February 2022, for details of the performance of the Group.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
