Tenancy Agreement

An Agreement made the 16th day of April 2021 between the Landlord and the Tenant as more particularly described in the Schedule I,

The Landlord shall let and the Tenant shall take the Premises for the Term of Tenancy and at the Rent as more particularly described in the Schedule I and both parties agree to observe and perform the terms and conditions as follows:-

If the Rent and/or any charges payable (whether legally demanded or not) or if the Tenant shall commit a breach of any of the terms and conditions herein contained, it shall be lawful for the Landlord at any thereafter to re-enter the Premises whereupon this Agreement shall absolutely determine and the Landlord may deduct any loss or damage suffered by the Landlord as a result of the Tenant's breach from the Security Deposit without prejudice any other right of action or any remedy of the Landlord in respect of such breach by the Tenant.




