The board ("Board") of directors ("Directors") of the Company wishes to inform the shareholders of the Company and potential investors that, based on the preliminary review and analysis of the latest available unaudited financial information of the Group, the Group is expected to record a net loss of not more than HK\$11.0 million for the year ended 31 December 2021 ("FY2021") as compared to the net loss of approximately HK\$32.4 million for the year ended 31 December 2020 ("FY2020"). The expected net loss for FY2021 was primarily the combined effects of (i) segment profit of the software business of the Group of approximately HK\$15.7 million (FY2020: approximately HK\$23.3 million), including an impairment loss on goodwill of approximately HK\$9.0 million (FY2020: nil); (ii) segment loss of the securities investment business of the Group of approximately HK\$5.9 million (FY2020: approximately HK\$12.8 million); (iii) segment loss of the corporate management solutions and information technology contract services business of the Group of approximately HK\$1.6 million (FY2020: approximately HK\$17.9 million); (iv) segment loss of the business-to-customer online sales platform and business-to-business product trading business of the Group of approximately HK\$3.7 million (FY2020: approximately HK\$1.8 million (FY2020: approximately HK\$1.8 million); and (v) other corporate expenses of approximately HK\$11.8 million (FY2020: approximately HK\$12.9 million).
