On 8 October 2021, the Company granted share options to certain individuals to subscribe for a total of 100,000,000 Shares at an exercise price of HK\$0.056 per share pursuant to the share option scheme adopted by the Company on 1 December 2017 (the "Share Option Scheme"). Pursuant to the terms of the Share Option Scheme, the exercise price and the number of the outstanding share options granted under the Share Option Scheme have been adjusted to a total of 10,000,000 Shares at an exercise price of HK\$0.56 per share with effect from 12 April 2022, being the effective date of the Share Consolidation. As at the date hereof, none of the share options have been exercised. For further details of the share options, please refer to the announcements of the Company dated 8 October 2021 and 8 April 2022.
