- 5. If you wish to vote for any of the resolutions set out above, please tick ("\(\sigma'\)") in the boxes marked "FOR". If you wish to vote against any of the resolutions, please tick ("\(\sigma'\)") in the boxes marked "AGAINST". If this revised form of proxy returned is duly signed but without specific direction on any of the proposed resolutions, the proxy will vote or abstain at his/her discretion in respect of all resolutions; or if in respect of a particular proposed resolution there is no specific direction, the proxy will, in relation to that particular proposed resolution, vote or abstain at his/her discretion on any resolution properly put to the meeting other than those set out in the revised notice of the AGM.
- 6. In the case of a joint holding, this revised form of proxy may be signed by any joint holder, but if more than one joint holder is present at the meeting, whether in person or by proxy, that one of the joint holder whose name stands first on the register of members in respect of the relevant joint holding shall alone be entitled to vote in respect thereof.
- 7. This revised form of proxy must be signed by a shareholder, or his/her attorney duly authorised in writing, or if the shareholder is a corporation, either under its common seal or under the hand of an officer or attorney so authorised. All powers of attorney referred to in this note must be notarially certified.
- 8. As regards to the holders of the domestic shares and in order to be valid, this revised form of proxy, together with any power of attorney or other authority (if any), under which it is signed or a notarially certified copy of such power or authority, must be deposited with the Company's mailing address at 11th Floor, Building 1, Xitou Innocentre, 239 Shuanglong Street, Xihu District, Hangzhou City, Zhejiang Province, the PRC not less than 24 hours before the time appointed for holding the AGM or any adjournment thereof.
- 9. As regards to the holders of the H shares and in order to be valid, this revised form of proxy, together with any power of attorney or other authority (if any), under which it is signed or a notarially certified copy of such power or authority, must be deposited with the Company's H share registrar, Hong Kong Registrars Limited of 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not less than 24 hours before the time appointed for holding the AGM or any adjournment thereof.
- 10. A proxy attending the AGM on behalf of a shareholder must present the proof of his/her identity.
- 11. Any alteration made to this revised form of proxy should be initialed by the person who signs the revised form of proxy.
- 12. Completion and return of this revised form of proxy will not preclude you from attending and voting at the AGM or at any adjournment thereof should you so wish. If you attend and vote at the AGM, the authority of your proxy will be revoked.
