#### 1. GENERAL INFORMATION AND BASIS OF PREPARATION

The Company is an investment holding company. The Group is principally engaged in the sales of motor vehicles and provision of car-related technical services, servicing of motor vehicles, sales of auto parts and provision of car rental services.

These unaudited condensed consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is the functional currency of the Company, unless otherwise stated.

# (a) Statement of compliance

The unaudited condensed consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRS"), Hong Kong Accounting Standards and Interpretations (hereinafter collectively referred to as "HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") and the disclosure requirements of the Hong Kong Companies Ordinance. In addition, the unaudited condensed consolidated financial statements include applicable disclosure required by the GEM Listing Rules.

In preparing the unaudited condensed consolidated financial statements, management make judgments, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities, income and expense. Actual results may differ from these estimates.

The significant judgments made by management in applying the Group's accounting policies, the key sources of estimation uncertainty, and, except for described below, the accounting policies adopted for the preparation of these unaudited condensed consolidated financial statements of the Group are consistent with those applied to the consolidated financial statements as at and for the year ended 31 December 2021.

#### (b) Adoption of new or revised HKFRSs

The Group has adopted all the new and revised HKFRSs that are relevant to its operations and effective for its accounting year beginning on 1 January 2022.

The adoption of the new and revised HKFRSs has no material impact on how the results for the current and prior periods have been prepared and presented.

The Group has not early adopted those new or revised HKFRSs that have been issued by HKICPA but are not yet effective.

#### 3. INCOME TAX EXPENSE

No provision for Hong Kong Profits Tax has been made for the three months ended 31 March 2022 and 2021 as there were no assessable profits for both periods. Taxation on overseas profits has been calculated on the estimated assessable profits for the period at the rate of tax prevailing in the countries in which the Group operates.

The income tax provision in respect of operations in the People's Republic of China (the "PRC") is calculated at the applicable rates on the estimated assessable profits for the period based on the unification of the income tax rates for domestic-invested and foreign-invested enterprises at 25% (2021: 25%).

Income tax in respect of operations in Singapore has not been provided for the three months ended 31 March 2022 and 2021 as the Company's Singapore subsidiary has no assessable profits for both periods.

The Group has no material unprovided deferred taxation for the period (2021: nil).

#### 4. EARNINGS PER SHARE

The calculation of basic earnings per share is based on the unaudited profit attributable to owners of the Company for the three months ended 31 March 2022 of profit of HK\$14,831,000 (2021: HK\$28,485,000) and on the weighted average number of 476,300,000 (2021: 476,300,000) ordinary shares in issue during the period.

Diluted earnings per share for the three months ended 31 March 2022 and 2021 are the same as the basic earnings per share as there were no dilutive potential ordinary shares during the relevant period.

#### MANAGEMENT DISCUSSION AND ANALYSIS

#### **BUSINESS REVIEW**

During the three months ended 31 March 2022, China experienced a new wave of COVID infections and prompted the government to take actions to contain the spread in many cities. Lockdowns and restrictions in various cities have damped the market and the economy. The Group's car sales and after sales services experienced slowdown since the month of March 2022 with significantly lower revenue and profit.

#### FINANCIAL REVIEW

#### Revenue

The unaudited consolidated revenue for the three months ended 31 March 2022 decreased by 14.7% from HK\$716,262,000 for the three months ended 31 March 2021 to HK\$611,226,000 for the three months ended 31 March 2022.

#### 1. Sales of motor vehicles

For the three months ended 31 March 2022, revenue generated from the sales of motor vehicles decreased by 15.2% from HK\$533,216,000 for the three months ended 31 March 2021 to HK\$452,208,000 for the three months ended 31 March 2022 mainly due to China's measures implemented for the control of COVID-19 epidemic during the three months ended 31 March 2022.

# 2. Servicing of motor vehicles and sales of auto parts

Revenue generated from servicing of motor vehicles and sales of auto parts decreased by 12.9% from HK\$172,781,000 for the three months ended 31 March 2021 to HK\$150,426,000 for the three months ended 31 March 2022. mainly due to the above-mentioned reason.

# 3. Technical fee income

The Group received technical fee income from Xiamen Zhong Bao Automobiles Co., Ltd.\* ("Xiamen Zhong Bao") for providing management consulting and technical assistance in relation to the PRC locally assembled BMW motor vehicles sold by Xiamen Zhong Bao.

Technical fee income for the three months ended 31 March 2022 was approximately HK\$2,551,000, decreased by 10.9% as compared to HK\$2,863,000 for the corresponding period in 2021 since there was a decrease in number of locally assembled BMW sold by Xiamen Zhong Bao during the three months ended 31 March 2022 due to COVID-19 related measures in the PRC during the first quarter of 2022.

#### 4. Car rental business

The income from car rental business in Hong Kong for the three months ended 31 March 2022 was HK\$6,041,000, representing a decrease of 18.4% compared to the corresponding period in 2021 which was mainly due to decrease in long-term customers amidst general business uncertainties resulting from the COVID-19 epidemic.

# **Gross Operating Profit and Gross Operating Margin**

Gross operating profit is calculated based on revenue for the period minus changes in inventories and auto parts and accessories, and motor vehicles purchased during the period. Gross operating margin is calculated based on the gross operating profit for the period divided by revenue for the period multiplied by 100%.

The gross operating profit for the three months ended 31 March 2022 decreased by 14.4% to HK\$85,809,000, as compared to HK\$100,197,000 for the three months ended 31 March 2021. This is in line with the decrease in revenue during the period.

The gross operating margin for the three months ended 31 March 2022 and 31 March 2021 remained stable at 14.0%.

#### Other Income

Other income increased by 15.8% from HK\$11,605,000 for the three months ended 31 March 2021 to HK\$13,436,000 for the three months ended 31 March 2022 mainly due to (i) increase in consultant service income and (ii) increase in gain on disposal of property, plant and equipment.

# **Employee Benefit Expenses**

The Group recorded employee benefit expenses of HK\$37,547,000 for the three months ended 31 March 2022, representing a 13.7% increase as compared to HK\$33,018,000 in the corresponding period in 2021. The increase was mainly due to (i) increase in average number of staff during the period and (ii) appreciation of RMB during the period.

# Depreciation and amortisation

Depreciation and amortisation expenses remained stable at HK\$15,219,000 and HK\$15,470,000 for the three months ended 31 March 2022 and 31 March 2021 respectively.

#### **Foreign Exchange Exposure**

During the three months ended 31 March 2022, the group recorded exchange loss of HK\$472,000 (2021: HK\$687,000), which was mainly resulted from the translation of receivables or payables denominated in foreign currencies other than the functional currencies of the Group.

# **Other Expenses**

For the three months ended 31 March 2022, other expenses were HK\$14,672,000, representing an increase of 15.2% compared to HK\$12,735,000 in the corresponding period in 2021. The increase was mainly attributable to increase in advertising expenses by approximately HK\$3.0 million during the three months ended 31 March 2022.

# **Finance Costs**

Finance costs increased slightly from HK\$8,428,000 for the three months ended 31 March 2021 to HK\$8,712,000 for the three months ended 31 March 2022.

# Profit attributable to owners of the Company

The profit attributable to owners of the Company for the three months ended 31 March 2022 was HK\$14,831,000, compared to HK\$28,485,000 for the three months ended 31 March 2021. The decrease in profit was mainly due to a decrease in revenue and gross operating profit due to measures implemented for the control of COVID-19 epidemic in the PRC during the three months ended 31 March 2022.

#### INTERIM DIVIDEND

The Board does not recommend the payment of an interim dividend for the three months ended 31 March 2022 (three months ended 31 March 2021: nil).

#### **PROSPECTS**

2022 will continue to be a year of uncertainties due to the COVID-19 epidemic. The Group expects the growth momentum in the automobiles market in the PRC from 2021 will substain, especially in the new energy vehicles sector. the Group will continue to exercise vigilant cost control to improve productivity and provide excellent customer-oriented services and improve customer experience at our automobile dealer shops as well as leverage on long-term good relationships with leading automobile suppliers of premium and ultra-luxury brands. The Group endeavours to overcome any hurdle ahead and realize its value to the shareholders and business partners.

#### AUDIT COMMITTEE

The audit committee of the Company ("Audit Committee") was formed on 5 June 2002 and is currently composed of namely, Mr. Yuen Kin Pheng, Ms. Guan Xin and Mr. Zhou Ming. Mr. Yuen Kin Pheng is the Chairman of the Audit Committee.

The primary duties of the Audit Committee are mainly (a) to review the Group's annual reports, consolidated financial statements, interim reports and quarterly reports; (b) to review and supervise the financial reporting process, risk management and internal control system of the Group; and (c) to liaise with the external auditor at least twice a year and provide advice and comments thereon to the Board.

The unaudited condensed consolidated financial statements for the three months ended 31 March 2022 have been reviewed by the Audit Committee and were approved by the Board on 10 May 2022.
