**As the discussion of the Possible Acquisition is only at its preliminary stage, the Possible Acquisition may or may not proceed. The Possible Acquisition, if materialized, may constitute a notifiable transaction of the Company under the GEM Listing Rules. The Company will make further announcement(s) as and when appropriate and comply with all other applicable requirements under the GEM Listing Rules. As the Possible Acquisition may or may not be**
