POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 8 JUNE 2022

The Board is pleased to announce that all of the resolutions set out in the AGM Notice were duly passed at the AGM held on 8 June 2022 by way of poll.

Reference is made to the notice of annual general meeting (the “**AGM**”) dated 5 May 2022 (the “**AGM Notice**”) and the circular dated 5 May 2022 (the “**Circular**”) of Glory Flame Holdings Limited (the “**Company**”). Unless otherwise defined, capitalized terms used herein shall have the same meanings as defined in the Circular.

RESULTS OF THE AGM

The Board is pleased to announce that, at the AGM held at Suite 821, 8th Floor, Ocean Centre, Harbour City, 5 Canton Road, Tsim Sha Tsui, Kowloon, Hong Kong on 8 June 2022 at 11:00 a.m., all of the resolutions set out in the AGM Notice (the “**Resolutions**”) were duly passed by the shareholders of the Company (the “**Shareholders**”) by way of poll. As more than 50% of the votes were cast in favour of each of the Resolutions, the Resolutions were duly passed as ordinary resolutions of the Company at the AGM.

The Hong Kong branch share registrar and transfer office of the Company, Boardroom Share Registrars (HK) Limited, was appointed as the scrutineer for the poll voting at the AGM.

Mr. Li Kar Fai, Peter attended the AGM in person while Mr. Liu Ying Jie, Ms. Zhou Jin, Mr. Cao Hong Min and Mr. Chan Chi Pan were unable to attend the AGM due to other business commitments.

Notes:

- (1) The total number of shares of the Company in issue as at the date of the AGM was 1,010,605,000 shares of HK\$0.01 each. No Shareholder was required under the GEM Listing Rules to abstain from voting on the Resolutions at the AGM.
- (2) There was no shares of the Company entitling the holders to attend and vote only against the Resolutions at the AGM as set out in Rule 17.47A of the GEM Listing Rules.
- (3) The total number of shares of the Company entitling the holders to attend and to vote for or against the Resolutions at the AGM was 1,010,605,000 shares of the Company.
