Pursuant to the subscription agreement dated 23 December 2020 and the supplemental subscription agreement dated 15 March 2021 for the subscription of the convertible bonds issued by the Company (the "CB"), the CB in the aggregate principal amount of HK\$3,105,556.91 was fully paid and any outstanding principal amount of the CB shall be cancelled on 16 March 2025, being the maturity date of the CB. The conversion price of the CB is HK\$0.01941712 per new share of the Company and shall from time to time be subject to adjustment upon occurrence of certain events. [As 14,650,550 outstanding share options had been lapsed in June 2022, the maximum number of new shares of the Company to be issued pursuant to the subscription agreements of the CB was adjusted to zero and the CB was cancelled.]
