Several executors or administrators of a deceased shareholder in whose names any share stands shall be deemed joint holders thereof.

To be valid, this form of proxy, together with the power of attorney or other authority (if any) under which it is signed or a certified copy of that power of attorney or authority must be deposited with the Hong Kong branch share registrar and transfer office of the Company, Tricor Investor Services Limited at Level 54, Hopewell Centre, 183 Queen's Road East, Hong Kong not less than 48 hours before the time appointed for holding the EGM or any adjournment thereof and in default thereof this form of proxy shall not be treated as valid. No instrument appointing a proxy shall be valid after the expiry of 12 months from the date of its execution.
- 8. A shareholder entitled to attend and vote at the EGM is entitled to appoint a person or persons (who must be individual) as his or her proxy or proxies to attend and vote instead of him or her. A proxy need not be a shareholder of the Company.
- 9. Completion and delivery of this form of proxy will not preclude you from attending and voting in person at the EGM if you so wish. This form of proxy is made in English and Chinese. In case of inconsistency, the English version prevails.
