This announcement is made by CL Group (Holdings) Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Future Ordinance (Chapter 571 of the Law of Hong Kong).

The board of directors (the “**Board**”) of the Company wishes to inform shareholders of the Company and potential investors that based on the preliminary assessment of the consolidated management accounts of the Group and information currently available, the Group expects to record profit attributable to shareholders of approximately HK\$3.9 million for the 3 months ended 30 June 2022 as compared with profit of approximately HK\$12.3 million for the 3 months ended 30 June 2021. The decline in the Group’s profit is mainly attributed to fair value loss on financial assets at fair value through profit or loss of approximately HK\$6.7 million.

The information contained in this announcement is only based on the preliminary assessment of the consolidated management accounts of the Group and information currently available. The Group is still in the process of finalising the first quarterly results for the 3 months ended 30 June 2022 which will be published on 9 August 2022. Shareholders of the Company and potential investors are advised to read the annual results announcement of the Company when it is published.
