### **POSITIVE PROFIT ALERT**

This announcement is made by Sanbase Corporation Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2) of the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors of the Company that based on the preliminary assessment of the unaudited consolidated management accounts of the Group for the three months ended 30 June 2022 (the “**Current Period**”) and the information currently available to the Board, the Group is expected to record a profit attributable to owners of the Company of approximately HK\$ 0.6 million for the Current Period as compared to the loss attributable to owners of the Company of approximately HK\$ 0.6 million for the three months ended 30 June 2021 (the “**Previous Period**”).

The turnaround anticipated was mainly attributable to the government grants in respect of the Employment Support Scheme and the Distance Business Programme provided by the Government of the Hong Kong Special Administrative Region, which amounted to approximately HK\$1.0 million for the Current Period (Previous Period: nil).

The information contained in this announcement is only based on the preliminary assessment of the unaudited consolidated management accounts of the Group and the information currently available, which have not been reviewed by the audit committee of the Company, and is therefore subject to necessary adjustments and amendments. The Group is still in the process of finalising the first quarterly results for the Current Period, which will be published by mid-August 2022. The Shareholders and potential investors of the Company are advised to read the first quarterly results announcement of the Group for the Current Period with care when it is published.
