Remarks:

On 13 May 2022, at the Extraordinary General Meeting, the Existing Domestic Share Class Meeting and the Existing H Share Class Meeting of Jiangsu NandaSoft Technology Company Limited ("Issuer"), the shareholders of the Issuer had approved to proceed with the Capital Reorganisation involving, among others, (i) the Share Consolidation by which every eight (8) Existing H Shares of the Issuer consolidated into one (1) Consolidated H Share with par value of RMB0.8 per Consolidated H Share and every eight (8) Existing Domestic Shares of the Issuer consolidated into one (1) Consolidated Domestic Share with par value of RMB0.8 per Consolidated Domestic Share; and (ii) the Capital Reduction by which reduced the par value of each Consolidated H Share and each Consolidated Domestic Shares from RMB0.8 to RMB0.1. After completion of the Share Consolidation and Capital Reduction, the Capital Reorganisation became effective as a whole on 13 July 2022.
