## HIGHLIGHTS

Turnover for the three months ended 30 June 2022 was approximately HK\$29,349,000 representing an increase of approximately 11% as compared to the Last Corresponding Period.

### NOTES TO THE INCOME STATEMENT

#### 1. BASIS OF PREPARATION

The Group's unaudited quarterly results have been prepared in accordance with Hong Kong Financial Reporting Standards issued by the Hong Kong Institute of Certified Public Accountants, accounting principles generally accepted in Hong Kong and the applicable disclosures required by the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the "**GEM Listing Rules**") and by the Hong Kong Companies Ordinance.

These financial statements have been prepared under the historical cost convention.

#### 2. REVENUE

Revenue, which is also the Group's turnover, presents net of value-added tax, trade discounts and returns.

#### 3. INCOME TAX

The statutory income tax rate of the Company and its subsidiaries operated in Hong Kong was 16.5% for the three months ended 30 June 2022 and 2021, except for one subsidiary of the Group which is a qualifying corporation under the two-tiered Profits Tax rates regime. For this subsidiary the first HK\$2 million of assessable profits are taxed at 8.25%, and the remaining assessable profits are taxed at 16.5%.

The provision for Hong Kong Profits Tax for the three months ended 30 June 2022 was HK0 (2021: approximately HK4,000).

A PRC subsidiary of the Company, Guangzhou Global Link Communications Inc. ("Guangzhou GL"), was qualified as "High and new technology enterprise" and subject to concessionary rate of PRC enterprise income tax (the "PRC EIT") at 15%, which was granted for further three years starting from December 2020. The remaining PRC subsidiaries were qualified as "Small Low-profit Enterprise" and subject to a concessionary PRC EIT rate.

The Company and its subsidiaries incorporated in countries other than the PRC and Hong Kong are not subject to any income tax pursuant to the rules and regulations of their respective countries of incorporation.

There was no significant unprovided deferred taxation for the three months ended 30 June 2022.

#### 4. DIVIDEND

The Board does not recommend an interim dividend for the three months ended 30 June 2022 (2021: Nil).

#### 5. LOSS PER SHARE

#### (a) Basic loss per share

The calculation of basic loss per share is based on the unaudited consolidated loss attributable to equity shareholders of the Company for the three months ended 30 June 2022 of approximately HK\$1,698,000 (2021: approximately HK\$4,117,000) and the weighted average number of approximately 326,380,800 ordinary shares (2021: approximately 326,380,800 ordinary shares) in issue during the period calculated.

#### (b) Diluted loss per share

The basic and diluted loss per share are the same for the three months ended 30 June 2022 and for the three months ended 30 June 2021, as there no diluted potential ordinary shares in issue during the period.

## MANAGEMENT DISCUSSION AND ANALYSIS

#### **Business Review and Outlook**

During the period under review, the combined impact of various factors, including the Russia-Ukraine conflict and China-US tensions and the recurrence of the COVID-19 pandemic (the "**Pandemic**") on a global scale, have resulted in global inflation with a substantial increase in the uncertainty from major economies. The East China region, the economic hub of China, was affected by the new round of COVID-19 virus variants. The business operations of enterprises have been extremely hit and the supply chain of related industries has experienced difficulties which had never encountered during the past years. Many companies suffered a decline in business performance and normal operations were also under challenge.

During the period, Guangzhou Global Link Communications Inc. ("Guangzhou Global Link"), a subsidiary of the Group, was mainly engaged in the delivery of the signed supply contracts. They mainly included some renovation projects like Rail Transit Line 2 in Huangpu District of Guangzhou, Harbin Line 3 and Shenzhen Metro Line 3, etc. Meanwhile, it also provided various spare parts and accessories to Guangzhou Metro, Shenzhen Metro, Hangzhou Metro, Zhuzhou Branch of CRRC and Guangdong Branch of CRRC. For projects that are implementing delivery work, the engineering service team of Guangzhou Global Link continued to carry out new line implementation operation guarantee work in many central cities in China and several overseas countries. Due to the recurrence of the Pandemic in China, we were required to comply with the relevant epidemic prevention requirements, which has caused travel restrictions and has seriously affected the efficiency of market expansion and other work. As a result of traffic restrictions and work restrictions in certain regions, our operating cash flows have been constrained due to delays in the collection of receivables.

Under the impact of many uncertain factors, there were also a number of uncertainties in the industry supply chain, especially the price of some imported ICs had increased significantly, and the price of some production materials had also increased due to the influence of the rise in international energy prices, which have caused the increase in the production cost of enterprises and directly affected their operating efficiency. Faced with the current objective situation, Guangzhou Global Link focused on its operation stability, rationalized its organizational structure and human resources, controlled its operating costs and carried out market activities and technology research and development in line with the local market conditions on the premise of completing production, delivery and operation security as scheduled. During the period under review, although the business expansion of the customer relationship management ("**CRM**") of the Group was affected by the new round of the Pandemic and the strict control of the local government on operating sites and the turnover of employees, our business maintained a stable development with the efforts of our staff. The Group continued to provide customers in Guangdong Province, Hong Kong and Macau in China (the "**Greater Bay Area**") with CRM services while identifying potential customers for the development of CRM business. Based on the current telecommunications, catering customer bases and market questionnaire surveys, the Group proactively negotiated with potential customers in financial, broadcasting communications, banking and other sectors to vigorously expand customers and revenue sources. It was hoped that as the Pandemic gradually fade out, business and operations in all sectors would recover as normal and the Group would also be able to put its development on to the right track and expand its CRM business as the regional economy rebounds.

### **FINANCIAL REVIEW**

For the three months ended 30 June 2022, the turnover of the Group was approximately HK\$29,349,000, representing an increase of approximately 11% as compared with approximately HK\$26,405,000 for the Last Corresponding Period. Loss attributable to equity shareholders of the Company for the three months ended 30 June 2022 amounted to approximately HK\$1,698,000, representing a decrease of approximately 59% as compared with approximately HK\$4,117,000 for the Last Corresponding Period.

During the period under review, the CRM business of the Group was affected by the new round of Pandemic and its growth slowed down. However, there is still much room for the development of the CRM business in Guangdong Province, Hong Kong and Macau in China, especially the increase in the meal ordering business of CRM due to the increasing demand for it. The turnover from CRM business for the three months ended 30 June 2022 was approximately HK\$17,000,000, representing an increase of approximately 17% as compared to approximately HK\$14,510,000 for the Last Corresponding Period. Guangzhou Global Link was mainly engaged in the delivery of the signed supply contracts to the train manufacturers under CRRC. During the period, it has delivered some renovation projects like Rail Transit Line 2 in Huangpu District of Guangzhou, Harbin Line 3 and Shenzhen Metro Line 3, etc. Meanwhile, it also supplied various spare parts and accessories to Guangzhou Metro, Shenzhen Metro, Hangzhou Metro, Zhuzhou Branch of CRRC and Guangdong Branch of CRRC. The turnover from rail transportation for the three months ended 30 June 2022 was approximately HK\$11,895,000 for the Last Corresponding Period.

Selling expenses for the period amounted to approximately HK\$2,473,000, representing an increase of approximately 65% as compared to approximately HK\$1,499,000 for the Last Corresponding Period.

Administrative expenses amounted to approximately HK\$2,107,000, representing a decrease of approximately 19% as compared to approximately HK\$2,600,000 for the Last Corresponding Period.

Other operating expenses amounted to approximately HK\$55,000, representing a decrease of approximately 21% as compared to approximately HK\$70,000 for the Last Corresponding Period.

Other income amounted to approximately HK\$1,909,000, representing an increase of approximately 14% as compared to approximately HK\$1,670,000 for the Last Corresponding Period. This was mainly due to the increase in foreign exchange income, reversal of provision for accounts receivable, interest income and other income during the period as compared with the Last Corresponding Period.

## USE OF PROCEEDS FROM THE SUBSCRIPTION COMPLETED ON 21 APRIL 2016

Honor Crest Holdings Limited, a direct wholly owned subsidiary of Goldstream Investment Limited (formerly known as International Elite Ltd.), a company listed on the Main Board of the Stock Exchange (stock code: 1328) completed the subscription of 1,000,000,000 shares of the Company on 21 April 2016. For details please refer to the announcements of the Company dated 29 February 2016 and 21 April 2016 and the circular published by the Company dated 30 March 2016 (the "**2016 Circular**").

The gross proceeds from the subscription were HK\$80.0 million. The net proceeds of the subscription, after deduction of expenses and professional fees, amounted to approximately HK\$79.0 million (the **"2016 Subscription Proceeds**"), amongst which approximately HK\$66.5 million had been utilised as at 30 June 2022. The breakdown of the Company's actual use of the Subscription Proceeds as at 30 June 2022 is as follows:

## USE OF PROCEEDS FROM THE SUBSCRIPTION COMPLETED ON 13 NOVEMBER 2019

Mr. Li Kin Shing, the chairman of the Board and the controlling shareholder of the Company, completed the subscription of 1,175,000,000 new shares of the Company on 13 November 2019, details of which are included in the announcements of the Company dated 28 August 2019, 24 October 2019 and 13 November 2019 and the circular of the Company dated 9 October 2019 (the "2019 Circular"). The net proceeds from the said subscription were approximately HK\$40 million (the "2019 Subscription Proceeds"). The audit committee further reviewed the Company's internal control and risk management system and is of the view that the internal control and risk management system in place are effective and adequate for the Group as a whole.
