PROPOSED AMENDMENTS TO THE MEMORANDUM AND ARTICLES OF ASSOCIATION

This announcement is made pursuant to Rule 17.50(1) of the Rules Governing the Listing of Securities on GEM (the “**GEM Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”), made in relation to the proposed amendments to the Company’s amended and restated Memorandum and Articles of Association (the “**M&A**”).

The board (the “**Board**”) of directors (the “**Directors**”) of Tonking New Energy Group Holdings Limited (the “**Company**”) proposed to amend the M&A. The GEM Listing Rules have been amended with effect from 1 January 2022 which requires, among other things, listed issuers to adopt a set of “Core Standards” for its shareholder protections.

Accordingly, the Board proposes to amend the M&A to (i) ensure that the M&A complies with the latest requirements of the GEM Listing Rules and applicable laws of the Cayman Islands; and (ii) make certain minor management amendments to the M&A.

The amendments to the M&A are subject to approval by shareholders of the Company (the “**Shareholders**”) at the forthcoming annual general meeting of the Company (the “**AGM**”) to be held on Friday, 23 September 2022, by way of a special resolution.

A special resolution in relation to the amendments to the M&A will be proposed at the AGM for Shareholders’ consideration and approval. A circular containing, among other things, details of the proposed amendments to the M&A, the proposed adoption of the new M&A, and the notice of the AGM will be despatched to the Shareholders as soon as practicable.
