Pursuant to the terms of the Share Option Scheme, the exercise price and the number of the outstanding share options granted under the Share Option Scheme have been adjusted to a total of 10,000,000 Shares at an exercise price of HK\$0.56 per share with effect from 12 April 2022, being the effective date of the Share Consolidation.
