POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON 31 AUGUST 2022

All the Proposed Resolutions as set out in the Notice of AGM were duly passed by the Shareholders by way of poll at the 2022 AGM.

Reference is made to the circular (the “**Circular**”) and notice of the annual general meeting (the “**Notice of AGM**”) of Seamless Green China (Holdings) Limited (the “**Company**”) both dated 2 August 2022. Unless otherwise defined, capitalised terms used herein shall have the same meanings as those defined in the Circular.

The Board is pleased to announce that all the proposed ordinary resolutions (the “**Proposed Resolutions**”) as set out in the Notice of AGM were duly passed by the Shareholders by way of poll at the 2022 AGM.

As at the date of the 2022 AGM, there were 188,702,070 issued Shares entitling the Shareholders to attend and vote for or against the Proposed Resolutions at the 2022 AGM. There were no Shares entitling the Shareholders to attend and abstain from voting in favour of the Proposed Resolutions at the 2022 AGM as set out in Rule 17.47A of the GEM Listing Rules.

None of the Shareholders were required under the GEM Listing Rules to abstain from voting on the Proposed Resolutions at the 2022 AGM. None of the Shareholders have stated in the Circular their intention to vote against or to abstain from voting on any of the Proposed Resolutions.

Link Market Services (Hong Kong) Pty Limited, the Hong Kong branch share registrar of the Company, was appointed and acted as the scrutineer for the vote-taking at the 2022 AGM.
