#### UPDATE ON PROGRESS OF RESUMPTION

As disclosed in the announcement of the Company dated 13 June 2022, the Company has formed the Investigation Committee. On 5 August 2022, the Company engaged SWRS Risk Services Limited as the independent investigator (the "Independent Investigator") to conduct an independent investigation into the Alleged Guarantees and prepare an independent investigation report on the findings of the independent investigation and provide recommendations to the Investigation Committee in respect of the Alleged Guarantees. As of the date of this announcement, the independent investigation is still ongoing. The Company will continue to provide all necessary assistance to the Independent Investigator to expedite the independent investigation. On 12 August 2022, the Company received a letter from the Stock Exchange, pursuant to which, the resumption guidance was modified, requiring the Company, inter alia, to conduct an appropriate independent forensic investigation into the Alleged Guarantees and the Alleged Disposal, announce the findings and take appropriate remedial actions.

In view of the aforesaid modified resumption guidance, the Independent Investigator will commence forensic investigation work on the Alleged Disposal. The Company will announce the relevant findings of the independent investigation as soon as practicable in accordance with the requirements under the Listing Rules, and will, if necessary, take appropriate remedial actions.

As of the date of this announcement, the Company is conducting an internal audit and evaluation of the Company's internal control system and is also in the course of engaging an internal control consultant to carry out a thorough review of the Group's internal control system.

Upon completion of the Investigation, the Company will continue to work closely with its auditors to finalize and publish the 2021 Annual Results, the 2021 Annual Report, the First Quarterly Results Annual Results An
