The board (the "**Board**") of the directors (the "**Directors**") of the Company wishes to inform the shareholders of the Company and potential investors that, based on the information currently available to the management of the Group and the preliminary review of the unaudited consolidated management accounts of the Group, it is expected that a net profit between HK\$9.0 million and HK\$11.0 million attributable to the owners of the Company for the year ended 30 June 2022 (the "2022 Annual Results") will be recorded as compared to the net profit of approximately HK\$19.2 million attributable to the owners of the Company for the year ended 30 June 2021. The decline in the consolidated financial performance of the 2022 Annual Results is primarily due to the net effect of the following factors:

- decrease in receipt of one-off subsidies by approximately HK\$22.9 million from the Employment Support Scheme under the Antiepidemic Fund granted by the government of the Hong Kong Special Administrative Region;
- (ii) decrease in the impairment allowance for the loan and interest receivables by approximately HK\$7.6 million under the Group's money lending business;
- (iii) increase in the revaluation gain by approximately HK\$1.8 million on the Group's selfowned properties in Hong Kong;
- (iv) recognition of the impairment loss of approximately HK\$2.9 million on the goodwill allocated to the cash generating unit of the environmental and cleaning businesses in the People's Republic of China; and

(v) improvement in the operating profit contributed from the Group's environmental and cleaning businesses in Hong Kong by approximately HK\$5.0 million.

The Company is still in the course of finalising the 2022 Annual Results. The information contained in this announcement is based on the Board's preliminary assessment after reviewing the unaudited consolidated management accounts of the Group for the year ended 30 June 2022 and the information currently available to the management of the Group. Therefore, the actual 2022 Annual Results may differ from the information contained in this announcement.
