ADDITIONAL RESUMPTION GUIDANCE AND CONTINUED SUSPENSION OF TRADING

This announcement is made by the board of directors (the “**Board**”) of China E-Information Technology Group Limited (the “**Company**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities (the “**GEM Listing Rules**”) on GEM of the Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined in the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcements of the Company dated 19 December 2021, 29 December 2021, 7 January 2022, 11 May 2022, 6 July 2022 and 22 August 2022 (collectively, the “**Announcements**”) in relation to, among others, (i) the decision of the Stock Exchange on Rule 17.26 of the GEM Listing Rules; (ii) the update on listing status; (iii) the Resumption Guidance; (iv) the Additional Resumption Guidance; and (v) quarterly update on progress of resumption. Unless otherwise stated, the capitalised terms used herein shall have the same meaning as defined in the Announcements.

ADDITIONAL RESUMPTION GUIDANCE

As disclosed in the announcement of the Company dated 7 January 2022, 11 May 2022 and 22 August 2022, the Company received a letter from the Stock Exchange setting out the Resumption Guidance and the Additional Resumption Guidance respectively that the Company shall:

- (i) demonstrate its compliance with Rule 17.26 of the GEM Listing Rules;
- (ii) inform the market of all material information for the Shareholders and investors to appraise the Company's position;
- (iii) publish all outstanding financial results and address any audit modification(s);
- (vi) re-comply with the GEM Listing Rules 5.05, 5.05A, 5.28, 5.34 and 5.36A; and
- (v) conduct an independent internal control review and demonstrate that the issuer has in place adequate internal controls and procedures to comply with the GEM Listing Rules.

On 31 August 2022, the Company received a letter from the Stock Exchange setting out the additional Resumption Guidance that the Company shall:

- (i) re-comply with GEM Rules 5.14 and 5.24.

The Stock Exchange further indicated that it may modify the resumption guidance and/or give further guidance as and when appropriate.

The Company will continue to take appropriate steps to fulfill the Resumption Guidance and to review its existing businesses and its financial position from time to time. The Company will use its best endeavours to seek resumption of trading in the Shares as soon as practicable.

CONTINUED SUSPENSION OF TRADING

At the request of the Company, trading in the shares of the Company on the Stock Exchange has been suspended with effect from 9:00 a.m. on 30 December 2021 and will remain suspended until further notice.

The Company will publish further announcement(s) as and when appropriate to provide its Shareholders and potential investors with any information updates.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
