On 22 November 2018, pursuant to the conditional subscription agreement (the "Subscription Agreement") dated 28 August 2018 (as supplemented and amended by a supplemental agreement dated 10 October 2018) entered into between the Company and Maximizer International Limited (the "Subscriber"), 123,529,400 convertible preference shares (the "Convertible Preference Shares") were issued by the Company to the Subscriber. Based on the initial conversion price of HK\$0.17 per new ordinary share upon the exercise of the conversion rights attaching to each the Convertible Preference Share, a maximum number of 123,529,400 new ordinary shares shall be allotted and issued upon full exercise of the conversion rights attaching to the Convertible Preference Shares.

On 30 August 2022, the Subscriber sold to iRregular Consulting Limited, and iRregular Consulting Limited purchased from the Subscriber, all Convertible Preference Shares issued by the Company at the consideration of HK\$0.049 per Convertible Preference Share.
