This announcement is made by the Company pursuant to Rule 17.10(2) of the GEM Listing Rules and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571).

The Board wishes to inform the shareholders of the Company and potential investors that the Group is expected to record a net loss of approximately RMB35,263,000 for the nine months ended 30 September 2022 as compared to a net loss of approximately RMB20,921,000 for the nine months ended 30 September 2021, representing an approximately 69% increase.

Shareholders of the Company and potential investors should exercise caution when dealing in the shares of the Company.

This announcement is made by the board (the “**Board**”) of directors (the “**Directors**”) of the Sing Lee Software (Group) Limited (the “**Company**”) and its subsidiaries (the “**Group**”) pursuant to Rule 17.10(2) of the Rules Governing the Listing of Securities on the GEM Listing Rules of the Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571).

After preliminary review by the Company's management based on the management accounts of the Company, the Directors of the Company wishes to inform the shareholders of the Company and the potential investors that the Group is expected to record a net loss of approximately RMB35,263,000 for the nine months ended 30 September 2022 as compared to a net loss of approximately RMB20,921,000 for the nine months ended 30 September 2021, representing an approximately 69% increase. The significant increase in loss was mainly attributable to (i) decreased in revenue of approximately RMB9,742,000 and (ii) the gain on disposal of a subsidiary of approximately RMB2,461,000 during the nine months ended 30 September 2021 which was absent during the nine months ended 30 September 2022.

Despite the unaudited results of the Group for the nine months ended 30 September 2022 is expected to record a loss, the Board considers that the Group's overall financial positions are healthy and the Board remains positive on the prospects of the Group. The Board would like to emphasize that the Group's financial positions remain stable and has sufficient cash resources to meet its present and future cash flow requirements. The Board will constantly keep reviewing the Group's strategies and operations with a view to improve its business performance and Company's shareholders' return.

The information as contained in this announcement is only based on the preliminary assessment by the Company's management according to the management accounts of the Company. Shareholders of the Company and the potential investors should read the Company's results announcement for the nine months ended 30 September 2022 carefully, which is expected to be published on 10 November 2022.
