POSITIVE PROFIT ALERT

This announcement is made by Michong Metaverse (China) Holdings Group Limited (*formerly known as Nomad Technologies Holdings Limited*) (the “**Company**”, together with its subsidiaries, collectively the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders of the Company and potential investors that based on a preliminary assessment by the Board with reference to the unaudited management accounts of the Group for the three months ended 30 September 2022 and the information currently available to the Board, the Group expects to record a net profit of approximately HK\$9,995,000 for the three months ended 30 September 2022 as compared to the net loss of approximately HK\$1,847,000 for the three months ended 30 September 2021.

The Board considers the expected net profit for the three months ended 30 September 2022 is mainly attributable to (i) an increase in the revenue from approximately HK\$15,446,000 for the three months ended 30 September 2021 to approximately HK\$33,825,000 for the three months ended 30 September 2022 mainly due to the subscription fee of approximately HK\$16,170,000 arisen in the electronic commerce services in the PRC (*Three months ended 30 September 2021: Nil*) and (ii) an improvement in gross profit margin from approximately 29.0% for the three months ended 30 September 2021 to approximately 62.2% for the three months ended 30 September 2022.

The Company is still in the process of finalising the quarterly results of the Group for three months ended 30 September 2022. The information contained in this announcement is only based on a preliminary assessment by the Board with reference to the unaudited management accounts of the Group for the three months ended 30 September 2022 and the information currently available to the

Company which may be subject to change and is not based on any figures or information that have been audited or reviewed by the Company's Auditors nor reviewed by the audit committee of the Company. The actual financial results of the Group may be different from what is disclosed in this announcement. Details of the Group's financial results will be disclosed as and when the quarterly results of the Group for the three months ended 30 September 2022 is announced in accordance with the requirements of the GEM Listing Rules.
