PROFIT WARNING

This announcement is made by China Saftower International Holding Group Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on a preliminary review of the unaudited consolidated management accounts of the Group for the nine months ended 30 September 2022 (“**9M2022**”) and the information currently available to the Board, the Group is expected to record a net loss of approximately RMB27.7 million for 9M2022, representing an increase in net loss of approximately RMB20.8 million as compared to a net loss of approximately RMB6.9 million for the nine months ended 30 September 2021. The increase in net loss for 9M2022 was mainly attributable to the substantial increase in the cost of raw materials, which caused the Group to record a gross loss of approximately RMB12.9 million, and increase of finance cost of approximately RMB3.9 million during 9M2022.

As the Company is still in the process of finalising its unaudited consolidated financial results for 9M2022, the information contained in this announcement is only based on the information currently available and the preliminary assessment by the Board with reference to the unaudited consolidated management accounts of the Group for 9M2022, which has not been reviewed or audited by the Company's auditor or reviewed by the audit committee of the Company, and is subject to further adjustments. The actual results for 9M2022 may be different from the information disclosed in this announcement. Shareholders and potential investors are advised to read carefully the third quarterly results announcement of the Group for 9M2022, which is expected to be published in mid-November 2022 in accordance with the GEM Listing Rules.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.
