Shareholders' Communication Policy

2. General Policy

- 2.1 The Board shall maintain an on-going dialogue with Shareholders and the investment community, and will regularly review this Policy to ensure its effectiveness.
- 2.2 Information shall be communicated to Shareholders and the investment community mainly through the Company's financial reports (quarterly, interim and annual reports), general meeting(s), as well as through the Company's website (www.sinofortune.hk).
- 2.3 Effective and timely dissemination of information to Shareholders and the investment community shall be ensured at all times. Any question regarding this Policy shall be directed to the Company Secretary of the Company (see paragraph 5.1 below for the contact details of the Company).

3. Communication Strategies

Shareholders' Enquiries

- 3.1 Shareholders should direct their questions about their shareholdings to the Company's Registrar (see paragraph 5.2 below for the contact details of the Company's Registrar).
- 3.2 Shareholders and the investment community may at any time make a request for the Company's information to the extent such information is publicly available.
- 3.3 Shareholders and the investment community shall be provided with email addresses and enquiry lines of the Company in order to enable them to make any query in respect of the Company.

Corporate Communications *

3.4 Corporate communications will be provided to Shareholders in plain language and in both English and Chinese versions to facilitate Shareholders' understanding. Shareholders are encouraged to access the Company's corporate communications electronically via the Company website (www.sinofortune.hk) to help protect the environment.

- 3.5 A dedicated "Communication" section is available on the Company's website (www.sinofortune.hk). Information on the Company's website is updated on a regular basis.
- 3.6 Information released by the Company to The Stock Exchange of Hong Kong Limited is also posted on the Company's website (www.sinofortune.hk) immediately thereafter. Such information includes financial reports, results announcements, circulars and notices of general meetings.

Shareholders' Meetings

- 3.7 Shareholders are encouraged to participate in general meetings or to appoint proxies to attend and vote at meetings for and on their behalf if they are unable to attend the meetings.
- 3.8 Appropriate arrangements for the annual general meetings shall be in place to encourage Shareholders' participation.

- 3.9 The process of the Company's general meeting will be monitored and reviewed on a regular basis, and, if necessary, changes will be made to ensure that Shareholders' needs are best served.
- 3.10 Board members and the external auditor will attend annual general meetings to answer Shareholders' questions.

4.1 The Company recognises the importance of Shareholders' privacy and will not disclose Shareholders' information without their consent, unless otherwise required by law.
