## **CHANGE OF COMPANY NAME, STOCK SHORT NAME AND WEBSITE**

References are made to the announcements of New Amante Group Limited (formerly known as “BCI Group Holdings Limited”) (“**Company**”, together with its subsidiaries collectively referred to as “**Group**”) dated 12 October 2022 and 14 November 2022 and the annual general meeting circular of the Company dated 20 October 2022 (“**Circular**”) in relation to, *inter alia*, the Change of Company Name.

Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

### **CHANGE OF COMPANY NAME**

The Board is pleased to announce that the proposed change of English name of the Company from “BCI Group Holdings Limited” to “New Amante Group Limited” and the dual foreign name in Chinese of the Company from “高門集團有限公司” to “新愛德集團有限公司” have become effective from 14 November 2022 pursuant to the Certificate of Incorporation on Change of Name issued by the Registrar of Companies in the Cayman Islands. The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 13 December 2022 confirming the registration of the new name of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

### **CHANGE OF STOCK SHORT NAME**

The stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “BCI GROUP” to “NEW AMANTE” in English and from “高門集團” to “新愛德集團” in Chinese with effect from 9:00 a.m. on 21 December 2022.

The stock code of the Company on the Stock Exchange remains unchanged as “8412”.

The website of the Company has been changed to [www.new-amante.com](http://www.new-amante.com) to reflect the Change of Company Name.

## **EFFECTS OF CHANGE OF COMPANY NAME AND STOCK SHORT NAME**

The Change of Company Name and change of stock short name of the Company will not affect any rights of the existing Shareholders. All existing share certificates of the Company in issue bearing the former name of the Company shall continue to be evidence of title to such Shares and valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for the exchange of the existing share certificates for new certificates bearing the new names of the Company. Any issue of share certificates thereafter will be in the new name of the Company.
