Remarks:
Pursuant to the fifth amendment agreement approved by the Shareholders at the extraordinary general meeting of the Company held on 22 March 2021, the Company amended some principal erms of the convertible bonds (the "CBs"), including to extend the maturity date of the CBs for one year from 17 January 2021 to 17 January 2022. Its conversion price shall be amended from HK 50.34 to HK\$0.221 per conversion share (subject to adjustment), which can be converted into the maximum number of 405,542,986 shares of the Company. The interest rate of the CBs shall be increased to 10% per annum and paid annually (the "Fifth Amendments"). Save for the Fifth Amendments, all other terms and conditions of the CBs shall remain unchanged. The bondholder has not exercised any of its conversion right for the Company's shares and has no conversion right of the CBs which have been matured since 17 January 2022. Therefore, the CBs have not been convertible since then.
As at the date of this monthly return, the Company has not received any notice of event of default from the bondholder demanding immediate repayment. The Company is still in the progress of negotiating with the bondholder for the renewal of or further extension on the CBs and will disclose further developments on the above matters by way of further announcement(s) in a timely nanner in accordance with regulatory requirements.
