On 16 November 2020, 3-year convertible bonds in the aggregate principal amount of HK\$97,800,000 with 8% interest per annum (the "Convertible Bonds") were issued by the Company pursuant to the subscription agreement dated 2 November 2020. Upon exercise of the conversion rights attached to the Convertible Bonds in full, the Convertible Bonds are convertible into 362,222,222 new shares of the Company at an initial conversion price of HK\$0.27 per conversion share (subject to adjustment). Details are disclosed in the announcements of the Company dated 2 November 2020 and 16 November 2020.
