Remarks:

On 11 May 2020, convertible bonds in the aggregate principal amount of US\$10,000,000 (the "2020 Convertible Bonds") were issued by the Company to Guoyuan Securities Investment (Hong Kong) Limited (the "Subscriber") pursuant to the subscription agreement dated 24 April 2020 entered into between the Company and the Subscriber. On 24 June 2022, the maturity date of the 2020 Convertible Bonds has been extended for two years from 10 May 2022 to 10 May 2024.

On 20 December 2022, the Company entered into a subscription agreement (the "Subscription Agreement") with the Subscriber, pursuant to which the Subscriber has conditionally agreed to subscribe for the convertible bonds in aggregate principal amount of US\$10,000,000 (the "Convertible Bonds"). Based on the initial conversion price of HK\$1.45, a maximum number of 54,137,931 conversion shares will be allotted and issued upon exercise of the conversion rights attached to the Convertible Bonds in full. Completion of the above transaction is subject to, among others, the fulfilment of the conditions precedent set out in the Subscription Agreement. All the conditions precedent of the Subscription Agreement have been fulfilled and the completion of the subscription took place on 30 December 2022. Accordingly, the Convertible Bonds in the principal amount of US\$10,000,000 have been issued by the Company to the Subscriber on 30 December 2022. The 2020 Convertible Bond was surrendered and cancelled. For details, please refer to the Company's announcements dated 20 December 2022 and 30 December 2022.
