### **DISCLOSEABLE TRANSACTION IN RELATION TO THE FACTORING AGREEMENT**

#### **FACTORING AGREEMENT WITH CUSTOMER D**

On 21 February 2023 (after trading hours), Metropolis Leasing, an indirect wholly-owned subsidiary of the Company, entered into the Factoring Agreement with Customer D, pursuant to which, Metropolis Leasing has agreed to provide accounts receivable factoring facility to Customer D with the Factoring Principal Amount of up to RMB4,750,000 (equivalent to approximately HK\$5,337,618) for the Factoring Period.

#### **IMPLICATIONS UNDER THE GEM LISTING RULES**

As one or more of the applicable percentage ratios for the transaction contemplated under the Factoring Agreement calculated in accordance with the GEM Listing Rules are more than 5% but all of them are less than 25%, the transaction contemplated under the Factoring Agreement constituted a discloseable transaction on the part of the Company under Chapter 19 of the GEM Listing Rules and is therefore subject to the reporting and announcement requirements under Chapter 19 of the GEM Listing Rules.

#### **INTRODUCTION**

On 21 February 2023 (after trading hours), Metropolis Leasing, an indirect wholly-owned subsidiary of the Company, entered into the Factoring Agreement with Customer D, pursuant to which, Metropolis Leasing has agreed to provide accounts receivable factoring facility to Customer D with the Factoring Principal Amount of up to RMB4,750,000 (equivalent to approximately HK\$5,337,618) for the Factoring Period.

## THE FACTORING AGREEMENT WITH CUSTOMER D

The principal terms and conditions of the Factoring Agreement are summarised as follow:

<b>Date:</b>	21 February 2023 (after trading hours)
<b>Parties:</b>	Metropolis Leasing (as factoring provider) Customer D (as seller)
<b>Type of factoring:</b>	One-off factoring facility with recourse
<b>Factoring Period:</b>	From 21 February 2023 to 21 August 2023
<b>Transfer of accounts receivable:</b>	Subject to the terms and conditions of the Factoring Agreement, the accounts receivable due from the debtor(s) of Customer D as referred to in the underlying transaction documents entered into between the parties pursuant to the Factoring Agreement shall be transferred to Metropolis Leasing.
<b>Factoring Principal Amount:</b>	The Factoring Principal Amount of up to approximately RMB4,750,000 (equivalent to approximately HK\$5,337,618), which is determined by Metropolis Leasing and Customer D through arm's length negotiation with reference to the accounts receivable to be transferred to Metropolis Leasing.
<b>Factor ratio:</b>	The factor ratio, which represents the ratio of the Factoring Principal Amount to the accounts receivable being transferred, shall not exceed 95%.
<b>Interest rate:</b>	12% per annum
<b>Repayment of Factoring Principal Amount and interest:</b>	The amount of Factoring Principal Amount and interest shall be payable monthly in accordance with the payment schedule as stipulated in the Factoring Agreement. The amount of factoring interest is calculated on a monthly basis based on the outstanding Factoring Principal Amount in accordance to the repayment schedule as stipulated in the Factoring Agreement. It is expected that the Factoring Agreement will enable the Group to earn a maximum aggregate income of approximately RMB285,000 (equivalent to approximately HK\$320,257).

**Repurchase:**

Metropolis Leasing shall be entitled to demand Customer D to immediately and unconditionally repurchase the outstanding amount of the accounts receivable being transferred to Metropolis Leasing, by repaying the outstanding Factoring Principal Amount of the Factoring Agreement and interest in the event that any of the triggering events occurs:

- (i) the debtor of Customer D (the “**Debtor**”) has failed to repay the accounts receivable within 90 days after the due date after Customer D, or Metropolis Leasing has demanded the repayment of such accounts receivable;
- (ii) prior to the due date of the accounts receivable, the Debtor or Customer D notifies Metropolis Leasing in writing that there are commercial disputes concerning the relevant contract between them, or Metropolis Leasing is made aware of such disputes in some other ways;
- (iii) Customer D fails to use the consideration for the transfer of accounts receivable in accordance with the use as agreed in the Factoring Agreement, or Customer D changes the designated account for the receipt of accounts receivable without the consent of Metropolis Leasing;
- (iv) commercial fraud is involved in the contract.

**Default:**

In case of any of the following events (including but not limited to the following), Metropolis Leasing has the right to unilaterally terminate the Factoring Agreement, and request Customer D to immediately return such consideration for the transfer of all accounts receivable that Metropolis Leasing has paid upon the receipt of the notice of termination of the Factoring Agreement, and pay the liquidated damages representing 5% of the consideration for the transfer of all the accounts receivable. Customer D further undertakes that it will pay an amount of 200% of such payment as compensation to Metropolis Leasing on a voluntary basis:

- a. Without the written consent of Metropolis Leasing, Customer D misappropriates the consideration for the transfer of accounts receivable received from Metropolis Leasing for other use not agreed by both parties or to a counterparty who has not been agreed by both parties;

- b. Customer D changes the designated account for the receipt of accounts receivable without written consent of Metropolis Leasing, or Customer D fails to pay the accounts receivable to Metropolis Leasing in a timely manner upon receipt of such accounts receivable pursuant to the Factoring Agreement; and
- c. Customer D fabricates underlying transaction and the accounts receivable, or applies for factoring business with Metropolis Leasing by use of encumbered accounts receivable.

In the case of Customer D refuses to repurchase the accounts receivable by the time specified by Metropolis Leasing, or delays payment for the repurchase of accounts receivable, Metropolis Leasing has the right to demand Customer D to pay liquidated damages based on the following:

$$L = D \times E \times F$$

D = the amount of accounts receivable

E = the daily default interest rate of 0.05%

F = the actual number of days of late payment

L = liquidated damages

In the case of Customer D fails to pay the factoring fee as stipulated in the Factoring Agreement, Metropolis Leasing has the right to demand a default penalty from Customer D at 0.05% of the outstanding amount per day from the date when such amount payable by Customer D falls due for payment.

In addition, in the event Metropolis Leasing suffered other losses as a result of Customer D's breach of contract, Metropolis Leasing is also entitled to liquidated damages representing 5% of the Factoring Principal Amount.

## **REASONS FOR AND BENEFITS OF THE TRANSACTION CONTEMPLATED UNDER THE FACTORING AGREEMENT**

The principal business of the Group is the provision of finance lease, finance leasing advisory and factoring services to its customers in the PRC. The Group started to provide factoring services to its customers from 2020 which has enabled the Group to generate additional revenue and cash flow stream to the Group. It is expected that the Factoring Agreement will enable the Group to earn a maximum aggregate income of approximately RMB285,000 (equivalent to approximately HK\$320,257).

The terms of the Factoring Agreement were agreed between the parties after arm's length negotiations and are on normal commercial terms. The provision of Factoring Principal Amount to Customer D under the Factoring Agreement will mainly be financed by internal resources of the Group.

Given that the Factoring Agreement was entered into in the ordinary and usual course of business of the Group and on normal commercial terms, the Directors are of the view that the terms of the Factoring Agreement are fair and reasonable and are in the interest of the Company and the shareholders of the Company as a whole.

## **INFORMATION ABOUT METROPOLIS LEASING AND THE GROUP**

Metropolis Leasing is an indirect wholly-owned subsidiary of the Company. The Group, including Metropolis Leasing, is primarily engaged in the provision of finance lease, finance leasing advisory and factoring services to its customers in the PRC.

## **INFORMATION ABOUT CUSTOMER D**

Customer D is a company established in the PRC with limited liability which is primarily engaged in financial leasing and leasing business. To the best of the Directors' knowledge, information and belief and having made all reasonable enquiries, Customer D is owned as to 75% by Shenzhen Huiqi Bright Light Technology Co.,Ltd.\* (深圳市惠奇亮光電科技有限公司) (“**Shenzhen Huiqi**”) and 25% by Star Holder Tech Co., Limited (星皓達科技發展有限公司) (“**Star Holder**”).

Shenzhen Huiqi is a company established in the PRC with limited liability and is owned by Guangdong Yiboguan Automobile Service Co., Ltd.\* (廣東億博冠汽車服務有限公司) (“**Yiboguan**”) and Guo Chengshuai\* (郭成帥) as to 51% and 49% respectively. Guo Chengshuai is a PRC citizen. Yiboguan is a company established in the PRC with limited liability and is wholly-owned by Shenzhen Xintai Automobile Trading Co., Ltd.\* (深圳市鑫泰汽車貿易有限公司), which in turn is owned by Tang Ling\* (唐玲) and Tang Qin\* (唐欽) as to 99% and 1% respectively, each being a PRC citizen.

Star Holder is a company incorporated in Hong Kong with limited liability and is owned by Zhen Caixia (甄彩霞), Ma Liqin (馬麗琴) and Yiboguan as to 33%, 33% and 34% respectively, each of Zhen Caixia (甄彩霞) and Ma Liqin (馬麗琴) being a PRC citizen.

To the best of the Directors' knowledge, information and belief and having made all reasonable enquiries, each of Customer D and its ultimate beneficial owners is an Independent Third Party and, save as disclosed in this announcement, they have no past or present relationships (formal or informal, business or otherwise, implied or explicit) with the Company or its connected persons.
