The board of directors of the Company (the "**Board**") wishes to inform the shareholders of the Company and potential investors that based on the information currently available to the Board and the preliminary review of the unaudited consolidated management accounts of the Group for the three months ended 31 January 2023 (the "**Current Period**"), the Group is expected to record a decrease in the profit attributable to owners of the Company for Current Period by approximately 50% to 60% as compared with the profit attributable to owners of the Company for the three months ended 31 January 2022 (the "**Last Period**") (2022: HK\$ 2,347,000).

As far as the Directors are aware of, the profit attributable to owners of the Company recorded for the Current Period was lower than that of Last Period, which was mainly attributable to, among others, approximately 40% to 50% decrease in the revenue of the Group's Environment-friendly products business segment due to the outbreak of Omicron Variant of COVID-19 virus and the corresponding control measures and restrictions in China, which not only affected the Group's Environment-friendly products business segment's sales and delivery activities during the Current Period but also caused the postponement of and delay in some of the customers' engineering, production and procurement activities.

Notwithstanding the impact of the above-mentioned factor, the Board is of the view that the Group operational and financial position of the Group remains sound and stable.

As the Company is still in the process of finalizing the unaudited quarterly results for the Current Period, the information contained in this announcement is only based on the information currently available and the preliminary review on the unaudited consolidated management accounts, which have not been reviewed by the audit committee nor the auditors of the Company. Further details of the Group's financial results and performance will be disclosed in the Group's unaudited quarterly results announcement for the Current Period to be published on 13 March 2023 pursuant to the requirement of the GEM Listing Rules.
