On behalf of the board (the “**Board**”) of directors (the “**Directors**”) of Glory Flame Holdings (the “**Company**”), I am honoured to present this annual report of the consolidated results of the Company and its subsidiaries (collectively, the “**Group**”) for the financial year ended 31 December 2022 (“**FY2022**” or the “**Reporting Period**”).

## PERFORMANCE

The Group posted a revenue of approximately HK\$118.5 million for FY2022, representing an increase by 19.7% as compared to approximately HK\$99.0 million for the year ended 31 December 2021 (“**FY2021**”).

The Group’s revenue attributable to concrete demolition services increased by 23.7% from approximately HK\$56.1 million for FY2021 to approximately HK\$69.4 million for FY2022. The Group’s revenue attributable to prefabricated construction increased by 15.0% from approximately HK\$42.8 million for FY2021 to approximately HK\$49.2 million for FY2022.

The Group recorded a net loss of approximately HK\$2.7 million for FY2022, representing a decrease by 92.7% as compared to a net loss of approximately HK\$37.2 million for FY2021. Basic loss per share for FY2022 was HK1.02 cents, as compared to HK3.65 cents for FY2021.

## BUSINESS REVIEW AND PROSPECT

After three years of Covid-19 pandemic disrupted social and business activities and cross-border business that dealt a heavy blow to Hong Kong economy, the Company saw the light to the end of the tunnel when Hong Kong relaxed the pandemic control measures and travel restriction. The Company was pinning its hopes on reopening cross-border of China to revitalize Hong Kong economy. The Company believes that Hong Kong would gradually return to normal with the lifting of most Covid-19 related restrictions and improved market sentiment. During FY2022, the Group’s revenue from concrete demolition services business grew by 23.7% due to Hong Kong’s post-pandemic rebound. In 2022, Hong Kong government planned to create more land, expand the railway and road infrastructure network and invest in housing and recreational projects under Northern Metropolis Development Strategy and Lantau Tomorrow Vision. The Company was confident in its strong competitiveness in the construction demolition industry.

本人謹代表朝威控股有限公司（「**本公司**」）董事（「**董事**」）會（「**董事會**」）呈報本公司及其附屬公司（合稱「**本集團**」）截至二零二二年十二月三十一日止財政年度（「**財政年度二二年**」或「**報告期**」）的綜合業績之年報，為此深感榮幸。

## 業績

本集團於財政年度二二年錄得收入約118,500,000港元，較截至二零二一年十二月三十一日止年度（「**財政年度二一年**」）之約99,000,000港元增加19.7%。

本集團之混凝土拆卸服務所佔之收益由財政年度二一年約56,100,000港元增加23.7%至財政年度二二年約69,400,000港元。本集團之裝配式建築所佔之收益由財政年度二一年約42,800,000港元增加15.0%至財政年度二二年約49,200,000港元。

本集團於財政年度二二年錄得淨虧損約2,700,000港元，較財政年度二一年之淨虧損約37,200,000港元減少92.7%。於財政年度二二年之每股基本虧損為1.02港仙，而財政年度二一年則為3.65港仙。

## 業務回顧及前景

三年來，新冠病毒疫情擾亂香港社會商業活動及跨境業務，對香港經濟造成沉重打擊，但在香港放寬疫情管控措施及旅遊限制後，本公司看見曙光。本公司寄望於中國重新開放邊境，以振興香港經濟。本公司相信，隨著大部分新冠病毒的相關限制得以解除以及市場情緒轉好，香港將逐步恢復正常。於財政年度二二年，由於香港於疫情後反彈，本集團之混凝土拆卸服務業務收益增加23.7%。於二零二二年，香港政府計劃開發更多土地，擴大鐵路及道路基礎建設網絡，並投資於《北部都會發展策略》及明日大嶼願景的房屋及休閒項目。本公司對其在建築拆卸行業的強大競爭力充滿信心。

The Group's prefabricated construction business in China continued to make a stride to grow amid the Covid-19 pandemic and geopolitical tensions. The Company believes that China economy will pose a robust improvement and hard-won growth. Revenue from the Group's prefabricated construction business recorded double digit growth in two years in a row and accounted for the growth by 15.0% for FY2022. During year 2022, many property developers in China have postponed and slowed their pace of construction projects due to liquidity problems and struggle through tough times amid an industry downturn. However, following China have loosed the reins on property developer's financing channel, China's property market demonstrated its resilience and improvement. The Company believes that enormous potential demand will be generated in the process of urbanization. The Company continues to have a positive outlook on the prefabricated construction business over long term.

The Group devotes to promote the green building. Prefabricated construction is not only green but also be more efficient and even higher quality. The Company has plans to develop and tap the prefabricated construction business into overseas market, particularly for the countries along the Belt and Road. As prefabricated construction business for overseas market is new to the Group, the Group intends to look for an experienced construction company to form a partnership and share the experience for new business in the overseas market. The Group believes that the market diversification may usher in a strong growth potential of the Group in long run. However, many countries still need to take more time to revive its economy and the Company felt difficult to source fund for the new projects due to the market liquidity tightness in China and Hong Kong. The market diversification plan was on the shelf for the time being. The Company will review this strategy from time to time and keep close watch on the development of the situation.

在新冠病毒疫情及地緣政治緊張局勢下，本集團於中國的裝配式建築業務繼續邁步增長。本公司相信，中國經濟將出現強勁改善及來之不易的增長。本集團之裝配式建築業務收益連續兩年錄得雙位數增長，佔財政年度二二年增長15.0%。於二零二二年，中國眾多物業開發商因流動資金問題推遲及放慢建築項目步伐，在行業低迷中艱難度日。然而，隨著中國放寬對物業開發商融資渠道的控制，中國物業市場恢復能力良好並有所改善。本公司認為，城市化過程中將產生巨大潛在需求。本公司繼續看好裝配式建築業務的長期前景。

本集團致力推廣綠色建築。裝配式建築不但環保，而且更具效率及質量更高。本公司計劃發展裝配式建築業務及將該業務擴展至海外市場，尤其是至一帶一路沿線國家。由於海外市場的裝配式建築業務對本集團而言較為陌生，故本集團擬物色經驗豐富的建築公司合作，分享海外市場新業務的經驗。本集團相信，市場多元化長遠而言或將為本集團帶來強勁的增長潛力。然而，眾多國家仍需要更多時間重振經濟，且由於中國及香港的市場流動資金緊張，本公司難以為新項目籌集資金。市場多元化計劃暫時擱置。本公司將不時檢討此策略，並密切關注事態發展。

We will continue to adhere to our core philosophy of “Building a Green World” and the ideology of “green building and green life” with quality, innovation and effectiveness and achieve our expansion of the Group’s business with a view to optimizing stakeholders’ interests and maximizing their value.

## BUSINESS REVIEW

The principal activity of the Company is investment holding. For the year ended 31 December 2022 (the “**Reporting Period**”), the Group mainly engages in provision of concrete demolition services and manufacturing and trading of prefabricated construction components.

### Concrete demolition services

Concrete demolition is one aspect of the construction industry in Hong Kong. The Group’s concrete demolition services were mainly concerned with the removal of pieces or section of concrete from concrete structures by applying a variety of methods, such as core drilling, sawing, bursting and crushing. Concrete demolition services are usually performed by subcontractors in (i) general building works, especially for alteration and redevelopment projects; and (ii) civil engineering works. Concrete demolition work can be applied in various situations, such as the construction of underground utilities, creation of openings for elevator, door, and window installation, redevelopment of buildings, roads, tunnels and underground facilities, removal of concrete during building construction and the preparation of road surfaces.

The customers of the Group’s concrete demolition services mainly include main contractors and subcontractors of different types of construction and civil engineering projects in Hong Kong. Such customers can generally be categorized into public sector projects’ customers and private sector projects’ customers. Public sector projects refer to projects of which the main contractors are employed by Government departments or statutory bodies in Hong Kong, while private sector projects refer to projects that are not public sector projects.

## 業務回顧

本公司的主要活動為投資控股。截至二零二二年十二月三十一日止年度（「**報告期**」），本集團主要從事提供混凝土拆卸服務以及裝配式預製建築組件製造及貿易。

### 混凝土拆卸服務

混凝土拆卸行業為香港建築行業特定領域之一。本集團的混凝土拆卸服務主要涉及透過採用各種方法，例如鑽取土芯、鋸切、逼裂及鉗碎等，移除混凝土結構的混凝土塊或組件。混凝土拆卸服務通常為分包商於(i)一般建築工程，特別是改建及重建工程；及(ii)土木工程所進行運作。混凝土拆卸工程可用於地下公共設施建設、電梯開口、門窗安裝、樓宇、道路、隧道及地下設施重建、建築施工過程中混凝土拆除及路面製備。

本集團的混凝土拆卸服務的客戶主要為香港各類建築及土木工程項目的總承建商及分包商。相關客戶一般可分類為公營及私營界別項目客戶。公營界別項目指由香港政府部門或法定機構聘請總承建商的項目，而私營界別項目指非公營界別項目。

### **Prefabricated construction**

Prefabricated construction is a new kind of architecture with the construction process that is splitting the traditional building products into precast reinforced concrete member produced in the factory and transported to the construction site for assembling into a whole building. Precast concrete contributes to green building practices as it can be very durable and energy efficient. Prefabricated Construction also reduces construction waste and debris on construction site as the precast concrete components are factory-made and employed by exact-batching technologies.

Prefabricated Constructions are becoming more popular in many developing countries, due to compressed project timelines, more affordable pricing, greener construction technology and the ability to service remote locations. Growth in urbanization and industrialization drive the demand in affordable urban housing that was built in a shorter construction time. The Group established its own production facilities and construction project team in Huizhou, the PRC for production, research and development of precast concrete components and glass fiber reinforced cement components, product installation guidance and sales which mainly serviced the construction projects in Greater Bay area of China and Hong Kong.

### **裝配式建築**

裝配式建築是將傳統建築產品分拆成於工廠生產的預製鋼筋混凝土部件並運輸至施工現場組裝成完整建築的一種新型建築形式。預製混凝土非常耐用及節能，有助於綠色建築實踐。由於預製混凝土部件乃於工廠生產並採用精確的配料技術，裝配式建築亦減少施工現場的建築垃圾及瓦礫。

由於項目時間壓縮、價格更實惠、建築技術更環保以及可以為偏遠地區提供服務的能力，裝配式建築在許多發展中國家越來越流行。城市化和工業化的發展推動建造時間更短的可負擔城市住房的需求。本集團於中國惠州建立自己的生產設施及建築項目團隊，以負責製造及研發預製混凝土組件及玻璃纖維增強混凝土組件、產品安裝指導及銷售，主要服務於中國大灣區及香港的建築項目。

## FINANCIAL REVIEW

### Revenue

Revenue increased by approximately HK\$19.5 million or 19.7% from approximately HK\$99.0 million for FY2021 to approximately HK\$118.5 million for the Reporting Period. The analysis of revenue was shown as follows:

### Concrete demolition services

For the Reporting Period, revenue attributable to concrete demolition services was approximately HK\$69.4 million, representing an increase of approximately HK\$13.3 million or 23.7% as compared with approximately HK\$56.1 million for FY2021. The increase was primarily due to an increase of approximately HK\$10.9 million in contract revenue from public sector projects, resulting from a rebound of construction demand and the backlog of the work affected by Covid-19 pandemic in previous years.

### Prefabricated construction

For the Reporting Period, revenue attributable to prefabricated construction was approximately HK\$49.2 million, representing an increase of approximately HK\$6.4 million or 15.0% as compared with approximately HK\$42.8 million for FY2021. The increase was primarily due to the increase was primarily due to an increase in delivery of modular prefabrication units for picking up the construction progress in the last quarter 2022, resulting from the ease of pandemic control and improvement of the financial channel for the property developers.

## 財務回顧

### 收入

收入由財政年度二一年的約99,000,000港元增加約19,500,000港元或19.7%至報告期的約118,500,000港元。收入分析如下：

### 混凝土拆卸服務

於報告期內，混凝土拆卸服務所佔之收益為約69,400,000港元，較財政年度二一年約56,100,000港元增加約13,300,000港元或23.7%。該增加主要是由於建築需求恢復以及過去數年受新冠病毒疫情影響積壓工作，導致公營界別項目之合同收益增加約10,900,000港元所致。

### 裝配式建築

於報告期內，裝配式建築所佔之收益為約49,200,000港元，較財政年度二一年約42,800,000港元增加約6,400,000港元或15.0%。該增加主要是由於放寬疫情防控及物業開發商金融渠道有所改善，導致模塊化預製單位的交付量於二零二二年最後一個季度增加以加快建設進度所致。

### Gross Profit and Gross Profit Margin

Gross profit increased by approximately HK\$10.8 million or 43.9% from approximately HK\$24.6 million for FY2021 to approximately HK\$35.4 million for the Reporting Period.

Gross profit margin increased from 24.9% for FY2021 to 29.9% for the Reporting Period. The increase was primarily due to an increase by 5.9 percentage points in gross profit margin attributable to concrete demolition services from 26.1% for FY2021 to 32.0% for the Reporting Period.

### Other Income and Other Gains, Net

Other income and other gains, net, increased by approximately HK\$6.6 million from approximately HK\$1.9 million for FY2021 to approximately HK\$8.5 million for the Reporting Period. The increase was primarily due to the combined effect of (i) a gain of HK\$5.8 million on reversal of impairment loss in respect of the recovery of certain long outstanding other receivable that had been fully impaired in year 2019; (ii) a loss of HK\$1.2 million on deregistration of subsidiaries which had ceased their businesses in trading of clean coal in Inner Mongolia in year 2019 and (iii) a government grant of HK\$1.9 million received during FY2022.

### Impairment losses on various assets

Impairment losses on various assets decreased by HK\$17.3 million from approximately HK\$21.9 million for FY2021 to approximately HK\$4.6 million for the Reporting Period. The decrease was primarily due to a combined effect of (i) a decrease of HK\$21.3 million in impairment loss on other receivable in connection with prefabricated construction projects led by a supplier who was one of the Group's cooperative partners in the overseas prefabricated construction business and (ii) an increase of HK\$4.0 million in impairment loss on trade receivables, primarily due to an increase in total amount of past due invoices on trade receivable resulting from the delay of the construction projects amid the Covid-19 pandemic.

### 毛利及毛利率

毛利由財政年度二一年的24,600,000港元增加約10,800,000港元或43.9%至報告期的約35,400,000港元。

毛利率由財政年度二一年的24.9%增至報告期內的29.9%。增加主要由於混凝土拆卸服務所佔之毛利率由財政年度二一年的26.1%增加5.9百分點至報告期的32.0%所致。

### 其他收入及其他利得淨額

其他收入及其他利得淨額由財政年度二一年的約1,900,000港元增加6,600,000港元至報告期的約8,500,000港元。該增加主要由於：(i)收回於二零一九年已悉數減值的若干長期未收其他應收款項之減值虧損撥回收益5,800,000港元；(ii)因於二零一九年終止在內蒙古營運清潔煤貿易業務而取消註冊附屬公司之虧損1,200,000港元及(iii)於財政年度二二年收到政府補助1,900,000港元的綜合影響。

### 各項資產之減值虧損

各項資產之減值虧損由財政年度二一年約21,900,000港元減少17,300,000港元至報告期間約4,600,000港元。該減少主要由於(i)與供應商牽頭的裝配式建築項目有關的其他應收款項減值虧損減少21,300,000港元，而該供應商為本集團海外裝配式建築業務的合作夥伴之一；及(ii)貿易應收款項減值虧損增加4,000,000港元，主要原因為在新冠病毒疫情期間建築項目延誤導致貿易應收款項的逾期發票總額增加之綜合影響所致。

### Administrative and Other Operating Expenses

Administrative and other operating expenses decreased by approximately HK\$0.4 million from approximately HK\$36.3 million for FY2021 to approximately HK\$35.9 million for the Reporting Period. Such decrease was primarily due to (i) a decrease of approximately HK\$0.4 million in consultancy fee.

### Loss Attributable to Owners of the Company

After a result of the foregoing, the Group's loss attributable to owners of the Company was approximately HK\$10.3 million for the Reporting Period, representing a decrease of approximately HK\$26.5 million as compared to a loss of HK\$36.8 million attributable to owners of the Company for FY2021.

### Liquidity, Financial Resources and Capital Structure

As at 31 December 2022, the Group had cash and bank deposits of approximately HK\$36.3 million (2021: approximately HK\$37.1 million).

The gearing ratio of the Group as at 31 December 2022 (defined as total borrowings including interest bearing and non-interest bearing, divided by the Group's total equity) is not applicable due to negative total equity of the Group (2021: approximately 18.9).

### Treasury Policy

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the Reporting Period. The Group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

### 行政及其他營運開支

行政及其他營運開支由財政年度二一年的約36,300,000港元增加約400,000港元至報告期的約35,900,000港元。該減少主要因為(i)諮詢費減少約400,000港元所致。

### 本公司擁有人應佔虧損

由於上述原因，於報告期內，本公司擁有人應佔虧損約為10,300,000港元，較財政年度二一年的本公司擁有人應佔虧損約36,800,000港元減少約26,500,000港元。

### 流動資金、財務資源及資本結構

於二零二二年十二月三十一日，本集團有現金及銀行存款約36,300,000港元（二零二一年：約37,100,000港元）。

於二零二二年十二月三十一日，本集團的資產負債比率（定義為借貸總額（包括計息及不計息）除以本集團權益總額）並不適用，因本集團的總權益為負數（二零二一年：約18.9）。

### 庫務政策

本集團已對其庫務政策採取審慎的財務管理方針，故在整個報告期內達致維持穩健的流動資金狀況。本集團致力透過進行持續的信貸評估及評估其客戶的財務狀況以降低信貸風險。為管理流動資金風險，董事會密切監視本集團的流動資金狀況，以確保本集團資產、負債及其他承擔的流動資金架構可時而符合其資金要求。



### Foreign Exchange Risk

The Group principally operates its businesses in Hong Kong and the PRC. The Group is exposed to foreign exchange fluctuations from various currencies, such as United States dollars and Chinese Renminbi. Since Hong Kong dollars remains pegged to the United States dollars within a defined range, the Group is not exposed to any significant foreign exchange risk against the United States dollars. The Group has certain subsidiaries operating in mainland China, in which most of their transactions, including revenue, expenses and other financing activities, are denominated in Chinese Renminbi. The Group is not exposed to any significant foreign exchange transaction risk in relation to these currencies and had not entered into any foreign exchange contract as hedging measures against these currencies.

### Significant Investment Held

As at 31 December 2022 and 2021, there were no material investment held by the Group.

### Debts and Charge on Assets

As at 31 December 2022, the total borrowings of the Group, including unsecured fixed bonds and other loan, amounted to approximately HK\$76.2 million (2021: approximately HK\$64.3 million). The annual interest rates of the borrowings during the Reporting Period ranged from 4.2% to 12.0% per annum (2021: 6.75% to 12.0% per annum). All of the borrowings are unsecured and denominated in Hong Kong dollars and Chinese Renminbi. The borrowings of HK\$46.9 million were repayable within one year which was accounted for as current liabilities of the Group and the borrowings of HK\$29.3 million were repayable over one year which was accounted for as non-current liabilities.

### Capital Commitments

The Group does not have material capital commitments as at 31 December 2022 (2021: Nil).

### Future plans for material investment or capital assets

Save as disclosed in the annual report, the Group does not have any other specific plan for material investments or capital assets as at 31 December 2022.

### 外匯風險

本集團主要在香港及中國經營業務。本集團承受美元及人民幣等外幣之外匯匯率波動。由於港元及美元仍在既定範圍內保持聯繫匯率，本集團並無承受任何重大美元外匯風險。本集團有若干附屬公司於中國內地營運，大部分交易（包括收入、開支及其他融資活動）以人民幣計值。本集團並未就該等外幣承受重大外匯交易風險，亦無就該等外幣訂立任何外匯合約作為對沖措施。

### 所持重大投資

於二零二二年及二零二一年十二月三十一日，本集團概無持有任何重大投資。

### 債務及資產抵押

於二零二二年十二月三十一日，本集團的借貸（包括無抵押定息債券及其他貸款）總額約為76,200,000港元（二零二一年：約64,300,000港元）。於報告期內，借貸的年利率介乎每年4.2%至12.0%（二零二一年：每年6.75%至12.0%）之間。所有借貸為無抵押及以港元及人民幣計值。46,900,000港元的借貸須於一年內償還，並入賬列作本集團的流動負債；而29,300,000港元的借貸須於超過一年後償還，並入賬列作非流動負債。

### 資本承擔

於二零二二年十二月三十一日，本集團並無重大資本承擔（二零二一年：無）。

### 有關重大投資或資本資產的未來計劃

除本年報所披露者外，於二零二二年十二月三十一日，本集團並無任何關於重大投資或資本資產的其他特別計劃。

The Group had no material contingent liabilities as at 31 December 2022 (2021: Nil).

### Employee and Remuneration Policies

As at 31 December 2022, the Group employed 98 staff (2021: 124 staff). Total employee costs for the Reporting Period including directors' emoluments, amounted to approximately HK\$41.0 million (2021: approximately HK\$41.2 million).

The salary and benefit levels of the employees of the Group are competitive. This is very important as the construction industry has been experiencing labour shortage in general. Individual performance of our employees is rewarded through the Group's salary and bonus system. In addition, the Group provides adequate job training to employees in order to equip them with practical knowledge and skills to tackle situations and challenges encountered in diverse work sites.

### Final Dividend

The Board does not recommend payment of final dividend to Shareholders for the Reporting Period (2021: Nil).

The Directors and the management of the Group recognize the importance of sound corporate governance to the long-term and continuing success of the Group. Therefore, the Board is committed to upholding good corporate standards and procedures for the best interest of the Company's shareholders.

## COMPLIANCE WITH THE CORPORATE GOVERNANCE CODE

The Corporate Governance Code (the “Code”) in Appendix 15 to the GEM Listing Rules sets out the principles of good corporate governance, code provisions and recommended best practices. Issuers are expected to comply with the code provisions or devise their own code on corporate governance on the terms they consider appropriate provided that considered reasons are given. Throughout the Reporting Period, save as disclosed below, the Company had complied with the applicable code provisions of the Code with the exception of the deviations as explained:

### C.1.8 Appropriate insurance cover in respect of legal action against the Directors

The Code provision C.1.8 stipulates that the Company should arrange appropriate insurance cover in respect of legal action against the Directors. The Company does not have insurance cover in this respect because the Board believes that the Director's risk of being sued or getting involved in litigation in their capacity as Directors is relatively low. The Board will review the need for taking out this sort of insurance from time to time.

### F.2.2 Attendance of Chairman in Annual General Meeting

The Code provision F.2.2 stipulates that the chairman of the Board should attend the annual general meeting. The chairman of the Company, Mr. Liu Yingjie, was unable to attend the annual general meeting held on 8 June 2022 due to the travel restriction in Covid-19 pandemic. The Board elected an independent non-executive Director, Mr. Li Kar Fai, Peter, to chair the annual general meeting.

## BOARD COMMITTEES

The Board has established a number of functional committees in compliance with the relevant GEM Listing Rules and to assist the Board to discharge its duties. Currently, three committees has been established, i.e. the audit committee (the “**Audit Committee**”), the nomination committee (the “**Nomination Committee**”) and the remuneration committee (the “**Remuneration Committee**”). The function and responsibilities of these committees have been set out in the relevant terms of reference which are of no less stringent than that stated in the Code. All committees have been provided with sufficient resources and support from the Group to discharge their duties.

### AUDIT COMMITTEE

The Company has established the Audit Committee on 2 August 2014 with its terms of reference in compliance with Rules 5.28 to 5.33 of the GEM Listing Rules, and provisions D.3.3 and D.3.7 of the Code. The majority of the Audit Committee members must be independent non-executive Directors and must be chaired by an independent non-executive Directors. If any member of the Audit Committee ceases to be a Director, he/she will cease to be a member of the Audit Committee automatically.

The Audit Committee must comprise a minimum of three members, at least one of whom is an independent non-executive Director with appropriate professional qualification or accounting or related financial management expertise as required under Rule 5.05(2) of the GEM Listing Rules. In addition, the majority of the Audit Committee shall be independent non-executive Directors. As at the date of this report, the Audit Committee comprises three members, namely Mr. Li Kar Fai Peter (Chairman), Mr. Chan Chi Pang and Mr. Cao Hongmin.

The Group adopted policy in relation to the diversity of the members of the Board ("**Board Diversity Policy**") and summary of the policy is as follows:

1. selection of Board members will be based on a range of diversity perspectives, which would include but not limited to gender, age, cultural and educational background, professional experience, skills, knowledge and length of service; and
2. the Nomination Committee will monitor the implementation of the diversity policy from time to time to ensure the effectiveness of the diversity policy.

With a view to achieving a sustainable and balanced development, the Company sees diversity at the Board level as an essential element in maintaining a competitive advantage. A truly diverse Board will include and make good use of differences in the skills, regional and industry experience, background, gender and other qualities of the Directors. These differences will be considered in determining the optimum composition of the Board. All appointment of the Directors are made on meritocracy, and will be considered against objective criteria, having due regard for the benefits of diversity on the Board.

As at the date of this report, the Board comprises five Directors, three are INEDs, thereby promoting critical review and control of the management process. The Board comprised four males, representing 80% of the Board, and one female, representing 20% of the Board; and our senior management comprised one male, representing 100% of senior management.

Construction industry has generally been short of female talents due to social and culture traditions. The Company managed to maintain a gender ratio of male to female in the workforce of approximately 4:1.

The Board has met the goals for gender diversity under the Board Diversity Policy for FY2022.

## DIVIDEND POLICY

The Company adopted a dividend policy on payment of dividends on 1 January 2019. It aims at enhancing transparency of the Company and facilitating its shareholders and the potential investors of the Company to make informed investment decision relating to the Company. The Board will review the dividend policy from time to time.

董事會於財政年度二二年已達致董事會多元化政策項下的性別多元化目標。

6. any other factors that the board of directors of the Company deems relevant.

Shareholders will be entitled to receive such dividends pro rata according to the amounts paid up or credited as paid up on the shares. The declaration, payment, and amount of dividends will be subject to the Board's discretion.

Dividends may be paid only out of distributable profits as permitted under the relevant laws. There can be no assurance that the Company will be able to declare or distribute any dividend in the amount set out in any of the plans or at all. The Company's dividend distribution record in the past may not be used as a reference or basis to determine the level of dividends that may be declared or paid by the Company in the future.

## 風險管理及內部控制

董事會負責建立、維護及審查本集團內部控制和風險管理體系。董事會必須確保本公司建立和維護有效的內部控制和風險管理體系，以實現目標，維護本公司股東及資產的利益。

The Board oversees the overall risk management and internal control system of the Group on an ongoing basis and endeavors to identify, control impact of the identified risks and facilitate implementation of coordinated mitigating measures. The risk management and internal control systems compatible with the Commissioner of Sponsoring Organization of the Treadway Commission (COSO) – Integrated Framework 2013 principles are designed to manage rather than eliminate the risk of failures to achieve business objectives, and provide only reasonable but not absolute assurance against material misstatement or loss.

The Group has established a risk management policy set out the process of identification, evaluation and management of the principal risks affecting the business.

1. Each division is responsible for identifying, assessing and managing risks within its division. It identifies and assesses the principal risks on a quarterly basis with mitigation plans to manage those risks;
2. The management is responsible for overseeing the risk management and internal control activities of the Group, quarterly meetings with each division to ensure principal risks are properly managed, and new or changing risks are identified and documented;
3. The Board is responsible for reviewing and approving the effectiveness and adequacy of the Group's risk management and internal controls.

The risk management framework, coupled with our internal controls, ensures that the risk associated with our different business units are effectively controlled in line with the Group's appetite.

The Company does not have an internal audit department and engaged an external internal control consultant, Premier Advisory Services Limited, to conduct review on the internal control system of the Group during the Reporting Period. The review covering certain procedures and implementation of risk management policies of the Group and make recommendations for improvement and strengthening of internal control system. No significant areas of concern that may affect the financial, operational, compliance, controls and risk management of the Group have been identified.

董事會按持續基準不斷監察本集團風險管理及內部控制系統，致力識別、控制已確定風險的影響，並促進實施協調減緩措施。與 Treadway 委員會 (COSO) — 「二零一三年綜合框架」原則的贊助組織專員兼容的風險管理和內部控制系統旨在管理而不是消除失敗實現業務目標的風險，並提供合理但不絕對的保證反對重大錯報或遺失。

本集團制定了風險管理政策，以確定影響業務的主要風險的識別，評估和管理過程。

1. 每個部門負責確定、評估和管理其各部門的風險，每季度確定和評估主要風險，並採取緩解計劃來管理這些風險；
2. 管理層負責監督本集團的風險管理和內部控制活動，並與各部門進行季度會議，以確保負責人的風險得到妥善管理且新風險或變化中的風險得到確認和記錄；
3. 董事會負責審議和批准本集團風險管理和內部控制的有效性和充分性。

The Group's risk management and internal control system are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss. The Board has the overall responsibility to maintain the adequacy of resources, staff qualifications and experience training programs and budget of accounting and financial reporting function and the Board has reached the conclusion that the Group's risk management and internal control system was in place and effective.

With respect to the monitoring and disclosure of inside information, the Group has adopted a policy on disclosure of inside information with an aim to ensure that the insiders abide by the confidentiality requirement and fulfill the disclosure obligation of the inside information.

The external auditor of the Company is also invited to be present at the AGM to address to queries of the Shareholders concerning the audit procedures and the auditors’ report.

The forthcoming AGM of the Company at which a special resolution is to be passed is scheduled to be held on 8 June 2023, the notice of which shall be sent to the Shareholders at least 21 days prior to this meeting.

## SHAREHOLDERS’ RIGHTS

### Convening Extraordinary General Meeting on Requisition by Shareholders

Pursuant to article 64 of the Articles, the Board may, whenever it thinks fit, convene an extraordinary general meeting (“EGM”). EGMs shall also be convened on the requisition of one or more Shareholders holding, at the date of deposit of the requisition, not less than one tenth of the paid up capital of the Company having the right of voting at general meetings. Such requisition shall be made in writing to the Board or the company secretary of the Company for the purpose of requiring an EGM to be called by the Board for the transaction of any business specified in such requisition. Such meeting shall be held within 2 months after the deposit of such requisition. If, within 21 days of such deposit, the Board fails to proceed to convene such meeting, all reasonable expenses incurred by the requisitioner(s) as a result of the failure of the Board shall be reimbursed to the requisitioner(s) by the Company.

The reporting period of this ESG report is from 1 January 2022 to 31 December 2022 (“**Reporting Period**”). This report highlights significant environmental and social impacts of our business activities in the provision of concrete demolition and construction engineering services, and the manufacturing and trading of prefabricated precast construction components.

The information contained herein is sourced from internal documents and statistics of the Group, as well as the combined control, management and operations information provided by the subsidiaries in accordance with the Group’s internal management systems. A complete content index is appended to the last section of the report for easy reference.

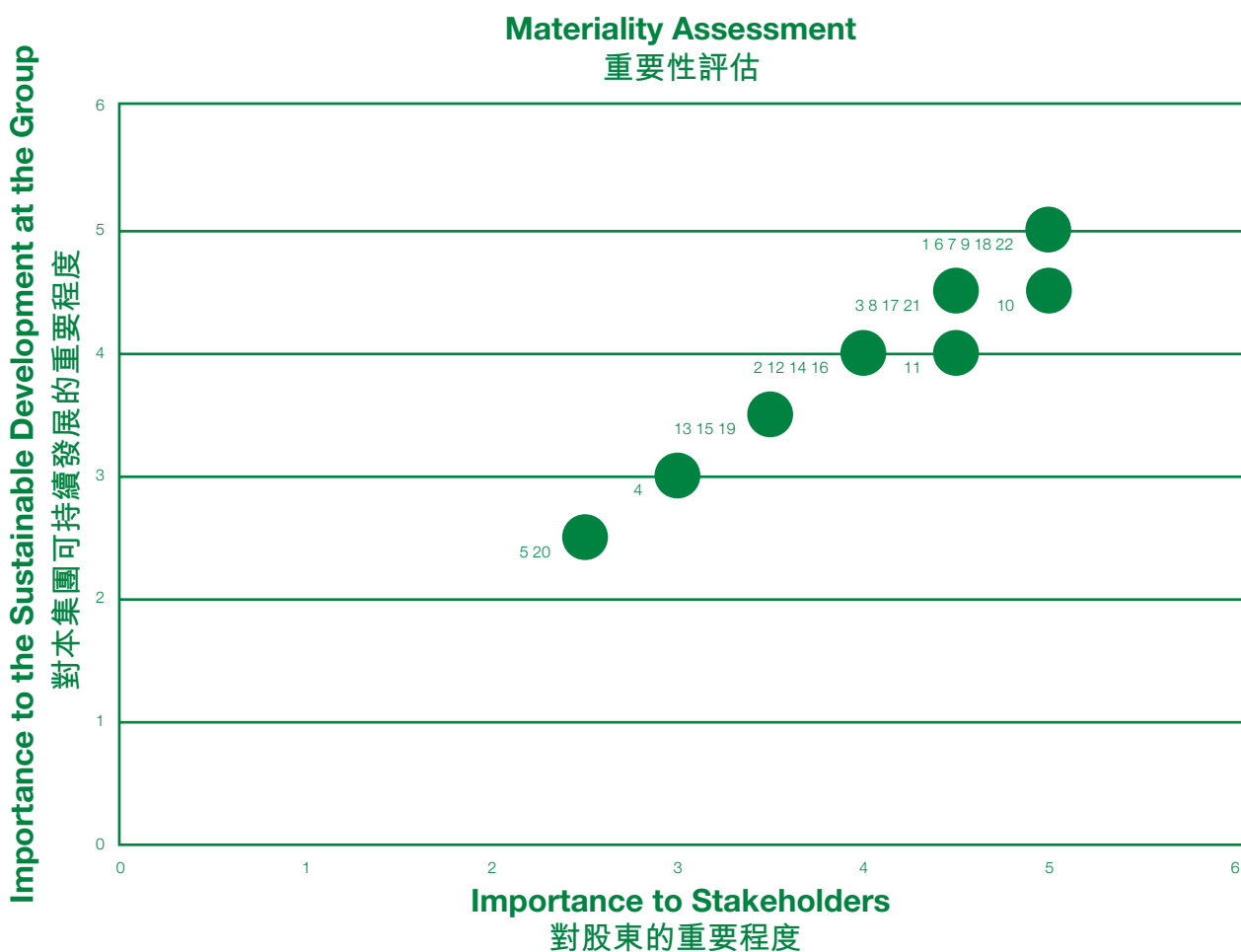


## MATERIALITY ASSESSMENT

## PROTECTING THE ENVIRONMENT

It is an indisputable fact that global warming is getting increasingly severe. The Group is aware of its responsibility and required commitment to the environmental sustainable development of its on-going operations. As a key player in the construction industry, we support the idea of green environment, comply with the requirements of the laws and regulations in Hong Kong and the PRC, and any specific guides in the industry.

## EMISSIONS

We are aware that emission reduction has increasingly become an important element for the global economy, hence has integrated environmental management into the operational decisions and various processes of the Group. Emissions from our daily business activities mainly represent greenhouse gases (“GHG”) emissions, noise, waste and effluents while carrying out construction works.

### Environmentally-Friendly Demolition Methods

Construction materials such as sands and cement stored outdoor as well as the dust of the exposed construction area are easily scattered. In order to prevent the generation of dust during our works, environmentally friendly construction methods such as scarifying and shot blasting are adopted. These methods significantly reduce the amount of dust emitted to the surrounding areas of construction sites. It also produces excellent bonding characteristics that reduce the risk of coating failure to improve road safety and maximise floor life.

For projects that involve indoor demolition works, demolition methods that would not emit exhaust gas and would cause only minimal vibration during works were used. To ensure the safety of workers, our machinery can be remotely controlled so that our workers do not have to work close to the areas under demolition.

We also adopt splitting/bursting as a demolition method. Under this method, splitter is inserted into a hole of the concrete structure drilled beforehand for bursting the structure from within, resulting in minimum noise emission and vibration.

## 保護環境

我們意識到減排日益成為全球經濟的重要組成部分，因此將環境管理納入本集團的經營決策及各個流程。我們日常業務活動產生的排放主要是從事建築工作時的溫室氣體（「溫室氣體」）排放、噪音、廢物及污水。

### 環保拆卸方法

室外存放的砂石及水泥等建築材料以及暴露的建築區域產生的灰塵容易造成塵土飛揚。為防止進行工程時產生灰塵，我們已採取打沙及石矢打花等環保建築方法。此等方法可大幅減少在建築工地周圍產生的灰塵。該技術亦具有超強粘結性能，可降低塗層失效的風險，從而改善道路安全並延長地面壽命。

對於涉及室內拆卸工程的項目，以我們所採用的拆卸方法，工作過程中不會產生廢氣，造成的振動也能降至最低。為確保工人的安全，我們的機械由工人遠程操作，工人毋須靠近拆卸區域工作。

我們亦採用逼裂／鉗碎的拆卸方法。該方法是將劈裂機插入混凝土構築物的事先鑽好的孔隙中，將構築物劈裂，使產生的噪音及振動降至最低。

## Prefabricated construction components

Unlike traditional construction methods, prefabricated construction components are constructed in a factory environment to facilitate materials to be recycled or reused. A considerable amount of dust and noise emissions can be further reduced thanks to compressed project timelines and the controlled environment of the production factory. In our production factory, we have introduced a water spraying device for daily maintenance of sub-assemblies and for the prevention of dust scattering.

For the Reporting Period, air emissions generated by the Group were as follows:

## WASTE MANAGEMENT

Handling and disposing of solid waste are an urgent environmental issue in Hong Kong. The Group realises that the construction wastes generated on construction sites will place a heavy burden on waste disposal facilities.

## 廢物管理

處理及處置固體廢物是香港緊迫的環境問題。本集團意識到建築工地產生的建築廢物會對廢棄物處理設施造成沉重負擔。



Waste is generated mainly from the disposal of materials from our construction sites, all of them are non-hazardous and have been properly transported to designated receiving facilities in accordance with the requirements of the Waste Disposal Ordinance. In general, the Group categorises the waste from construction works before removal from the site. General inert waste from work, such as rocks, shall be reused as filling materials at the site if applicable or disposed to public fill for reclamation in the future. Other waste that is not applicable for recycling or reuse shall be discarded to the public filling areas to conserve landfills.

In respect of office waste, we shall continue to encourage our employees to fully utilise all materials to avoid producing unnecessary waste and to reduce paper usage electronic means.

For the Reporting Period, the amount of non-hazardous waste produced by the Group was as follows:

To reduce waste reduction, the Group separates waste before disposal and take waste to the allocated sorting area. We have adopted a trip-ticket system to avoid fly-tipping and to ensure waste is disposed of properly when our client did not provide the disposal area. The Group also implement the following measures to reduce:

- Order the appropriate amount of raw material at the appropriate time;
- Store materials in an allocated area with suitable protective measures;
- Periodically review operating procedures to minimise waste generation; and
- Collect the exact number of materials and return the surplus to stock as needed.

Due to our business nature (provision of construction services and building materials supply), no hazardous waste was generated from our operations for the Reporting Period.

由於我們的業務性質（提供建築服務及建築材料供應）使然，我們於報告期間的營運並無產生任何有害廢物。

## USE OF RESOURCES

To make good on the Group's promise of achieving environmentally sustainable development, we have actively assumed our environmental responsibility in our daily operations and formulated the code of practice and technical skills. The Group's major use of resources includes paper, energy and water consumption. For energy use, both office operation and the carrying out of construction works consume electricity and fuel. Fuel consumption mostly came from equipment operation and ground transportation of equipment during delivery, while electricity consumption was from office operation. We place great emphasis on resource conservation and strives to enhance the energy efficiency by strengthening the maintenance of construction equipment, optimising operation procedures, and adopting energy-saving measures.

## 資源使用

為兌現本集團實現環境可持續發展的承諾，我們在日常營運中積極承擔環境責任，並制定標準守則及技術技能。本集團的主要資源使用包括紙張、能源及水消耗。對於能源使用而言，我們的辦公室運營及建築工作須消耗電力及燃料。燃料消耗大部分產生於設備操作及付運期間的設備地面運輸，而電力消耗則來自辦公室運營。我們高度重視資源節約，努力透過維護建築設備、優化操作流程及採納節能措施提高能源效率。

Several initiatives have been implemented in offices and construction sites to control energy consumption as follows:

Apart from office operation, the major source of the Group's water consumption is from our construction segment. The Group prudently uses water resources and strictly handles sewage discharge to alleviate water shortage, and strives to reduce the negative impact on the surrounding environment. To promote water conservation, the Group incorporated various water conservation measures in both offices and project sites. Control measures like protection of drainage system and discharge point to avoid blockage, and conduction of regular self-monitoring checks to ensure the quality of the effluent discharged meeting the prescribed standards, are being practised in our daily operations. At our construction sites, ground wastewater is collected and properly treated by on-site wastewater treatment facilities and then reused for dust suppression and vehicle wheel washing mud to lower freshwater consumption and sewage. Our sub-contractors were also encouraged to work closely with our staff to implement appropriate measures to prevent the waste of fresh water on site.

To achieve our efficient use of energy, the Group advocates the Reduce, Replace and Reuse approach, in line with national initiatives. Our management will constantly update the latest news on environmental protection to enhance existing services and reduce environmental pollution.

For the Reporting Period, the resources consumption by the Group were as follows:

辦公室營運外，本集團用水消耗的主要源頭為建築分部。本集團謹慎使用水資源，嚴格處理污水排放，緩解水資源短缺，致力減少對周邊環境的負面影響。為提倡節水，本集團在辦公室及建築工地納入了各種節水措施。我們於日常營運中實施了多項控制措施，如保護排水系統以避免阻塞及定期進行自主監測檢查，確保排放廢水治理符合規定標準。於建築工地，我們收集並以現場污水處理設施妥為處理地下廢水，之後將其用於抑制揚塵和清洗汽車輪胎淤泥，以減少食水消耗及污水。我們亦鼓勵我們的分包商與我們員工緊密合作，執行適當措施減少工地的食水浪費。

為實現我們的能源有效使用，本集團根據國家倡議採取減少、替換及再利用的方法。我們的管理層會不斷更新有關環保的最新消息，以提升現有服務並減少環境污染。

## ENVIRONMENT AND NATURAL RESOURCES

In view of the growing greenhouse effect and climate change, energy conservation, carbon reduction and minimising pollution have become global issue that could affect any one of us. In compliance with applicable environmental legislation, our operating activities have no significant impact on the environment and natural resources. For the sake of compliance with relevant laws and regulations, we regularly assess the environmental risks of our operations and adopt preventive measures as necessary to reduce the risks.

To join the global efforts in reducing emissions and secure a sustainable future, the Group took into consideration the industry's best practices and analysed its previous quantitative environmental data disclosed in past ESG reports in developing a set of appropriate environmental targets. To this end, we have set clear emission reduction targets to be achieved by the year 2026 by comparing with the 2021 baseline year:

- Reduce greenhouses gases emission by 10%;
- Reduce waste disposal by 10%; and
- Reduce resources consumption by 10%.

As a responsible corporate citizen, the Group has complied with the Air Pollution Control Ordinance, Waste Disposal Ordinance, Water Pollution Control Ordinance, Noise Control Ordinance, Dumping at Sea Ordinance, Environment Impact Assessment Ordinance and other regulations promulgated by governments and currently applicable to the Group, as well as environmental requirements from customers.

For the Reporting Period, the Group was not aware of any cases of non-compliance with laws and regulations that have a significant impact on the Group in relation to air and GHG emissions, noise control, discharges into water and land, and generation of hazardous and non-hazardous waste.

## 環境及天然資源

鑑於溫室效應及氣候變化日益嚴重，節能減碳及減少污染已成為可能影響我們每個人的全球性問題。我們的經營活動遵守適用的環保法例，並無對環境及天然資源造成重大影響。為符合相關法律及法規，我們定期評估業務經營的環境風險，並在必需時採取預防措施以降低風險。

為了成為全球減排的一份子，確保未來可持續發展，本集團參考業內最佳做法，並分析其於過往環境、社會及管治報告中披露的先前量化環境數據，以製定一套適當的環境目標。就此，我們與二零二一年基準年進行比較，已制定於二零二六年前實現減排的明確目標：

- 溫室氣體排放量減少10%；
- 廢物棄處理減少10%；及
- 資源消耗減少10%。

作為負責任的企業公民，本集團已遵守《空氣污染管制條例》、《廢物處置條例》、《水污染管制條例》、《噪音管制條例》、《海上傾倒物料條例》、《環境影響評估條例》及政府頒佈且目前適用於本集團之其他法規，以及客戶提出的環保要求。

於報告期內，本集團概不知悉任何違反關於空氣及溫室氣體排放、噪音控制、向水或土地排污以及產生有害及無害廢物且對本集團構成重大影響的法律及法規事件。

### Governance 管制

**Board oversight:** The Board meets quarterly to oversee climate-related strategies, policies, actions and disclosure.

**Management's role:** The Management supports climate action planning and internal policy setting, as well as coordinating responses to climate-related risks.

### Strategy 策略

**Policies and guidelines:** The Management meets monthly and discusses any potential climate change risk to our business. Corresponding mitigative measures will be implemented and reviewed from time to time to assess their effectiveness.

**政策及指引：**管理層每月召開會議，討論我們業務面臨的任何潛在氣候變化風險。本公司將不時實施及檢討相應緩解措施，以評估其有效性。

**Physical risks:** Weather-related events such as storms, floods, fires or heatwaves that cause damage to construction site facilities and operations. We work closely with the sub-contractor at the site and assist with implementing fast-response measures, regular inspections and hoarding to ensure sufficient sites operations.

**實體風險：**與天氣有關的事件（如風暴、洪水、火災或熱浪）會對建築工地設施及營運造成損害。我們與現場的分包商密切合作，協助實施快速響應措施、定期檢查及採用臨時護欄，以確保現場營運充足。

**Transition risks:** Impacts related to market risk are assessed in our construction materials and energy efficiency requirements. In line with national initiative, we also keep abreast of green building technologies.

**過渡風險：**我們會就建築材料及能源效益規定評估與市場風險相關的影響。為配合國家倡議，我們亦緊接發展綠色建築技術。

### Risk Management 風險管理

Climate-related risks are incorporated into the Group's risk management framework and ESG materiality assessment by different stakeholders. The Group will monitor and follow up on both transition and physical climate-related risks and set up the policy to respond with our management.

氣候相關風險被不同利益相關者納入本集團的風險管理框架及ESG重要性評估。本集團將監控及跟進過渡及氣候相關實體風險，並制定政策以與我們的管理層共同應對。

### Metrics and Targets 指標及目標

Our management encourages employees to participate in green workshops to enhance their environmental awareness, and continuously assess compliance with the green office guidelines.

我們的管理層鼓勵員工參與綠色工作坊，以提高其環保意識，並持續評估綠色辦公室指引的合規事宜。



## EMPLOYMENT AND LABOUR PRACTICES

The Group values people and considers a respectful and fair working environment to be vital to its operations. We make sure compensation packages offered to staff can be commensurate with their performance and experience. Specifically, compensatory leave, overtime allowance, discretionary bonus, mandatory provident fund or pension security, social insurance, rewards for long-term services, and an annually reviewed salary level in our employment contracts allow the Group to retain quality talent.

Throughout the recruitment and promotion process, candidates are assessed in regard to their qualifications and work experiences and we treat all employees and candidates equally. The Group has established a series of internal policies related to employment with reference to anti-discrimination ordinances and the guidance under Employment Ordinance, Laws of Hong Kong, the Labour Law and Labour Contract Law of the PRC, as well as industry features and practices to ensure that our employees are treated fairly, and their employment, remuneration and promotion are not affected by their social identities such as age, gender, marital status, family status, sexual orientation, race, nationality or religion.

A comprehensive Staff Handbook was formulated to support human resources function, which covers guidelines on recruitment and promotion, compensation and dismissal, working hours, rest periods, appraisal, training and other benefits. The Group has been reviewing its related policies from time to time to ensure the Group complies with the latest statutory requirements. We motivate employees by promotion, salary increment, and discretionary bonus based on an annual performance appraisal. In our demolition works subsidiary, a long service award is given to those employees that have been employed for over 10 years as a reward to their loyalty.

We take staff opinion seriously. All employees are welcome to make comments and suggestions through various communication channels such as letters, emails, or by communicating with their direct supervisors, department heads, or our human resources function. We make sure to keep the detail of such communications and the identity of the employee confidential, and to address any grievances of the employee as appropriate as we can.

## 僱傭及勞工常規

本集團重視人才，並認為互相尊重及公平的工作環境對其營運至關重要。我們確保員工的薪酬待遇與其表現及經驗相匹配。具體而言，我們的僱傭合同中列明有薪假期、加班津貼、酌情花紅、強制性公積金或退休金保障、社會保險、長期服務獎勵以及按年檢討薪資水平，使本集團得以保留優質人才。

在整個招聘及晉升過程中，我們會根據候選人的資格及工作經驗對其進行評估，我們對所有員工及候選人一視同仁。本集團已參照香港法例《僱傭條例》、《中國勞動法》及《中國勞動合同法》下的反歧視條例及指引以及行業特點及常規制定一系列內部僱傭政策，確保僱員享有公平待遇，不會因年齡、性別、婚姻狀況、家庭狀況、性取向、種族、國籍或宗教信仰等社會身份而影響彼等之就職、薪酬及晉升。

本集團已制定全面的員工手冊以支持人力資源職能，當中包含有關招聘及晉升、薪酬及解僱、工作時間、休假、評估、培訓及其他福利等方面的指引。本集團不時檢討其相關政策，以確保本集團符合最新的法定要求。我們激勵僱員的方式包括根據年度績效考核結果對其晉升、加薪及給予酌情花紅。在我們的拆卸工程附屬公司工作超過10年的僱員可獲得長期服務獎，以表揚其忠誠。

我們尊重僱員的意見。我們歡迎全體僱員透過信件、電子郵件等各種通訊渠道，或直接與上司、部門負責人或人力資源部進行溝通，提出意見及建議。我們為有關通訊資料及僱員身份保密，並盡我們所能解決僱員的任何不滿（如合適）。

## Staff Composition

The Group's principal businesses are prefabricated construction and demolition works which requires plenty of physical labour. Traditionally male employees comprise a majority of our workforce, which does not mean we prefer hiring male employees to female employees. We are firmly committed to gender equality, and particularly encourages female participation in the Board, and at managerial and operational levels.

As at 31 December 2022, we employed a total of 97 full-time staff and 1 casual staff, including back-office and site staff. All of our staff members are located in Hong Kong and the PRC.

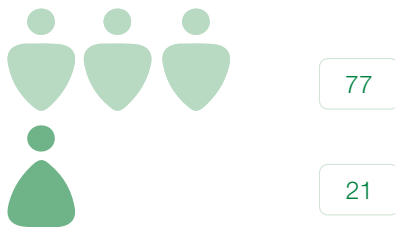
## 員工組成

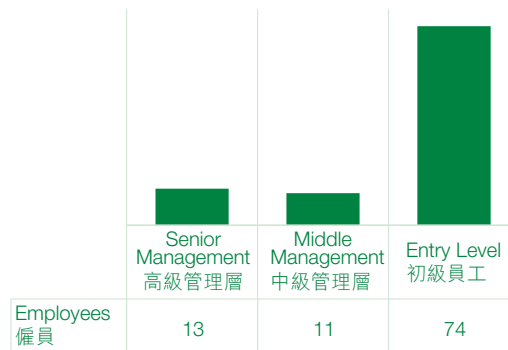
### Employees by Gender

按性別劃分的僱員



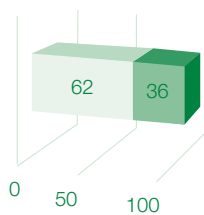
### Employees by Employment Category

### Employees by Region

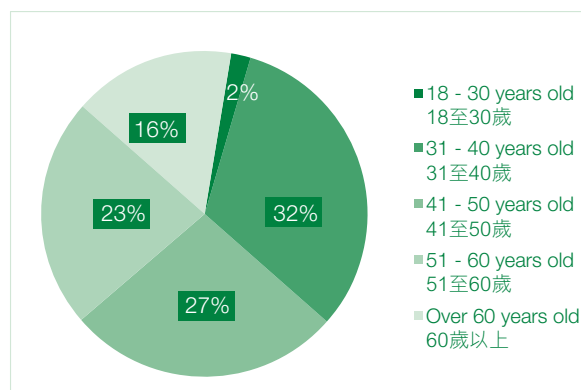

## HEALTH AND SAFETY

Recognising that the construction industry is one of those industries with a higher risk in terms of occupational health and safety (“OHS”), we put safety first and are committed to maintaining a workplace that is safe for our people. To ensure that all employees are equipped with adequate knowledge in protecting themselves from occupational hazards, the Group has provided training for all levels of employees.

## 健康與安全

我們深知，建築業是職業健康與安全（「職業健康及安全」）風險較高的行業之一，故我們將安全置於首位，並致力於為僱員維持安全的工作場所。為確保全體僱員均具備保護自己免受職業危害的充足知識，本集團為各級僱員提供培訓。

For the Reporting Period, the Group's operations do not possess high-risk areas related to OHS to its employees except for construction-related operations. We are determined to ensure that all construction works are carried out in accordance with the best OHS practices. Specifically, protective equipment such as safety helmets, safety shoes and high visibility clothing are provided to all personnel who needs to work at construction sites. Relevant OHS training such as safety induction training, toolbox talks, specific training for high-risk activities, periodic emergency contingency drills to heighten employee awareness of workplace hazards are provided to staff to ensure they are competent to discharge their OHS responsibilities and obligations and respond to emergencies.

We hire professionally qualified persons in OHS to oversee the management of safety risks and issues in our operations. Safety measures are tailored to respond to different site conditions and activity risks to ensure a safe working environment for all employees and those who work on our projects. Our safety officers would regularly review and check for updates in applicable safety laws and regulations. Site inspections are also regularly performed to conduct risk assessment and Safety officers will note for material safety issues, suggest remediation measures, and follow up implementation of safety recommendations. Our on-site foremen and site supervisors are required to co-operate with our safety officers to ensure all health hazards would be rectified promptly.

To keep the Group abreast of the latest OHS best practices and/or updated in-laws and regulations relevant to OHS, one of our subsidiaries had registered as a Green Cross Group member under the Occupation Safety and Health Council (“OSHC”) in Hong Kong. This allows the Group to access the OSHC's library to obtain the latest information and participate in workshops to facilitate experience sharing and gain deeper insights into the implementation of OHS best practices. The Group has continued to optimise its work practices and daily management for the sake of its staff's health and safety with the aim to create a safe, healthy and comfortable working environment. To this end, our operations fully comply with applicable laws and regulations such as the Occupational Safety and Health Ordinance, Employees' Compensation Ordinance, Factories and Industrial Undertakings Ordinance, Laws of Hong Kong, and Work Safety Law of the PRC.

於報告期內，除建築相關業務外，本集團之營運並無涉足對僱員之職業健康與安全而言屬高風險的領域。我們堅決確保根據職業健康與安全最佳慣例開展所有建築工作。具體而言，我們為所有須於施工現場工作的人員提供頭盔、安全鞋及反光衣等防護設備。我們亦為員工提供相關的職業健康與安全培訓，如入職安全培訓、工具箱講座、高風險活動的專項培訓以及定期的應急演習，以提高僱員的工作場所危機意識，確保彼等有能履行其職業健康與安全責任及義務以及應對緊急情況。

我們僱用專業合資格的職業健康與安全人員，監督我們於運營期間對安全風險及問題的管理。安全措施針對不同的現場條件及活動風險而制定，以確保為所有員工及我們項目的工作人員提供安全的工作環境。我們的安全主任會定期檢討並檢查適用的安全法律和法規是否有更新。還定期進行現場檢查，進行風險評估，安全人員會關注材料安全問題，就補救措施提出建議，並跟進安全建議的實施。我們的現場工長及現場監督員須與安全主任合作，確保任何所有健康危害得到及時糾正。

為使本集團瞭解最新的職業健康與安全最佳慣例及／或與職業健康與安全有關的法律法規更新，我們的一家附屬公司已註冊為香港職業安全健康局（「職業安全健康局」）綠十字會成員。此舉讓本集團能夠進入職業安全健康局的圖書館以獲得最新資料，並參與研討會，推動經驗分享及深入洞悉職業健康與安全最佳慣例的執行情況。出於員工的健康及安全考慮，本集團持續優化其工作常規及日常管理，務求創建一個安全、健康及舒適的工作環境。為此，我們的營運完全遵守適用的法律及法規，如香港法例《職業安全及健康條例》、《僱員補償條例》、《工廠及工業經營條例》以及《中國安全生產法》。

Due to the nature of the construction industry, the risk of work injuries cannot be completely eliminated. For the Reporting Period, the work injury statistics for the Group were as follows:

In addition to providing adequate protective equipment and implementing aforementioned site safety measures, the Group introduced new plant and equipment to further enhance site safety and productivity, such as camera drone which enhance the effectiveness of site safety supervision. For the Reporting Period, the Group was not aware of any cases of non-compliance with laws and regulations that have a significant impact on the Group in relation to providing a safe working environment and protecting employees from occupational hazards.

本集團留意到於報告期內工傷意外有所增加，未來一年本集團將加大力度降低員工工傷風險。除了提供足夠的防護設備及實施上述工地安全措施外，本集團亦引進了新的廠房及設備以進一步提高工地安全及生產力，例如提高工地安全監管有效性的帶攝像頭無人機。於報告期內，本集團概不知悉任何違反關於提供安全工作環境及保護僱員免受職業危害的法律及法規而對本集團構成重大影響的事件。

The Group has introduced a number of measures in response to the COVID-19 outbreak to safeguard the health of our employees and to enable them to carry on with their daily work with a healthy and positive state of mind. COVID-19 prevention facilities and equipment, for example, non-contact forehead thermometers were set up in offices and construction sites, while individual health packs were distributed to show our care for the welfare of our employees.

本集團已採取多項措施應對新冠病毒疫情，以保障我們員工的健康，讓其可以健康積極的心態繼續日常工作。我們在辦公室及建築工地設有非接觸式額溫計等新冠病毒預防設施及設備，同時分發個人健康包，以表達我們對員工福祉的關心。



## DEVELOPMENT AND TRAINING

We recognised that our construction workers are exposed to higher injury risks than office staff. In order to reasonably mitigate the risk of work-related injuries, our site foremen, site supervisors and safety officers would conduct work safety briefings to all site workers from time to time and when needed. Causes of accidents in the construction industry are identified and corresponding recommendations or training sessions will be provided to workers to avoid the reoccurrence of similar accidents.

The Group recognises the importance of skilled and professionally trained employees to its business growth and future success. We provide equal opportunity for all staff to develop their knowledge, skills and abilities through a blend of learning methods including mentoring, coaching, on-the-job training, courses, conferences and seminars. Employees' self-development is encouraged through the taking up of training programmes and seminars. We also arranged for senior staff to guide junior so that employees can complement each other and pass on valuable experience, establishing a talent hierarchy for the future development of the Group.

The Group also acknowledges the importance of conducting performance appraisal with employees. On an annual basis, performance appraisal is conducted between management and employees for continuous improvement. Employees are able to communicate and seek professional advice from their supervisors on their career development progress.

## 發展及培訓

我們深知建築工人比辦公室工作人員面臨更高的受傷風險。為合理減低工傷風險，我們的現場工長、現場監督員及安全主任會於必要時不時向全體工地工人提供工作安全簡報。我們確定建築行業事故原因並向工人提供相應的建議或培訓課程，以避免類似事故再次發生。

本集團深知技能熟練及經專業培訓的僱員對其取得業務增長及未來成功至關重要。我們為所有員工提供平等機會，通過各種學習方法（包括指導、輔導、在職培訓、課程、會議及研討會）發展其知識、技能及能力。通過參加培訓計劃及研討會，鼓勵員工自我發展。我們亦安排高級員工帶領初級員工，使僱員能夠取長補短，傳授寶貴經驗，為本集團的未來發展建立人才團隊。

本集團亦明白評估僱員表現的重要性。管理層與僱員每年進行績效考核，以持續改進。僱員能夠就其職業發展進程與上司進行溝通及尋求專業建議。

## LABOUR STANDARDS

The Group highly respects human rights and freedom. We strictly prohibit the uses of child and forced labour in our workplace by adhering with the Employment of Children Regulations and Employment of Young Persons (Industry) Regulations under the Employment Ordinance, Laws of Hong Kong, Provisions on the Prohibition of Using Child Labour, and the Law of the People's Republic of China on Protection of the Minors. Comprehensive recruitment procedures are required to be performed to check and verify the age of a job applicant before the Group can hire him/her. The procedures require a job applicant to present their valid proof of identity to ensure that they have reached the legal working age. Important details such as job duties, locations and working hours of the staff are also set out clearly in the employment contract to protect their rights of both parties are always duly signed between the Group and the employees. Under no circumstance will we tolerate labour exploitation, forced labour and child labour.

For the Reporting Period, the Group was not aware of any cases of non-compliance with laws and regulations that have a significant impact on the Group in relation to preventing child and forced labour.

## SUPPLY CHAIN MANAGEMENT

We place great emphasis on product quality to protect the interests of our clients. Vendor management is a crucial part of our quality control procedures. The Group stringently manage suppliers and sub-contractors to avoid any inferior materials acquired and adopt strict quality control over the production and construction process. The Group has established a long-term relationship with a variety of suppliers, service providers, material manufacturers and sub-contractors who share our goals in responsible management of business ethics, quality, safety, labour, environmental management that we can integrate and interlink them to deliver the best quality, timely, responsive and valuable construction services to our clients. In daily operations, we work closely with sub-contractors and communicate our management requirements and obligations with documented instructions and guidelines for safety and health management, including report on work injuries and cooperating with the follow up investigation and rectification.

## 勞工準則

本集團高度尊重人權與自由。我們遵循香港法例《僱傭條例》下的《僱用兒童規例》及《僱用青年（工業）規例》、《禁止使用童工規定》及《中華人民共和國未成年人保護法》規定，嚴禁於我們的工作場所使用童工及強制勞工。我們要求執行全面的招聘程序，在本集團僱用之前檢查及核實崗位申請人的年齡。該等程序要求崗位申請人出示有效的身份證明文件，確保彼等符合法定工作年齡。僱傭合約內亦會清楚列明員工的工作內容、地點及工時等重要細節，保障雙方權利，本集團與僱員已妥為簽署。在任何情況下，我們均不會容忍剝削勞工、強制勞工及童工。

於報告期內，本集團概不知悉任何違反關於禁止童工及強制勞工的法律及法規而對本集團構成重大影響的事件。

## 供應鏈管理

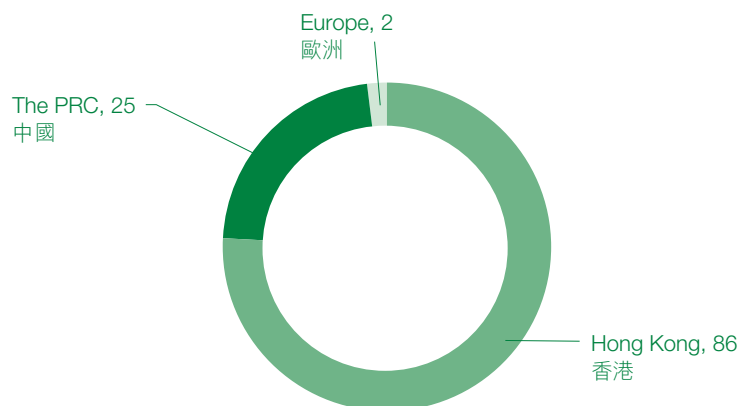
我們高度重視產品質量以保障客戶權益。賣方管理為本集團質量控制的重要部分，本集團嚴格管理供應商及分包商以避免採購任何劣質材料，並對生產及施工過程採取嚴格的質量控制。本集團與各供應商、服務供應商、材料生產商及分包商建立長期合作關係，致力於商業道德、質量、安全、勞工的負責管理及環境管理，我們可將其整合及互相銜接，為我們的客戶提供最優質、及時、積極回饋及有價值的建築服務。在日常營運中，我們與分包商密切合作，通過已備檔的安全及健康管理指引及指南傳達我們的管理要求及義務，包括報告工傷以及配合後續調查及糾正行動。

Through the implementation of a robust procurement and tendering mechanism, we select reliable and competent business partners from potential organisations in adherence to the principle of equal opportunity and fair competition.

Specifically, we maintain approved lists of suppliers and subcontractors while regular reviews are conducted to ensure our suppliers, sub-contractors and service providers continue to have the capability and capacity to provide stable and reliable services and products. The Group evaluates and selects and sub-contractors to provide materials, products and services to ensure they are met with our end clients' standards and requirements of purchase. The Group's suppliers are selected based on the following factors: environmental compliance of products supplied; quality of materials; and any background issues concerning potential conflict of interest in supplying goods to the Group.

Looking forward, the Group aims to promote local economic development and reduce carbon footprint, by prioritising local suppliers by shortening the distance of transportation. In addition to geographical factors, we expect our suppliers to meet the requirements including but not limited to areas such as child or forced labour, health and safety, working hours, discrimination and disciplinary processes.

For the Reporting Period, the number of suppliers by geographical region of the Group was as follows:



透過實施健全的採購及招標機制，我們根據機會均等及公平競爭原則自潛在組織甄選可靠及能力勝任的業務夥伴。

具體而言，我們維持已批准的供應商及分包商名單，同時進行定期審查，以確保我們的供應商、分包商及服務提供商繼續有能力提供穩定可靠的服務及產品。本集團評估及篩選提供材料、產品及服務的分包商，以確保其符合我們終端客戶的標準及採購要求。本集團挑選供應商乃基於以下因素：所供應產品的環保合規性、材料質量、以及任何有關向本集團供應商品的潛在利益衝突的背景事宜。

展望未來，本集團計劃優先選用本地供應商以縮短運輸距離，從而促進本地經濟發展及減少碳足跡。除地區因素外，我們期望供應商符合以下方面的要求，包括但不限於童工或強制勞工、健康與安全、工時、歧視和紀律程序。

於報告期內，本集團按地區劃分的供應商數目如下：

## PRODUCT RESPONSIBILITY

The Group considers customer satisfaction is a key factor to the success of project management. The Group strives to understand and integrate customers' needs into our architectural design and planning of construction sites management. To meet the demand of our clients, the Group has developed its internal management system and closely monitored its project execution process, with an aim to render premium and reliable service to our clients.

In our prefabricated construction business, we have established and implemented a quality management system (“**QMS**”) in our operations, which conforms with internationally recognised ISO 9001:2015 standard in Hong Kong. This system helps us to comply with relevant laws, regulations and contract obligations that are applicable to our products and services; control quality issues systematically to enhance our customers' satisfaction; as well as continuously improve quality performance in our operations. The Group also provides adequate training to all levels of employees to raise their awareness of QMS in their responsible tasks. For instance, the design, production and supply of our product, Ready Mixed Concrete, has obtained the Quality Scheme for the Production and Supply of Concrete (“**QSPSC**”) under the Hong Kong Quality Assurance Agency.

For the Reporting Period, we received no complaints or claims from our customers arising from the quality issues of the work performed either by us or our sub-contractors, which in the view of Directors, is attributable to the effective quality control measures.

In our ordinary course of business, we would hardly have access to confidential information of our clients. However, we attach great attention to the protection of privacy and intellectual property. In compliance with the Personal Data (Privacy) Ordinance, Laws of Hong Kong, we ensure that all the collected business data from our clients will be treated as strictly confidential and properly dealt with by our staff. Our clients' data can only be accessed by designated personnel to prevent information leakage to unauthorised persons or parties.

## 產品責任

本集團認為客戶滿意度是項目管理成功的關鍵因素。本集團致力了解客戶需求並將其融入我們的建築設計及建築工地管理規劃中。為滿足客戶需要，本集團已制定內部管理制度，對其項目執行流程進行嚴密監控，務求為客戶提供優質可靠的服務。

就我們的裝配式建築業務而言，我們已於營運中制定並執行一套符合香港的國際認可 ISO 9001：2015 標準的質量管理系統（「**質量管理系統**」）。此系統有助我們遵守適用於我們的產品及服務的有關法律、法規及合約責任；控制系統性質量問題以提高客戶滿意度並持續改善我們營運的質量表現。本集團亦為各級僱員提供充裕培訓，提升僱員進行所負責工作時的質量管理系統意識。例如，我們的產品——預拌混凝土之設計、生產及供應已符合香港品質保證局制定的混凝土生產和供應質量規範（「**混凝土生產和供應質量規範**」）。

於報告期內，我們概無因我們或分包商開展的工作出現質量問題而接獲客戶投訴或索償，董事認為此乃得益於有效的質量控制措施。

於日常業務過程中，我們較少接觸到客戶的機密資料，但我們仍然高度重視對私隱及知識產權的保護。我們遵守香港法例《個人資料（私隱）條例》，確保員工對向客戶收集的所有商業資料嚴格保密並妥善處理。只有特定人員能夠評估我們的客戶資料，以避免向未經許可人士洩漏資料。



On respecting intellectual property (“IP”) rights, employees should also refrain from having unlicensed computer software on their computers at the workplace. The Group complies with applicable laws and regulations relevant to IP right to protect the interest of the Group and our clients. We also request our suppliers to comply with such laws and regulations.

With respect to fair advertising, the Group requires the employees of the sales department to provide customers with accurate and true information on the Group’s products and services. Hotline and e-mail are also available for customers’ enquiries on service details in order to provide better before and after-sale services.

For the Reporting Period, the Group was not aware of any cases of non-compliance with laws and regulations that have a significant impact on the Group in relation to health and safety, advertising, labelling, and privacy matters related to products and services provided.

## ANTI-CORRUPTION

We believe in fairness and honesty in business dealing and we do not tolerate corruption, bribery, money laundering and other fraudulent activities in connection with any of our business operations. The Group strictly adhere to relevant regulations and laws, such as the Prevention of Bribery Ordinance, the Anti-Money Laundering and Counter-Terrorist Financing Ordinance, Laws of Hong Kong, and the Criminal Law of the PRC.

To facilitate the identification of suspected cases of corruption, money laundering and other misconducts, the Group has developed a whistle-blowing policy as stated in our staff handbook. Employees are prohibited from accepting or offering any advantages, including but not limited to rewards, gifts, fees, loans, services, from or to any clients, suppliers or person having a business relationship with the Group. In the event that they identify any irregularities, staff can report to senior management or the audit committee of the Group as they see fit, and we will protect the identity of the whistleblower. Detailed investigation on the reported event shall be conducted and would be followed by appropriate actions according to the result.

在尊重知識產權（「知識產權」）方面，僱員亦應避免在工作場所使用未經授權的電腦軟件。本集團遵守與知識產權有關的法律及法規，從而保障本集團及客戶的權益。我們亦要求供應商遵守該等法律及法規。

在公平廣告方面，本集團規定銷售部員工向客戶提供本集團準確、真實的產品及服務資料。客戶亦可通過熱線及電子郵件查詢服務詳情，提供優質售前售後服務。

於報告期內，本集團概不知悉任何違反關於所提供產品及服務的健康與安全、廣告、標籤及隱私事宜以及補救方法的法律及法規，因而對本集團構成重大影響的事件。

## 反貪污

我們信奉公平及誠信的商業交易，不容忍在我們經營任何業務中的貪污、賄賂、洗黑錢及其他欺詐活動。本集團嚴格遵守相關規例及法例，例如香港法例《防止賄賂條例》、《打擊洗黑錢及恐怖分子資金籌集條例》及《中華人民共和國刑法》。

為便於查明涉嫌貪污、洗黑錢及其他不當行為事件，本集團已制定舉報政策，載於我們的員工手冊。禁止僱員接受任何客戶、供應商或與本集團存在業務關係的人士或向其提供任何利益，包括但不限於獎勵、禮物、費用、貸款、服務。倘彼等發現任何違規行為，員工可酌情向高級管理層或本集團審核委員會報告，我們將保護舉報人的身份。我們將對所報告的事件進行詳細調查，然後根據結果採取適當行動。



The tendering process is vital to our business and all tendering documents are kept confidential and restricted to concerned parties only. It must be done in a fair manner in order to protect the interest of the Group and our clients. Employees responsible for tendering must comply with the Competition Ordinance, Laws of Hong Kong, refraining themselves exchanging or communicating any sensitive information with competitors, participating in price-fixing, imposing restrictions on clients, and abusing the dominant market position.

Due to the pandemic situation in the Reporting Period, the Group provided our employees with a wide range of corruption prevention guides and training resources developed by The Corruption Prevention Department of Independent Commission Against Corruption through internal email. The event aimed to help our employees to understand the basics of anti-corruption laws and uphold a high standard of integrity.

For the Reporting Period, the Group was not aware of any cases of non-compliance with laws and regulations that have a significant impact on the Group in relation to bribery, extortion, fraud, and money laundering.

## GIVING BACK TO THE COMMUNITY

We are committed to supporting the community by incorporating social participation and contribution into our strategic development. We believe that this will nurture a sound corporate culture and good practices in the Group. We will continue to adhere to our core philosophy of “Building a Green World” and the ideology of “green building and green life” with quality, innovation and effectiveness and achieve our business expansion.

投標流程對我們的業務至關重要，所有投標文件均會保密，僅限有關人士查閱。投標必須公平進行，以保護本集團及客戶的利益。負責投標的僱員須遵守香港法例《競爭條例》，不得與競爭對手交換或交流任何敏感信息、參與合謀定價、對客戶施加限制及濫用市場主導地位。

由於報告期內的疫情，本集團通過內部電子郵件向員工提供由廉政公署防止貪污處編製的一系列針對不同範疇的防貪錦囊及培訓資源。該活動旨在幫助我們的員工了解反貪污法律的基本知識並維持高標準的誠信。

於報告期內，本集團概不知悉任何違反與賄賂、勒索、欺詐及洗黑錢有關且對本集團有重大影響的法例及規例事件。

## 回饋社區

我們將社會參與及貢獻納入我們的戰略發展，盡力支持社區。我們相信此舉有助於在本集團內部形成優良的企業文化及實踐。我們將繼續秉承「建設綠色世界」核心理念及「綠色建築、綠色生活」思想，以品質、創新、效益實現業務拓展。

In April 2008, the Environmental Protection Department of the Government of the Hong Kong Special Administrative Region, launched the Cleaner Production Partnership Programme in collaboration with the Economic and Information Commission of Guangdong Province to encourage and facilitate Hong Kong-owned factories in Hong Kong and Guangdong to adopt cleaner production technologies and practices, thereby contributing to improving the environment. One of our subsidiaries, Huizhou Precast Building Materials Co. Ltd., has extended its continuous partnership in the programme for years. The Group will continue efforts to make a positive contribution to a cleaner environment by reducing emissions.

With a focus to contribute towards the work safety area, the Group made donations to the Hong Kong General Building Conference that aim to enhance safety awareness through experience sharing and encourage management and frontline staff to implement a safe system of work.

The Group shall keep abreast latest trends and best practices related to environmental protection at construction sites, and workers' health and safety. We also encourage employees to actively participate in community and voluntary work to further the benefits of local communities and render assistance to the needy. Meanwhile, the Group has strengthened its ties and ensured continuous communication with members of the community where it operates, in an effort to advocate a caring and serving spirit.

The basis of eligibility of any participant to the grant of any option shall be determined by the Board (or as the case may be, the independent non-executive Directors) from time to time on the basis of his contribution or potential contribution to the development and growth of the Group.

As at 31 December 2022 and 2021, the number of outstanding share options under the Scheme is 6,200,000 options, representing 0.61% of the total issued Shares. During the Reporting Period, none of share options was granted, exercised, cancelled and lapsed.

The maximum number of entitlement to Shares of each grantee under the Scheme (including exercised, cancelled and outstanding options) in any 12-month period shall not exceed 1% of the total number of the issued Shares. **QUALIFIED OPINION**

We have audited the consolidated financial statements of Glory Flame Holdings Limited (the “**Company**”) and its subsidiaries (collectively referred to as the “**Group**”) set out on pages 98 to 167, which comprise the consolidated statement of financial position as at 31 December 2022, and the consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion section of our report, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2022, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards (“**HKFRSs**”) issued by the Hong Kong Institute of Certified Public Accountants (the “**HKICPA**”) and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

**BASIS FOR QUALIFIED OPINION**

**Prepayment (note 20 to the consolidated financial statements)**

As at 31 December 2022 and 2021, the consolidated statement of financial position included a fully impaired prepayment balance, which was made previously to a supplier in the construction business. For the year ended 31 December 2021, an impairment loss of approximately HK\$21,317,000 was recognised.

**保留意見**

吾等已完成審核列載於第98至167頁朝威控股有限公司（「**貴公司**」）及其附屬公司（統稱「**貴集團**」）之綜合財務報表，此綜合財務報表包括於二零二二年十二月三十一日之綜合財務狀況表與截至該日止年度之綜合損益及其他全面收入表、綜合權益變動表及綜合現金流量表，以及綜合財務報表的附註（包括主要會計政策概要）。

吾等認為，除吾等報告中保留意見的基礎一節所述事項可能產生的影響外，綜合財務報表已根據香港會計師公會（「**香港會計師公會**」）頒佈之香港財務報告準則（「**香港財務報告準則**」）真實而公平地反映 貴集團於二零二二年十二月三十一日之綜合財務狀況，及 貴集團截至該日止年度之財務表現及現金流量，並按照香港公司條例之披露規定妥為編製。

**保留意見的基礎**

**預付款項（綜合財務報表附註20）**

於二零二二年及二零二一年十二月三十一日，綜合財務狀況表包括一項已完全減值的預付款項結餘，該結餘以前是支付予一間建築業務供應商。截至二零二一年十二月三十一日止年度，已確認減值虧損約21,317,000港元。

The Group and the supplier have entered into a supplemental agreement (“**Supplemental Agreement**”) on 16 March 2021, which stated that (i) The supplier would partially refund RMB7.0 million to the Group by March 2021; (ii) Should the Group be unable to enter into any new business with the supplier before 31 August 2021, the supplier would partially refund another RMB7.0 million to the Group; and (iii) Should the Group be unable to enter into any new business with the supplier before 31 December 2021, the rest amount of RMB12.1 million would be refunded to the Group.

The first partial refund of RMB7.0 million was received by the Group in March 2021 in accordance with the terms as stated in the Supplemental Agreement. Yet, the second partial refund and the final refund of totaling RMB19.1 million (equivalent to approximately HK\$21,317,000) were both defaulted. There was no further development for this prepayment balance during the reporting period.

Due to the above uncertainties, the management is not able to provide further evidences in justifying the sufficiency, adequacy and extent of the impairment loss being recognised. Accordingly, we are not able to obtain sufficient appropriate audit evidences to ascertain the recoverability of the aforesaid balances as at 31 December 2022 and 2021. There is no other satisfactory audit procedures that we could perform to satisfy ourselves whether the aforesaid balance of HK\$nil are fairly stated as at 31 December 2022 and 2021, respectively. Consequently, we are not able to obtain sufficient appropriate audit evidences on whether the profit or loss effect on the provision for impairment loss on aforesaid balance of approximately HK\$21,317,000 for the year ended 31 December 2021 is properly stated, respectively.

Any adjustments to the figures as described above might have a consequential effect on the Group's financial performance and cash flows for the year ended 31 December 2022 and 2021 and the financial position of the Group as at 31 December 2022 and 2021, and the related disclosures thereof in the consolidated financial statements.

貴集團與供應商已於二零二一年三月十六日簽訂補充協議（「**補充協議**」），當中訂明(i) 供應商將在二零二一年三月前向 貴集團退還部分金額人民幣7,000,000元；(ii) 倘 貴集團未能在二零二一年八月三十一日前與供應商訂立任何新業務，供應商將向 貴集團再退還部分金額人民幣7,000,000元；及(iii) 倘 貴集團未能於二零二一年十二月三十一日前與供應商訂立任何新業務，則剩餘的人民幣12,100,000元將退還予 貴集團。

貴集團於二零二一年三月根據補充協議所述條款收到第一筆部分退款人民幣7,000,000元。然而，總額為人民幣19,100,000元（相等於約21,317,000港元）的第二筆部分退款及最終退款均被拖欠。於報告期間，該預付款項餘額並無進一步發展。

由於上述不確定性，管理層無法提供進一步證據證明已確認減值虧損的充分性、足夠性及程度。因此，吾等無法獲取充分及適當的審計證據，以確定上述結餘於二零二二年及二零二一年十二月三十一日的可收回性。吾等並無其他可執行之適當審核程序，以使吾等信納是否已公平呈列上述於二零二二年及二零二一年十二月三十一日之結餘零港元。因此，吾等無法獲取充分及適當的審計證據，以確認是否已適當地分別就截至二零二一年十二月三十一日止年度上述結餘之減值虧損撥備約21,317,000港元的損益影響作出撥回。

對上述數字的任何調整可能會對 貴集團截至二零二二年及二零二一年十二月三十一日止年度的財務表現及現金流量、 貴集團於二零二二年及二零二一年十二月三十一日的財務狀況以及其在綜合財務報表中的相關披露產生後續影響。

We conducted our audit in accordance with Hong Kong Standards on Auditing (“**HKSAs**”) issued by the HKICPA. Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Consolidated Financial Statements section of our report. We are independent of the Group in accordance with the HKICPA’s Code of Ethics for Professional Accountants (the “**Code**”), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified opinion.

## MATERIAL UNCERTAINTY RELATED TO GOING CONCERN

We draw attention to note 2 to the consolidated financial statements which states that the Group incurred loss attributable to owners of the Company of approximately HK\$10,329,000 for the year ended 31 December 2022 and as at 31 December 2022, the Group had net liabilities of approximately HK\$825,000. These conditions indicate the existence of a material uncertainty which may cast significant doubt on the Group’s ability to continue as a going concern. Our opinion is not modified in respect of this matter.

## KEY AUDIT MATTERS

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. In addition to the matters described in the Basis for Qualified Opinion section and the Material Uncertainty Related to Going Concern Section, we have determined the matters described below to be the key audit matters to be communicated in our report.

## 有關持續經營之重大不確定性

吾等謹請 閣下注意綜合財務報表附註2，當中說明 貴集團於截至二零二二年十二月三十一日止年度及於二零二二年十二月三十一日產生 貴公司擁有人應佔虧損約10,329,000港元，且 貴集團之負債淨值為約825,000港元。該等情況顯示存在重大不確定性，可能對本集團持續經營的能力產生重大疑慮。吾等就該事宜的意見並無修改。

## 關鍵審核事項

關鍵審核事項為吾等的專業判斷中，審核本期綜合財務報表中最重要的事項。吾等於審核整體綜合財務報表處理此等事項及就此形成意見，而不會就此等事項單獨發表意見。除於保留意見的基礎及有關持續經營之重大不確定性一節所述事項外，吾等已釐定以下事項為於吾等的報告中將予傳達之關鍵審核事項。

## TRADE AND OTHER RECEIVABLES

Refer to note 20 to the consolidated financial statements.

The Group tested the amount of trade and other receivables for recoverability. Apart from the prepayment mentioned in the Basis for Qualified Opinion, this recoverability review is significant to our audit because the balance of trade and other receivables of approximately HK\$71,321,000 as at 31 December 2022 is material to the consolidated financial statements. In addition, the Group's recoverability review involves application of judgement and is based on estimates.

Our audit procedures included, among others:

- Assessing the Group's procedures on granting credit limits and credit periods to customers and debtors;
- Assessing the Group's relationship and transaction history with the customers and debtors;
- Evaluating the Group's recoverability assessment;
- Assessing ageing of the debts;
- Assessing creditworthiness of the customers and debtors;
- Checking subsequent settlements from the customers and debtors; and
- Assessing the disclosure of the Group's exposure to credit risk in the consolidated financial statements.

We consider that the Group's recoverability review for trade and other receivables is supported by the available evidence.

## 貿易及其他應收款項

貴集團對貿易及其他應收款項金額之可收回程度進行測試。除於保留意見的基礎所述事項外，此可收回程度審查可能出現的結果對吾等之審計尤其重要，由於截至二零二二年十二月三十一日的貿易及其他應收款項結餘約71,321,000港元為綜合財務報表重要的部分。另外，貴集團之可收回程度測試涉及有關判斷之應用並以估計為基礎。

吾等採用之審計程序包括（其中包括）：

- 評估 貴集團授予客戶及債權人信貸額度及信貸期限之程序；
- 評估 貴集團與客戶及債權人之關係與交易記錄；
- 評估 貴集團之可收回程度評估；
- 評估債務之賬齡；
- 評估客戶及債權人之信譽；
- 評估客戶及債權人之期後結算事宜；及
- 評估 貴集團在綜合財務報表有關信貸風險之披露。

吾等認為 貴集團就貿易及其他應收款項之可收回程度審查有憑證支持。



## OTHER INFORMATION

The directors of the Company (the “**Directors**”) are responsible for the other information. The other information comprises all the information in the Company’s annual report, but does not include the consolidated financial statements and our auditor’s report thereon.

Our opinion on the consolidated financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the consolidated financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the consolidated financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. As described in the Basis for Qualified Opinion section above, we were unable to obtain sufficient appropriate evidence about the certain prepayment. Accordingly, we are unable to conclude whether or not the other information is materially misstated with respect to this matter.

## RESPONSIBILITIES OF DIRECTORS FOR THE CONSOLIDATED FINANCIAL STATEMENTS

The Directors are responsible for the preparation of the consolidated financial statements that give a true and fair view in accordance with HKFRSs issued by the HKICPA and the disclosure requirements of the Hong Kong Companies Ordinance, and for such internal control as the Directors determine is necessary to enable the preparation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the consolidated financial statements, the Directors are responsible for assessing the Group’s ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Directors either intend to liquidate the Group or to cease operations, or have no realistic alternative but to do so.

## 其他信息

貴公司董事（「**董事**」）需對其他信息負責。其他信息包括刊載於 貴公司年報內的全部信息，但不包括綜合財務報表及吾等的核數師報告。

## 1. GENERAL INFORMATION

Glory Flame Holdings Limited (the “**Company**”) was incorporated in the Cayman Islands on 25 April 2014 as an exempted company with limited liability under the Companies Law of the Cayman Islands. The address of its registered office is Windward 3, Regatta Office Park, PO Box 1350, Grand Cayman KY1-1108, Cayman Islands. The address of the Company’s principal place of business in Hong Kong is Suite 821, 8th Floor, Ocean Centre, Harbour City, 5 Canton Road, Tsim Sha Tsui, Kowloon, Hong Kong. The Company’s shares are listed on GEM of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The Company is an investment holding company. The principal activities of its subsidiaries are set out in note 31 to the consolidated financial statements.

## 2. GOING CONCERN BASIS

The Group incurred a loss attributable to the owners of the Company of approximately HK\$10,329,000 for the year ended 31 December 2022 and as at 31 December 2022, the Group has net liabilities of approximately HK\$825,000. These conditions indicate the existence of a material uncertainty which may cast significant doubt on the Group’s ability to continue as a going concern. Therefore, the Group may be unable to realise its assets and discharge its liabilities in the normal course of business.

The Directors have been undertaking a number of plans and measures to improve the Group’s liquidity and financial position, including:

- (i) the Directors have reviewed the Group’s cash flow projection prepared by management, which covered a period of not less than twelve months from 31 December 2022. In the opinion of the Directors, the Group will have sufficient working capital to meet its financial obligations as and when they fall due and carry on its business without a significant curtailment of operations not less than twelve months from 31 December 2022. Accordingly, the consolidated financial statements have been prepared on a going concern basis;

## 1. 一般資料

朝威控股有限公司（「**本公司**」）於二零一四年四月二十五日根據開曼群島公司法在開曼群島註冊成立為獲豁免有限公司。本公司的註冊辦事處位於 Windward 3, Regatta Office Park, PO Box 1350, Grand Cayman KY1-1108, Cayman Islands。本公司的香港主要營業地點位於香港九龍尖沙咀廣東道5號海港城海洋中心8樓821室。本公司股份於香港聯合交易所有限公司（「**聯交所**」）GEM上市。

本公司為一間投資控股公司。其附屬公司之主要業務載列於綜合財務報表附註31。

## 2. 持續經營基礎

本集團於截至二零二二年十二月三十一日止年度產生本公司擁有人應佔虧損約10,329,000港元，且本集團於二零二二年十二月三十一日之負債淨值為約825,000港元。該等情況顯示存在重大不確定性，可能對本集團持續經營的能力產生重大疑慮。因此，本集團可能無法於正常業務過程中變現其資產並清償其負債。

董事一直在採取多項計劃及措施以改善本集團之流動資金及財務狀況，包括：

- (i) 董事已審閱管理層編製之本集團現金流量預測，該預測涵蓋自二零二二年十二月三十一日起不少於十二個月的期間。董事認為，自二零二二年十二月三十一日起不少於十二個月，本集團將有充足營運資金履行其到期財務責任，並在不顯著削減營運的情況下開展業務。因此，綜合財務報表乃按持續經營基礎編製；

## 2. GOING CONCERN BASIS (Continued)

- (ii) the borrower of the other loan executed a letter agreed not to demand for repayment for other loan with principal of HK\$40,000,000 and the accrued interest until the Group can meet all the other financial obligations of the Group and willing to negotiate with the Group when the terms mature;
- (iii) the holder of the bonds payables executed a letter agreed not to demand for repayment for bonds payables with principal of HK\$5,800,000 and the accrued interest until the Group can meet all the other financial obligations of the Group and willing to negotiate with the Group when the terms mature; and
- (iv) the Group shall implement cost-saving measures to maintain adequate cash flows for the Group's operations.

Based on the cash flow projection of the Group and having taken into account the available financial resources of the Group and the above measures, the Directors consider that the Group will have sufficient working capital to finance its operations and meet its financial obligations as and when they fall due in the foreseeable future, and accordingly, are satisfied that it is appropriate to prepare the consolidated financial statements on a going concern basis.

Should the Group be unable to continue as a going concern, adjustments would have to be made to the consolidated financial statements to adjust the value of the Group's assets to their recoverable amounts, to provide for any further liabilities which might arise and to reclassify non-current assets and liabilities as current assets and liabilities, respectively.

- (ii) 其他貸款的借款人已簽立一份函件，同意不會要求償還本金為40,000,000港元的其他貸款及應計利息，直至本集團能夠履行本集團的所有其他財務責任並願意於年期屆滿時與本集團磋商為止；
- (iii) 應付債券持有人簽立一份函件，同意不會要求償還本金為5,800,000港元的應付債券及應計利息，直至本集團能夠履行本集團所有其他財務責任並願意於年期屆滿時與本集團磋商為止；及
- (iv) 本集團應實施節約成本的措施，為本集團的經營維持充足現金流。

根據本集團的現金流量預測並考慮本集團的可用財務資源及上述措施後，董事認為，本集團將擁有充足營運資金於可預見的未來為其營運提供資金及履行其到期財務責任，因此，董事信納按持續經營基礎編製綜合財務報表乃屬適當。

倘本集團無法持續經營，則必須對綜合財務報表進行調整，以將本集團資產的價值調整至其可收回金額，為可能產生的任何進一步負債計提撥備，並分別將非流動資產及負債重新分類為流動資產及負債。

### 3. ADOPTION OF NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS

In the current year, the Group has adopted all the new and revised Hong Kong Financial Reporting Standards (“**HKFRSs**”) issued by the Hong Kong Institute of Certified Public Accountants (the “**HKICPA**”) that are relevant to its operations and effective for its accounting year beginning on 1 January 2022. HKFRSs comprise Hong Kong Financial Reporting Standards (“**HKFRS**”); Hong Kong Accounting Standards (“**HKAS**”); and Interpretations. The adoption of these new and revised HKFRSs did not result in significant changes to the Group’s accounting policies, presentation of the Group’s consolidated financial statements and amounts reported for the current year and prior years.

The Group has not applied the new and revised HKFRSs that have been issued but are not yet effective. The Group has already commenced an assessment of the impact of these new and revised HKFRSs but is not yet in a position to state whether these new and revised HKFRSs would have a material impact on its results of operations and financial position.

### 3. 採納新訂及經修訂香港財務報告準則

於年內，本集團已採納香港會計師公會（「香港會計師公會」）頒佈與其營運相關，並於二零二二年一月一日會計年度起生效的所有新訂及經修訂香港財務報告準則（「香港財務報告準則」）。香港財務報告準則包括香港財務報告準則（「香港財務報告準則」）、香港會計準則（「香港會計準則」）及詮釋。除以下所述者外，採納該等新訂及經修訂香港財務報告準則並無導致本集團於本年度及過往年度的會計政策、本集團綜合財務報表之呈列方式及所呈報金額出現重大變動。

本集團尚未採納已頒佈但尚未生效之新訂及經修訂香港財務報告準則。本集團已著手評估該等新訂及經修訂香港財務報告準則之影響，但尚無法確定該等新訂及經修訂香港財務報告準則是否會對其經營業績及財務狀況產生重大影響。



#### 4. SIGNIFICANT ACCOUNTING POLICIES

These consolidated financial statements have been prepared in accordance with HKFRSs issued by HKICPA, accounting principles generally accepted in Hong Kong and the applicable disclosures required by the Rules Governing the Listing of Securities on GEM of the Stock Exchange and by the Hong Kong Companies Ordinance.

These consolidated financial statements have been prepared under the historical cost convention. These consolidated financial statements are presented in Hong Kong dollars (“**HK\$**”) and all values are rounded to the nearest thousand except when otherwise indicated.

The preparation of consolidated financial statements in conformity with HKFRSs requires the use of certain key assumptions and estimates. It also requires the directors to exercise its judgements in the process of applying the accounting policies. The areas involving critical judgements and areas where assumptions and estimates are significant to these consolidated financial statements, are disclosed in note 5 to the consolidated financial statements.

The significant accounting policies applied in the preparation of these consolidated financial statements are set out below.

##### Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 31 December. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity’s returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties, to determine whether it has control. A potential voting right is considered only if the holder has the practical ability to exercise that right.

#### 4. 主要會計政策

本綜合財務報表乃根據香港會計師公會頒佈的香港財務報告準則、香港公認的會計原則及聯交所創業板證券上市規則及香港公司條例規定的適用披露編製。

本綜合財務報表乃根據歷史成本慣例編製。本綜合財務報表乃以港元（「**港元**」）呈列，除另有指明外，所有數值已四捨五入至最接近的千位數。

編製符合香港財務報告準則的綜合財務報表需要使用若干關鍵假設及估算。這亦需要管理層在應用會計政策過程中作出判斷。涉及批判性判斷的範疇以及涉及對綜合財務報表屬重大假設及估算的範疇，在附註5中披露。

編製本綜合財務報表所應用之主要會計政策載列如下。

##### 綜合

綜合財務報表包括本公司及其附屬公司截至十二月三十一日止之財務報表。附屬公司指本集團擁有控制權之實體。當本集團承受或享有參與實體所得之可變回報，且有能力透過其對實體之權力影響該等回報時，則本集團控制該實體。當本集團之現有權力賦予其目前掌控有關業務（即大幅影響實體回報之業務）之能力時，則本集團對該實體擁有權力。

在評估控制權時，本集團會考慮其潛在投票權以及其他人士持有之潛在投票權，以釐定其是否擁有控制權。僅在持有人能實際行使潛在投票權之情況下，方會考慮潛在投票權。

#### 4. SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### Consolidation (Continued)

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are de-consolidated from the date the control ceases.

The gain or loss on the disposal of a subsidiary that results in a loss of control represents the difference between (i) the fair value of the consideration of the sale plus the fair value of any investment retained in that subsidiary and (ii) the Company's share of the net assets of that subsidiary plus any remaining goodwill relating to that subsidiary and any related accumulated foreign currency translation reserve.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests represent the equity in subsidiaries not attributable, directly or indirectly, to the Company. Non-controlling interests are presented in the consolidated statement of financial position and consolidated statement of changes in equity within equity. Non-controlling interests are presented in the consolidated statement of profit or loss and other comprehensive income as an allocation of profit or loss and total comprehensive income for the year between the non-controlling shareholders and owners of the Company.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling shareholders even if this results in the non-controlling interests having a deficit balance.

##### 綜合 (續)

附屬公司之賬目由其控制權轉至本集團當日起綜合入賬，並於控制權終止當日起不再綜合入賬。

致使控制權喪失之出售一間附屬公司之盈虧為(i)出售代價公平值加於該附屬公司保留之任何投資之公平值，及(ii)本公司應佔該附屬公司之資產淨值加任何有關該附屬公司之餘下商譽以及任何有關累計外幣匯兌儲備兩者之間之差額。

集團內公司間之交易、結餘及未變現溢利予以對銷。除非交易提供已轉讓資產出現減值之憑證，否則未變現虧損亦予以對銷。附屬公司之會計政策已於必要時作出更改，以確保與本集團所採納之政策一致。

非控股權益指本公司不直接或間接應佔之附屬公司權益。非控股權益乃於綜合財務狀況表及綜合權益變動表之權益內呈列。於綜合損益及其他全面收入表內，非控股權益呈列為年內溢利或虧損及全面收入總額於非控股股東與本公司擁有人之間的分配。

損益及其他全面收入各成份歸屬於本公司擁有人及非控股股東，即使導致非控股權益出現赤字結餘。

#### 4. SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### Business combination and goodwill

The acquisition method is used to account for the acquisition of a subsidiary in a business combination. The cost of acquisition is measured at the acquisition-date fair value of the assets given, equity instruments issued, liabilities incurred and contingent consideration. Acquisition-related costs are recognised as expenses in the periods in which the costs are incurred and the services are received. Identifiable assets and liabilities of the subsidiary in the acquisition are measured at their acquisition-date fair values.

The excess of the cost of acquisition over the Company's share of the net fair value of the subsidiary's identifiable assets and liabilities is recorded as goodwill. Any excess of the Company's share of the net fair value of the identifiable assets and liabilities over the cost of acquisition is recognised in consolidated profit or loss as a gain on bargain purchase which is attributed to the Company.

Goodwill is tested annually for impairment or more frequently if events or changes in circumstances indicate that it might be impaired. Goodwill is measured at cost less accumulated impairment losses. The method of measuring impairment losses of goodwill is the same as that of other assets as stated in the accounting policy below. Impairment losses of goodwill are recognised in consolidated profit or loss and are not subsequently reversed. Goodwill is allocated to cash-generating units that are expected to benefit from the synergies of the acquisition for the purpose of impairment testing.

The non-controlling interests in the subsidiary are initially measured at the non-controlling shareholders' proportionate share of the net fair value of the subsidiary's identifiable assets and liabilities at the acquisition date.

##### 業務合併及商譽

本集團採用收購法為業務合併中所收購之附屬公司列賬。收購成本乃按所獲資產、所發行之股本工具、所產生之負債及或然代價於收購日期之公平值計量。收購相關成本於有關成本產生及接獲服務期間確認為開支。於收購時，附屬公司之可識別資產及負債，均按其於收購日期之公平值計量。

收購成本超出本公司應佔附屬公司可識別資產及負債之公平淨值之差額乃列作商譽。本公司應佔可識別資產及負債之公平淨值超出收購成本之差額乃於綜合損益內確認為本公司應佔之議價購買收益。

商譽會每年進行減值測試或當事件或情況改變顯示可能減值時則更頻繁地進行減值測試。商譽乃按成本減累計減值虧損計量。商譽減值虧損之計量方法與下文會計政策內所述其他資產之計量方法相同。商譽之減值虧損於綜合損益確認，隨後不予撥回。就減值測試而言，商譽分配至預期會因收購協同效益而產生利益之現金產生單位。

於附屬公司的非控股權益初步以收購日期非控股股東應佔附屬公司可識別資產及負債之公平淨值的比例計量。

#### 4. SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### Foreign currency translation

(i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the “**functional currency**”). The consolidated financial statements are presented in HK\$, which is the Company's functional and presentation currency.

(ii) Transactions and balances in each entity's financial statements

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.

(iii) Translation on consolidation

The results and financial position of all the Group entities that have a functional currency different from the Company's presentation currency are translated into the Company's presentation currency as follows:

- (i) Assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- (ii) Income and expenses are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the exchange rates on the transaction dates); and
- (iii) All resulting exchange differences are recognised in the foreign currency translation reserve.

##### 匯兌換算

(i) 功能及呈列貨幣

本集團各實體財務報表內所包括項目，均利用該實體經營的主要經濟環境的貨幣（「**功能貨幣**」）計量。綜合財務資料以港元呈列，港元為本公司之功能及呈列貨幣。

(ii) 於各實體財務報表中的交易及結餘

外幣交易於初始確認時使用交易日期之通行匯率換算為功能貨幣。以外幣為單位之貨幣資產及負債按各報告期末之匯率換算。此換算政策產生之盈虧於損益內確認。

(iii) 綜合換算

功能貨幣與呈列貨幣與本公司不同的所有集團實體的業績及財務狀況，均按以下方法換算為本公司的呈列貨幣：

- (i) 呈列於每份財務狀況表的資產及負債，均以財務狀況表的收市匯率換算；
- (ii) 每份損益及其他全面收入表的收入及支出，均按平均匯率換算（惟該平均值並非有關交易日通行匯率累積影響的合理近似值則作別論，在此情況收入及支出均按交易日匯率換算）；及
- (iii) 所有最終匯兌差額於其他全面收入內確認。

#### (iii) Translation on consolidation (Continued)

On consolidation, exchange differences arising from the translation of the net investment in foreign entities and of borrowings are recognised in the foreign currency translation reserve. When a foreign operation is sold, such exchange differences are recognised in consolidated profit or loss as part of the gain or loss on disposal.

Goodwill and fair value adjustments arising on the acquisition of a foreign entity are treated as assets and liabilities of the foreign entity and translated at the closing rate.

### Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance are recognised in profit or loss during the period in which they are incurred.

Depreciation of property, plant and equipment is calculated at rates sufficient to write off their cost less their residual values over the estimated useful lives on a straight-line basis. The principal annual rates are as follows:

– Plant and machinery	: 25%
– Furniture and fixtures	: 20%
– Motor vehicles	: 10% – 25%
– Decoration	: 20% – 50%
– Office equipment	: 20% – 33%

The residual values, useful lives and depreciation method are reviewed and adjusted, if appropriate, at the end of each reporting period.

#### (iii) 綜合換算 (續)

於綜合賬目時，換算境外實體之投資淨額及借貸所產生之匯兌差額於外幣匯兌儲備內確認。當境外業務被出售時，有關匯兌差額作為出售之盈利或虧損之一部份於綜合損益內確認。

收購一間海外實體所產生的商譽及公平值被視為海外實體的資產及負債，並按收市匯率計算。

### 物業、廠房及設備

物業、廠房及設備乃以成本減累積折舊及減值虧損後入賬。

其後成本只有在與該資產有關的未來經濟利益有可能流入本集團，而該項目的成本能可靠計量時，才包括在項目的賬面值或確認為獨立資產（按適用）。所有其他維修及保養成本在產生的財政期間內於損益內扣除。

物業、廠房及設備的折舊採用估計可使用年期將成本按直線法分攤至剩餘價值計算。主要年率如下：

– 廠房及機器	: 25%
– 傢俬及裝置	: 20%
– 汽車	: 10% – 25%
– 裝飾	: 20% – 50%
– 辦公設備	: 20% – 33%

資產的剩餘價值、可使用年期及折舊方法在報告期末進行檢討，及在適當時調整。

##### Property, plant and equipment (Continued)

The gain or loss on disposal of property, plant and equipment is the difference between the net sales proceeds and the carrying amount of the relevant asset, and is recognised in profit or loss.

##### Leases

###### The Group as lessee

Leases are recognised as right-of-use assets and corresponding lease liabilities when the leased assets are available for use by the Group. Right-of-use assets are stated at cost less accumulated depreciation and impairment losses. Depreciation of right-of-use assets is calculated at rates to write off their cost over the shorter of the asset's useful life and the lease term on a straight-line basis. The principal annual rates are as follows:

<u>Land and buildings</u>	
- Offices	: 5% – 50%
- Warehouse	: 50%

Right-of-use assets are measured at cost comprising the amount of the initial measurement of the lease liabilities, lease payments prepaid, initial direct costs and the restoration costs. Lease liabilities include the net present value of the lease payments discounted using the interest rate implicit in the lease if that rate can be determined, or otherwise the Group's incremental borrowing rate. Each lease payment is allocated between the liability and finance cost. The finance cost is charged to profit or loss over the lease term so as to produce a constant periodic rate of interest on the remaining balance of the lease liability.

Payments associated with short-term leases and leases of low-value assets are recognised as expenses in profit or loss on a straight-line basis over the lease terms. Short-term leases are leases with an initial lease term of 12 months or less. Low-value assets are assets of value below US\$5,000.

##### 物業、廠房及設備 (續)

出售物業、廠房及設備之收益或虧損為相關資產的出售所得款項淨額與賬面值之間的差額，並確認於綜合損益。

##### 租賃

###### 本集團作為承租人

租賃於租賃資產可供本集團使用時確認為使用權資產及相應租賃負債。使用權資產乃以成本減累積折舊及減值虧損後入賬。使用權資產折舊一般按照直線法在資產使用年期與租賃期兩者中較短者內以撇銷其成本的利率計算。主要年率如下：

<u>土地及樓宇</u>	
- 辦公室	: 5% – 50%
- 倉庫	: 50%

使用權資產按成本計量，包括租賃負債的初步計量金額、預付租賃款項、初始直接成本及復原成本。租賃負債包括租賃隱含的使用實際利率貼現之租賃付款現值，條件為該利率可予釐定，否則按本集團之增量借貸利率計算。各項租賃付款在負債與財務成本之間分攤。財務成本在租賃期限內計入損益，以使租賃負債餘額產生的利息率保持一致。

與短期租賃及低價值資產租賃有關的付款在租賃期內按直線法於損益確認為開支。短期租賃為初始租賃期為12個月或更短的租賃。低價值資產為價值低於5,000美元的資產。

### Leases (Continued)

#### The Group as lessor

##### Operating leases

Leases that do not substantially transfer to the lessees all the risks and rewards of ownership of assets are accounted for as operating leases. Rental income from operating leases is recognised on a straight-line basis over the term of the relevant lease.

### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the first-in-first-out method. The cost of finished goods comprises raw materials, direct labour and an appropriate proportion of all production overhead expenditure, and where appropriate, subcontracting charges. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

### Recognition and derecognition of financial instruments

Financial assets and financial liabilities are recognised in the statement of financial position when the Group becomes a party to the contractual provisions of the instruments.

Financial assets are derecognised when the contractual rights to receive cash flows from the assets expire; the Group transfers substantially all the risks and rewards of ownership of the assets; or the Group neither transfers nor retains substantially all the risks and rewards of ownership of the assets but has not retained control on the assets. On derecognition of a financial asset, the difference between the asset's carrying amount and the sum of the consideration received is recognised in profit or loss.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expires. The difference between the carrying amount of the financial liability derecognised and the consideration paid is recognised in profit or loss.

### 租賃 (續)

#### 本集團作為租賃人

##### 經營租賃

並無將資產所有權的絕大部分風險及回報轉移予承租人的租賃列為經營租賃。經營租賃的租金收入在相關租賃期內按直線法確認。

### 存貨

存貨按成本及可變現淨值兩者之間的較低者列賬。成本使用先進先出法釐定。成品之成本包括原材料、直接勞動力及所有生產間接開支的適當部分及(倘適用)分包費用。可變現淨值為日常業務過程中之估計售價減完工的估計成本與達致銷售所需的估計成本。

### 確認及終止確認金融工具

金融資產及金融負債於本集團成為工具合約條文的訂約方時於財務狀況表內確認。

倘自資產收取現金流量的合約權利屆滿；本集團轉移資產所有權的絕大部分風險及回報；或本集團概無轉讓亦不保留資產所有權的絕大部分風險及回報但無保留對資產的控制權，則終止確認金融資產。於終止確認金融資產時，資產賬面值與已收代價總和之間的差額於損益內確認。

倘相關合約訂明的責任獲解除、取消或屆滿，則終止確認金融負債。已終止確認的金融負債的賬面值與已付代價的差額於損益內確認。

#### 4. SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### Financial assets

Financial assets are recognised and derecognised on a trade date basis where the purchase or sale of an asset is under a contract whose terms require delivery of the asset within the timeframe established by the market concerned, and are initially recognised at fair value, plus directly attributable transaction costs except in the case of investments at fair value through profit or loss. Transaction costs directly attributable to the acquisition of investments at fair value through profit or loss are recognised immediately in profit or loss.

Financial assets of the Group are classified under financial assets at amortised cost.

Financial assets (including trade and other receivables) are classified under this category if they satisfy both of the following conditions:

- the assets are held within a business model whose objective is to hold assets in order to collect contractual cash flows; and
- the contractual terms of the assets give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

They are subsequently measured at amortised cost using the effective interest method less loss allowance for expected credit losses.

##### 金融資產

倘根據要求在相關市場中約定的時間內交付該項資產的合約購買或出售資產，則有關金融資產會按交易日基準確認及終止確認，並初步按公平值加直接應佔交易成本確認，按公平值計入損益之投資除外。收購按公平值計入損益之投資直接應佔之交易成本，即時於損益中確認。

本集團將金融資產分類為按攤銷成本計量之金融資產。

符合下列兩項條件的金融資產（包括貿易及其他應收款項）分類至此類別：

- 資產乃按目的為持有資產以收取合約現金流量的業務模式持有；及
- 資產合約條款於特定日期產生現金流量，有關現金流量僅為本金及尚未償還本金之利息付款。

有關項目其後以實際利率法按攤銷成本減去預期信貸虧損之虧損撥備計量。

#### 4. SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### Loss allowances for expected credit losses

The Group recognises loss allowances for expected credit losses on financial assets at amortised cost. Expected credit losses are the weighted average of credit losses with the respective risks of a default occurring as the weights.

At the end of each reporting period, the Group measures the loss allowance for a financial instrument at an amount equal to the expected credit losses that result from all possible default events over the expected life of that financial instrument (“lifetime expected credit losses”) for trade receivables, or if the credit risk on that financial instrument has increased significantly since initial recognition.

If, at the end of the reporting period, the credit risk on a financial instrument (other than trade receivables) has not increased significantly since initial recognition, the Group measures the loss allowance for that financial instrument at an amount equal to the portion of lifetime expected credit losses that represents the expected credit losses that result from default events on that financial instrument that are possible within 12 months after the reporting period.

The amount of expected credit losses or reversal to adjust the loss allowance at the end of the reporting period to the required amount is recognised in profit or loss as an impairment gain or loss.

##### Cash and cash equivalents

For the purpose of the statement of cash flows, cash and cash equivalents represent cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term highly liquid investments which are readily convertible into known amounts of cash and subject to an insignificant risk of change in value. Bank overdrafts which are repayable on demand and form an integral part of the Group’s cash management are also included as a component of cash and cash equivalents.

##### 預期信貸虧損之虧損撥備

本集團按攤銷成本確認金融資產的預期信貸虧損之虧損撥備。預期信貸虧損乃加權平均信貸虧損，並以發生相關違約風險之金額作為加權數值。

於各報告期末，本集團計量金融工具的虧損撥備，金額等於該金融工具預計年期內所有可能違約事件所產生貿易應收款項、合約資產及應收租賃款項的預期信貸虧損（「全期預期信貸虧損」），或自初步確認後該金融工具的信貸風險大幅增加。

倘於報告期末，金融工具（貿易應收款項除外）的信貸風險自初步確認後並無大幅增加，本集團會按相等於反映該金融工具可能於報告期後12個月內發生的違約事件所引致預期信貸虧損的全期預期信貸虧損部分的金額，計量該金融工具之虧損撥備。

於報告期末將虧損撥備調整至所需金額的預期信貸虧損或撥回金額，於損益中確認為減值收益或虧損。

##### 現金及現金等價物

就現金流量表而言，現金及現金等價物指銀行及手頭現金、銀行及其他金融機構的活期存款、以及可隨時兌換為已知數額現金且並無明顯變值風險的短期高流通性投資。須按要求償還並構成本集團現金管理組成部分的銀行透支亦入賬列作現金及現金等價物的一部分。

#### 4. SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### Financial liabilities and equity instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument under HKFRSs. An equity instrument is any contract that evidences a residual interest in the assets of the Group after deducting all of its liabilities. The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

##### Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred, and subsequently measured at amortised cost using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

##### Trade and other payables

Trade and other payables are stated initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

##### Equity instruments

Equity instruments issued by the Company are recorded at the proceeds received, net of direct issue costs.

##### 金融負債及股本工具

金融負債及股本工具按所訂立合約安排的內容及香港財務報告準則中金融負債和股本工具的定義分類。股本工具為證明本集團的資產於扣除其所有負債後的剩餘權益的任何合約。下文載列就特定金融負債及股本工具採納的會計政策。

##### 借貸

借貸初步按公平值扣除所產生之交易成本確認，並其後以實際利率法按攤銷成本值計算。

除非本集團擁有無條件權利，可將負債之償還日期遞延至報告期後至少十二個月，否則借貸被分類為流動負債。

##### 貿易及其他應付款項

貿易及其他應收款項按公平值初始確認，其後使用實際利率法按攤銷成本計量，但貼現影響不大，則以成本計量。

##### 股本工具

本公司所發行的股本工具按已收所得款項（扣除直接發行成本）入賬。



#### 4. SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### Revenue from contracts with customers

Revenue is measured based on the consideration specified in a contract with a customer with reference to the customary business practices and excludes amounts collected on behalf of third parties. For a contract where the period between the payment by the customer and the transfer of the promised product or service exceeds one year, the consideration is adjusted for the effect of a significant financing component.

The Group recognises revenue when it satisfies a performance obligation by transferring control over a product or service to a customer. Depending on the terms of a contract and the laws that apply to that contract, a performance obligation can be satisfied over time or at a point in time. A performance obligation is satisfied over time if:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance;
- the Group's performance creates or enhances an asset that the customer controls as the asset is created or enhanced; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

If a performance obligation is satisfied over time, revenue is recognised by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the product or service.

##### 客戶合約之收益

收益乃根據與客戶訂立的合約所指明的代價參考慣常業務慣例計量，並不包括代表第三方收取的金額。對於客戶付款及轉移協定產品或服務期間超過一年的合約，代價會就重大融資部分的影響進行調整。

本集團於完成向客戶轉讓產品或服務控制權的履約責任時確認收益。視乎合約條款及有關合約適用的法例，履約責任可隨時間或於某個時間點完成。倘屬以下情況，履約責任則可隨時間內達成：

- 客戶同時收取及消耗本集團履約所提供的利益；
- 本集團履約創建或提升一項於創建或提升時由客戶控制的資產；或
- 本集團履約並無創建供本集團用於其他用途的資產，且本集團有權就迄今為止已完成的履約部分強制收回款項。

倘履約責任可隨時間內達成，收益乃根據完成有關履約責任的進度確認。否則，收益於客戶獲得產品或服務控制權的時間點確認。

#### 4. SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### Other revenue

Interest income is recognised on a time-proportion basis using the effective interest method.

Rental income is recognised on a straight-line basis over the lease term.

##### Employee benefits

###### (i) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

###### (ii) Pension obligations

The Group contributes to defined contribution retirement schemes which are available to all employees. Contributions to the schemes by the Group and employees are calculated as a percentage of employees' basic salaries. The retirement benefit scheme cost charged to profit or loss represents contributions payable by the Group to the funds.

###### (iii) Termination benefits

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits and when the Group recognises restructuring costs and involves the payment of termination benefits.

##### 其他收益

利息收入按時間比例採用實際利率法確認。

租金收入於租期內按直線法確認。

##### 僱員福利

###### (i) 僱員應享假期

僱員的年假及長期服務假期於僱員應享有時予以確認。截至報告期末，因僱員所提供的服務而產生的年假及長期服務假期的估計負債已計提撥備。

僱員享有的病假及產假於僱員休假時方會確認。

###### (ii) 退休金責任

本集團向為所有僱員提供的定額供款退休計劃進行供款。本集團及僱員對計劃的供款根據僱員基本薪金的百分比計算。在損益內扣除的退休福利計劃成本指本集團須向基金支付的供款。

###### (iii) 離職福利

離職福利於本集團不能取消提供該等福利時及本集團確認重組成本並涉及支付離職福利時（以較早者為準）予以確認。

#### 4. SIGNIFICANT ACCOUNTING POLICIES (Continued)

##### Share-based payments

The Group issues equity-settled share-based payments to certain directors.

Equity-settled share-based payments to directors are measured at the fair value (excluding the effect of non market-based vesting conditions) of the equity instruments at the date of grant. The fair value determined at the grant date of the equity-settled share-based payments is expensed on a straight-line basis over the vesting period, based on the Group's estimate of shares that will eventually vest and adjusted for the effect of non market-based vesting conditions.

##### Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

To the extent that funds are borrowed generally and used for the purpose of obtaining a qualifying asset, the amount of borrowing costs eligible for capitalisation is determined by applying a capitalisation rate to the expenditures on that asset. The capitalisation rate is the weighted average of the borrowing costs applicable to the borrowings of the Group that are outstanding during the period, other than borrowings made specifically for the purpose of obtaining a qualifying asset.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

##### 以股份為基礎的付款

本集團向若干董事發行按股本結算以股份為基礎的付款。

向董事作出的按股本結算以股份為基礎的付款乃於授出日期按股本工具的公平值計量 (不包括非市場歸屬條件的影響)。按股本結算以股份為基礎的付款於授出日期釐定的公平值，乃根據本集團對最終將歸屬股份的估計及就非市場歸屬條件的影響作出調整，於歸屬期內以直線法支銷。

##### 借貸成本

直接歸屬於收購、興建或生產合資格資產 (指必須經一段長時間處理以作其預定用途或銷售的資產) 的一般及特定借貸成本，加入該等資產的成本內，直至資產大致上備妥供其預定用途或銷售為止。在特定借貸撥作合資格資產的支出前暫時用作投資所賺取的投資收入，須從合資格資本化的借貸成本中扣除。

以一般性借入資金用於獲取一項合資格資產為限，可撥充資本之借貸成本數額乃透過該項資產之支出所採用之資本化率而釐定。資本化率乃適用於本集團借貸 (於有關期間內尚未償還) 之借貸成本之加權平均數，惟特別為獲取合資格資產而作出之借貸則除外。

所有其他借貸成本於產生期間在損益確認。

##### Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences, unused tax losses or unused tax credits can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

##### 稅項

所得稅指即期稅項及遞延稅項的總額。

即期應付稅項按本年度應課稅溢利計算。應課稅溢利與於損益內確認的溢利有所不同，原因是其不包括其他年度的應課稅或可扣稅收入或開支項目，亦不包括免稅或不可扣稅項目。本集團有關即期稅項的負債採用於報告期末前已實行或實際已實行的稅率計算。

遞延稅項就財務報表內資產及負債的賬面值與計算應課稅溢利所採用相應稅基之間的差額予以確認。遞延稅項負債一般就所有應課稅暫時差額確認，而遞延稅項資產則會在預期應課稅溢利可供作抵銷可扣減暫時差額、未動用稅項虧損或未動用稅項抵免時確認。倘暫時差額乃因商譽或初步確認一項既不影響應課稅溢利亦不影響會計溢利的交易（業務合併除外）中的其他資產及負債而產生，則不會確認有關資產及負債。

遞延稅項負債就於附屬公司投資而產生的應課稅暫時差額予以確認，惟倘本集團可控制暫時差額的撥回，且該暫時差額可能不會於可見將來撥回者除外。

##### Taxation (Continued)

Deferred tax is calculated at the tax rates that are expected to apply in the period when the liability is settled or the asset is realised, based on tax rates that have been enacted or substantively enacted by the end of the reporting period. Deferred tax is recognised in profit or loss, except when it relates to items recognised in other comprehensive income or directly in equity, in which case the deferred tax is also recognised in other comprehensive income or directly in equity.

The measurement of deferred tax assets and liabilities reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to set off current tax assets against current tax liabilities and when they relate to income taxes levied by the same taxation authority and the Group intends to settle its current tax assets and liabilities on a net basis.

##### Related parties

A related party is a person or entity that is related to the Group.

- (A) A person or a close member of that person's family is related to the Group if that person:
- (i) has control or joint control over the Group;
  - (ii) has significant influence over the Group; or
  - (iii) is a member of the key management personnel of the Company or of a parent of the Company.

##### 稅項 (續)

遞延稅項根據於報告期末前已實行或實際已實行的稅率，按預期在負債償還或資產變現期間適用的稅率計算。遞延稅項於損益內確認，惟倘遞延稅項與於其他全面收入內確認或直接於權益中確認的項目有關，則遞延稅項亦於其他全面收入內確認或直接於權益中確認。

遞延稅項資產及負債的計量反映按照本集團預期於報告期末收回或結算其資產及負債賬面值的方式而產生的稅務影響。

當合法執行權利許可將即期稅項資產與即期稅項負債抵銷，並且當與同一稅務機關所徵收的所得稅有關且本集團擬按淨額基準結算其即期稅項資產及負債時，遞延稅項資產及負債可予以對銷。

##### 關連人士

關連人士為與本集團有關連之人士或實體。

- (A) 倘屬以下人士，即該人士或該人士的近親為本集團的關連方：
- (i) 控制或共同控制本集團；
  - (ii) 對本集團有重大影響力；或
  - (iii) 為本公司或本公司母公司主要管理人員的其中一名成員。

##### Related parties (Continued)

(B) An entity is related to the Group if any of the following conditions applies:

- (i) The entity and the Company are members of the same group (which means that each parent, subsidiary and fellow subsidiary is related to the others).
- (ii) One entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).
- (iii) Both entities are joint ventures of the same third party.
- (iv) One entity is a joint venture of a third entity and the other entity is an associate of the third entity.
- (v) The entity is a post-employment benefit plan for the benefit of employees of either the Group or an entity related to the Group. If the Group is itself such a plan, the sponsoring employers are also related to the Group.
- (vi) The entity is controlled or jointly controlled by a person identified in (A).
- (vii) A person identified in (A)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity).
- (viii) The entity, or any member of a group of which it is a part, provides key management personnel services to the Company or to a parent of the Company.

(B) 倘符合下列任何條件，即該實體與本集團有關連：

- (i) 該實體與本公司屬同一集團的成員公司（即各母公司、附屬公司及同系附屬公司彼此間有關連）。
- (ii) 一間實體為另一實體的聯營公司或合營公司（或另一實體為成員公司的集團旗下成員公司的聯營公司或合營公司）。
- (iii) 兩間實體均為同一第三方的合營公司。
- (iv) 一間實體為第三方實體的合營公司，而另一實體為該第三方實體的聯營公司。

### Segment reporting

Operating segments and the amounts of each segment item reported in the financial statements are identified from the financial information provided regularly to the Group's most senior executive management for the purpose of allocating resources and assessing the performance of the Group's various lines of business.

Individually material operating segments are not aggregated for financial reporting purposes unless the segments have similar economic characteristics and are similar in respect of the nature of products and services, the nature of production processes, the type or class of customers, the methods used to distribute the products or provide the services, and the nature of the regulatory environment. Operating segments which are not individually material may be aggregated if they share a majority of these criteria.

### Impairment of assets

Intangible assets that have an indefinite useful life or not yet available for use are reviewed annually for impairment and are reviewed for impairment whenever events or changes in circumstances indicate the carrying amount may not be recoverable.

At the end of each reporting period, the Group reviews the carrying amounts of its tangible and other intangible assets except goodwill, inventories and receivables to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of any impairment loss. Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash generating unit to which the asset belongs.

##### Impairment of assets (Continued)

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

If the recoverable amount of an asset or cash-generating unit is estimated to be less than its carrying amount, the carrying amount of the asset or cash-generating unit is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the impairment loss is treated as a revaluation decrease.

Where an impairment loss subsequently reverses, the carrying amount of the asset or cash-generating unit is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined (net of amortisation or depreciation) had no impairment loss been recognised for the asset or cash-generating unit in prior years. A reversal of an impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the reversal of the impairment loss is treated as a revaluation increase.

##### Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

##### Events after the reporting period

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period or those that indicate the going concern assumption is not appropriate are adjusting events and are reflected in the financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the financial statements when material.

## 5. CRITICAL JUDGEMENTS AND KEY ESTIMATES

### Critical judgements in applying accounting policies

In the process of applying the accounting policies, the Directors have made the following judgements that have the most significant effect on the amounts recognised in the consolidated financial statements (apart from those involving estimations, which are dealt with below).

#### Going concern basis

These consolidated financial statements have been prepared on a going concern basis. This involves critical judgements. Details are explained in note 2 to the consolidated financial statements.

### Key sources of estimation uncertainty

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

#### (a) Impairment loss for bad and doubtful debts

The Group makes impairment loss for bad and doubtful debts based on assessments of the recoverability of the trade and other receivables, including the current creditworthiness and the past collection history of each debtor. Impairments arise where events or changes in circumstances indicate that the balances may not be collectible. The identification of bad and doubtful debts requires the use of judgement and estimates. Where the actual result is different from the original estimate, such difference will impact the carrying value of the trade and other receivables and doubtful debt expenses in the year in which such estimate has been changed. If the financial conditions of the debtors were to deteriorate, resulting in an impairment of their ability to make payments, additional allowances may be required.

#### (b) Property, plant and equipment, right-of-use assets and depreciation and impairment

The Group determines the estimated useful lives, residual values and related depreciation charges for the Group's property, plant and equipment and right-of-use assets. This estimate is based on the historical experience of the actual useful lives and residual values of property, plant and equipment and right-of-use assets of similar nature and functions. The Group will revise the depreciation charge where useful lives and residual values are different to those previously estimated, or it will write-off or write-down technically obsolete or non-strategic assets that have been abandoned or sold. Property, plant and equipment and right-of-use assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount of the assets exceeds its recoverable amount. The recoverable amount is determined with reference to the present value of estimated future cash flows. Where the future cash flows are less than expected or there are unfavourable events and change in facts and circumstance which result in revision of future estimate cash flows, a material impairment loss may arise.

The Group's activities expose it to a variety of financial risks: foreign currency risk, credit risk, liquidity risk and interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

### (a) Foreign exchange risk

The Group has minimal exposure to foreign currency risk as most of its business transactions, assets and liabilities are principally denominated in the functional currencies of the Group entities. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group will monitor its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

### (b) Credit risk

The carrying amount of the bank and cash balances and trade and other receivables included in the consolidated statement of financial position represents the Group's maximum exposure to credit risk in relation to the Group's financial assets.

The credit risk on bank and cash balances is limited because the counterparties are banks with high credit-ratings assigned by international credit-rating agencies.

The Group's maximum exposure to credit risk in the event that counterparties fail to perform their obligations at the end of the reporting period in relation to each class of recognised financial assets is the carrying amounts of those assets as stated in the consolidated statement of financial position. The Group's credit risk is primarily attributable to its trade and other receivables. In order to minimise credit risk, the Directors review the recoverable amount of each individual receivable regularly to ensure that adequate impairment losses are recognised for irrecoverable receivable. In this regard, the Directors consider that the Group's credit risk is significantly reduced.

The Group considers whether there has been a significant increase in credit risk of financial assets on an ongoing basis throughout each reporting period by comparing the risk of a default occurring as at the reporting date with the risk of default as at the date of initial recognition. It considers available reasonable and supportive forwarding-looking information. Especially the following information is used:

- internal credit rating;
- external credit rating (if available);
- actual or expected significant adverse changes in business, financial or economic conditions that are expected to cause a significant change to the borrower's ability to meet its obligations;
- actual or expected significant changes in the operating results of the borrower;
- significant increases in credit risk on other financial instruments of the same borrower; and
- significant changes in the expected performance and behaviour of the borrower, including changes in the payment status of borrowers.

### (b) Credit risk (Continued)

A significant increase in credit risk is presumed if a debtor is more than 30 days past due in making a contractual payment. A default on a financial asset is when the counterparty fails to make contractual payments within 60 days of when they fall due.

Financial assets are written off when there is no reasonable expectation of recovery, such as a debtor failing to engage in a repayment plan with the Group. The Group normally categorises a loan or receivable for write off when a debtor fails to make contractual payments greater than 360 days past due. Where loans or receivables have been written off, the Group, if practicable and economical, continues to engage in enforcement activity to attempt to recover the receivable due.

The Group uses two categories for non-trade receivables which reflect their credit risk and how the loss provision is determined for each of the categories. In calculating the expected credit loss rates, the Group considers historical loss rates for each category and adjusts for forward looking data.

### Construction service fee income

The Group provides construction service to the customers. When the progress towards complete satisfaction of the performance obligations of a construction contract can be measured reasonably, revenue from the contract and the contract costs are recognised using the percentage of completion method, measured by reference to the percentage of contract costs incurred to date to the estimated total contract costs for the contract. This method provides the most reliable estimate of the percentage of completion.

- (a) During the year ended 31 December 2019, other receivables of RMB5,000,000 from a customer was fully impaired. The Group entered into the legal process during the year ended 31 December 2019. Approximately RMB5,385,000 (equivalent to approximately HK\$6,264,000) (including (i) Repayment of other receivable of RMB5,000,000 (equivalent to approximately HK\$5,816,000) and (ii) retainer fee of approximately RMB385,000 equivalent to approximately HK\$448,000) was received from the court during the year ended 31 December 2022. Hence, the Group reverse the written-off on trade and other receivables during the year ended 31 December 2022.
- (b) During the year ended 31 December 2022, the Group recognised government grants of approximately HK\$1,397,600 which was related to the Employment Support Scheme. The recoverable amounts of the CGUs are determined on the basis of their value in use using discounted cash flow method. The key assumptions for the discounted cash flow method are those regarding the discount rates, growth rates and budgeted gross margin and revenue during the period. The Group estimates discount rates using pre-tax rates that reflect current market assessments of the time value of money and the risks specific to the CGUs. The growth rates are based on long-term average economic growth rate of the geographical area in which the businesses of the CGUs operate. Budgeted gross margin and revenue are based on past practices and expectations on market development.

The Group prepares cash flow forecasts derived from the most recent financial budgets approved by the directors for the next five years with the residual period using the growth rate of 5% (2021: 5%). This rate does not exceed the average long-term growth rate for the relevant markets.

The rate used to discount the forecast cash flows from the Group's manufacturing and trading of prefabricated precast construction components is 18% (2021: 18%).

## 28. SHARE OPTION SCHEME

The Company operates a share option scheme (the “Scheme”) for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group’s operations. Eligible participants include the full-time and part-time employees, executives, officers, directors, business consultants, agents, legal and financial advisers of the Company and the Company’s subsidiaries. The Scheme became effective on 2 August 2014 and refreshed on 2 June 2017 and 8 June 2018, respectively, unless otherwise cancelled or amended, will remain in force for 10 years from that date.

The maximum number of unexercised share options currently permitted to be granted under the Scheme is an amount equivalent, upon their exercise, to 10% of the shares of the Company in issue at any time. The maximum number of shares issuable under share options to each eligible participant in the Scheme within any 12-month period, is limited to 0.1% of the shares of the Company in issue at any time. Any further grant of shares options in excess of this limit is subject to shareholders’ approval in a general meeting.

Share options granted to a director, chief executive or substantial shareholder of the Company, or to any of their associates, are subject to approval in advance by the independent non-executive directors. In addition, any share options granted to a substantial shareholder or an independent non-executive director of the Company, or to any of their associates, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the price of the Company’s shares at the date of the grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders’ approval in advance in a general meeting.

## 28. 購股權計劃

本公司實行購股權計劃（「該計劃」）旨在向合資格參與者提供額外獎勵以及推動本集團業務創出佳績。合資格參與者包括本公司及本公司附屬公司的僱員（全職及兼職）、行政人員、高級人員、董事、業務顧問、代理、法律及財務顧問。該計劃於二零一四年八月二日生效及分別於二零一七年六月二日及二零一八年六月八日更新，除非另有取消或修訂，否則自該日起十年內仍然有效。

根據該計劃，現時可授出之尚未行使購股權數目最多可相等於其獲行使時佔本公司任何時間之已發行股份之10%。於任何十二個月期間內，該計劃每位合資格參與者獲授的購股權可予發行的股份最高數目，任何時候須以本公司已發行股份的0.1%為限。任何額外授出超逾此限額的購股權須在股東大會上獲股東批准。
