#### 1. INTRODUCTION

The purposes of this circular are to provide you with information regarding the resolutions to be proposed at the AGM and to give you notice of the AGM. At the AGM, resolutions relating to, among other matters, (i) the grant of the Repurchase Mandate, the General Mandate and the Extension Mandate; and (ii) the proposed re-election of Directors, will be proposed.

#### LETTER FROM THE BOARD

#### 2. GENERAL MANDATES TO REPURCHASE AND ISSUE SHARES

At the annual general meeting of the Company held on 2 August 2022, the Directors were granted (a) a general unconditional mandate to exercise all the powers of the Company to purchase Shares not exceeding 10% of the number of issued Shares as at the date of the passing of the relevant resolution; (b) a general unconditional mandate to allot, issue and deal with Shares not exceeding 20% of number of issued Shares as at the date of the passing of the relevant resolution; and (c) an extension of the general mandate mentioned in (b) above by adding an amount not exceeding 10% of the number of issued Shares as at the date of the passing of the relevant resolution to the number of issued Shares that could be repurchased by the Company pursuant to the general mandate referred to in (a) above.

The general mandates previously granted to the Directors to repurchase and issue Shares by the Shareholders at the annual general meeting of the Company held on 2 August 2022 will expire at the conclusion of the AGM. In order to give the Company the flexibility to repurchase and issue Shares if and when appropriate, the following ordinary resolutions will be proposed at the AGM to approve the grant of new general mandates to the Directors:

#### 3. PROPOSED RE-ELECTION OF THE RETIRING DIRECTORS

In accordance with Articles 105(A) and 105(B) of the Articles, each of Mr. Kam Hou Yin, John and Ms. Chong Kan Yu will retire from the office of Director by rotation and each of them, being eligible, will offer themselves for re-election at the AGM.

The following is an explanatory statement required by the GEM Listing Rules to be sent to the Shareholders to enable them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the AGM in relation to the grant of the Repurchase Mandate.

#### 1. REASONS FOR REPURCHASE OF SHARES

The Directors believe that the grant of the Repurchase Mandate is in the best interests of the Company and the Shareholders.

Repurchases of Shares may, depending on the market conditions and funding arrangements at the time, result in an enhancement of the net asset value per Share and/or earnings per Share. The Directors are seeking the grant of the Repurchase Mandate to give the Company the flexibility to do so if and when appropriate. The number of Shares to be repurchased on any occasion and the price and other terms upon which the same are repurchased will be decided by the Directors at the relevant time, having regard to the circumstances then pertaining.

#### 2. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 34,628,650 Shares.

Subject to the passing of the ordinary resolution as set out in resolution numbered 4 in the notice convening the AGM in respect of the grant of the Repurchase Mandate and on the above basis, the Directors would be authorised under the Repurchase Mandate to repurchase a maximum of 3,462,865 Shares.

#### 3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its memorandum of association and the Articles, the laws of the Cayman Islands and/or any other applicable laws, as the case may be.

#### 4. IMPACT OF REPURCHASES

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 December 2022) in the event that the Repurchase Mandate is to be carried out in full at any time during the proposed repurchase period. However, the Directors do not intend to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

#### 5. TAKEOVERS CODE

Should the Directors exercise the proposed Repurchase Mandate in full, to the best of the knowledge and belief of the Directors, on the basis that the shareholdings of Mr. Zheng Weijing, holding 812,604 Shares, and Ming Cheng Investments Limited, a company whollyowned by Mr. Zheng Weijing and the largest substantial shareholder of the Company holding 7,354,791 Shares, representing in aggregate approximately 23.59% of the issued share capital of the Company as at the Latest Practicable Date, remain the same and there is no change in the issued share capital of the Company, the aggregate shareholding of Mr. Zheng Weijing and Ming Cheng Investments Limited would be increased to approximately 26.21% of the reduced issued share capital of the Company. Such increase would not give rise to an obligation of such Shareholders to make a mandatory offer under Rule 26 of the Takeovers Code.

Based on the information set out above, the Directors are not aware of any Shareholder or group of Shareholders acting in concert, who may become obliged to make a mandatory offer under Rule 26 of the Takeovers Code as a consequence of any purchases pursuant to the Repurchase Mandate.

#### 6. GENERAL

He was appointed as an Executive Director and Chief Executive Officer of Century Ginwa Retail Holdings Limited from 2 May 2017 to October 2018 and was Zone Manager — Corporate Banking Division and General Manager of Shenzhen Branch of The Bank of East Asia (China), Limited from July 2012 to March 2017 and Zone Manager (Western China) — Corporate Banking Division and General Manager of Xi'an Branch of The Bank of East Asia (China), Limited from November 2006 to June 2012. #### ORDINARY RESOLUTIONS

4. To consider and, if thought fit, pass with or without amendments, the following resolutions as ordinary resolutions:

- (b) the approval in paragraph (a) above shall authorize the Directors to make or grant offers, agreements or options, including warrants to subscribe for Shares, during the Relevant Period which would or might require the exercise of such powers after the end of the Relevant Period;

  - "THAT conditional upon the passing of the resolutions numbered 4 and 5 in the notice convening this Meeting ("Notice"), the general mandate referred to in the resolution numbered 5 in the Notice be and is hereby extended by the addition to the number of Shares which may be allotted and issued or agreed conditionally or unconditionally to be allotted and issued by the Directors pursuant to such general mandate of an amount representing the number of Shares purchased or agreed to be purchased by the Company pursuant to the mandate referred to in the resolution numbered 4 in the Notice, provided that such amount shall not exceed 10 per cent of the number of issued shares as at the date of the passing of this resolution."
