

NOTES TO THE UNAUDITED CONSOLIDATED FINANCIAL STATEMENTS

For the three months ended 31 March 2022

1. CORPORATE INFORMATION

The Company was incorporated as an exempted company with limited liability in the Cayman Islands under the Companies Law of the Cayman Islands on 18 April 2018. The address of registered office is located at Windward 3, Regatta Office Park, PO Box 1350, Grand Cayman KY1-1108, Cayman Islands. The principal place of business of the Company is located at 5/F, Winning Commercial Building, 46–48 Hillwood Road, Tsim Sha Tsui, Kowloon, Hong Kong.

The Company is an investment holding company. The Group is principally engaged in provision of engineering consultancy services in Hong Kong.

The Company's immediate and ultimate holding company is Waywin Investment Holding Limited, a company incorporated in the British Virgin Islands (the "BVI"). The ultimate controlling shareholder of the Group is Mr. Cheung Kwan Tar ("Mr. Cheung" or "Controlling Shareholder").

2. BASIS OF PREPARATION AND REORGANISATION

The unaudited condensed consolidated financial statements for the three months ended 31 March 2023 have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and the applicable disclosure requirements of the GEM Listing Rules.

The unaudited condensed consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is also the functional currency of the Company and its subsidiaries, and all values are rounded to the nearest thousands ("HK\$'000"), except where otherwise indicated

1. 公司資料

本公司於二零一八年四月十八日在開曼群島根據開曼群島公司法註冊成立為獲豁免有限公司。註冊辦事處地址為Windward 3, Regatta Office Park, PO Box 1350, Grand Cayman KY1-1108, Cayman Islands。本公司主要營業地點位於香港九龍尖沙咀山林道46-48號運通商業大廈5樓。

本公司為一家投資控股公司。本集 團主要從事於香港提供工程顧問服 務。

本公司的直接及最終控股公司為煒 榮投資控股有限公司。該公司為一家 於英屬處女群島(「英屬處女群島」) 註冊成立的公司。本集團的最終控股 股東為張群達先生(「張先生」或「控 股股東」)。

2. 編製基準及重組

截至二零二三年三月三十一日止三個月的未經審核簡明綜合財務報表已根據香港會計師公會(「香港會計師公會」)頒佈的香港財務報告準則(「香港財務報告準則」)及GEM上市規則的適用披露規定編製。

該等未經審核簡明綜合財務報表乃 以港元(「港元」)呈列·該貨幣亦為 本公司及其附屬公司的功能貨幣· 除非另有指明·否則所有金額均約 整至最接近之千元(「千港元」)。

2. BASIS OF PREPARATION AND REORGANISATION (CONTINUED)

The unaudited condensed consolidated financial statements should be read in conjunction with the audited combined financial information for the year ended 31 December 2022 as set out in the annual report of the Company dated 27 March 2023 ("Annual Report") and the unaudited consolidated financial information for the period ended 31 March 2022 as set out in the first quarterly report of the Company dated 6 May 2022 ("First Quarterly Report").

Except as described below, the accounting policies used in the financial highlights for the three months ended 31 March 2023 are the same as those followed in the preparation of the Group's annual consolidated financial statements for the year ended 31 December 2022.

Pursuant to the reorganisation of the Group in connection with the listing of the shares of the Company on GEM (the "Reorganisation"), the Company became the holding company of the companies now comprising the Group on 10 August 2018. Details of the Reorganisation are set out in the section headed "History, Reorganisation and Corporate Structure – Reorganisation" in the Prospectus.

The Group is under the common control of the Controlling Shareholder prior to and after the Reorganisation. The Group comprising the Company and its subsidiaries resulting from the Reorganisation is regarded as a continuing entity.

Accordingly, the unaudited condensed financial statements of the Group have been prepared using the principles of merger accounting in accordance with Hong Kong Accounting Guideline 5 "Merger Accounting for Common Control Combinations" issued by HKICPA as if the group structure under the Reorganisation had been in existence throughout the period presented, or since their respective dates of incorporation, where it is a shorter period. The assets and liabilities of all the companies now comprising the Group are consolidated using the book values from the Controlling Shareholder's perspective.

2. 編製基準及重組(續)

該等未經審核簡明綜合財務報表應 與本公司日期為二零二三年三月 二十七日的年報(「年報」)所載的框 至二零二二年十二月三十一日止年 度的經審核合併財務資料及本公司 日期為二零二二年五月六日的第一 季度報告(「第一季度報告」)所載的 載至二零二二年三月三十一日止期 間的未經審核綜合財務資料一併閱 覽。

除下文所述外,截至二零二三年三 月三十一日止三個月之財務概要所 應用之會計政策與本集團編製截至 二零二二年十二月三十一日止年度 之年度綜合財務報表所採納者完全 一致。

根據本集團就本公司股份於GEM上市進行的重組(「重組」),本公司於二零一八年八月十日成為本集團現時旗下公司之控股公司。重組詳情載於招股章程「歷史、重組及公司架構一重組」一節內。

本集團於重組前後受控股股東共同控制。重組而成的本集團(包括本公司及其附屬公司)被視為持續經營實體。

因此,本集團的未經審核簡明財務 報表已根據香港會計師公會頒佈的 香港會計指引第5號「共同控制合併的合併會計法」使用合併會計原則編 製,猶如重組項下的集團架構於整個呈報期間或自各公司各自註冊成 位呈報期間或自各公司各自註冊成 可在。本集團現時旗下所有公司的 資產及負債乃使用控股股東認可的 賬面值合併入賬。

3. REVENUE

Revenue, which is also the Group's turnover, represent the engineering consultancy services receipts in the ordinary course of business.

4. SEGMENT INFORMATION

The chief operating decision-maker has been identified as the executive directors of the Company. The directors regard the Group's business of provision of engineering consultancy services as a single operating segment and reviews the overall results of the Group as a whole to make decision about resources allocation. Accordingly, no segment analysis information is presented.

5. INCOME TAX EXPENSE

The provision for Hong Kong Profits Tax for the three months ended 31 March 2023 is calculated at 16.5% (three months ended 31 March 2022: 16.5%) of the estimated assessable profits for the period, except for Mannings, a subsidiary of the Group, which is a qualifying corporation under the two-tiered profits tax rates regime. Under the two-tiered profits tax rates regime, the first HK\$2 million of profits of qualifying entities are taxed at 8.25%, and the profits above HK\$2 million are taxed at 16.5%. The provision for Hong Kong Profits Tax for this subsidiary was calculated at the same basis in 2022.

3. 收益

收益(亦為本集團之營業額)指日常 業務過程中工程顧問服務之收入。

4. 分部資料

主要經營決策者被認定為本公司執 行董事。董事將本集團提供工程顧 問服務的業務視為單一經營分部, 並審閱本集團整體之業績,以就資 源分配作出決策。因此,並無呈列 分部分析資料。

5. 所得稅開支

截至二零二三年三月三十一日止三個月,香港利得稅撥備按期內估計應課稅溢利16.5%(截至二零二二年三月三十一日止三個月:16.5%)計算,本集團一間附屬公司萬利計算,各資格公司)以利得稅兩級制計算內。根據利得稅兩級制,合資體按8.25%之稅率就首2百萬港元溢利繳納稅項,並按16.5%之稅率繳納2百萬港元以上溢利之稅項。該附屬公司的香港利得稅撥備乃按二零二二年相同基準計算。

MANAGEMENT DISCUSSION AND ANALYSIS

DEVELOPMENT OF BUSINESS AND PROSPECTS

The Group is an engineering consultant in Hong Kong with a focus on the field of infrastructure developments. The Group has accumulated expertise in different branches of engineering, covering (i) civil engineering mainly comprising road and structural engineering as well as geotechnical engineering; (ii) traffic engineering; and (iii) building engineering.

For the three months ended 31 March 2023, the Group recorded a net profit of approximately HK\$6.4 million as compared to a net profit of approximately HK\$7.7 million for the same period in 2022. The decrease was primarily due to the increase in staff cost. In view of the fact that there has been an increasing number of project quotation invitations received by the Group from potential and current customers, the Directors are cautiously optimistic about the Group's business outlook

OUTLOOK

The Group always strives to improve our operation efficiency and profitability of our business. The Group will also proactively seek opportunities to expand our customer base and our market share and undertake more projects which will enhance value to our shareholders.

FINANCIAL REVIEW

Revenue

Our revenue remain constant at approximately HK\$37.1 million for the three months ended 31 March 2023 (three months ended 31 March 2022 approximately HK\$37.0 million).

管理層討論及分析

業務發展及前景

本集團為專注基礎設施發展領域的香港工程顧問。本集團已積累不同工程分支專業知識,涵蓋(1)土木工程(主要包括道路及結構工程以及岩土工程);(ii)交通工程;及(iii)樓字工程。

截至二零二三年三月三十一日止三個月,本集團錄得純利約6.4百萬港元,而二零二二年同期則錄得純利約7.7百萬港元。減少主要由於員工成本增加。鑒於本集團自潛在及現有客戶接獲的項目報價邀請數目日益增加,董事對本集團的業務前景謹慎樂觀。

計昌

本集團一直致力於提高業務營運效率及盈 利能力。本集團亦將積極尋求機會以擴大 客戶群及市場份額,承接更多項目以提升 股東價值。

財務回顧

收益

收益於截至二零二三年三月三十一日止三個月維持不變,約為37.1百萬港元(截至二零二二年三月三十一日止三個月約為37.0百萬港元)。

Costs of Revenue

Our costs of revenue increased to approximately HK\$23.4 million for the three months ended 31 March 2023 by approximately HK\$0.7 million or 3.2%, from approximately HK\$22.7 million for the corresponding period ended 31 March 2022. The increase in costs was mainly due to the increase in direct labour cost.

Gross Profit

Our gross profit decreased to approximately HK\$13.7 million for the three months ended 31 March 2023 by approximately HK\$0.6 million or 4.0%, from approximately HK\$14.3 million for the corresponding period ended 31 March 2022. The decrease was substantially due to the increase in direct labour cost.

Administrative Expenses

Our administrative expenses increased to approximately HK\$6.9 million for the three months ended 31 March 2023 by approximately HK\$0.9 million or 15.7%, from approximately HK\$6.0 million for the corresponding period ended 31 March 2022. The increase was mainly due to increase in staff benefit.

Dividend

The Board does not recommend the payment of dividend for the three months ended 31 March 2023 (three months ended 31 March 2022; nil).

COMPETITION AND CONFLICT OF INTERESTS

None of the Directors, the controlling shareholders or substantial shareholders of the Company or any of its respective close associates (as defined in the GEM Listing Rules) has engaged in any business that competes or may compete, either directly or indirectly, with the businesses of the Group, or has any other conflict of interests with the Group as required to be disclosed pursuant to Rule 11.04 of the GEM Listing Rules during the three months ended 31 March 2023.

收益成本
