FINANCIAL SUMMARY

The Group's total revenue for the Period was approximately HK\$2.85 million, representing a decrease of approximately 94.7% as compared with the total revenue of approximately HK\$53.6 million for the corresponding period in 2022.

Loss before taxation for the Period was approximately HK21.0 million, representing a decrease of loss of approximately 7.5% as compared with the loss before taxation of approximately HK\$22.7 million for the corresponding period in 2022.

Loss attributable to the equity holders of the Company for the Period was approximately HK\$20.2 million, representing a decrease of loss of approximately 7.8% as compared with the loss attributable to the equity holders of the Company of approximately HK\$21.9 million for the corresponding period in 2022.

Loss per share for the Period was approximately HK1.57 cents (the corresponding period in 2022: approximately HK1.70 cents).

NOTES TO THE UNAUDITED FIRST QUARTERLY FINANCIAL STATEMENTS

For the three months ended 31 March 2023

1. CORPORATION INFORMATION

The Company was incorporated in the Cayman Islands on 13 September 2011 as an exempted company with limited liability under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The address of the registered office of the Company is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands.

2. BASIS OF PREPARATION

The First Quarterly Financial Statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("**HKFRS**"), which collective term includes all applicable individual HKFRS, Hong Kong Accounting Standards ("**HKAS**") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants, accounting principles generally accepted in Hong Kong and the disclosure requirements of the Companies Ordinance. The First Quarterly Financial Statements also comply with the applicable disclosure requirements under the GEM Listing Rules.

Other than additional accounting policies resulting from application of amendments to the HKFRS, the accounting policies and methods of computation used in the First Quarterly Financial Statements are the same as those presented in the Group's audited annual financial statements for the year ended 31 December 2022.

Adoption of new/revised HKFRS

The adoption of the new/revised HKFRS that are relevant to the Group and effective from the current period, did not have any significant effect on the results and financial position of the Group for the current and prior accounting periods.

The Group has not early adopted any new/revised HKFRS that have been issued but are not yet effective for the current period. The Directors have already commenced an assessment of the impact of these new and revised HKFRS but are not yet in a position to reasonably estimate whether these new and revised HKFRS would have a significant impact on the Group's results of operations and financial position.

5. TAXATION

Hong Kong Profits Tax is calculated in accordance with the two-tiered profits tax rates regime. Under the two-tiered profits tax rates regime, the profits tax rate for the first HK\$2 million of estimated assessable profits of the qualifying group entity is lowered to 8.25%, while the estimated assessable profits above HK\$2 million continue to be subject to the rate of 16.5% for corporations. Neither the Company nor its subsidiaries in Hong Kong have obtained taxable profits and no income tax has been accrued.

The PRC Enterprise Income Tax is calculated at the prevailing tax rate at 25% (2022: 25%) on taxable income determined in accordance with the relevant laws and regulations in the PRC.

Pursuant to the rules and regulations of the British Virgin Islands and the Cayman Islands, the Group is not subject to any taxation under those jurisdictions.

6. DIVIDEND

The Board did not recommend the payment of any interim dividend for the Period (2022: Nil).

7. LOSS PER SHARE

Basic loss per share for the three months ended 31 March 2023 and 2022 are calculated by dividing the loss attributable to equity holders of the Company by the weighted average number of ordinary shares in issue.

8. APPROVAL OF THE FIRST QUARTERLY FINANCIAL STATEMENTS

The First Quarterly Financial Statements were approved and authorised for issue by the Board on 11 May 2023.

MACRO SITUATION REVIEW

During the Period, the global supply chain was being restructured in an accelerated pace in the post-pandemic era, and the competition between great powers and geopolitical conflicts intensified and prolonged. High energy costs, persistent inflation and further interest rate hikes to curb inflation had a significant impact on the global economy, and the global political and economic situation was still facing great uncertainties. The Company will continue to closely monitor the global economic situation, remain attentive and vigilant to global developments and their implications, and do its best to minimise its impact on the Group and maintain stable operations during this downturn.

BUSINESS REVIEW

For the Period, the Group was principally engaged in trading business, and the provision of petrochemical products storage business.

1. Trading Business

The Group is engaged in the trading and import and export businesses of electronic products, petrochemical products and various other products. During the Period, the Group's trading business recorded revenue of approximately HK\$0.14 million (2022: approximately HK\$50.2 million). The decrease in revenue in this segment was mainly due to the continued and increased trade tensions between China and the United States of America (the "**US**") and that the Group remained to be suffering from the resultant impact from the escalated COVID-19 epidemic situation. The Group's trading and import and export businesses of electronic products has been heavily affected since last year, which led to the decrease in revenue of the trading segment. The Group is currently in negotiation with clients regarding new trading business opportunities.

2. Petrochemical Products Storage Business

The Group is engaged in petrochemical products storage business through Port Storage Petrochemical. During the Period, the Group's petrochemical products storage business recorded a decrease in revenue by approximately 20.3% to approximately HK\$2.71 million (2022: approximately HK\$3.4 million). The decrease in revenue was mainly attributable to the fact that some of the storage tanks were currently out of service for refurbishment in response to new environmental safety requirements.

FINANCIAL REVIEW

The Group's revenue decreased by approximately 94.7% to approximately HK\$2.85 million for the Period (2022: approximately HK\$53.6 million). For factors leading to the decrease in revenue, please refer to the above paragraph headed "Business Review" for details.

The Group's cost of revenue decreased by approximately 92.8% to approximately HK\$4.08 million for the Period (2022: approximately HK\$57.0 million). The decrease in cost was mainly driven by the effect of decrease in revenue of the Group's trading business.

With the combined effects of revenue and cost of revenue, the Group recorded a gross loss margin of approximately 43.2% for the Period (2022: gross loss margin of approximately 6.5%). The increase in gross loss was mainly due to the trade tensions between China and the US which led to a substantial decrease in the trading and import and export businesses of electronic products during the Period, leading to a decrease in gross profit. Further, despite the decrease in revenue generated from the petrochemical products storage business, fixed costs and expenses remained unchanged during the Period.

The Group's finance costs amounted to approximately HK\$6.8 million for the Period (2022: approximately HK\$5.4 million). The finance costs mainly consist of the interests on bank loans, listed credit-enhanced guaranteed bonds and amount due to connected companies. The increase in finance costs was mainly attributable to the increase in borrowings of HK\$5,700,000 from Port Shipping International and HK\$17,000,000 from Port Storage Petrochemical, both of which were provided by Dafeng Port Development Group.

The Group recorded the loss for the Period of approximately HK\$21.0 million (2022: approximately HK\$22.7 million). The loss attributable to equity holders of the Company was approximately HK\$20.2 million (2022: approximately HK\$21.9 million) and the loss per share was 1.57 HK cents (2022: 1.70 HK cents).

CAPITAL STRUCTURE

As at 31 March 2023, the Group's total deficit attributable to equity holders of the Company amounted to approximately HK\$543.8 million (31 December 2022: approximately HK\$523.5 million). The capital of the Company comprised only the ordinary share. There was no movement in the issued share capital of the Company during the Period.

DIVIDEND

The Board did not recommend the payment of any interim dividend in respect of the Period (2022: Nil).

PLEDGE OF ASSETS

The Group used bank facilities and other borrowings to finance the expansion of its business. As at 31 March 2023, the Group did not have any secured borrowings (31 December 2022: the Group did not have any secured borrowings).

ISSUE US\$55 MILLION OF CREDIT ENHANCED GUARANTEED BONDS INTENDED FOR PURCHASE BY PROFESSIONAL INVESTORS ONLY AND LISTED ON THE HONG KONG STOCK EXCHANGE

On 17 March 2021, the Company, as issuer, Dafeng Port Development Group, as guarantor, and Tensant Securities Limited, Haitong International Securities Company Limited, BOSC International Company Limited, Shanghai Pudong Development Bank Co., Ltd., Hong Kong Branch, CEB International Capital Corporation Limited, China Everbright Securities (HK) Limited, Huarong International Securities Limited and China Industrial Securities International Brokerage Limited (together, the "**Placing Agents**"), entered into a placing agreement pursuant to which the Company agreed to appoint the Placing Agents as placing agents for the purpose of procuring, and to use its best efforts, the subscription of the bonds of up to an aggregate principal amount of US\$55,000,000 (the "**Placing**").

The Placing was completed on 24 March 2021. Pursuant to the results of a book building exercise, the bonds in the principal amount of US\$55 million has been placed to bondholders at a coupon rate of 2.4% per annum, and terms of 3 years.

The net proceeds from this Placing, after deducting commissions to be charged by the Placing Agents and other estimated expenses payable in connection with this offering, was approximately US\$52.70 million. The net proceeds has been used in repayment of the principal of US\$50 million and interest of approximately US\$1.9 million of unlisted secured bonds due on 28 March 2021, and the balance of approximately US\$0.8 million has been used to satisfy the Group's normal working capital requirement.

For further details, please refer to the announcements of the Company dated 24 March 2021 in relation to the Placing.

SIGNIFICANT INVESTMENT, MATERIAL ACQUISITIONS AND DISPOSALS

As at 31 March 2023, the Group was interested in approximately RMB100 million registered capital in Jiangsu Hairong, a company providing integrated logistics handling services in the PRC market, representing approximately 40% of its total registered capital.

Jiangsu Hairong is a private company and there is no quoted market price available for the investment. The carrying amount of the investment was nil as at 31 March 2023 (31 December 2022: Nil). The Group has not recognised further losses as the Group's share of losses of Jiangsu Hairong exceeds the carrying amount of its interest in Jiangsu Hairong. The unrecognised share of loss of Jiangsu Hairong for the Period and cumulative up to the end of the Period amounted to approximately HK\$2.1 million (for the period from 1 January 2022 to 31 December 2022: approximately HK\$7.7 million) and HK\$26.7 million (2022: approximately HK\$24.6 million), respectively.

Save as disclosed in this report, the Company did not make any significant investments, material acquisitions or disposals of subsidiaries and associates during the Period.

FUTURE PLANS FOR MATERIAL INVESTMENTS OR CAPITAL ASSETS AND EXPECTED SOURCES OF FUNDING

The Group had no future plans for material investments or capital assets as at 31 March 2023. The Group will continue to monitor the industry closely and review its business expansion plans regularly so as to take necessary measures in the Group's best interests.

OUTLOOKS

The Group expects that China's economy will gradually recover from the pandemic. Looking ahead, the Company will operate the existing businesses of the Group in a prudent manner and actively seize the opportunities from the integrated development of Yancheng, Jiangsu Province. The Group will rationally reorganise and optimise the resources of the Company, simplify and restructure to conserve resources and prudently identify investment opportunities. Considering the impact on the import and export businesses of electronic products caused by the trade tensions between China and the US may not improve in the short run, the Group is currently concentrating its resources on its business in Yancheng, Jiangsu Province.

CONTINGENT LIABILITIES

As at 31 March 2023, the Group had no material contingent liabilities (31 December 2022: Nil).

EVENTS AFTER THE PERIOD

Save as disclosed in this report, the Group did not have any material events after the Period and up to the date of this report.

DIRECTORS' AND CHIEF EXECUTIVES' INTERESTS AND SHORT POSITIONS IN THE SHARES, UNDERLYING SHARES AND DEBENTURES OF THE COMPANY OR ANY ASSOCIATED CORPORATION

As at 31 March 2023, none of the Directors or the chief executive of the Company had any interests or short positions in the shares, underlying shares and debentures of the Company or any associated corporation (within the meaning of Part XV of the SFO which were required to be notified to the Company and the Stock Exchange pursuant to Divisions 7 and 8 of Part XV of the SFO (including interests or short positions which they were taken or deemed to have under such provisions of the SFO) or which were required, pursuant to Section 352 of the SFO, to be entered in the register referred to therein; or which were required, pursuant to Rules 5.46 to 5.67 of the GEM Listing Rules relating to securities transactions by the Directors, to be notified to the Company and the Stock Exchange.

SHARE OPTION SCHEME, CONVERTIBLE SECURITIES, WARRANTS OR SIMILAR RIGHTS

The Company operates a share option scheme (the "Scheme") for the purpose of providing incentives, recognising and acknowledging the contributions that eligible persons had made or may make to the Group. The Scheme was adopted pursuant to the written resolutions of the sole shareholder of the Company passed on 3 August 2013. The expiry date of the Scheme is 2 August 2023. Since the Scheme came into effect after the Company was listed on GEM of the Stock Exchange, no share options have been granted, exercised or cancelled by the Company under the Scheme during the Period and there were no outstanding share options under the Scheme as at 31 March 2023 and as at the date of this report.

Up to 31 March 2023, the Company and its subsidiaries have not issued or granted any convertible securities, warrants or other similar rights.

Jing Ji (Holding) Co., Limited, a company wholly-owned by Mr. Jiang Wen, directly and beneficially owns 13,600,000 Shares. As such, under the SFO, Mr. Jiang Wen is deemed, or taken to be, interested in 75,470,000 Shares.
- Ms. Li Qiu Hua directly and beneficially owns 10,520,000 Shares. As Mr. Jiang Wen's spouse, she is, under the SFO, deemed to be, or taken to be, interested in the same number of Shares in which Mr. Jiang Wen is interested.

Save as disclosed above, as at 31 March 2023, the Directors were not aware of any other persons or entities (other than the Directors and chief executives of the Company) who had interests or short positions in the shares or underlying shares of the Company which would fall to be disclosed to the Company under the provisions of Divisions 2 and 3 of Part XV of the SFO or which were recorded in the register required to be kept by the Company under Section 336 of the SFO.

PURCHASE, SALE OR REDEMPTION OF THE COMPANY'S LISTED SECURITIES

During the Period, neither the Company nor any of its subsidiaries purchased, sold or redeemed any of the Company's listed securities.

COMPETING INTERESTS

Dafeng Port Development Group, a controlling shareholder of the Company, has a direct wholly-owned subsidiary, namely 江蘇鹽城港供應鏈科技集團有限公司 (Jiangsu Yancheng Port Supply Chain Technology Group Co., Ltd*) ("Yancheng Port Supply Chain"), and a direct non wholly-owned subsidiary, namely 江蘇悦達港口物流發展有限公司 (Jiangsu Yueda Harbour Logistics Development Company Limited*) ("Yueda Logistics") which are engaged in trading of various goods including coals, metal ores, non-metallic ores, non-ferrous metal, chemical products, non-metal construction materials, scrap steel and wood. Whereas the Group has also developed the business of trading of electronic products, petrochemical products and various other products. Accordingly, the businesses of Dafeng Port Development Group and its subsidiaries (the "Dafeng Port Development Group Companies") may be construed as businesses which compete with or are likely to compete with one of the core principal activities of the Group. The Board considered that the businesses of the Dafeng Port Development Group Companies do not pose material competitive threat to the Group because the Group and Dafeng Port Development Group Companies have different focuses on the type of products offered which target at different customers in the market.

There is no overlap in the directorships among the Company, Dafeng Port Development Group, Yancheng Port Supply Chain and Yueda Logistics. The Directors consider that the Board can operate independently from Dafeng Port Development Group in the best interest of the Company and its shareholders as the whole.

Save as disclosed above, as at 31 March 2023, none of the Directors, controlling shareholders of the Company or their respective close associates had any interests in a business, which competes or is likely to compete either directly or indirectly with the business of the Group which would be required to be disclosed under Rule 11.04 of the GEM Listing Rules.

CODE OF CONDUCT REGARDING SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted a code of conduct regarding securities transactions by Directors on terms no less exacting than the required standard of dealings set out in Rules 5.48 to 5.67 of the GEM Listing Rules. Having made specific enquiries to all the Directors, the Company was not aware of any non-compliance with the required standard of dealings and its code of conduct regarding securities transactions by Directors for the Period.

CORPORATE GOVERNANCE CODE

The Company is committed to maintain a high standard of corporate governance. In the opinion of the Directors, the Company has complied with all the code provisions set out in the CG Code during the Period. The Company will continue to review its corporate

governance practices in order to enhance its corporate governance standard, comply with regulatory requirements and meet the growing expectations of the shareholders and investors.

AUDIT COMMITTEE

The Audit Committee has been established on 3 August 2013 with written terms of reference in compliance with Rules 5.28 to 5.29 of the GEM Listing Rules and code provision D.3.3. The members of the Audit Committee comprise Mr. Lau Hon Kee (Chairman), Dr. Bian Zhaoxiang and Mr. Yu Xugang, all of whom are independent non-executive Directors. The primary duties of the Audit Committee are to make recommendations to the Board on the appointment and removal of the external auditor, review the financial statements and related materials and provide advice in respect of the financial reporting process and oversee the internal control procedures and the risk management system of the Group.

The First Quarterly Financial Statements have not been audited by the Company's auditor, but have been reviewed by the Audit Committee. The Audit Committee is of the opinion that the First Quarterly Financial Statements complied with the applicable accounting standards, the GEM Listing Rules and legal requirements, and that adequate disclosures have been made.
