**POLL RESULTS OF THE
ANNUAL GENERAL MEETING HELD ON 12 MAY 2023**

The board of directors (the “**Board**”) of M&L Holdings Group Limited (the “**Company**”) hereby announces that at the annual general meeting of the Company held on 12 May 2023 (the “**AGM**”), all the proposed resolutions as set out in the notice of AGM dated 31 March 2023 were duly passed by holders of the shares of the Company by way of poll.

As at the date of the AGM, the total number of issued shares of the Company was 600,000,000 shares (“**Shares**”), which was the total number of Shares entitling the holders thereof to attend and vote on any of the resolutions proposed at the AGM. None of the holders of any Shares was required to abstain from voting on, or abstain from voting in favour of, any resolutions at the AGM. None of the holders of the Share has stated their intention in the circular of the AGM to vote against or to abstain from voting on any of the resolutions proposed at the AGM.

All directors of the Company attended the AGM in person, except Mr. Ng Lai Po who attended by teleconference. The Company’s branch share registrar in Hong Kong, Tricor Investor Services Limited, was appointed as the scrutineer for the vote-taking at the AGM.
