# CHAIRLADY'S STATEMENT

## 主席報告書

On behalf of the board of directors ("Board") of North Asia Strategic Holdings Limited ("Company"), I am pleased to present the annual results of the Company and its subsidiaries (collectively, the "Group") for the financial year ended 31st March 2023 (the "Year").

Facing tremendous challenges during the Year, the Group managed to record a consolidated net profit of approximately HK\$1,088,000, representing a decrease by 98.6% from last year.

### NORMALISATION AFTER THE PANDEMIC

The COVID-19 pandemic has finally ended with the announcement by the World Health Organization on 5th May 2023 that COVID-19 is no longer a global health emergency. Like most countries around the world, China has eased the pandemic measures and scrapped its strict zero-Covid policy which caused a rebound of China economy shortly after the reopening of border. However, the combined effect of geopolitical factors and Russian-Ukraine war and rising interest rates in the United States during the Year have hindered the recovery of the global economy.

The Group's high-tech distribution and services business was affected by sluggish demand in global mobile phone market. However, we are seeing an upward trend in the replacement of petroleum fueled vehicles by electric vehicles and have benefitted from increased orders from leading electric vehicle makers or their OEM manufacturers in China. While the total order sizes are no comparable to those serving the mobile phone markets, these increased orders compensated to some extent for the loss of orders from mobile phone manufacturing customers. We are also seeing normalisation in deliveries, after the order backlog due to semiconductor chip shortages and global supply chain disruptions during the Year. The Group has been able to fulfil more orders during the fourth quarter of the Year, when measures for COVID-19 were scrapped.

The Group's leasing business has been experiencing shrinking operating lease orders for SMT machines and severe price competition due to poor demand in mobile phone market.

本人謹代表北亞策略控股有限公司(「本公司」)董事會(「董事會」)，欣然呈列本公司及其附屬公司(統稱「本集團」)截至二零二三年三月三十一日止財政年度(「本年度」)之年度業績。

縱使本年度面臨嚴峻挑戰，本集團仍能錄得綜合純利約1,088,000港元，較去年減少98.6%。

### 疫後復常

隨著世界衛生組織於二零二三年五月五日宣佈2019冠狀病毒病不再構成國際關注的突發公共衛生事件，2019冠狀病毒病疫情終於完結。與全球大多數國家一樣，中國放寬防疫措施並取消其嚴格的「清零」政策，使中國經濟於開放邊境後不久反彈。然而，本年度全球經濟復甦受地緣政治因素及俄烏戰爭以及美國利率不斷上升的共同影響拖累。

本集團之高科技產品分銷及服務業務受全球手機市場需求低迷所影響。然而，我們看到電動汽車取代燃油汽車呈上升趨勢，而我們亦受惠於來自中國領先的電動汽車製造商或其OEM製造商的訂單增加。儘管總訂單規模無法與手機市場的訂單相比，但這些訂單增量可某程度上填補手機生產客戶減少的訂單。我們亦觀察到，於本年度因半導體芯片短缺及全球供應鏈中斷導致的訂單積壓後，交付已回復正常。本集團能於本年度第四季度(2019冠狀病毒病措施在此期間取消)履行更多訂單。

由於手機市場需求疲弱，本集團之租賃業務的SMT機器經營租賃訂單縮減及遭受嚴峻的價格競爭。



### STRENGTHENING OF BUSINESS

The Group has continued to upgrade its enterprise resource planning (“ERP”) system during the Year for supporting the Group’s future business growth and improving work efficiency. Since it became increasingly difficult to recruit talent, the Group will leverage on IT transformation and deliver more training to sales and service engineering staff teams to prepare for future business expansion.

The Group will continue to adopt a prudent and low leverage policy while seeking growth of its business. The Group will leverage on its listing status to raise capital, if and when appropriate to address financing needs for its future development and investment.

### DIVERSIFICATION OF BUSINESS

For the long term development of the Group, the Group agreed to acquire in a small online payment business operating under the “Jarvix” brand in Hong Kong during the Year. The roll-out of consumer coupons by the Hong Kong Government on electronic payment platform during the COVID-19 pandemic not only stimulated the local economy but also helped popularised electronic payments in Hong Kong. The Hong Kong Government also plans to issue retail central bank digital currency (e-HKD) in the future, which can provide the Group ample business opportunities from more widespread of electronic payments.

### OUTLOOK

The Greater Bay Area blue print of President Xi outlines the future for growth and development for Hong Kong. With its headquarters in Hong Kong and major operating units in Southern China area, the Group is motivated and enthusiastic about the future of Hong Kong and its role in the Greater Bay Area initiative. To further strengthen soft power of Hong Kong, the Hong Kong Government has launched the “top talent pass scheme” and received overwhelming response. The Hong Kong Government has also proposed the “Northern Metropolis Strategy” and “Lantau Tomorrow Vision” to complement the Greater Bay Area initiative. The Group will proactively look for opportunities to increase investment in line with the 14th five-year plan and Great Bay Area initiatives, through both internal growth and external acquisition.

### 強化業務

本集團於本年度亦持續升級其企業資源規劃（「ERP」）系統，以支持本集團之未來業務增長及改進工作效率。由於招聘人才越趨艱難，本集團將利用數碼轉型並為銷售及服務工程員工團隊提供更多培訓，為未來的業務擴張做好準備。

本集團在尋求拓展業務的同時，將繼續採取審慎及低槓桿之政策。本集團將在適當時候利用其上市地位集資，以滿足其未來發展及投資方面的融資需求。

### 業務多元化

為了本集團的長遠發展，本集團於本年度同意收購一家以「Jarvix」品牌營運的香港小型網上支付企業。香港政府於2019冠狀病毒病疫情期間在電子支付平台上推出消費券，不僅刺激本地經濟，更推動電子支付於香港變得普及。香港政府未來亦計劃發行零售層面央行數碼貨幣（數碼港元），能為本集團在電子支付廣泛使用時提供充裕商機。

### 展望

大灣區由習近平主席謀劃，概述了香港未來的增長及發展。本集團總部位於香港，主要營運部門位於華南地區，對香港的未來充滿信心，對其在大灣區計劃中的角色滿懷動力及熱情。為進一步加強香港的軟實力，香港政府推出「高端人才通行證計劃」，反應熱烈。香港政府亦已動議「北部都會區發展策略」及「明日大嶼願景」來配合大灣區計劃。本集團將通過內部增長及外部收購，配合「十四五」規劃及大灣區計劃，積極尋求增加投資機會。



## OUTLOOK *(Continued)*

More and more companies are rethinking their subcontracting strategy of outsourcing manufacturing in China due to the ongoing trade war between China and United States. With the increasing risk of US-China decoupling is accelerating, we are likely to see more manufacturers move their manufacturing base outside China to Southeast Asia. Having foreseen this risk, the Group has established offices in Southeast Asia countries and will continue to expand its Southeast Asia countries sales and engineering cohort to better respond to the needs of our customers.

## A SOCIALLY RESPONSIBLE COMPANY

The long-term sustainability of the Group depends on its ability to maintain a balance between its stakeholders. As a member of a community, the Group believes that it is responsible not only to the Company's shareholders but also to other stakeholders such as its suppliers, customers, employees and the society in which it operates and the government. The Group has continued to support the Hong Kong Government's initiative to retain employment during pandemic and will continue to do so after the pandemic. We support the thinking that an empowered employee will bring long-term benefit to the Company and to the society. Therefore, the Group has started a sponsorship program to encourage talented employees to broaden their skills and is reviewing its remuneration policies to provide better support and rewards to our staff for their long term commitment and enhanced professionalism. In 2022, the Company was awarded "The Eleventh Junzi Corporate Award" by the Hang Seng University of Hong Kong for conducting its operations in accordance with the Confucian ethics of "Five Virtues" referring to "Benevolence, Rightness, Propriety, Wisdom and Trustworthiness". The award encourages the Group in its continuous effort in becoming a socially responsible company.

## 展望(續)

由於中美貿易戰持續，越來越多公司重新考慮其將生產外判到中國的分包策略。由於中美脫鈎的風險正在加劇，我們可能會看到更多生產商將生產基地遷離中國至東南亞。有見及此，本集團已於東南亞國家設立辦事處，並將繼續擴大其東南亞國家之銷售及工程團隊，以更好地應對客戶需求。

## 對社會負責的公司

本集團的長期可持續發展能力取決於其能否維持持份者之間的平衡。作為社區的一員，本集團認為其不僅要對本公司股東負責，亦要對其他持份者（例如供應商、客戶、僱員及其經營所在之社會及政府）負責。本集團繼續支持香港政府在疫情期間的保就業，此舉亦將於疫情後持續。我們堅信有能力的僱員將為本公司及社會帶來長期利益，因此本集團推出資助計劃以鼓勵優秀僱員擴大自身技能，並正審閱其薪酬政策，以更好支持及獎勵僱員作出的長期奉獻及提升專業水準。於二零二二年，本公司以合乎儒家的「五常」（即「仁、義、禮、智、信」）道德準則經營，因而榮獲香港恒生大學頒發「第十一屆君子企業大獎」。此項殊榮鼓勵本集團繼續努力成為對社會負責的公司。



## APPRECIATION

Without the trust and support of our shareholders, customers, suppliers, fellow directors, management and staff, I could not have persevered and to overcome the challenges during the Year. The financial and operational performance are the direct results of years of relentless hard work of our entire staff, management team and directors. I would like to take this opportunity to thank the directors for their long-term service and commitment. I am also grateful for the support and guidance of the Listing Division staff who have been helpful in facilitating our corporate actions.

# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層論述及分析

### FINANCIAL AND BUSINESS PERFORMANCE

During the Year, the Group recorded consolidated revenue of approximately HK\$2,266,642,000, representing a decrease of 7.3% from approximately HK\$2,445,150,000 last year. The decrease in revenue was mainly due to the drop in revenue of direct machines sales from our hi-tech distribution and services division by 6.8% compared with last year.

During the Year, the Group recorded consolidated net profit of approximately HK\$1,088,000, representing a decrease of 98.6% from approximately HK\$79,793,000 in last year. The Group's gross profit ratio decreased slightly from last year's 16.2% to 14.7% in the Year. The decrease in consolidated net profit of the Group was mainly due to increase in supply chain costs and administration expenses.

The Group's total operating cost during the Year increased by approximately HK\$45,834,000 or 15.4% from last year's approximately HK\$298,443,000 to HK\$344,277,000. The increase in operating expenses was due to the depreciation of both the Japanese Yen and Renminbi against the Hong Kong dollar. That contributed to net exchange loss of approximately HK\$26,306,000 by the Group during the Year, compared to a net exchange gain of approximately HK\$3,153,000 recorded last year.

Sluggish consumer electronic market caused most of the Group's customers to cut down or postpone their manufacturing equipment acquisition plan during the Year. As evidenced by the manufacturing Purchasing Manager Index (PMI) published by National Bureau of Statistics of China, during the first 3 quarters from April 2022 to December 2022, PMI were below 50 except for June and September at 50.2 and 50.1 respectively, reflecting contraction of the manufacturing industry during first 3 quarters. During Q4, PMI rebounded to above 50 from January to March 2023 with its highest at 52.6 for February 2023. That rebound did not extend to later periods and has dropped below 50 again from April 2023 being a strong signal that the outlook of the manufacturing industry remained pessimistic. In view of this, the Group will pay extra attention on operating cost control under the worsening business environment.

The basic earnings per share in the Year was approximately HK0.3 cents, representing a decrease of 98.6% from approximately HK21.9 cents in last year. As at 31st March 2023, the consolidated net asset value of the Company per ordinary share was approximately HK\$3.16, representing a decrease of HK\$0.24 from approximately HK\$3.40 as at 31st March 2022.

### 財務及業務表現

於本年度，本集團錄得綜合收入約2,266,642,000港元，較去年約2,445,150,000港元減少7.3%。收入減少主要由於本集團高科技產品分銷及服務分部之直接機器銷售收入較去年減少6.8%所致。

本集團於本年度錄得綜合純利約1,088,000港元，較去年約79,793,000港元減少98.6%。本集團之毛利率由去年16.2%稍微減少至本年度14.7%，本集團綜合純利減少主要由於供應鏈成本及行政開支增加所致。

本集團之經營費用總額由去年約298,443,000港元增加約45,834,000港元或15.4%至本年度344,277,000港元。經營開支上漲是由於日圓及人民幣兌港元貶值。其為本集團本年度帶來匯兌虧損淨額約26,306,000港元，相比之下，本集團於去年則錄得匯兌收益淨額約3,153,000港元。

全球消費電子市場需求低迷，導致本集團大多數客戶於本年度縮減或推遲其製造設施採購計劃。誠如中國國家統計局的製造業採購經理指數 (PMI) 顯示，從二零二二年四月至二零二二年十二月的首三個季度，除六月及九月分別為50.2及50.1外，PMI均低於50，反映製造業於首三個季度處於緊縮狀態。於第四季度，PMI從二零二三年一月至三月回升至高於50，最高為二零二三年二月的52.6。該反彈並無延續至較後期間，並於二零二三年四月再次跌至低於50，為製造業前景仍然悲觀的強烈訊號。有鑑於此，本集團將在業務環境惡化的情況下格外著重控制經營成本。

本年度之每股基本盈利約為0.3港仙，較去年約21.9港仙減少98.6%。於二零二三年三月三十一日，本公司每股普通股綜合資產淨值約為3.16港元，較二零二二年三月三十一日約3.40港元減少0.24港元。



# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層論述及分析

### FINANCIAL AND BUSINESS PERFORMANCE *(Continued)*

Below is a summary of the financial and business highlights of our business divisions. The profit/loss figures disclosed below do not include any intra-group sales and charges, as they are eliminated upon consolidation.

### HI-TECH DISTRIBUTION AND SERVICES DIVISION

The Group conducts its hi-tech distribution and services business through its wholly-owned subsidiary, American Tec Company Limited (“AMT”). AMT, a 30 plus years old firm is a leading distributor and after-market service provider of surface-mount technology (“SMT”) equipment and semiconductor manufacturing equipment in Asia. AMT has more than 270 professional engineers and customer care staff in more than 25 cities in China, Vietnam and India and other South-East Asia countries to service the needs of its customers. Customers include most of the major telecom and electronic equipment manufacturers in the world. AMT is especially well positioned with its growing base of Chinese manufacturers. Its suppliers include leading equipment and solutions manufacturers from Asia, the United States and Europe.

During the Year, the division’s revenue was approximately HK\$2,130,305,000, representing a decrease of HK\$208,835,000 or 8.9%, compared to approximately HK\$2,339,140,000 in the last year. The decrease in revenue was mainly due to sluggish demand in the global mobile phone market which directly impact the Group’s mobile phone manufacturing customers. The Group experienced significant decline in orders during the first 3 quarters during which the customers have been delaying or scaling down their procurement plans for manufacturing equipment. China had eased the pandemic measures and scrapped its strict zero-Covid policy in December 2022 and the disruptions in component production and logistics were eased from the 4th quarter of the Year. The customer orders received by the division in the 4th quarter of the Year were rebound and the division was vigorously chasing the completion of orders. From the exceptional effort put in by various operational teams of the division, it managed to minimize the level of decrease in revenue for the Year compared to last year.

### 財務及業務表現 *(續)*

以下為我們業務分部之財務及業務摘要。由於集團內公司間之銷售及費用已於綜合入賬時對銷，故以下披露之溢利／虧損數字並不包括任何該等款項。

### 高科技產品分銷及服務分部

本集團透過其全資附屬公司美亞電子科技有限公司（「美亞科技」）經營高科技產品分銷及服務業務。美亞科技營業超過30年，為亞洲領先之表面貼裝技術（「SMT」）設備及半導體製造設備分銷商及售後服務提供者。美亞科技由逾270名專業工程師及客戶服務員工組成，分佈於中國、越南、印度及其他東南亞國家逾25個城市，為其客戶之需求效力。客戶包括全球大部分主要電訊及電子設備製造商。隨着其中國製造商不斷增加，美亞科技具備之條件尤為有利。其供應商包括來自亞洲、美國及歐洲之領先設備及解決方案製造商。

於本年度，該分部之收入約為2,130,305,000港元，較去年約2,339,140,000港元減少208,835,000港元或8.9%。收入減少主要由於全球手機市場需求低迷導致本集團手機製造客戶直接受到影響所致。首三個季度期間，客戶一直推遲或縮減其製造設施採購計劃，導致本集團期內之訂單大幅下跌。中國於二零二二年十二月放寬防疫措施並取消其嚴格的「清零」政策，對零部件生產及物流之干擾自本年度第四季度起放寬。本年度第四季度收到之客戶訂單反彈，該分部全力爭取將訂單完成。憑藉該分部不同營運團隊加大力度，使本年度收入相對於去年之減幅得以盡量減少。

## HI-TECH DISTRIBUTION AND SERVICES DIVISION

(Continued)

Direct machine sales revenue was approximately HK\$1,968,076,000, representing a decrease of HK\$144,436,000 or 6.8%, compared to approximately HK\$2,112,512,000 in the last year. The division's spare part and software sales were approximately HK\$82,218,000, representing a decrease of HK\$169,000 or 0.2%, compared to approximately HK\$82,387,000 in the last year. The sales support service, commission and other services income was approximately HK\$80,011,000, representing a decrease of HK\$64,230,000 or 44.5%, compared to approximately HK\$144,241,000 in last year. The decrease in high-margin sales support services, commissions and other services was primarily due to a large sales support service order placed last year by one of our major customers for its new smartphone product line.

The division's net profit for the year was approximately HK\$60,594,000, representing a decrease of HK\$85,610,000 or 58.6% compared to approximately HK\$146,204,000 last year.

## LEASING DIVISION

The Group conducts its leasing business through its wholly-owned subsidiaries, North Asia Financial Leasing (Shanghai) Co., Ltd. ("NAFL") in China Shanghai Pilot Free Trade Zone and Fuji North Asia Financial Leasing (Shenzhen) Co., Ltd. ("FNAFL") in Qianhai Shenzhen-Hongkong Modern Service Industry Cooperation Zone. The leasing division provides finance and operating lease arrangements to customers of the Group's hi-tech distribution and services division and other projects.

The leasing business encountered a highly challenging operating environment during the Year. Due to the prolonged impact of the COVID-19 pandemic and a decrease in consumer purchasing power, it resulted in weakened demand for consumer electronic products. The supply chain, production schedules of manufacturers and customer terms of equipment rental became highly unstable and often disrupted, making them more volatile and unpredictable.

## 高科技產品分銷及服務分部(續)

直接機器銷售收入約為1,968,076,000港元，較去年約2,112,512,000港元減少144,436,000港元或6.8%。該分部之零部件及軟件銷售約為82,218,000港元，較去年約82,387,000港元減少169,000港元或0.2%。銷售支援服務、佣金及其他服務收入約為80,011,000港元，較去年約144,241,000港元減少64,230,000港元或44.5%。高利潤之銷售支援服務、佣金及其他服務減少，主要因為去年有其中一個主要客戶就其新智能手機生產線發出一份大額銷售支援服務訂單所致。

於本年度，該分部錄得純利約60,594,000港元，較去年約146,204,000港元減少85,610,000港元或58.6%。

## 租賃分部

本集團透過其全資附屬公司比亞融資租賃(上海)有限公司(「比亞融資租賃」)於中國上海自由貿易試驗區，及富士比亞融資租賃(深圳)有限公司(「富士比亞融資租賃」)於前海深港現代服務業合作區經營租賃業務。租賃分部為向本集團之高科技產品分銷及服務分部及其他項目之客戶提供融資及經營租賃安排。

租賃業務在本年度遭遇競爭激烈之經營環境。由於長期受2019冠狀病毒病疫情之影響，加上消費者購買力下降，導致對消費電子產品之需求轉弱。供應鏈、製造商生產時間表，以及設備租賃之客戶條款變得極不穩定及常被中斷，導致彼等均為不穩及不可預測。





# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層論述及分析

### LEASING DIVISION *(Continued)*

The division generated revenue of approximately HK\$136,337,000 during the Year, representing a significant increase of 28.6% from approximately HK\$106,010,000 last year. In order to support business growth and diversify revenue streams, various new areas have been developed this Year, including the sale of machines related to the semiconductor industry and the addition of different brands to our portfolio. The division recorded sales of machineries at approximately HK\$93,865,000 during the Year, representing a 58.9% increase from approximately HK\$59,066,000 last year.

Despite the challenging operating lease business environment this Year, the division maintained a reasonable utilization rate of its available machines leveraging on our professional expertise and allocating resources to meet the needs of our major customers who are small home appliances and mobile phones manufacturers. However, the market has become increasingly difficult due to rental price competition from other leasing businesses competitors and second-hand machine dealers, resulting in a higher volume of idle machines in the market. This led to approximately 50.6% year-on-year decrease in gross profit margin of the division's operating lease business in the Year. Revenue from operating lease arrangements during the Year recorded approximately HK\$35,049,000, decreased by 6.8% from approximately HK\$37,614,000 last year.

Despite the decline in demand from large customers and the effects of risk control measures implemented, the division's financing lease business has shown slight growth. To further mitigate risks, we have diversified our customer base to high-tech products with substantial growth potential, and offered short-term (6-12 months) financing options, consistent with the goal to minimize exposure to longer-term financing to ensure sustainable and stable growth. During the Year, the interest income derived from finance lease receivables decreased by approximately 20.4% to approximately HK\$7,423,000 in the Year from approximately HK\$9,330,000 last year. As at 31st March 2023, the aggregate principal amount of finance lease receivables increased by 27.2% to approximately HK\$78,350,000 from approximately HK\$61,583,000 at 31st March 2022. As risk management remains a top priority, management will continue to maintain a conservative approach in managing the Group's exposure to finance lease business.

### 租賃分部(續)

該分部於本年度錄得收入約136,337,000港元，較去年約106,010,000港元大幅增長28.6%。為支持業務增長及實現多元化的收入來源，本年度開發了多個新領域，包括與半導體行業相關的機器銷售，及於我們產品組合中增加不同的品牌。該分部於本年度錄得機器銷售額約為93,865,000港元，較去年約59,066,000港元上升58.9%。

儘管本年度經營租賃業務挑戰重重，由於我們善用專業專才及分配資源以配合小型家庭電器及手機製造商等主要客戶之需要，該分部可供使用機器仍保持合理使用率。然而，其他租賃業務競爭對手及二手機器交易商之租金價格競爭，令市場形勢日趨嚴峻，導致市場上閒置機器數量增加。此事導致租賃分部之經營租賃業務的毛利率於本年度按年下跌約50.6%。本年度來自經營租賃安排的收入由去年約37,614,000港元減少6.8%至約35,049,000港元。

儘管大型客戶需求減少及採取風險管控措施，惟租賃分部之融資租賃業務仍顯示輕微增長。為進一步舒緩風險，我們分散客戶群，以納入具龐大增長潛力之高科技產品，並提供短期(六至十二個月)融資選項，與將所面臨長期融資之風險盡量減少以確保增長可持續及穩定的目標一致。於本年度，融資租賃應收款項所產生之利息收入較去年約9,330,000港元減少約20.4%至本年度約7,423,000港元。於二零二三年三月三十一日，融資租賃應收款項本金總額較二零二二年三月三十一日約61,583,000港元增長27.2%至約78,350,000港元。由於風險管理仍為高優次項目，管理層將繼續在管理本集團融資租賃業務風險方面維持保守態度。



## LEASING DIVISION *(Continued)*

Although the division recorded revenue growth for the Year, the reduction in profit margin has had a substantial impact on the division's overall financial performance. Consequently, the division recorded a net loss of approximately HK\$1,893,000 for the Year, compared to a net profit of approximately HK\$4,064,000 last year.

## CORPORATE DEVELOPMENT

On 21st December 2022, the Group entered into a sale and purchase agreement ("SPA") with Aigniter Holdings Limited ("AHL"), Aigniter Technologies Limited ("ATL") and their affiliated companies, to acquire upon the fulfilment of certain conditions precedent (i) AHL entire interest in Jarvix (Hong Kong) Limited ("Jarvix"), (ii) the Tech and IP Rights which ATL is required under the SPA to assign to Jarvix at completion of the acquisition and (iii) the ATL receivables, for an initial consideration of USD2,400,000 in cash subject to adjustments according to the terms of SPA. Jarvix is principally engaged in operating the payment business (using the Tech and IP Rights) which provides merchants with a payment solution that bridges online payment acquirers (that operate payment platforms with a wide range of credit card issuers) and such merchants. The Group's proposed acquisition of Jarvix was driven by the growth prospects of its business which, post-acquisition, can contribute towards the diversification of the Group's revenue streams. Further details of the proposed acquisition were disclosed in the Company's announcement dated 21st December 2022.

The acquisition of Jarvix was completed on 3rd April 2023 ("Completion"). As a brief financial update, the unaudited turnover and loss (before and after taxation) of Jarvix from its incorporation to 31st March 2023 was approximately HK\$20,011,000 and HK\$2,430,000 respectively. During this period, aggregate fees of approximately HK\$6,966,000 were payable by Jarvix to ATL (the unpaid portion of which will be included in the ATL receivables) for the use of the Tech and IP Right (which form part of the Acquisition) and this arrangement was terminated with effect from Completion.

## 租賃分部 *(續)*

雖然該分部於本年度錄得收入增長，惟利潤率下降對該分部的整體財務表現帶來沉重影響。結果，該分部於本年度錄得虧損淨額約1,893,000港元，相比去年則錄得純利約4,064,000港元。

## 企業發展

於二零二二年十二月二十一日，本集團與Aigniter Holdings Limited (「AHL」)、Aigniter Technologies Limited (「ATL」) 及其聯屬公司訂立買賣協議 (「買賣協議」)，待達成若干先決條件後，以初始代價2,400,000美元現金 (可根據買賣協議條款進行調整) 收購 (i) AHL 於 Jarvix (Hong Kong) Limited (「Jarvix」) 之全部權益、(ii) ATL 根據買賣協議要求之技術及知識資產權利，需於收購完成時指讓予 Jarvix，以及 (iii) ATL 應收款項。Jarvix 主要從事營運支付業務 (使用技術及知識資產權利)，為商戶提供支付解決方案，連結網上支付收單機構 (營運具備大量信用卡發行商之支付平台) 與該等商戶。本集團擬議收購 Jarvix，乃受其業務的發展前景吸引，在收購後可望為本集團帶來收入來源多元化。有關擬議收購的詳情於本公司日期為二零二二年十二月二十一日之公告內披露。

收購 Jarvix 於二零二三年四月三日完成 (「完成」)。作為財務更新簡況，Jarvix 於註冊成立時至二零二三年三月三十一日之未經審核營業額及虧損 (除稅前及除稅後) 分別約為20,011,000港元及2,430,000港元。於該期間，就使用技術及知識資產權利 (組成收購事項之一部分) 而言，Jarvix 應向 ATL 支付之總費用約為6,966,000港元 (其未付部分將列入 ATL 應收款項)，而有關安排已自於完成時起終止。



### OUTLOOK

#### Overall Summary

The COVID-19 pandemic finally came to an end with the announcement by the World Health Organization on 5th May 2023 that COVID-19 is no longer a global health emergency. Most countries have terminated their social distancing and quarantine policies and expect economic recovery from the impact of such policies in near future. In response to the pandemic and geopolitical risks, we see a trend of diversification of manufacturing bases outside China amongst our customers. In order to serve our customer, management has also diversified and expanded its operations in Thailand and Vietnam.

The Greater Bay Area blue print by President Xi outlines the future for growth and development for Hong Kong. Since the Group is motivated and optimistic about the future of Hong Kong and its role in the Greater Bay Area initiative, it acquired the “Jarvix” online payment business in Hong Kong to capture the local business opportunities. Going forward, the Group will seek to continue to grow its business and to enhance the operational efficiency of its various business divisions to improve their profitability and increase shareholders’ value.

#### Hi-Tech Distribution and Services Division

Most countries have set a net-zero emission target by 2030. Some of these countries have codified this target in their laws. To achieve this net-zero emissions target, the Company expects to see the large-scale replacement of petroleum fuelled vehicles with electric vehicles. The emerging electric vehicle manufacturing industry creates new opportunities for the Group since some of the Group’s major customers are leading electric vehicle manufacturers, or their OEM manufacturers in China.

On the other hand, with the emergence of the metaverse that provides new experience of virtual interaction in the 3D world in social networking, entertainment, gaming, education and commerce, we expect to see more investments on infrastructure building for more virtual reality and virtual augmented equipped applications. Furthermore, ChatGPT (AI Chatbot by OpenAI) suddenly became popular all over the world contributing to a new wave of growth of the demand for Cloud server build on GPU platform.

### 展望

#### 整體概要

隨著世界衛生組織於二零二三年五月五日宣佈2019冠狀病毒病不再構成國際關注的突發公共衛生事件，2019冠狀病毒病疫情終於完結。大部分國家已終止其社交距離及隔離政策，經濟預計於不久的將來從該等政策影響中復甦。為應對疫情及地緣政治風險，我們看到我們的客戶間出現將生產基地分散至中國以外的趨勢。為服務我們的客戶，管理層亦已將其業務分散及擴展至泰國及越南。

大灣區由習近平主席謀劃，概述了香港增長及發展的未來。由於本集團對香港的未來充滿信心，對其在大灣區計劃中的角色滿懷動力及熱情，因此收購一家香港網上小額支付企業「Jarvix」，以掌握本地商機。展望未來，本集團將繼續努力擴展業務，同時亦會提高不同業務分部之營運效率，力求改善其盈利能力及提升股東價值。

#### 高科技產品分銷及服務分部

大多數國家已制定於二零三零年達致淨零排放目標。部分國家已編纂此目標至其法律。為達此淨零排放目標，本公司預期可見電動汽車將大規模取代燃油汽車。新興的電動汽車製造行業可為本集團創造新機會，乃由於本集團部分主要客戶為中國領先的電動汽車製造商或其OEM製造商。

另一方面，元宇宙的出現為社交網絡、娛樂、遊戲、教育及商業領域提供3D世界的新穎虛擬互動體驗，我們預見更多的投資注入基礎設施建設及更多虛擬現實及虛擬擴增應用程式。此外，ChatGPT（OpenAI開發的AI聊天機器人）突然風靡全球，對GPU平台上的雲服務器需求產生新一波的增長。

## OUTLOOK (Continued)

### Hi-Tech Distribution and Services Division (Continued)

These trends create ample opportunities for the semiconductor and SMT industries. Some of the Group's major customers are leading electric vehicle manufacturers, telecommunication companies and OEM electronic device manufacturers in China. They play a vital role in the metaverse and electric vehicle transformation. The Group will strive to provide them leading edge equipment and top notch service.

The International Monetary Fund ("IMF") announced recently in its latest World Economic Outlook published in April 2023 that the outlook is uncertain again amid financial sector turmoil, high inflation, ongoing effects of the Russia Ukraine conflict, and three years of COVID-19. IMF revised down its projected world economy growth rate to 2.8% in 2023, which is slightly lower than 2022 economic growth rate of 3.4%. According to Canalys, smartphone shipments in the Q1 of 2023 fell by 13% to 269.8 million units compared to 311.2 million units in Q1 2022. This situation was really disappointing given the early signs of recovery from the end of pandemic. However, Canalys maintained its forecast of marginal declines for 2023 and that the smartphone market will start to regain momentum in the second half of 2023. In March 2023, the International Data Corporation (IDC) Worldwide Quarterly Mobile Phone Tracker predicted that the worldwide smartphone market will decline by 1.1% in 2023 to 1.19 billion units from 2022 shipments of 1.21 billion units, down from 2.8% growth in its previous forecast, since the market continues to suffer from weak demand and ongoing macroeconomic challenges. IDC expects real recovery to occur from 2024, and from there shipments will reach 1.37 billion units in 2027 representing a CAGR of 2.6%. Although China reopening brought good news to the market, the outlook of the smartphone industry is highly uncertain, resulting in cautious outlook.

The Group will continue to closely monitor its working capital, gross margin, operating cost and industry developments with a view to maintaining adequate cash flow, improving its results and achieving long-term sustainability and growth of its business.

## 展望(續)

### 高科技產品分銷及服務分部(續)

該等趨勢為半導體及SMT行業創造充足的機會。本集團部分主要客戶為中國領先的電動汽車製造商、電訊公司及OEM電子設備製造商。彼等在元宇宙及電動汽車轉型中舉足輕重。本集團將致力為彼等提供領先的設備及一流服務。

國際貨幣基金組織(「IMF」)最近在其於二零二三年四月發佈的最新《世界經濟展望》中宣佈，在金融部門動蕩、通貨膨脹高位運行、俄烏衝突持續以及2019冠狀病毒病進入第三年的影響下，未來前景再次充滿了不確定性。IMF將二零二三年的預計全球經濟增速下調至2.8%，略低於二零二二年經濟增速3.4%。根據Canalys所述，於二零二三年第一季度，全球智能手機出貨量為2.698億部，較二零二二年第一季度的3.112億部下跌13%。鑑於疫情完結後出現復甦先兆，此情況令人極為失望。然而，Canalys仍預測二零二三年將有輕微下降，而智能手機市場將於二零二三年下半年開始恢復增長動力。於二零二三年三月，國際數據資訊有限公司(IDC)全球季度手機追蹤報告預測，由於市場仍受需求疲弱及宏觀經濟挑戰持續所拖累，二零二三年全球智能手機市場將從二零二二年出貨量12.1億部下跌1.1%至11.9億部，低於之前預測的2.8%增長。IDC預期二零二四年起將會真正復甦，由此，出貨量於二零二七年將達13.7億部，複合年增長率為2.6%。儘管中國重新開放為市場帶來佳音，惟智能手機市場展望存在高度不確定性，導致對前景持保守態度。

本集團將繼續密切監察其營運資金、毛利率、經營成本及行業發展，以維持足夠現金流、改善業績以及達致業務長期可持續發展及增長。



### OUTLOOK (Continued)

#### Leasing Division

The Group will remain very cautious on developing its leasing business in 2023/24. The Chinese government has implemented measures to stimulate the economy and consumption, such as in the new energy vehicles, energy storage facilities and green energy development are unlikely to offset the challenges faced by the leasing industry. These challenges include the weak outlook for the manufacturing sector generally, including huge excess capacity in the consumer electronics industry. Such an operating environment has contributed to the leasing industry holding a large inventory of leasing equipment in warehouses and being afflicted by falling rental prices (in many cases to half of the peak rental rates in the past few years).

Faced with a severe and uncertain market environment, the leasing division will improve the leasing rate of equipment to speed up return of funds through diversified operational leasing plans, such as increasing support of lease-to-own plans. In addition, we also provide customers with value-added services through independent research and development and customized modification to reduce customers' costs, and at the same time maintain customer relations through our core competitiveness and exclusivity.

For direct finance leases, we will increase risk control by diversifying our business areas, focusing on high-tech products with good growth potential, increasing the development of short-term (6-12 months) financing business, and avoiding long-term direct finance lease business as much as we can.

Considering the macro view of the Russia-Ukraine conflict, the situation in the Taiwan Strait and the major uncertainties in Sino-US relations, as well as the microscopic unfavorable factors such as overcapacity in the electronics manufacturing industry, offshore transfers, uncertain AI policies and lack of new product highlights in smart devices, our strategic business planning will face more difficulties in the new financial year, and there will be great uncertainties in our business development. Based on the principle of prudence, we will on the one hand increase diversified cooperation with our partners to improve the disposal and leasing rate of equipment, and on the other hand, reserve sufficient funds and technologies to prepare for opportunities arising from the crisis.

### 展望 (續)

#### 租賃分部

本集團將對二零二三／二四年發展租賃業務發展保持非常謹慎的態度。中國政府已採取措施刺激經濟及消費，如在新能源車輛消費、儲能設施和綠色能源發展方面，惟不太可能抵銷租賃行業面臨的挑戰。該等挑戰包括製造業整體前景疲弱、消費電子產業過剩產能。該等經營環境導致租賃行業持有大量租賃設備庫存，並受到租賃價格下跌的影響（在大部份個案下，租金為過去幾年高位的一半）。

面對嚴峻、不確定的市場環境，租賃分部將通過加大扶持先租後買等多樣化的經營性租賃方案，提高設備的出租率，加快資金的回籠；另外，我們也通過自主研發，定制化改造等，給客戶提供有附加值的服務，一方面降低客戶成本，另一方面，也通過核心競爭力及排他性維持客戶關係。

融資直租方面，我們將通過分散業務領域，關注成長性好的高技術產品，加大短期（6-12個月）的融資業務的開發，儘量規避長期的融資直租業務等方式，加大風險管控力度。

面對宏觀上的俄烏局勢、台海局勢、中美關係的重大不確定性，以及微觀上電子製造業的產能過剩，像境外轉移、AI政策不確定及智慧裝備缺乏產品新亮點等不利因素，我們在新財年的業務戰略規劃存在較大難度，業務發展也將有很大的不確定性，我們將本著審慎原則，一方面加大與合作夥伴的多元合作，提高設備的處置和出租率，另一方面，也做好資金和技術儲備，為危機中的機會做好準備。

## LIQUIDITY AND FINANCIAL RESOURCES

During the year, the Group generally finance its operation with internally generated resources and banking facilities provided by its principal bankers in Hong Kong. As at 31st March 2023, the Group had a secured other borrowings of HK\$1,800,000 (2022: HK\$15,269,000), which are denominated in RMB. As at 31st March 2023, the Group had banking facilities of approximately HK\$870,268,000 (2022: approximately HK\$876,084,000) from several banks for trade financing. As at 31st March 2023, banking facilities of approximately HK\$147,350,000 (2022: approximately HK\$279,776,000) were utilised by the Group. These facilities were secured by corporate guarantees of approximately HK\$1,130,270,000 (2022: approximately HK\$931,437,000) provided by the Company. As at 31st March 2023, the Group had total assets of approximately HK\$2,079,936,000 (2022: approximately HK\$3,161,987,000) and total liabilities of approximately HK\$644,600,000 (2022: approximately HK\$1,714,545,000). The Group had net cash position as at 31st March 2023 and 2022.

## CONTINGENT LIABILITIES

As at 31st March 2023, pledged deposits of HK\$4,490,000 (2022: HK\$1,275,000) were held as security at a bank in respect of performance bonds in favour of certain contract customers. The guarantees given by the Group to certain banks in respect of performance bonds and standby letter of credit in favour of certain contract customers and a supplier amounted to HK\$61,303,000 (2022: HK\$58,151,000).

## NET ASSET VALUE

Consolidated net asset value per ordinary share attributable to ordinary shareholders of the Company was approximately HK\$3.16 as at 31st March 2023, decreased by HK\$0.24 from approximately HK\$3.40 as at 31st March 2022.

## 流動資金及財務資源

於本年度，本集團一般以內部產生之資源及其香港主要往來銀行提供之銀行融資撥付其營運資金。於二零二三年三月三十一日，本集團之有抵押其他借貸為1,800,000港元(二零二二年：15,269,000港元)，有關借貸以人民幣計值。於二零二三年三月三十一日，本集團之銀行融資約為870,268,000港元(二零二二年：約876,084,000港元)，乃來自多間銀行，作貿易融資用途。於二零二三年三月三十一日，本集團已動用銀行融資約147,350,000港元(二零二二年：約279,776,000港元)。此等融資乃以本公司提供之公司擔保約1,130,270,000港元(二零二二年：約931,437,000港元)作擔保。於二零二三年三月三十一日，本集團之資產總值約為2,079,936,000港元(二零二二年：約3,161,987,000港元)，而負債總額約為644,600,000港元(二零二二年：約1,714,545,000港元)。本集團於二零二三年及二零二二年三月三十一日維持淨現金狀況。

## 或然負債

於二零二三年三月三十一日，抵押按金4,490,000港元(二零二二年：1,275,000港元)已就若干合約客戶獲得之履約保證金於銀行持作抵押。本集團已就其若干合約客戶及一間供應商獲得之履約保證金及備用信用狀向若干銀行提供擔保61,303,000港元(二零二二年：58,151,000港元)。

## 資產淨值

於二零二三年三月三十一日，本公司普通股股東應佔每股普通股綜合資產淨值約為3.16港元，較於二零二二年三月三十一日約3.40港元減少0.24港元。





### NUMBER OF EMPLOYEES AND REMUNERATION POLICIES

As at 31st March 2023, the Group employed 388 (2022: 375) staff. Salaries and annual bonuses are determined according to positions and performance of the employees. Remuneration policies are reviewed annually by the management and remuneration packages are structured to take into account the comparable level of the market. The Group provides on-the-job training and training subsidies to its employees in addition to pension schemes and medical insurance. Total staff costs including contribution to retirement benefit schemes incurred during the year amounted to approximately HK\$194,215,000 (2022: HK\$177,703,000).

The Company operates a share option scheme for the purpose of providing incentives and rewards to Directors, employees and eligible participants who contributed or will contribute to the Group. Details of the share option scheme are set out in the Report of Directors under the section of “Equity-Linked Agreements”.

# CORPORATE GOVERNANCE REPORT

## 企業管治報告

The Company endeavours to maintain high standards of corporate governance in the interests of shareholders, and follows the principles set out in the Corporate Governance Code (the “Code”) contained in Appendix 15 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”).

The Board will continue reviewing and updating its corporate governance practices from time to time to ensure compliance with applicable codes and standards. The Company is committed to developing a corporate culture that is aligned with its purpose, vision, strategy and value. The Group’s employees have to thrive on the culture that enable the Company to achieve long-term sustainability growth and maximize the value of the shareholders and balance the interest of the stakeholders at the same time.

**Purpose:** To establish a leading one-stop service provider for customers, merchants, electronic manufacturers and equipment suppliers.

**Vision:** To be an expert service provider in future smart manufacturing industry and community.

**Strategy:** Achieve long-term sustainability and maintain commitment to responsibilities towards shareholders and stakeholders like employees and suppliers and relevant local government.

**Value:** Integrity, gender diversification, excellence in performance, internal and external collaboration and professionalism.

Throughout the year ended 31st March 2023 (the “year”), the Company complied with all the Code provisions with the exceptions addressed below and, where appropriate, adopted the recommended best practices set out in the Code.

Code provision C.2.1 stipulates that the roles of chairman and chief executive should be separate and should not be performed by the same individual. However, the Board’s decisions are implemented under the leadership of the Chairlady with the involvement and support of the chief executive officer(s) and general manager(s) of the Company’s operating companies. The Board believes that the balance of authority and division of responsibility are adequately ensured by the operations of the Board and management which comprise experienced and high calibre individuals.

### Board Meetings

The Board regularly meets in person or through other electronic means of communication at least four times every year to determine overall strategic direction and objectives and approve quarterly, interim and annual results, budgets and other significant matters. At least 14 days' notice of regular Board meetings are given to all Directors, who are all given an opportunity to attend and include matters in the agenda for discussion. Apart from formal meetings, matters requiring Board approval are also arranged by means of circulation of written resolutions. Senior management from time to time provides to the Directors information on activities and development of the business of the Group. The company secretary takes detailed minutes of the meetings and keeps records of matters discussed and decisions resolved at the meetings.

The Directors can seek independent professional advice in performing their duties at the Company's expense, if necessary. According to the current Board's practices, should a potential conflict of interest involving a substantial shareholder of the Company or Director arise, the matter is discussed in a Board meeting, as opposed to being dealt with by written resolution. Independent non-executive Directors with no conflict of interest should be present at meetings dealing with conflict issues. When the Board considers any proposal or transaction in which a Director has a conflict of interest, the Director should declare his interest and abstains from voting.

### Roles and responsibilities

The Board has the responsibility for leadership and control of the Company. They are collectively responsible for promoting the success of the Group by directing and supervising the Group's affairs. The Board is accountable to shareholders for the strategic development of the Group with the goal of maximizing long-term shareholders' value, while balancing broader stakeholder interests. Given the diversity and volume of the Company's business, responsibilities for execution and daily operations are delegated to management.

The Directors have distinguished themselves in their field of expertise, and have exhibited high standards of personal and professional ethics and integrity. The Board is of reasonable size and composition to provide checks and balances that safeguard the interests of the shareholders and the Company as a whole. All the Directors have given sufficient time and attention to the Company's affairs.

During the year, the executive Directors were responsible for the day-to-day management of the Group's operations. These Directors conducted regular meetings with the senior management of the Company and its subsidiaries, at which operational issue and financial performance were evaluated. The non-executive Directors provided the Company with a wide range of expertise and experience. They brought advice and judgment on issues relating to the Group's strategy, performance, risk and management process, and corporate governance through their contribution at Board and committee meetings.

According to the Bye-laws of the Company, newly appointed Directors shall hold office until the next following general meeting and shall be eligible for re-election at that meeting. Every Director, including those appointed for a specific term, should be subject to retirement by rotation at least once every three years.

The Company has established mechanisms to ensure independent views and input are available to the Board. The Board shall review the implementation and effectiveness of such mechanisms on annual basis.

During the year and up to the date of this report, the Company had at least three independent non-executive Directors. Amongst the independent non-executive Directors, at least one of whom had appropriate financial management expertise.

According to code provision B.2.3 of the Corporate Governance Code, if an independent non-executive director has served more than nine years, such director's further appointment should be subject to a separate resolution to be approved by the shareholders. For the year ended 31st March 2023, Mr. Joseph Liang Hsien Tse has been appointed as independent non-executive Director for more than 9 years since 2013. The Company has received annual confirmations of independence from each of the existing independent non-executive Directors in accordance with Rule 5.09 of the GEM Listing Rules. Taking into consideration of three independent non-executive directors' independent scope of work in the past years, the Board considers all of them to be independent under the guidelines set out in the GEM Listing Rules despite the fact that one of them has served the Company for more than 9 years. Up to the date of this report, the Board has not been aware of the occurrence of any events which would cause it to believe that their independence has been impaired. The three independent non-executive directors have confirmed that they will continue to devote sufficient time for the discharge of their functions and responsibilities as independent non-executive Directors. With their background, the three independent non-executive directors are fully aware of the responsibilities and expected amount of time dedicated to the Company. Based on the foregoing, the Board believes that their positions outside the Company will not affect them in maintaining their current roles in, and their functions and responsibilities for the Company. The Board also believes that their continued tenure will bring considerable stability to the Board and the Board has benefited greatly from the presence of all of them who have over time gained valuable insight of the Group.

On appointment to the Board, each Director receives a comprehensive induction package covering policy and procedures of the Company as well as the general, statutory and regulatory obligations of being a director to ensure that he/she is sufficiently aware of his/her responsibilities under the GEM Listing Rules and other relevant regulatory requirements. All Directors shall participate in continuous professional development to develop and refresh their knowledge and skills.

The Directors are from time to time provided materials on amendments to or updates on the relevant laws, rules and regulations to ensure that their contribution to the Board remains informed and relevant. The Company has been encouraging the Directors and officers to participate in a wide range of professional development courses and seminars relating to the GEM Listing Rules, applicable regulatory requirements and corporate governance practices organized by professional bodies and/or independent auditors to further improve their relevant knowledge and skills.

The Board has adopted a set of the revised terms of reference of the nomination committee which are aligned with the provisions set out in the Code. The terms of reference of the committee setting out its authority, duties and responsibilities are available on both the websites of the Company and the GEM.

### Audit Committee

During the year and up to the date of this report, the Company's audit committee comprised not less than three members at all time. The members of the audit committee comprised Mr. Joseph Liang Hsien Tse (who served as committee chairman and has appropriate professional qualifications and experience in financial matters), Mr. Joseph Chan Nap Kee and Dr. Cai Qing, all being independent non-executive Directors.

The Board has adopted a set of the revised terms of reference of the audit committee to align with the provisions set out in the Code in November 2018. The committee's principal duties are to ensure the adequacy and effectiveness of the accounting and financial controls of the Group, oversee the performance of internal control systems, risk management and financial reporting process, monitor the integrity of the financial statements and compliance with statutory and listing requirements and to oversee independence and qualifications of the external auditors.

The audit committee meets at least four times a year to discuss any area of concern during the audits or reviews and at least twice of the meetings shall be with the external auditors. The audit committee reviews the quarterly, interim and annual reports before submission to the Board. Senior representatives of the external auditors, executive Directors and senior management are invited to attend the meetings, if required.

The Board as a whole is responsible for performing the corporate governance duties including: (a) to develop and review the Company's policies and practices on corporate governance; (b) to review and monitor the training and continuous professional development of Directors and senior management; (c) to review and monitor the Company's policies and practices in compliance with legal and regulatory requirements; (d) to develop, review and monitor the code of conduct and compliance manual (if any) applicable to employees and Directors; and (e) to review the Company's compliance with the code and disclosure in the Corporate Governance Report. During the year, the Board reviewed the Company's policies and practices on corporate governance.

於本年度內，審核委員會已批准法定審核之性質及範圍，並審閱本集團之季度、中期及年度財務報表，且滿意本集團之會計政策及準則乃符合香港現時之最佳常規。審核委員會亦已檢討本集團之風險管理及內部監控系統，以及本集團內部審核職能之有效性。於本年度內曾舉行五次會議，出席率為100%。於本年度內，各審核委員會成員出席會議之情況載列如下：

**企業管治職能**

董事會整體負責履行企業管治職責，包括：(a) 制訂及檢討本公司之企業管治政策及常規；(b) 檢討及監察董事及高級管理人員之培訓及持續專業發展；(c) 檢討及監察本公司在遵守法律及監管規定方面之政策及常規；(d) 制訂、檢討及監察適用於僱員及董事之操守守則及合規手冊（如有）；及(e) 檢討本公司遵守守則之情況及在企業管治報告內之披露。於本年度內，董事會已檢討本公司之企業管治政策及常規。

## AUDITOR'S REMUNERATION

The Company reviews the appointment of external auditor on an annual basis including a review of the audit scope and approval of the audit fee. During the year, the fee payable to the Company's external auditor for the audit of the Company and its subsidiaries amounted to approximately HK\$2,800,000 (2022: HK\$2,600,000) and fee for non-audit related activities of the Company and its subsidiaries amounted to approximately HK\$525,000 (2022: HK\$900,000).

## RISK MANAGEMENT AND INTERNAL CONTROLS

During the year, the Group has complied with Principle D.2 of the Corporate Governance Code by establishing appropriate and effective risk management and internal control systems. Management is responsible for the design, implementation and monitoring of such systems, while the Board oversees management in performing its duties on an ongoing basis.

### Risk Assessment System

The Group adopts a risk management system which manages the risk associated with its strategic, financial, operations, compliance and significant environmental, social and governance ("ESG") issues. The system comprises the following phases:

- Phase 1: Identify ownership of risks, business objectives and risks that could affect the achievement of objectives
- Phase 2: Analyze the likelihood and impact of risks and evaluate the risk portfolio accordingly
- Phase 3: Consider the risk responses and ensure effective communication to the Board
- Phase 4: On-going monitor the residual risks

Based on the risk assessments conducted in 2022, no significant risk was identified.

## 核數師酬金

本公司每年檢討外聘核數師之委任，包括檢討審核範圍及批准核數費用。於本年度內，就本公司及其附屬公司之核數及非核數相關活動應付本公司外聘核數師之費用分別為約2,800,000港元(二零二二年：2,600,000港元)及約525,000港元(二零二二年：900,000港元)。

## 風險管理及內部監控

於本年度內，本集團透過建立適當及有效風險管理及內部監控系統，遵守企業管治守則原則第D.2條。管理層負責設計、實施及監控有系統，而董事會持續監察管理層履行其職責。

### 風險評估系統

本集團採用風險管理系統，該系統管理與其策略、財務、運營、合規及重大環境、社會和治理(「ESG」)事項相關之風險。該系統包括以下階段：

- 第1階段：識別自身風險、業務目標及可影響達成目標之風險
- 第2階段：分析風險之可能性及影響並據此評估風險組合
- 第3階段：考慮風險承擔範圍及確保與董事會之有效通訊
- 第4階段：持續監控剩餘風險

根據於二零二二年進行之風險評估，並無識別任何重大風險。

#### Internal Control System

The Company has in place an internal control system which is compatible with the Committee of Sponsoring Organizations of the Treadway Commission (“COSO”) 2013 framework. The framework enables the Group to achieve objectives regarding effectiveness and efficiency of operations, reliability of financial reporting and compliance with applicable laws and regulations. The components and main features of the framework are shown as follow:

#### Control Environment

- Proper structures, reporting lines and appropriate authorities and responsibilities in the pursuit of objectives are established.

#### Risk Assessment

- Changes in risk that could significantly impact the system of internal control are identified using the abovementioned risk management system.

#### Control Activities

- Formal policy and procedures, such as financial reporting, revenue and receipts, are established, implemented and communicated throughout the Group.

#### Information and Communication

- Proper safeguards are established for handling and dissemination inside information. For example, confidentiality agreements are in place when the Group enters into significant negotiations, and the executive Directors are designated to speak on behalf of the Group when communicating with external parties such as the media, analysts or investors.

#### Monitoring

- Internal control deficiencies are communicated to the responsible departments in a timely manner for taking corrective action.

Based on the internal control reviews conducted in 2022, no significant control deficiency was identified.

#### 內部監控系統

本公司已設有與 Committee of Sponsoring Organizations of the Treadway Commission (「COSO」) 二零一三年框架一致之內部監控系統。該框架使本集團得以達致有關營運有效性及效率以及財務報告可靠性之目標，並符合適用法例及規例。框架之組成部分及主要特色列示如下：

#### 監控環境

- 已建立為達成目標之適當架構、匯報流程以及適當權力及責任。

#### 風險評估

- 已使用上述風險管理系統，識別對內部監控系統造成重大影響之風險變動。

#### 監控活動

- 已建立、實施及於整個集團發佈財務報告、收益及收據等正式政策及程序。

#### 資料及通訊

- 已建立適當保險措施，以處理及傳發內部資料。舉例而言，當本集團進行重大磋商時將會訂立保密協議，並指派執行董事代表本集團與媒體、分析師或投資者等外部人士通訊。

#### 監控

- 已就內部監控之不足之處及時與負責部門溝通，以採取修正行動。

### Internal Control System (continued)

The abovementioned risk assessment and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable and not absolute assurance against material misstatement or loss.

### Internal Auditor

The Group has engaged an independent professional internal control consultant firm (the “Internal Control Consultant”) to review the entity level policies, risk assessment and internal control systems of major business processes of the Group for financial year ended 31st March 2023. The Internal Control Consultant performs the review, reports the relevant findings and recommendations to the Board and Audit Committee and follows up on management responses to the recommendations on an ongoing basis. Overall, the Board considers the risk management and internal control system of the Group are effective and adequate.

The Group does not have an internal audit department and the Board has reviewed the need for an internal audit function and considered that it more cost-effective to appoint external independent professionals to independently review and continuously evaluate the Group’s internal monitoring systems and risk management systems, taking into account the size and nature of the Board. The Board will review the need for an internal audit function at least annually.

According to the established plan approved by the Board, review of the risk management and internal control systems is conducted annually and the results are reported to the Board/Audit Committee afterwards.

During the year, the audit committee reviewed the effectiveness of the internal control system through the following processes and subsequently reported the review results to the Board:

- discussions with the executive management on areas of risk identified
- review of risks reported by the Internal Control Consultant
- review of the external audit plans

### 內部監控系統(續)

上述風險評估及內部監控系統旨在管理而非消除未能達成業務目標之風險，並僅可就重大錯誤陳述或虧損提供合理而非絕對保證。

### 內部核數師

本集團已委聘獨立專業的內部監控顧問公司(「內部監控顧問」)審閱本集團截至二零二三年三月三十一日止財政年度於主要業務過程的實體層面政策、風險評估及內部監控制度。內部監控顧問進行審查，向董事會及審核委員會報告相關的調查結果及推薦建議，並持續跟進管理層對建議的回應。整體而言，董事會認為本集團的風險管理及內部監控制度屬有效及充足。

本集團並無設立內部審核部門，而董事會已檢討內部審核職能的需要，並認為考慮到董事會的規模及性質，委聘外部獨立專業人士獨立審閱及持續評估本集團內部監察制度及風險管理制度更具成本效益。董事會將至少每年檢討一次是否需要設立內部審核部門。

根據該已被董事會批准的制定之計劃，風險管理及內部監控系統每年進行檢討，而有關結果其後匯報予董事會／審核委員會。

Based on the result of the review for the year ended 31st March 2023, the Board considered that the risk management system and internal control system of the Group, including the adequacy of resources, qualifications and experience of staff of the accounting and financial reporting function, and their training programs and budget, are adequate and effective and have complied with the provisions of the Code during the year.

### COMPANY SECRETARY

The company secretary supports the Chairlady, the Board and Board committees by ensuring good information flow within the Board and that Board policy and procedures are followed. The company secretary reports to the Board and assists the Board in functioning effectively and efficiently. He also advises the Board on governance matters and facilitates the induction and professional development of Directors. All Directors of the Company may call upon the company secretary for advice and assistance at any time in respect to their duties and the effective operation of the Board and the Board committees.

Mr. Law Wai Fai is the chief financial officer and company secretary of the Company. He is a full time employee of the Company and had day-to-day knowledge of the Company's affairs. Mr. Law undertook not less than 15 hours of relevant professional training during the year.

根據截至二零二三年三月三十一日止年度之檢討結果，董事會認為本集團於本年度之風險管理系統及內部監控系統(包括在會計及財務匯報職能方面之資源、員工資歷及經驗之足夠程度，以及員工所接受之培訓課程及有關預算之充足程度)足夠及有效，並符合守則條文之要求。

### 公司秘書

公司秘書支援主席、董事會及董事委員會，確保董事會內部資訊流通無阻以及董事會政策及程序得到遵循。公司秘書向董事會報告，並協助董事會有效及具效率地運作。彼亦就管治事宜向董事會提供意見，並協助安排董事之入職及專業發展。本公司全體董事可隨時要求公司秘書提供有關其職責及致使董事會及董事委員會有效運作之意見及協助。

羅偉輝先生為本公司之財務總裁兼公司秘書。彼為本公司之全職僱員，對本公司事務有日常認識。羅先生於本年度內已接受不少於15小時之相關專業培訓。

## NOMINATION POLICY

During the year under review, the Company has adopted a nomination policy in November 2018 (“Nomination Policy”). The Nomination Policy sets out the criteria and procedures for nominating candidates for election as Directors.

### Selection Criteria

1. The factors listed below would be used as reference by the Nomination Committee (“NC”) in assessing the suitability of a proposed candidate.
  - > Reputation for integrity
  - > Accomplishment and experience in relation to the Company’s line of business
  - > Commitment in respect of available time
  - > Diversity in all its aspects, including but not limited to gender, age (18 years or above), cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service

These factors are for reference only, and not meant to be exhaustive and decisive. The NC has the discretion to nominate any person, as it considers appropriate.

2. Retiring independent non-executive Directors (“INEDs”), save for those who have served as INEDs for a period of 9 consecutive years, are eligible for nomination by the Board to stand for re-election at a general meeting. For the avoidance of doubt, (a) the 9-year period for determining the eligibility of an INED for nomination by the Board to stand for election at a general meeting would count from his/her date of first appointment as an INED until the date of the forthcoming annual general meeting when his/her current term of service will expire at the end of that meeting; and (b) an INED who has been serving on the Board for a period of 9 consecutive years or more may continue to hold office until expiry of his/ her current term.

## 提名政策

於回顧年度內，本公司已於二零一八年十一月採納提名政策（「提名政策」）。提名政策載列提名候選人參選董事之標準及程序。

### 甄選準則

1. 提名委員會（「提委會」）於評估建議候選人之合適性時，將參考下列因素。
  - > 信譽
  - > 有關本公司業務線之成就及經驗
  - > 可投放之時間
  - > 各方面之多元化，包括但不限於性別、年齡（18歲或以上）、文化及教育背景、種族、專業經驗、技能、知識及服務年期等方面

該等因素僅供參考，並不旨在涵蓋所有因素，也不具決定性作用。提委會可酌情提名任何其認為合適之人士。

2. 即將退任的獨立非執行董事（「獨立非執行董事」）（已連續九年擔任獨立非執行董事者除外）均合資格獲董事會提名在股東大會上再度參選董事。為免產生疑問，(a) 決定一名獨立非執行董事是否合資格獲董事會提名在股東大會上參選的九年期限，乃由該董事首次獲委任為獨立非執行董事之日起計，至即將舉行的股東週年大會的日期止（該董事的現有任期將於股東週年大會結束時屆滿）；及 (b) 已任職董事會連續九年或以上的獨立非執行董事可繼續擔任該職位，直至其現有任期屆滿為止。

### Selection Criteria *(continued)*

- Proposed candidates will be asked to submit the necessary personal information, together with their written consent to be appointed as a Director and to the public disclosure of their personal data on any documents or the relevant websites for the purpose of or in relation to their standing for election as a Director.
- The NC may request candidates to provide additional information and documents, if considered necessary.

### Nomination Procedures

- The Secretary of the NC shall call a meeting of the NC, and invite nominations of candidates from Board members if any, for consideration by the NC prior to its meeting. The NC may also put forward candidates who are not nominated by Board members.
- For filling a casual vacancy, the NC shall make recommendations for the Board's consideration and approval. For proposing candidates to stand for election at a general meeting, the NC shall make nominations to the Board for its consideration and recommendation.
- Until the issue of the shareholder circular, the nominated persons shall not assume that they have been proposed by the Board to stand for election at the general meeting.
- In order to provide information of the candidates nominated by the Board to stand for election at a general meeting, a circular will be sent to shareholders. The names, brief biographies (including qualifications and relevant experience), independence, proposed remuneration and any other information, as required pursuant to the applicable laws, rules and regulations, of the proposed candidates will be included in the circular to shareholders.

### 甄選準則 *(續)*

- 建議人選將會被要求提交所需的個人資料，以及提交同意書，同意被委任為董事，並同意就其參選董事或與此有關的事情在任何文件或相關網站公開披露其個人資料。
- 提委會如認為有需要，可以要求候選人提供額外資料及文件。

### 提名程序

- 提委會秘書須召開提委會會議，並邀請董事會成員提名候選人（如有）供提委會於其會議前考慮。提委會亦可提出未獲董事會成員提名之人選。
- 為填補臨時空缺，提委會須作出推薦供董事會考慮及批准。就推薦建議候選人於股東大會上參選，提委會須向董事會提名供其考慮及推薦。
- 直至刊發股東通函為止，獲提名人士不能假設彼等已獲董事會推薦於股東大會上參選。
- 為提供有關獲董事會提名在股東大會上參選的候選人資料，本公司將會向股東發出通函。候選人的姓名、簡歷（包括資格及相關經驗）、獨立性、建議酬金及任何其他資料將根據適用的法律、規則及規例載於向股東發出的通函。

5. A shareholder can serve a notice to the Company Secretary in accordance with Bye-law 88 of the Bye-laws of the Company, to propose a resolution to elect a certain person as a Director, without the Board's recommendation or the NC's nomination, other than those candidates set out in the shareholder circular. The particulars of the candidates so proposed will be sent to all shareholders for information by a supplementary circular.
6. A candidate is allowed to withdraw his candidature at any time before the general meeting by serving a notice in writing to the Company Secretary.
7. The Board shall have the final decision on all matters relating to its recommendation of candidates to stand for election at any general meeting.
8. As there may be more candidates than the vacancies available, and the "gross-vote" method will be used to determine who shall be elected as a Director, shareholder proposed resolutions shall therefore take the same form as the resolutions proposed for the candidates recommended by the Board.

## BOARD DIVERSITY POLICY

The Company has adopted a board diversity policy ("Board Diversity Policy") in September 2013 which sets out the approach to achieve diversity on the Board in order to enhance the quality of its performance.

The Company recognizes and embraces the benefits of having a diverse Board to enhance the quality of its performance.

5. 股東可根據本公司的公司細則第88條，在沒有董事會推薦或提委會的提名下向公司秘書發送通知，提出議案提名股東通函所載候選人以外的其他人士參選董事。有關建議候選人的個人資料將透過補充通函發送全體股東以提供有關資料。
6. 候選人可於股東大會前任何時間向公司秘書發出書面通知退選。
7. 董事會對於其推薦候選人在任何股東大會上參選之所有事宜擁有最終決定權。
8. 由於候選人可能會多於空缺，且「總票數」方法將用作釐定選任哪一位候選人為董事，故股東提呈之決議案須與董事會就推薦候選人提呈之決議案之方式相同。

## 董事會成員多元化政策

本公司已於二零一三年九月採納董事會成員多元化政策（「董事會成員多元化政策」），當中載列達致董事會成員多元化之方針，以提升董事會表現之素質。

本公司明白並深信董事會成員多元化對提升本公司表現素質裨益良多。

With a view to achieving a sustainable and balanced development, the Company sees increasing diversity at the Board level as an essential element in supporting the attainment of its strategic objectives and its sustainable development. In designing the Board's composition, Board diversity has been considered from a number of aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and independence. All Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board.

The gender ratio in the Group's workforce, including the Directors and senior management as at 31st March 2023 is 25% (female): 75% (male). The Company has been taking, and will continue to take, steps to promote gender diversity across the workforce, with the ultimate goal of achieving gender parity.

The nomination committee of the Company will monitor the implementation of the Board Diversity Policy and review the Board Diversity Policy annually to ensure the effectiveness of the Board Diversity Policy. The nomination committee of the Company will discuss any revisions that may be required, and recommend any such revisions to the Board for consideration and approval.

### DIVIDEND POLICY

The Company has adopted a dividend policy ("Dividend Policy") in February 2019, pursuant to which the Company may declare and distribute dividends to the shareholders of the Company, provided that the Company shall maintain adequate cash reserves for meeting its working capital requirements and future growth as well as its shareholder value.

於二零二三年三月三十一日，本集團員工（包括董事及高級管理人員）的性別比例為25%（女性）：75%（男性）。本公司一直並將繼續採取措施，促進員工隊伍中的性別多樣性，最終目標為實現性別平等。

本公司提名委員會將監察落實董事會成員多元化政策及每年檢討董事會成員多元化政策，以確保董事會成員多元化政策行之有效。本公司提名委員會將會討論任何可能需要作出之修訂，並向董事會提出任何有關修訂建議，以供考慮及批准。

### 股息政策

本公司已於二零一九年二月採納股息政策（「股息政策」），據此，本公司可向本公司股東宣派及分派股息，惟本公司應維持足夠現金儲備，以達到其營運資金需求及未來增長以及其股東價值。

## DIVIDEND POLICY *(continued)*

The Company does not have any pre-determined dividend distribution ratio and the Board has the discretion to declare and distribute dividends to the shareholders of the Company, subject to the provisions of the Bye-Laws of the Company and all applicable laws and regulations and the factors set out below:

Any dividend unclaimed shall be forfeited and shall revert to the Company in accordance with the Bye-Laws of the Company.

The Board will review the Dividend Policy as appropriate from time to time.

The Company has adopted an anti-corruption policy, with a view to promoting and reinforcing compliance with anti-corruption laws and regulations.

On 4th September 2014, the shareholders of the Company approved the adoption of a share option scheme (the “2014 Scheme”).

The major terms of the 2014 Scheme are summarized as follows:

- (1) The purpose of the 2014 Scheme is to reward participants who have contributed or will contribute to the Group and to encourage participants to work towards enhancing the value of the Company and its shares for the benefit of the Company and its shareholders as a whole.
- (2) The participants of the 2014 Scheme are the employee, agent, consultant or representative of the Company or any subsidiary, including any executive or non-executive Director of the Company or any subsidiary or any other person who the Board considers, in its sole discretion, have contributed or will contribute to the Group.
- (3) The maximum number of ordinary shares which may be issued upon exercise of all options to be granted under the 2014 Scheme and any other share option scheme of the Company shall not in aggregate exceed 10% of the ordinary shares in issue on the date of approval of the 2014 Scheme (the “Scheme Limit”) or as at the date of the Shareholders’ approval of the refreshed Scheme Limit.

The maximum number of shares of the Company which may be issued upon exercise of all option granted and yet to be exercised under the 2014 Scheme and any other share option scheme of the Company shall not, in aggregate exceed 30% of the ordinary shares in issue from time to time. As at the date of this report, the total number of the ordinary shares of the Company available for issue in respect of which share options have been granted and yet to be granted under 2014 Scheme is 32,056,919, representing approximately 7.05% of the issued share capital of the Company.

  - c. The nominal value of the ordinary shares on the date of grant.
- (9) The 2014 Scheme shall be valid and effective for a period of ten years commencing on its adoption of the 2014 Scheme on 4th September 2014.

The binomial model is a generally accepted method of valuing share options. ### OPINION

We have audited the consolidated financial statements of North Asia Strategic Holdings Limited (the “Company”) and its subsidiaries (the “Group”) set out on pages 73 to 212, which comprise the consolidated statement of financial position as at 31st March 2023, and the consolidated statement of profit or loss, the consolidated statement of comprehensive income, the consolidated statement of changes in equity and the consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31st March 2023, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”) issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”) and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

North Asia Strategic Holdings Limited (the “Company”) and its subsidiaries (collectively, the “Group”) are principally engaged in the following businesses during the year:

- **hi-tech distribution and services:** trading of surface mount technology (“SMT”) assembly machinery and spare parts and provision of related installation, training, repair and maintenance services for SMT assembly machinery;
- **leasing:** provision of finance to its customers via a wide array of assets under finance lease arrangements and operating lease arrangements, and trading of lease assets; and
- **property and investment holding.**

The Company is a limited liability company incorporated in Bermuda as an exempted company under the Bermuda Companies Act 1981 (the “Companies Act”). The address of its registered office is Clarendon House, 2 Church Street, Hamilton HM 11, Bermuda and that of its principal place of business is Suite 1618, 16th Floor, Jardine House, 1 Connaught Place, Central, Hong Kong.

The Company’s ordinary shares are listed on GEM of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”).

These financial statements have been approved and authorised for issue by the Company’s board of directors on 21st June 2023.

The amendments also add to HKFRS 3 an exception to its recognition principle for an entity to refer to the Conceptual Framework to determine what constitutes an asset or a liability. The exception specifies that, for liabilities and contingent liabilities that would be within the scope of HKAS 37 or HK(IFRIC)-Int 21 if they were incurred separately rather than assumed in a business combination, an entity applying HKFRS 3 should refer to HKAS 37 or HK(IFRIC)-Int 21 respectively instead of the Conceptual Framework. Furthermore, the amendments clarify that contingent assets do not qualify for recognition at the acquisition date. The Group has applied the amendments prospectively to business combinations that occurred on or after 1st April 2022. As there were no contingent assets, liabilities and contingent liabilities within the scope of the amendments arising in the business combination that occurred during the period, the amendments did not have any impact on the financial position and performance of the Group.

- (b) Amendments to HKAS 16 prohibit an entity from deducting from the cost of an item of property, plant and equipment any proceeds from selling items produced while bringing that asset to the location and condition necessary for it to be capable of operating in the manner intended by management. Instead, an entity recognises the proceeds from selling any such items, and the cost of those items as determined by HKAS 2 Inventories, in profit or loss. The Group has applied the amendments retrospectively to items of property, plant and equipment made available for use on or after 1st April 2021. Since there was no sale of items produced prior to the property, plant and equipment being available for use, the amendments did not have any impact on the financial position or performance of the Group.
- (c) Amendments to HKAS 37 clarify that for the purpose of assessing whether a contract is onerous under HKAS 37, the cost of fulfilling the contract comprises the costs that relate directly to the contract. Costs that relate directly to a contract include both the incremental costs of fulfilling that contract (e.g., direct labour and materials) and an allocation of other costs that relate directly to fulfilling that contract (e.g., an allocation of the depreciation charge for an item of property, plant and equipment used in fulfilling the contract as well as contract management and supervision costs). General and administrative costs do not relate directly to a contract and are excluded unless they are explicitly chargeable to the counterparty under the contract. The Group has applied the amendments prospectively to contracts for which it has not yet fulfilled all its obligations at 1st April 2022 and no onerous contracts were identified. Therefore, the amendments did not have any impact on the financial position or performance of the Group.

Amendments to HKFRS 10 and HKAS 28 (2011) address an inconsistency between the requirements in HKFRS 10 and in HKAS 28 (2011) in dealing with the sale or contribution of assets between an investor and its associate or joint venture. The amendments require a full recognition of a gain or loss resulting from a downstream transaction when the sale or contribution of assets between an investor and its associate or joint venture constitutes a business. For a transaction involving assets that do not constitute a business, a gain or loss resulting from the transaction is recognised in the investor's profit or loss only to the extent of the unrelated investor's interest in that associate or joint venture. The amendments are to be applied prospectively. The previous mandatory effective date of amendments to HKFRS 10 and HKAS 28 (2011) was removed by the HKICPA in January 2016 and a new mandatory effective date will be determined after the completion of a broader review of accounting for associates and joint ventures. However, the amendments are available for adoption now.

Amendments to HKAS 1 Classification of Liabilities as Current or Non-current clarify the requirements for classifying liabilities as current or non-current, in particular the determination over whether an entity has a right to defer settlement of the liabilities for at least 12 months after the reporting period. Classification of a liability is unaffected by the likelihood that the entity will exercise its right to defer settlement of the liability. The amendments also clarify the situations that are considered a settlement of a liability. In 2022, the HKICPA issued the 2022 Amendments to further clarify that, among covenants of a liability arising from a loan arrangement, only those with which an entity must comply on or before the reporting date affect the classification of that liability as current or non-current. In addition, the 2022 Amendments require additional disclosures by an entity that classifies liabilities arising from loan arrangements as non-current when it has a right to defer settlement of those liabilities that are subject to the entity complying with future covenants within 12 months after the reporting period. The amendments are effective for annual periods beginning on or after 1 January 2024 and shall be applied retrospectively. Earlier application is permitted. An entity that applies the 2020 Amendments early is required to apply simultaneously the 2022 Amendments, and vice versa. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKAS 1 Disclosure of Accounting Policies require entities to disclose their material accounting policy information rather than their significant accounting policies. Accounting policy information is material if, when considered together with other information included in an entity's financial statements, it can reasonably be expected to influence decisions that the primary users of general purpose financial statements make on the basis of those financial statements. Amendments to HKFRS Practice Statement 2 provide non-mandatory guidance on how to apply the concept of materiality to accounting policy disclosures. Amendments to HKAS 1 are effective for annual periods beginning on or after 1 January 2023 and earlier application is permitted. Since the guidance provided in the amendments to HKFRS Practice Statement 2 is non-mandatory, an effective date for these amendments is not necessary. The Group is currently revisiting the accounting policy disclosures to ensure consistency with the amendments.

Amendments to HKAS 8 clarify the distinction between changes in accounting estimates and changes in accounting policies. Accounting estimates are defined as monetary amounts in financial statements that are subject to measurement uncertainty. The amendments also clarify how entities use measurement techniques and inputs to develop accounting estimates. The amendments are effective for annual reporting periods beginning on or after 1 January 2023 and apply to changes in accounting policies and changes in accounting estimates that occur on or after the start of that period. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

Amendments to HKAS 12 narrow the scope of the initial recognition exception in HKAS 12 so that it no longer applies to transactions that give rise to equal taxable and deductible temporary differences, such as leases and decommissioning obligations. Therefore, entities are required to recognise a deferred tax asset (provided that sufficient taxable profit is available) and a deferred tax liability for temporary differences arising from these transactions. The amendments are effective for annual reporting periods beginning on or after 1 January 2023 and shall be applied to transactions related to leases and decommissioning obligations at the beginning of the earliest comparative period presented, with any cumulative effect recognised as an adjustment to the opening balance of retained profits or other component of equity as appropriate at that date. In addition, the amendments shall be applied prospectively to transactions other than leases and decommissioning obligations. Earlier application is permitted. The amendments are not expected to have any significant impact on the Group's financial statements.

The Group has applied the initial recognition exception and did not recognise a deferred tax asset and a deferred tax liability for temporary differences for transactions related to leases. The amendments are not expected to have any significant impact on the Group's financial statements.

### 2.4 Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries for the year ended 31st March 2023. A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the parent of the Group and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

綜合財務報表包括本公司及其附屬公司截至二零二三年三月三十一日止年度之財務報表。附屬公司乃本公司直接或間接控制之實體(包括結構性實體)。當本集團承擔或享有來自參與被投資對象之可變回報之權利及能透過對被投資對象之權力(即賦予本集團現有能操控被投資對象之相關活動之現有權利)影響該等回報時,則達致控制權。

倘本公司直接或間接擁有被投資對象少於大多數之投票或類似權利,則本集團於評估其是否對被投資對象擁有權力時會考慮一切相關事實及情況,包括:

- (a) 與被投資對象之其他投票持有之合約安排;
- (b) 其他合約安排所產生之權利;及
- (c) 本集團之投票權及潛在投票權。

附屬公司之財務報表乃就與本公司相同之報告期間編製,並採用一致之會計政策。附屬公司之業績由本集團取得控制權之日起綜合入賬,並繼續綜合入賬至該等控制權終止之日。

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described above. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in the statement of profit or loss. The Group's share of components previously recognised in other comprehensive income is reclassified to the statement of profit or loss or accumulated losses, as appropriate, on the same basis as would be required if the Group had directly disposed of the related assets or liabilities.

#### **Business combinations and goodwill**

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

The Group determines that it has acquired a business when the acquired set of activities and assets includes an input and a substantive process that together significantly contribute to the ability to create outputs.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts of the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability is measured at fair value with changes in fair value recognised in profit or loss. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in the statement of profit or loss as a gain on bargain purchase.

當所收購之一系列活動及資產包括對創造產出能力有重大貢獻的投入及實質性進程，本集團認為其已收購一項業務。

當收購一項業務時，本集團會根據於收購日期之合約條款、經濟情況及相關狀況評估其金融資產及所承擔負債之適當分類及指定類別。此包括分離被收購方主合約之嵌入式衍生工具。

倘業務合併分階段進行，早前持有之股權將按其於收購日期之公允值重新計量，而任何產生之盈虧將於損益內確認。

任何將由收購方轉讓之或然代價均於收購日期以公允值確認。獲分類為資產或負債之或然代價將按公允值計量，而公允值之變動將於損益內確認。獲分類為權益之或然代價將不會獲重新計量，而其後結算將於權益內入賬。

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31st March. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cash-generating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the operation of and the portion of the cash-generating unit retained.

於初次確認後，商譽將以成本減任何累計減值虧損計量。商譽每年進行減值測試，倘發生任何事件或情況有變並顯示賬面值可能減值，則減值測試更為頻密。本集團每年於三月三十一日進行商譽減值測試。為進行減值測試，因業務合併所得之商譽，從收購日期起被分配至本集團各個或各組預期將受惠於合併協同效應之現金產生單位，不論本集團之其他資產或負債是否被分配到該等或該組單位。

減值乃透過評估與商譽有關之現金產生單位(一組現金產生單位)之可收回金額而釐定。減值虧損須於現金產生單位(一組現金產生單位)之可收回金額少於其賬面值時確認。商譽減值虧損於確認後不會在其後期間撥回。

當商譽已獲分配至一個現金產生單位(或一組現金產生單位)，而當該單位之部分業務被出售時，有關出售業務之附帶商譽計入該業務之賬面值內，以釐定該項出售之盈虧。在此等情況下，出售之商譽乃根據所保留之現金產生單位業務及部分之相對價值計量。

### 2.5 Fair value measurement

The Group measures its financial assets at fair value through profit or loss at fair value at the end of each reporting period.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either in the principal market for the asset or liability, or in the absence of a principal market, in the most advantageous market for the asset or liability. The principal or the most advantageous market must be accessible by the Group. The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest.

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs.

本集團於各報告期末按公允值計量其按公允值計入損益之金融資產。

公允值是於計量日市場參與者間於有秩序交易中出售資產所收取或轉讓負債須支付之價格。公允值計量假設出售資產或轉讓負債之交易於該資產或負債之主要市場，或在無主要市場之情況下，則於對該資產或負債最有利之市場進行。本集團必須可於該主要市場或最有利市場進行交易。資產或負債之公允值乃採用市場參與者為資產或負債定價時所用之假設計量，並假設市場參與者按其最佳經濟利益行事。

非金融資產之公允值計量計入市場參與者透過使用其資產之最高及最佳用途或透過將資產出售予將使用其最高及最佳用途之另一名市場參與者而產生經濟利益之能力。

本集團採用在各情況下適當之估值技巧，而其有足夠資料以計量公允值，以盡量使用相關可觀察輸入數據及盡量避免使用不可觀察輸入數據。

All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy, described as follows, based on the lowest level input that is significant to the fair value measurement as a whole:

Level 1 – based on quoted prices (unadjusted) in active markets for identical assets or liabilities

Level 2 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is observable, either directly or indirectly

Level 3 – based on valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable

For assets and liabilities that are recognised in the financial statements on a recurring basis, the Group determines whether transfers have occurred between levels in the hierarchy by reassessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period.

An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs. In testing a cash-generating unit for impairment, a portion of the carrying amount of a corporate asset (e.g., a headquarters building) is allocated to an individual cash-generating unit if it can be allocated on a reasonable and consistent basis or, otherwise, to the smallest group of cash-generating units.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises in those expense categories consistent with the function of the impaired asset.

### 2.8 Property, plant and equipment and depreciation

Property, plant and equipment are stated at cost less accumulated depreciation and any accumulated impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other repair and maintenance costs are charged to the statement of profit or loss during the financial period in which they are incurred.

Depreciation is calculated using the straight-line method to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. Their estimated useful lives are as follows:

物業、廠房及設備按成本減累計折舊及任何累計減值虧損入賬。物業、廠房及設備項目成本包括其購買價及使該等資產達致運作狀態及位置以用作擬定用途直接應佔之成本。

物業、廠房及設備項目投入運作後產生之支出(如維修及保養)一般於產生期間在損益表內列為支出。在符合確認條件之情況下,主要檢驗支出亦作為重置於資產之賬面值內資本化。倘物業、廠房及設備之重要部分須定期更換,則本集團將有關部分確認為具有特定可使用年期之獨立資產,並相應計算折舊。

The assets' residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with carrying amounts and are recognised in the statement of profit or loss.

### 2.9 Investment properties

Investment properties are interests in land and buildings (including the leasehold property held as a right-of-use asset which would otherwise meet the definition of an investment property) held to earn rental income and/or for capital appreciation, rather than for use in the production or supply of goods or services or for administrative purposes; or for sale in the ordinary course of business. Such properties are measured initially at cost, including transaction costs. Subsequent to initial recognition, investment properties are stated at cost less subsequent accumulated depreciation and any accumulated impairment losses.

Depreciation is calculated on the straight-line basis to write off the cost of investment properties over their estimated useful lives. The principal annual rates used for this purpose are as follows:

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposal. Any gain or loss arising on derecognition of property (calculated as difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the period in which the property is derecognised.

Any impairment losses on investment properties are included in the statement of profit or loss in the year in which they arise.

### 2.10 Intangible assets (other than goodwill)

Intangible assets acquired separately are measured on initial recognition at cost. The cost of intangible assets acquired in a business combination is the fair value at the date of acquisition. The useful lives of intangible assets are assessed to be either finite or indefinite. Intangible assets with finite lives are subsequently amortised over the useful economic life and assessed for impairment whenever there is an indication that the intangible asset may be impaired. The amortisation period and the amortisation method for an intangible asset with a finite useful life are reviewed at least at each financial year end.

Intangible assets with indefinite useful lives are tested for impairment annually either individually or at the cash-generating unit level. Such intangible assets are not amortised. The useful life of an intangible asset with an indefinite life is reviewed annually to determine whether the indefinite life assessment continues to be supportable. If not, the change in the useful life assessment from indefinite to finite is accounted for on a prospective basis.

The Group applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Group recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

Right-of-use assets are measured at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Lease liabilities are recognised at the commencement date of the lease at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payments of penalties for termination of a lease, if the lease term reflects the Group exercising the option to terminate the lease. The variable lease payments that do not depend on an index or a rate are recognised as an expense in the period in which the event or condition that triggers the payment occurs.

In calculating the present value of lease payments, the Group uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in lease payments (e.g., a change to future lease payments resulting from a change in an index or rate) or a change in assessment of an option to purchase the underlying asset.

租賃負債於租賃開始日期按於租賃期內作出之租賃付款現值確認。租賃付款包括固定付款(包括實質固定付款)減任何應收租賃優惠、取決於某一指數或比率之可變租賃付款及預期根據在剩餘價值擔保中將支付之金額。租賃付款亦包括本集團合理確定行使購買選擇權之行使價，並倘租賃期反映了本集團行使終止租賃選擇權，則須就終止租賃支付罰款。並非取決於某一指數或比率之可變租賃付款於觸發付款之事件或狀況出現期間確認為開支。

##### (c) Short-term leases and leases of low-value assets

The Group applies the short-term lease recognition exemption to its short-term leases of office properties and warehouses (that is those leases that have a lease term of 12 months or less from the commencement date and do not contain a purchase option). It also applies the recognition exemption for leases of low-value assets to leases that are considered to be of low value. Lease payments on short-term leases and leases of low-value assets are recognised as an expense on a straight-line basis over the lease term.

#### Group as a lessor

When the Group acts as a lessor, it classifies at lease inception (or when there is a lease modification) each of its leases as either an operating lease or a finance lease.

Leases in which the Group does not transfer substantially all the risks and rewards incidental to ownership of an asset are classified as operating leases. When a contract contains lease and non-lease components, the Group allocates the consideration in the contract to each component on a relative stand-alone selling price basis. Rental income is accounted for on a straight-line basis over the lease terms and is included in other income and gains in the statement of profit or loss due to its non-operating nature. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised over the lease term on the same basis as rental income. Contingent rents are recognised as revenue in the period in which they are earned.

##### (c) 短期租賃及低價值資產租賃

本集團將短期租賃確認豁免應用於其辦公室物業及倉庫之短期租賃(即自開始日期起租期為12個月或以下且不包含購買選擇權之租賃)。本集團亦將低價值資產租賃之確認豁免應用於被視為低價值之辦公室設備租賃。短期租賃之租賃付款及低價值資產租賃在租期內以直線法確認為開支。

#### 本集團作為出租人

當本集團作為出租人時，其於租賃開始時(或出現租賃修改時)將其租賃各自分類為經營租賃或融資租賃。

本集團不會轉讓資產擁有權附帶之絕大部分風險及回報之租賃分類為經營租賃。當合約包含租賃及非租賃部分時，本集團根據相對獨立售價將合約中之代價分配予各部分。租金收入於租期內以直線法入賬，並因其非經營性質而於損益表中列為其他收入及收益。磋商及安排經營租賃所產生之初始直接成本加入租賃資產之賬面值，並於租期內按相同基準確認為租金收入。或然租金於產生期間確認為收益。

Leases that transfer substantially all the risks and rewards incidental to ownership of an underlying asset to the lessee are accounted for as finance leases. At the commencement date, the cost of the leased asset is capitalised at the present value of the lease payments and related payments (including the initial direct costs), and presented as a receivable at an amount equal to the net investment in the lease. The finance income on the net investment in the lease is recognised in the statement of profit or loss so as to provide a constant periodic rate of return over the lease terms.

### 2.12 Investments and other financial assets

#### *Initial recognition and measurement*

Financial assets are classified, at initial recognition, as subsequently measured at amortised cost and fair value through profit or loss.

The classification of financial assets at initial recognition depends on the financial asset's contractual cash flow characteristics and the Group's business model for managing them. With the exception of trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient of not adjusting the effect of a significant financing component, the Group initially measures a financial asset at its fair value, plus in the case of a financial asset not at fair value through profit or loss, transaction costs. Trade receivables that do not contain a significant financing component or for which the Group has applied the practical expedient are measured at the transaction price determined under HKFRS 15 in accordance with the policies set out for "Revenue recognition" below.

#### *Initial recognition and measurement (Continued)*

In order for a financial asset to be classified and measured at amortised cost or fair value through other comprehensive income, it needs to give rise to cash flows that are solely payments of principal and interest (“SPPI”) on the principal amount outstanding. Financial assets with cash flows that are not SPPI are classified and measured at fair value through profit or loss, irrespective of the business model.

The Group's business model for managing financial assets refers to how it manages its financial assets in order to generate cash flows. The business model determines whether cash flows will result from collecting contractual cash flows, selling the financial assets, or both. Financial assets classified and measured at amortised cost are held within a business model with the objective to hold financial assets in order to collect contractual cash flows, while financial assets classified and measured at fair value through other comprehensive income are held within a business model with the objective of both holding to collect contractual cash flows and selling. Financial assets which are not held within the aforementioned business models are classified and measured at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

#### *Subsequent measurement*

The subsequent measurement of financial assets depends on their classification as follows:

#### *初步確認及計量(續)*

為使金融資產按攤銷成本或按公允值計量且其變動計入其他全面收入分類及計量，需產生僅為支付本金及未償還本金利息（「SPPI」）的現金流量。不論其業務模式如何，現金流量不僅為支付本金及未償還本金利息之金融資產按公允值計入損益分類及計量。

本集團管理金融資產的業務模式指為產生現金流量管理金融資產的方式。業務模式釐定現金流量會否來自收取合約現金流量、出售金融資產或以上兩者。按攤銷成本分類及計量之金融資產於目的為持有金融資產以收取合約現金流量的業務模式持有，而按公允值計入其他全面收益分類及計量之金融資產於目的為持有以收取合約現金流量及出售的業務模式持有。並非於上述業務模式持有之金融資產按公允值計入損益分類及計量。

#### **Financial assets at amortised cost (debt instruments)**

Financial assets at amortised cost are subsequently measured using the effective interest method and are subject to impairment. Gains and losses are recognised in the statement of profit or loss when the asset is derecognised, modified or impaired.

#### **Financial assets at fair value through profit or loss**

Financial assets at fair value through profit or loss are carried in the statement of financial position at fair value with positive net changes in fair value presented as other income and gains and negative net changes in fair value presented as other expense in the statement of profit or loss.

### 2.13 Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is primarily derecognised (i.e. removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

按攤銷成本列賬的金融資產隨後使用實際利率法計量，並可予減值。收益及虧損於資產終止確認、修改或減值時於損益表中確認。

#### **按公允值計入損益之金融資產**

按公允值計入損益之金融資產，在財務狀況表中以公允值列示，公允值正淨變動於損益表內呈列為其他收入及收益，而公允值負變動淨額則呈列為其他費用。

### 2.13 終止確認金融資產

金融資產(或(倘適用)一項金融資產之一部分或一組類似金融資產之一部分)主要於下列情況下終止確認(即從本集團之綜合財務狀況表中移除)：

- 從該資產收取現金流量之權利已到期；或

### 2.13 Derecognition of financial assets (Continued)

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates, if and to what extent, it has retained the risks and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the asset is recognised to the extent of the Group's continuing involvement in the asset. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

### 2.14 Impairment of financial assets

The Group recognises an allowance for expected credit losses ("ECLs") for all debt instruments not held at fair value through profit or loss. ECLs are based on the difference between the contractual cash flows due in accordance with the contract and all the cash flows that the Group expects to receive, discounted at an approximation of the original effective interest rate. The expected cash flows will include cash flows from the sale of collateral held or other credit enhancements that are integral to the contractual terms.

#### **General approach**

ECLs are recognised in two stages. For credit exposures for which there has not been a significant increase in credit risk since initial recognition, ECLs are provided for credit losses that result from default events that are possible within the next 12 months (a 12-month ECL). For those credit exposures for which there has been a significant increase in credit risk since initial recognition, a loss allowance is required for credit losses expected over the remaining life of the exposure, irrespective of the timing of the default (a lifetime ECL).

倘本集團已轉讓其從資產收取現金流量之權利或已訂立轉付安排，其將評估其是否保留該資產之擁有權之風險及回報以及保留之程度。倘其並無轉讓或保留該資產之絕大部分風險及回報，亦無轉讓該資產之控制權，則以本集團持續參與該資產之程度為限確認該資產。在此情況下，本集團亦確認相關負債。已轉讓資產及相關負債乃按可反映本集團所保留權利及責任之基準計量。

### 2.14 金融資產減值

本集團就所有並非按公允值計入損益持有的債務工具確認預期信貸虧損(「預期信貸虧損」)撥備。預期信貸虧損乃以根據合約應付的合約現金流量與本集團預期收取的所有現金流量之間的差額為基準，按原有實際利率相近的差額貼現。預期現金流量將包括來自銷售所持有抵押品或其他信用增級的現金流量，此乃合約條款不可或缺的部分。

#### **一般方法**

預期信貸虧損於兩個階段進行確認。對於自初步確認後並無顯著增加的信貸風險，預期信貸虧損就可能於未來12個月內(12個月預期信貸虧損)出現的違約事件計提撥備。對於自初步確認後有顯著增加的信貸風險，須在信貸虧損風險預期的剩餘年期計提虧損撥備，不論違約事件於何時發生(存續期預期信貸虧損)。

#### General approach (Continued)

At each reporting date, the Group assesses whether the credit risk on a financial instrument has increased significantly since initial recognition. When making the assessment, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition and considers reasonable and supportable information that is available without undue cost or effort, including historical and forward-looking information.

The Group considers a financial asset in default when contractual payments are 90 days past due. However, in certain cases, the Group may also consider a financial asset to be in default when internal or external information indicates that the Group is unlikely to receive the outstanding contractual amounts in full before taking into account any credit enhancements held by the Group. A financial asset is written off when there is no reasonable expectation of recovering the contractual cash flows.

Financial assets at amortised cost are subject to impairment under the general approach and they are classified within the following stages for measurement of ECLs except for trade receivables which apply the simplified approach as detailed below.

Stage 1 – Financial instruments for which credit risk has not increased significantly since initial recognition and for which the loss allowance is measured at an amount equal to 12-month ECLs

Stage 2 – Financial instruments for which credit risk has increased significantly since initial recognition but that are not credit-impaired financial assets and for which the loss allowance is measured at an amount equal to lifetime ECLs

於各報告日期，本集團於評估自初始確認後金融工具的信貸風險是否顯著增加時，本集團將於報告日期金融工具發生之違約風險與初始確認日起金融工具發生之違約風險進行比較，本集團會考慮合理且可支持的資料，包括無需付出不必要的成本或努力而可得之歷史及前瞻性資料。

本集團將合約付款逾期90日的金融資產視作違約。然而，於若干情況下，當內部或外部資料顯示本集團不可能在本集團採取任何信貸提升安排前悉數收回未償還合約金額時，本集團亦可能認為該金融資產違約。當合理預期不會收回合約現金流量時，金融資產將予撤銷。

按攤銷成本計量的金融資產，在一般方法下可能會發生減值，並且除了採用簡化方法的貿易應收款項(以下詳述)外，彼等在以下階段分類用於預期信貸虧損計量。

Stage 3 – Financial assets that are credit-impaired at the reporting date (but that are not purchased or originated credit-impaired) and for which the loss allowance is measured at an amount equal to lifetime ECLs

For finance lease receivables included in trade and other receivables that contain a significant financing component, the Group chooses as its accounting policy to adopt the general approach in calculating ECLs with policies as described above.

#### Simplified approach

For trade receivables that do not contain a significant financing component or when the Group applies the practical expedient of not adjusting the effect of a significant financing component, the Group applies the simplified approach in calculating ECLs. Under the simplified approach, the Group does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date. The Group has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

第三階段 — 於報告日期信貸減值的金融資產(但非購買或原始信貸減值),其虧損撥備相等於終身預期信貸虧損

就計入包含重大融資成分的貿易及其他應收款項之融資租賃應收款項而言,本集團會計政策選擇採用一般方法根據上述政策進行預期信貸虧損計量。

#### 簡化方法

對於不包含重大融資成分的貿易應收款項,或本集團採用實際權宜之計,不會就重大融資成分的影響調整時,本集團採用簡化方法進行預期信貸虧損計量。根據簡化方法,本集團不會追蹤信貸風險的變化,而是於各報告日期進行終身預期信貸虧損確認虧損撥備。本集團已根據其歷史信貸虧損經驗建立撥備矩陣,並根據債務人及經濟環境的前瞻性因素作出調整。

### 2.15 Financial liabilities

#### **Initial recognition and measurement**

Financial liabilities are classified, at initial recognition, as loans and borrowings, or payables, as appropriate.

All financial liabilities are recognised initially at fair value and, in the case of loans and borrowings and payables, net of directly attributable transaction costs.

The Group's financial liabilities include trade and other payables and borrowings.

#### **Subsequent measurement**

The subsequent measurement of financial liabilities depends on their classification as follows:

#### **Financial liabilities at amortised cost (loans and borrowings)**

After initial recognition, borrowings are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost. Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

#### **初步確認及計量**

金融負債於初步確認時分類為貸款及借貸或應付款項(倘適用)。

所有金融負債初步按公允值確認，而貸款及借貸，及應付款項則於扣除直接應佔交易成本後確認。

本集團之金融負債包括貿易應付款項及其他應付款項以及借貸。

#### **其後計量**

金融資產的其後計量取決於其分類，載列如下：

#### **按攤銷成本計量之金融負債(貸款及借貸)**

於初步確認後，借貸其後採用實際利率法按攤銷成本計量，惟倘貼現之影響並不重大，則在此情況下按成本列賬。終止確認負債及透過實際利率攤銷過程中產生之盈虧會於損益表內確認。

### 2.16 Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

### 2.17 Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the statement of financial position if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

### 2.18 Share capital

Ordinary shares and non-redeemable preference shares are classified as equity.

Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

普通股及不可贖回優先股分類為權益。

直接歸屬於發行新股或購股權之遞增成本在權益內列為所得款項之減少(扣除稅項)。

### 2.19 Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis and, in the case of work in progress and finished goods, comprises direct materials, direct labour and an appropriate proportion of overheads. Net realisable value is based on estimated selling price less any estimated costs to be incurred to completion and disposal.

### 2.20 Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the consolidated statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits, which are not restricted as to use.

### 2.19 存貨

存貨按成本及可變現淨值兩者中之較低者列賬。成本按先進先出基準釐定，若為在製品及製成品，則包括直接材料、直接勞工及適當部分的經常開支。可變現淨值乃按估計售價減完成及出售所產生將產生之任何估計成本而計算得出。

### 2.20 現金及現金等值項目

就綜合現金流量表而言，現金及現金等值項目由手頭現金及即期存款以及可隨時轉換為已知金額現金、須承擔價值變動之為不重大之風險及擁有一般為收購時三個月內之較短到期日之短期高流動性投資組成，扣除須按要求償還及組成本集團現金管理一部分之銀行透支。

就綜合財務狀況表而言，現金及現金等值項目由手頭及銀行現金組成，包括用途不受限制之定期存款。

### 2.21 Provisions

A provision is recognised when a present obligation (legal or constructive) has arisen as a result of a past event and it is probable that a future outflow of resources will be required to settle the obligation, provided that a reliable estimate can be made of the amount of the obligation.

When the effect of discounting is material, the amount recognised for a provision is the present value at the end of the reporting period of the future expenditures expected to be required to settle the obligation. The increase in the discounted present value amount arising from the passage of time is included in finance costs in the statement of profit or loss.

### 2.22 Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside profit or loss is recognised outside profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the tax authorities, based on tax rates (and tax laws) that have been enacted or substantially enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the countries in which the Group operates.

Deferred tax is provided, using the liability method, on all temporary differences at the end of each reporting period between the tax bases of assets and liabilities and their carrying amounts for financial reporting purposes.

### 2.21 撥備

當因以往事件而承擔現有法律或推定責任，且較可能需要有未來資源外流以償付責任，惟在可靠估計該責任金額之前提下，將會確認撥備。

當貼現影響屬重大時，就撥備確認之金額為預期將須償付責任之未來開支於報告期末之現值。隨時間流逝所產生之已貼現現值金額增加在損益表中列為財務費用。

### 2.22 所得稅

所得稅包括當期及遞延稅項。涉及於損益以外確認之項目之所得稅均在損益外（在其他全面收益或直接於權益內）確認。

Deferred tax liabilities are recognised for all taxable temporary differences, except:

- when the deferred tax liability arises from the initial recognition of goodwill or an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of taxable temporary differences associated with investments in subsidiaries, when the timing of the reversal of the temporary differences can be controlled and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax assets are recognised for all deductible temporary differences, and the carryforward of unused tax credits and any unused tax losses. Deferred tax assets are recognised to the extent that it is probable that taxable profit will be available against which the deductible temporary differences, and the carryforward of unused tax credits and unused tax losses can be utilised, except:

- when the deferred tax asset relating to the deductible temporary differences arises from the initial recognition of an asset or liability in a transaction that is not a business combination and, at the time of the transaction, affects neither the accounting profit nor taxable profit or loss; and
- in respect of deductible temporary differences associated with investments in subsidiaries, deferred tax assets are only recognised to the extent that it is probable that the temporary differences will reverse in the foreseeable future and taxable profit will be available against which the temporary differences can be utilised.

所有應課稅暫時差異均被確認為遞延稅項負債，惟：

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be utilised. Unrecognised deferred tax assets are reassessed at the end of each reporting period and are recognised to the extent that it has become probable that sufficient taxable profit will be available to allow all or part of the deferred tax asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and deferred tax liabilities are offset if a legally enforceable right exists to set off current tax assets against current tax liabilities and the deferred taxes relate to the same taxable entity and the same taxation authority on either the same taxable entity or different taxable entities which intend either to settle current tax liabilities and assets on a net basis, or to realise the assets and settle the liabilities simultaneously, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered.

### 2.23 Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, for which it is intended to compensate, are expensed.

遞延稅項資產之賬面值於各報告期末檢討，並減至不再可能有足夠應課稅溢利令全部或部分遞延稅項資產得以動用為止。未確認之遞延稅項資產於各報告期末重新評估，並於可能有足夠應課稅溢利令全部或部分遞延稅項資產得以收回時確認。

遞延稅項資產及負債乃根據於報告期末已頒佈或實質上已頒佈之稅率(及稅務法例)，按預期於資產變現或負債償還期間適用之稅率計量。

倘存在一項可依法強制執行之權利可就同一應課稅實體或擬於各未來期間(預期將結清或收回大量遞延稅項負債或資產)以淨額基準償付當期稅項負債及資產或同時變現資產及償付負債之不同應課稅實體，將當期稅項資產與當期稅項負債抵銷，且遞延稅項涉及同一應課稅實體及同一稅務機關，則可將遞延稅項資產與遞延稅項負債互相抵銷。

### 2.24 Revenue recognition

#### *Revenue from contracts with customers*

Revenue from contracts with customers is recognised when control of goods or services is transferred to the customers at an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services.

When the consideration in a contract includes a variable amount, the amount of consideration is estimated to which the Group will be entitled in exchange for transferring the goods or services to the customer. The variable consideration is estimated at contract inception and constrained until it is highly probable that a significant revenue reversal in the amount of cumulative revenue recognised will not occur when the associated uncertainty with the variable consideration is subsequently resolved.

When the contract contains a financing component which provides the customer with a significant benefit of financing the transfer of goods or services to the customer for more than one year, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction between the Group and the customer at contract inception. When the contract contains a financing component which provides the Group with a significant financial benefit for more than one year, revenue recognised under the contract includes the interest expense accreted on the contract liability under the effective interest method. For a contract where the period between the payment by the customer and the transfer of the promised goods or services is one year or less, the transaction price is not adjusted for the effects of a significant financing component, using the practical expedient in HKFRS 15.

#### *來自客戶合約的收益*

來自客戶合約的收益乃於商品或服務的控制權轉讓予客戶時確認，該金額能反映本集團預期就交換該等商品或服務有權獲得的代價。

當合約中的代價包含可變金額時，代價金額於本集團向客戶轉讓商品或服務而有權獲得交換時估計。可變代價於合約開始時估計並受到約束，直至與可變代價相關的不確定因素得到解決時，確認的累積收益金額極有可能不會發生重大收益回撥。

當合約中包含融資成分，該融資成分為客戶提供超過一年的商品或服務轉讓融資的重大利益時，收益按應收款項的現值計量，使用貼現率折現，該貼現率將反映在本集團與客戶在合同開始時的單獨融資交易中。當合約中包含融資部分，該融資部分為在本集團提供了一年以上的重大財務利益時，合約項下確認的收益包括按實際利息法在合約負債上加算的利息。就客戶付款至轉讓承諾商品或者服務的期限為一年或者更短的合約而言，交易價格採用香港財務報告準則第15號中實際權宜之計，不會對重大融資部分的影響作出調整。

#### Revenue from contracts with customers (Continued)

(a) Sale of goods

Revenue from the sale of goods is recognised at the point in time when control of the asset is transferred to the customer.

Incidental to the sale of machinery, the Group also provides installation services in accordance with the terms of the contracts with customers. These services, which are not separately provided by the Group and are bundled together with the sale of machinery to customers, are combined with the sale of machinery into a functional machinery for which the customers have contracted. Accordingly, revenue from the sale of machinery with installation services is recognised at the point in time when the respective installation services are completed.

(b) Sales support services

Revenue from the provision of sales support services is recognised at the point in time when the installation services in relation to the underlying machinery are completed.

(c) Commission, other service and management fee income

Commission, other service and management fee income is recognised over time because the customer simultaneously receives and consumes the benefits provided by the Group. Given that these services are generally completed within a short period of time, the revenue from the provision of these services is generally recognised when the services have been rendered.

(a) 銷售貨品

銷售貨品之收入於資產控制權轉移至客戶之時間點確認。

附帶於銷售機器，本集團亦根據客戶合約之條款提供安裝服務。該等服務並非由本集團獨立提供而是向客戶銷售機器捆綁提供。該等服務與銷售機器結合在一起，成為客戶已簽約之功能性機器。因此，當完成相關安裝服務之時間點確認來自銷售具有安裝服務機器之收入。

(b) 銷售支援服務

提供銷售支援服務之收入於與相關機器有關的安裝服務完成時之時間點確認。

(c) 佣金服務及其他服務及管理費收入

佣金、其他服務及管理費收入隨著時間確認，原因為客戶同時收取及消耗由本集團提供利益。鑑於該等服務一般於短時間內完成，提供該等服務之收入一般於提供服務時予以確認。

#### **Revenue from other sources**

Finance leasing income is recognised on an accrual basis using the effective interest method by applying the rate that discounts the estimated future cash receipts through the expected life of the net investment of the finance lease or a shorter period, when appropriate, to the net carrying amount of the net investment of the finance lease.

Rental income is recognised on a time proportion basis over the lease terms.

#### **Other income**

Interest income is recognised on an accrual basis using the effective interest method by applying the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, when appropriate, to the net carrying amount of the financial asset.

Dividend income is recognised when the shareholders' right to receive payment has been established, it is probable that the economic benefits associated with the dividend will flow to the Group and the amount of the dividend can be measured reliably.

### 2.25 Contract liabilities

A contract liability is recognised when a payment is received or a payment is due (whichever is earlier) from a customer before the Group transfers the related goods or services. Contract liabilities are recognised as revenue when the Group performs under the contract (i.e., transfers control of the related goods or services to the customer).

#### **其他收入來源**

融資租賃收入乃按累計基準於融資租賃淨投資之預計年期或較短期間(倘適用)確認，其採用實際利率法將估計未來現金收入貼現至融資租賃淨投資賬面淨值。

租金收入按時間比例於租期確認。

#### **其他收入**

利用實際利率法計算按累計基準確認的利息收入，利率為在金融工具的預期壽命或更短期間(倘適用)將估計未來現金收入準確折現至金融資產賬面淨值。

股息收入於確立股東收取付款的權利時確認。股息涉及的經濟利益可能流入本集團，且股息數額能可靠地計量。

### 2.25 合約負債

合約負債於本集團轉移相關貨品或服務前向客戶收取付款或應收付款(以較早者為準)時確認。當本集團履行合約(即相關貨品或服務之控制權轉移予客戶)時，合約負債確認為收益。

### 2.26 Share-based payments

The Company operates a share option scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Employees (including directors) of the Group receive remuneration in the form of share-based payments, whereby employees render services as consideration for equity instruments ("equity-settled transactions").

The cost of equity-settled transactions with employees for grants is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external valuer using a binomial model.

The cost of equity-settled transactions is recognised in employee benefit expense, together with a corresponding increase in equity, over the period in which the performance and/or service conditions are fulfilled. The cumulative expense recognised for equity-settled transactions at the end of each reporting period until the vesting date reflects the extent to which the vesting period has expired and the Group's best estimate of the number of equity instruments that will ultimately vest. The charge or credit to the statement of profit or loss for a period represents the movement in the cumulative expense recognised as at the beginning and end of that period.

Service and non-market performance conditions are not taken into account when determining the grant date fair value of awards, but the likelihood of the conditions being met is assessed as part of the Group's best estimate of the number of equity instruments that will ultimately vest. Market performance conditions are reflected within the grant date fair value. Any other conditions attached to an award, but without an associated service requirement, are considered to be non-vesting conditions. Non-vesting conditions are reflected in the fair value of an award and lead to an immediate expensing of an award unless there are also service and/or performance conditions.

本公司設立一項購股權計劃，旨在向為本集團成功營運作出貢獻之合資格參與者提供獎勵及回報。本集團僱員(包括董事)以股份支付形式收取酬金，而僱員提供服務作為股本工具之代價(「股權結算交易」)。

就授出與僱員進行股權結算交易之成本乃參考其授出日期之公允值計量。有關公允值乃由外聘估值師按二項式模式釐定。

股權結算交易之成本連同股權相應增幅於履約及／或服務條件達成期間內確認於僱員福利開支。於各報告期末直至歸屬日期止就股權結算交易確認之累計開支反映歸屬期已屆滿及本集團對最終將歸屬之股本工具數目之最佳估計。期內於損益表內扣除或計入損益表指於該期初及期末確認之累計開支變動。

於釐定獎勵之授出日期公允值時，並不會考慮服務及非市場表現條件，惟達成條件之可能性作為本集團對最終將歸屬之股本工具數目之最佳估計一部分予以評估。市場表現條件反映於授出日期公允值。獎勵附帶之任何其他條件(惟並無想相關服務規定)被視為非歸屬條件。非歸屬條件反映於獎勵之公允值，並導致獎勵立即支銷，惟亦有服務及／或表現條件之情況下則另當別論。

For awards that do not ultimately vest because non-market performance and/or service conditions have not been met, no expense is recognised. Where awards include a market or non-vesting condition, the transactions are treated as vesting irrespective of whether the market or non-vesting condition is satisfied, provided that all other performance and/or service conditions are satisfied.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified, if the original terms of the award are met. In addition, an expense is recognised for any modification that increases the total fair value of the share-based payments, or is otherwise beneficial to the employee as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. This includes any award where non-vesting conditions within the control of either the Group or the employee are not met. However, if a new award is substituted for the cancelled award, and is designated as a replacement award on the date that it is granted, the cancelled and new awards are treated as if they were a modification of the original award, as described in the previous paragraph.

The dilution effect of outstanding options is reflected as additional share dilution in the computation of earnings per share.

就因非市場表現及／或服務條件並無達成而最終並無歸屬之獎勵而言，概無開支予以確認。倘獎勵包括市場或非歸屬條件，則於所有其他表現及／或服務條件達成之情況下，不論該市場或非歸屬條件是否達成，該等交易被視為歸屬。

當股權結算獎勵之條款修改時，倘符合該獎勵之原有條款，則確認最低開支，猶如條款並無修改。此外，就增加以股份支付之公允值或對僱員有利之任何修改按修改日期計量確認開支。

當股權結算獎勵註銷時，會被視作其已於註銷日期歸屬，並即時確認該獎勵尚未確認之任何開支。此包括任何未能符合本集團或僱員控制以內非歸屬條件之獎勵。然而，如前段所述，倘已註銷獎勵替代新獎勵，並於授出日期指定為重置獎勵，則已註銷及新獎勵會按猶如以其為原獎勵之修改處理。

計算每股盈利時，尚未行使購股權之攤薄影響反映為額外股份攤薄。

### 2.27 Employee benefits

#### (a) Employees' leave entitlement

Employees' entitlement to annual leave and long service leave is recognised when it accrues to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employees' entitlement to sick leave and maternity leave is not recognised until the time of leave.

#### (b) Pension obligations

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for all of its employees. Contributions are made based on a percentage of the employees' basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiaries which operate in Mainland China are required to participate in a central pension scheme operated by the local municipal government. The subsidiaries are required to contribute a percentage of the payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

#### (a) 僱員應享假期

僱員之應享年假及長期服務假期乃於應計予僱員時確認。僱員因提供服務而產生之應享年假及長期服務假期乃按截至報告期末之有關假期估計負債計算撥備。

僱員應享病假及產假於支取時方予確認。

#### (b) 退休金責任

本集團根據強制性公積金計劃條例為其所有僱員設立一項界定供款強制性公積金退休福利計劃(「強積金計劃」)。根據強積金計劃之規則，供款乃按僱員基本薪酬之若干百分比計算，並根據強積金計劃之規則於應付時在損益表內扣除。強積金計劃的資產與本集團的資產分開，並由獨立管理之基金持有。本集團之僱員供款於對強積金計劃作出供款時悉數歸屬於僱員。

本集團於中國內地營運之附屬公司之僱員須參與由地方市政府營運之中央退休金計劃。該等附屬公司須按相關薪金成本之若干百分比向中央退休金計劃作出供款。該等供款根據中央退休金計劃之規則於應付時在損益表內扣除。

#### (c) Bonus plans

The Group recognises a liability and an expense for bonuses. It recognises a provision where contractually obliged or where there is a past practice that has created a constructive obligation.

### 2.28 Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

### 2.29 Dividends

Final dividends are recognised as a liability when they are approved by the shareholders in a general meeting.

Proposed final dividends are disclosed in the notes to the financial statements.

本集團就獎金確認負債及支出，並就合約責任或據過往經驗已產生之推定責任確認撥備。

### 2.28 借貸成本

為購買、建造或生產須一段長時間才可達至其擬定用途或銷售之合資格資產而直接應佔之借貸成本乃資本化為該資產之部分成本。當有關資產大致可投放作擬定用途或銷售時，即終止將該等借貸成本資本化。當特定借貸仍有待支付合資格資產之開支而用作暫時投資，所賺取之投資收入乃自己資本化之借貸成本扣除。所有其他借貸於產生期間支銷。借貸成本包括利息及實體產生有關基金借貸之其他成本。

### 2.29 股息

末期股息於在股東大會上獲股東批准時確認為負債。

### 2.30 Foreign currency translation

These financial statements are presented in Hong Kong dollars, which is the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of the reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation difference on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss is also recognised in other comprehensive income or profit or loss, respectively).

In determining the exchange rate on initial recognition of the related asset, expense or income on the derecognition of a non-monetary asset or non-monetary liability relating to an advance consideration, the date of initial transaction is the date on which the Group initially recognises the non-monetary asset or non-monetary liability arising from the advance consideration. If there are multiple payments or receipts in advance, the Group determines the transaction date for each payment or receipt of the advance consideration.

該等財務報表以港元呈列，其為本公司之功能貨幣。本集團各實體釐定其自身之功能貨幣及各實體財務報表所列示之項目乃以功能貨幣計量。本集團實體錄得之外幣交易初步以其各自於交易日期之現行功能貨幣匯率列賬。以外幣計值之貨幣性資產及負債按報告期末之現行功能貨幣匯率換算。結算或換算貨幣性項目所產生之差額於損益表確認。

按外幣之歷史成本計量之非貨幣性項目以初步交易日期之匯率換算。以外幣按公允值計量之非貨幣性項目以公允值計量當日之匯率換算。換算按公允值計量之非貨幣性項目所產生之收益或虧損與確認該項目公允值變動之收益或虧損之處理方式一致(即公允值收益或虧損於其他全面收益或損益確認之項目，其換算差額亦分別於其他全面收益或損益確認)。

為了確定涉及預付代價及終止非貨幣性資產或非貨幣性負債的相關資產、開支或收入於初始確認時的匯率，初始交易日期為本集團初始確認因支付或收到預付代價而產生的非貨幣性資產或負債的日期。倘於確認相關項目之前有多個付款或收據，則應以這種方式確定每筆預付代價付款或收據的交易日期。

### 2.30 Foreign currency translation *(Continued)*

The functional currencies of certain group companies are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into Hong Kong dollars at the exchange rates prevailing at the end of the reporting period and their statements of profit or loss are translated into Hong Kong dollars at the weighted average exchange rates for the year.

The resulting exchange differences are recognised in other comprehensive income and accumulated in the “Cumulative translation adjustments” under reserves. On disposal of an operation with currency other than the Hong Kong dollar, the component of other comprehensive income relating to that particular operation is recognised in the statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of certain group companies with functional currency other than the Hong Kong dollar are translated into Hong Kong dollars at exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of these group companies which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

若干集團公司之功能貨幣為港元以外之貨幣。於報告期末，該等實體之資產及負債按報告期末之現行匯率換算為港元，而其損益表按年內加權平均匯率換算為港元。

由此產生之匯兌差額於其他全面收益確認，並累計於儲備項下之「累計換算調整」。以港元以外之貨幣出售業務時，有關該特定業務之其他全面收益部分於損益表確認。

收購海外業務所產生之任何商譽及收購所產生之資產及負債賬面值之任何公允價值調整被視為海外業務之資產及負債處理，並按收市匯率換算。

就綜合現金流量表而言，港元以外之功能貨幣之集團公司現金流量按現金流量日期之現行匯率換算為港元。該等集團公司於整個年度內產生之經常性現金流量按年內加權平均匯率換算為港元。

### 3. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

#### 3.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk, fair value interest rate risk and cash flow interest rate risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

Risk management is carried out by the finance department of the Company under policies approved by the board of directors. The finance department identifies, evaluates and hedges financial risks in close co-operation with the Group's operating units. The board of directors provides written principles for overall risk management, as well as written policies covering specific areas, such as foreign exchange risk, interest rate risk, credit risk, the use of derivative financial instruments and non-derivative financial instruments, and investment of excess liquidity.

#### (a) Market risk

##### (i) Foreign exchange risk

The Group operates principally in Hong Kong and Mainland China and is exposed to foreign exchange risk arising from various currency exposures, primarily with respect to the United States dollar (the "US dollar"), Japanese Yen, and Renminbi ("RMB"). Foreign exchange risk arises from future commercial transactions, recognised assets and liabilities and net investments in foreign operations.

### 3. 財務風險管理

#### 3.1 財務風險因素

本集團之活動面對多種財務風險：市場風險（包括匯兌風險、公允值利率風險及現金流量利率風險）、信貸風險及流動資金風險。本集團整體風險管理計劃針對難以預測之金融市場，務求減輕對本集團財務表現之潛在不利影響。

本公司財務部門根據董事會批准之政策進行風險管理，並通過與本集團營運部門通力合作，識別、評估及對沖財務風險。董事會制訂書面之整體風險管理原則，並制訂涵蓋特定範疇之書面政策，例如外匯風險、利率風險、信貸風險、使用衍生金融工具及非衍生金融工具以及過剩流動資金之投資。

#### (a) 市場風險

##### (i) 外匯風險

本集團主要於香港及中國內地經營，面對由多種貨幣產生之外匯風險，主要與美元（「美元」）、日圓及人民幣（「人民幣」）有關。外匯風險來自未來商業交易、已確認資產及負債以及海外業務之淨投資。

###### (i) Foreign exchange risk (Continued)

Management has set up a policy to require entities within the Group to manage their foreign exchange risk against their functional currencies. Foreign exchange risk arises when future commercial transactions or recognised assets or liabilities are denominated in a currency that is not the entity's functional currency.

The Hong Kong dollar is pegged to the US dollar ("US\$") at a range of rates between 7.75 and 7.85, and therefore, the foreign exchange exposure between the US dollar and the Hong Kong dollar is limited.

The Group has certain investments in foreign operations, whose net assets are exposed to foreign currency translation risk.

###### (i) 外匯風險(續)

管理層已制訂政策，要求本集團之實體管理其各自功能貨幣之外匯風險。當未來商業交易或已確認資產或負債以並非該實體功能貨幣之貨幣計值，外匯風險就會產生。

港元與美元(「美元」)掛鈎，匯率介乎7.75至7.85之間，故美元與港元之間之外匯風險有限。

本集團有若干海外業務投資，其淨資產面對外幣換算風險。

Credit risk arises from cash and cash equivalents, trade receivables, finance lease receivables and certain other receivables.

The Group has policies in place to ensure that sales are made to customers with an appropriate financial strength and an appropriate percentage of down payment. It also has other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group regularly reviews the recoverable amount of each individual receivable to ensure that adequate loss allowance is made for irrecoverable amounts. The Group implements its industry risk management system according to its plan based on the actual situation with a focus on industry research, customer credit rating, and understanding of the lessee's operations and financial condition. The Group also obtained deposits from lessees as disclosed in note 26 to the consolidated financial statements. The Group has no significant concentrations of credit risk, with exposure spreading over a number of counterparties and customers.

No credit limits were exceeded during the reporting period, and management does not expect any losses from non-performance by counterparties, except as disclosed in note 17 to the consolidated financial statements. The Group does not hold any collateral as security except for finance leasing operation, for which in the event of default, the Group may demand return of finance lease assets, repossession of finance lease assets or disposal of finance lease assets, whichever is appropriate.

Due to the capital intensive nature of the Group's business, the Group ensures that it maintains sufficient cash and credit lines to meet its liquidity requirements.

The Group's policy is to regularly monitor current and expected liquidity requirements and its compliance with lending covenants, and to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term.

#### 3.2 Capital risk management

The Group's objectives for managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the dividend payment to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debt.

During the year ended 31st March 2023, the Group's strategy, which was unchanged from last year, was to maintain a net cash position. Net cash position is calculated as cash and cash equivalents less other borrowings and lease liabilities. The net cash positions as at 31st March 2023 and 2022 were analysed as follows:

Management has assessed that the fair values of cash and cash equivalents, pledged deposits, trade, bills and other receivables, trade and other payables and other borrowings approximate to their carrying amounts largely due to short term maturities of these instruments.

The Group's corporate finance team is responsible for determining the policies and procedures for the fair value measurement of financial instruments. The corporate finance team reports directly to the chief financial officer and the audit committee. At each reporting date, the corporate finance team analyses the movements in the values of financial instruments and determines the major inputs applied in the valuation. The valuation is reviewed and approved by the chief financial officer. The valuation process and results are discussed with the audit committee twice a year for interim and annual financial reporting.

The fair values of the financial assets and liabilities are included at the amount at which the instrument could be exchanged in a current transaction between willing parties, other than in a forced or liquidation sale. The following methods and assumptions were used to estimate the fair values:

The fair values of finance lease receivables have been calculated by discounting the expected future cash flows using rates currently available for instruments with similar terms, credit risk and remaining maturities. The carrying amounts of finance lease receivables approximate to their fair values.

#### 4.1 Provision for expected credit losses on trade receivables

The Group uses a provision matrix to calculate ECLs for trade receivables. The provision rates are based on days past due for groupings of various customer segments that have similar loss patterns (i.e., by customer type).

The provision matrix is initially based on the Group's historical observed default rates. The Group will calibrate the matrix to adjust the historical credit loss experience with forward-looking information. At the reporting date, the historical observed default rates are updated and changes in the forward-looking estimates are analysed.

The assessment of the correlation among historical observed default rates and ECLs is a significant estimate. The amount of ECLs is sensitive to changes in circumstances and forward-looking information. The Group's historical credit loss experience and forward-looking estimates may also not be representative of a customer's actual default in the future. The information about the ECLs on the Group's trade receivables is disclosed in note 17 to the financial statements.

#### 4.2 Impairment assessment of goodwill

The Group tests annually whether goodwill is impaired in accordance with the accounting policies stated in note 2.4 to the financial statements. For the purposes of impairment testing, goodwill acquired has been allocated to an individual cash-generating unit which is reviewed for impairment based on forecast operating performance and cash flows. The recoverable amount of an asset or a cash-generating unit has been determined based on value in use calculations. Cash flow projection is prepared on the basis of reasonable assumptions reflective of prevailing and future market conditions, and cash flows are discounted appropriately.

##### 4.3 Provision for expected credit losses on other financial assets included in trade and other receivables

The ECLs for finance lease receivables and other financial assets included in trade and other receivables apart from the financial assets mentioned in note 4.1 above are based on assumptions about probability of default and expected loss rates. The Group uses judgement in making these assumptions and selecting inputs to the ECLs calculations, based on the Group's historical loss record, current conditions as well as forward-looking information.

##### Performance obligations

Information about the Group's performance obligations is summarised below:

##### Sale of goods

The performance obligation is satisfied when the control of the goods is transferred, generally on delivery of goods and when the respective installation services are completed. Payment is generally due within 5 to 180 days from completion of installation. Payment in advance is normally required.

##### Sales support services

The performance obligation is satisfied when the installation services in relation to the underlying machinery are completed. Payment is made based on the terms stipulated in the relevant agreements.

##### Commission and other service income

The performance obligation is satisfied over time as services are rendered and payment is generally due upon completion of services, except for new customers, where payment in advance is normally required.

The amount of unsatisfied performance obligation principally comprises the balance of contract liabilities as at 31st March 2023 and 2022, which is expected to be recognised in one year.

#### 5.2 Operating segment information

For management purposes, the Group is organised into two major reportable operating segments – hi-tech distribution and services, and leasing. The hi-tech distribution and services operating segment derives revenue from the sale of goods, sales support services, commission and other service income. The leasing operating segment derives revenue from finance lease and operating lease arrangements, and trading of lease assets.

Segment assets consist primarily of property, plant and equipment, intangible assets, right-of-use assets, other non-current assets, inventories and trade and other receivables. Unallocated assets comprise investment properties, deferred tax assets, financial assets at fair value through profit or loss, pledged deposits, cash and cash equivalents and corporate and others.

Segment liabilities consist primarily of trade and other payables, deposits received, lease liabilities and other non-current liabilities. Unallocated liabilities comprise income tax liabilities, other borrowings and corporate and others.

Capital expenditure comprises additions to property, plant and equipment, investment properties, intangible assets and right-of-use assets.

Hong Kong profits tax has been calculated at the rate of 16.5% (2022: 16.5%) on the estimated assessable profits for the year, except for one subsidiary of the Group which is a qualifying entity under the two-tiered profits tax rates regime. The first HK\$2,000,000 (2022: HK\$2,000,000) of assessable profits of this subsidiary is taxed at 8.25% (2022: 8.25%) and the remaining assessable profits are taxed at 16.5% (2022: 16.5%).

Subsidiaries established in Mainland China are subject to Mainland China corporate income tax at the standard rate of 25% (2022: 25%).

### Hi-tech distribution and services operation cash-generating unit

The recoverable amount of the hi-tech distribution and services operation cash-generating unit has been determined based on a value-in-use calculation using a pre-tax cash flow projection based on a financial budget covering a five-year period approved by senior management. The pre-tax discount rate applied to the cash flow projection was 13.1% (2022: 13.6%). The growth rate used to extrapolate the cash flows of the hi-tech distribution and services operation cash-generating unit beyond the five-year period was 3% (2022: 3%).

Assumptions were used in the value-in-use calculations of the hi-tech distribution and services operation cash-generating unit for the years ended 31st March 2023 and 2022. The following describes each key assumption on which management has based its cash flow projections to undertake impairment testing of goodwill:

**Distribution rights** – The continuance of the distribution rights for the hi-tech distribution and services operation in the foreseeable future would not need any additional cost or investment.

**Budgeted gross margins** – The basis used to determine the value assigned to the budgeted gross margins is based on past performance and management's expectations for market development.

**Discount rate** – The discount rate used is pre-tax and reflects specific risks relating to the unit.

As at 31st March 2023, the Group had unrecognised deferred tax assets of HK\$6,736,000 (2022: HK\$6,159,000), primarily representing the tax effect of cumulative tax losses (subject to agreement by relevant tax authorities) which can be carried forward indefinitely. Deferred tax assets have not been recognised in respect of these losses as they have arisen in subsidiaries that have been loss-making for some time and it is not considered probable that taxable profits will be available against which the tax losses can be utilised.

Pursuant to the enterprise income tax law of the PRC, a 10% withholding tax is levied on dividends declared to foreign investors from the foreign investment enterprises established in Mainland China. The requirement is effective from 1st January 2008 and applies to earnings after 31st December 2007. A lower withholding tax rate may be applied if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors. For the Group, the applicable rate is 5% or 10%. The Group is therefore liable for withholding taxes on dividends distributed by those subsidiaries established in Mainland China in respect of earnings generated from 1st January 2008.

As at 31st March 2023, the aggregate amount of temporary differences associated with investments in subsidiaries in Mainland China for which deferred tax liabilities have not been recognised totalled approximately HK\$176,876,000 (2022: HK\$151,340,000). In the opinion of the directors, it is not probable that these subsidiaries will distribute these unremitted earnings that are subject to withholding taxes in the foreseeable future.
