# CHAIRMAN'S STATEMENT

## 主席報告

The past year was a complicated and ever-changing year. From the beginning to the middle of 2022, all industries in Hong Kong were badly hit by the fifth wave of the COVID-19 pandemic. The impact was especially severe when Shanghai was locked down. When the city was locked down for more than two months, the local economy in Shanghai was definitely the first to bear the brunt. This was also a turning point for the deterioration of the Chinese economy. Coupled with the rising global interest rates and the rapid rise in prices, the Chinese economy, which was already very sluggish, had become even more catastrophic. The purchasing desire of Chinese customers also dropped to a low level, which was the first impact on the Group.

In late 2022 and in the beginning of 2023, there was finally a ray of light. On January 8, 2023, the Chinese government significantly relaxed travel restrictions. This is the good news we have been waiting for three years. With the easing of inbound and outbound travel, travelling between Hong Kong and the PRC has begun to take off. During the May Day holiday, on the street of Tsim Sha Tsui and Causeway Bay, we can finally feel the long-lasting lively atmosphere! The Canton Road shopping street, which has been quiet for the past 3 years, was full of people with long queues outside the famous stores. This is of course a good sign that the economy is picking up again.

When everyone feels that the border between China, Hong Kong and Macau will become smoother, the sudden outbreak of the small bank crisis in the United States has caused major enterprises to appear conservative about the future prospects with low purchasing desire. This is the second impact on the Group.

In addition to the markets in the PRC and the United States, the Japanese Yen unexpectedly weakened sharply, which was the biggest and most damaging factor for our Group. The prices of Japanese goods rose rapidly due to the devaluation of the Japanese Yen, which further reduced the consumption power of Japanese people. In the financial year of 2022–2023, the Company had been hard hit both internally and externally and it was hard for us to get through.

In the coming year, we will be prudent. As we enter the middle of 2023, although the economies in various regions began to stabilize and the impact of the pandemic began to disappear, the problems of inflation and devaluation of the Japanese Yen have not improved, and they are still a hindrance to the development of the Group. Therefore, in this year, we will adopt a more conservative business approach to control risks as much as possible and seek to win in stability.

過去一年，是複雜多變的一年。2022年頭至年中，香港各行各業都飽受第5波新冠疫情的摧殘。尤其影響極深的，莫過於上海封城了。2個多3個月的封城，上海當地經濟當然是首當其衝。這亦成為了中國經濟轉差的轉逆點。再加上環球息口不斷上行，物價高速上漲，令本來十分疲乏的中國經濟更顯得百上加斤。中國客人的購買慾亦跌至低點。這是對本集團的第一衝擊……

來到2022年尾，2023年頭，終於出現了一線曙光。2023年1月8日，中國政府大幅放寬出入境限制。這是大家等了3年的好消息！隨著出入境放寬，中港往來亦開始繁盛起來。五一假期，走上尖沙咀，銅鑼灣街道上，終於明顯感受到久違了的熱鬧氣氛！人流絡繹不絕，過去3年都顯得冷清的廣東道名店街，亦人來人往，名店外大排長龍。這當然是經濟重新復甦的好兆頭！

當大家覺得中港澳通關，往後的道路將會變得順暢之時，美國突然爆出小型銀行危機。令各大企業對未來前景顯得保守，買貨意欲低迷。這是本集團迎來第2衝擊……

除中國和美國的市場外，日元意外大幅走貶，是對我們集團做成最大最重的致命因素。日本的物價由於日元貶值而瞬速膨脹。進一步減低日本人的消費能力。於2022–2023年的財政年，我司可謂受盡內外夾擊，好不容易捱過。

未來一年，我們都是審慎的。踏入2023年中，雖然各地經濟開始回穩，疫情的影響亦開始消失。但通漲和日元貶值的問題一天沒有得到改善，始終對本集團發展做成一定阻礙。因此，我們在這一年，將會以較保守的經營方針，盡量把控風險，但求穩中求勝。

# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論及分析

### Business Review

Amuse Group Holding Limited (the “Company”) is a company incorporated in the Cayman Islands with limited liability under the Companies Law (as revised) of the Cayman Islands. The Company and its subsidiaries (the “Group”) are principally engaged in design, marketing, distribution and retail sales of toys and related products, and provision of agency services.

### Sales of original design manufacturer (“ODM”) toys

After three years of COVID-19 pandemic, the production and supply chains across the globe has returned to normal slowly. The sales of ODM toys has increased slightly and continues to account for the largest portion of the sales business segment of the Group. The Group’s two major customers, namely Sentinel Japan and Wing Co., Ltd., have worked with us for over 12 years and 16 years respectively, representing the primary revenue source of the sales of ODM toys. During the year ended 31 March 2023 (the “Year”), revenue from sales of ODM toys increased by approximately 6.6% to approximately HK\$114,835,000 (2022: approximately HK\$107,749,000).

The profit margin of the sales of ODM toys has declined by approximately 29.7%, which was decrease from 11.1% for the year ended 31 March 2022 (“Prior Year”) to 7.8% for the Year due to the same reason in Prior Year, with the increment of labour and raw material costs passed on by our suppliers to the Group during the Year being the main reason for the decrease of the overall gross profit margin for the Year.

### Distribution of imported toys and related products

The high-end robot figures is continuously top-dollar growth category in the revenue from distribution of imported toys and related products in the Year. Several hot-selling high-end robot figures were released and delivered which strongly push up the sales of the segment in the year. The revenue from this segment has increased sharply by approximately 36.6% to HK\$68,645,000 (2022: approximately HK\$50,264,000) during the Year.

### Sales of own licensed toys and related products

The Group applied the “SENTINEL/ 千值練”, “TOPI” and “FLAME TOYS” brands in developing our own licensed toys and related products over the years. A number of hot-selling high-end robot figures were released and delivered in the Prior Year, but not in the Year, leading to the significantly dropped in revenue from sales of own licensed toys and related products during the Year by 16.0%, to approximately HK\$49,099,000 (2022: approximately HK\$58,472,000).

### 業務回顧

佰悅集團控股有限公司(「本公司」)乃根據開曼群島公司法(經修訂)於開曼群島註冊成立的有限公司。本公司及其附屬公司(「本集團」)之主要業務為設計、營銷、分銷及零售玩具及相關產品以及提供代理服務。

### 銷售原設計製造(「ODM」)玩具

經過三年的新冠疫情，全球的生產及供應鏈已慢慢恢復正常。ODM玩具的銷售額輕微上升，繼續佔本集團銷售業務分部的最大部分。本集團的兩名主要客戶：千值練日本及Wing Co., Ltd. 分別與本集團合作逾12年及16年，為ODM玩具銷售主要的收益來源。於截至二零二三年三月三十一日止年度(「本年度」)，銷售ODM玩具之收益增加約6.6%至約114,835,000港元(二零二二年：約107,749,000港元)。

與去年的原因相同，本年度供應商將勞工及原材料成本增長轉嫁予本集團，導致銷售ODM玩具的利潤率下降約29.7%，由截至二零二二年三月三十一日止年度(「去年」)11.1%下降至本年度7.8%，此乃本年度整體毛利率下降的主要原因。

### 分銷進口玩具及相關產品

於本年度分銷進口玩具及相關產品的收益之中，高端機械人手辦玩具繼續名列高價增長類別。本年度發行及交付多款熱銷高端機械人手辦玩具，強力推升該分部銷售額。本年度，來自該分部的收益急劇增長約36.6%至68,645,000港元(二零二二年：約50,264,000港元)。

### 銷售自家特許玩具及相關產品

本集團多年來使用「SENTINEL/ 千值練」、 「TOPI」及「FLAME TOYS」品牌開發自家特許玩具及相關產品。本集團於去年而非本年度發行及交付多款熱銷高端機械人手辦玩具，令本年度銷售自家特許玩具及相關產品的收益大幅下跌16.0%至約49,099,000港元(二零二二年：約58,472,000港元)。



# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論及分析

### Agency services related to engineering projects

The Group's new revenue stream from agency services related to engineering projects commenced on 8 August 2022, which mainly contributed from the project in Fo Tan, Hong Kong. There are three areas of work including typical lobby, lift car and main lobby for this project, that contributed the revenue of approximately HK\$3,384,000 for the Year (2022: Nil).

### Financial Analysis Revenue

Revenue is recognised when the customer takes possession of and accepts the products. Revenue is after deduction of any trade discounts.

Revenue increased by approximately 9.0% to approximately HK\$235,963,000 for the Year from approximately HK\$216,485,000 for the Prior Year. The increase in revenue was mainly due to the rapid increase in sales of distribution of imported toys and related products and sales of ODM toys.

### Cost of sales

Our Group's cost of sales, incurred from the ODM toys, distribution of imported toys and related products and own licensed toys and related products comprising of (i) production costs of related products; (ii) license fee; (iii) depreciation of mould and (iv) others.

Cost of sales increased by approximately 4.7% to approximately HK\$190,227,000 for the Year from approximately HK\$181,612,000 for the Prior Year. The increase of cost of sales is in line with the increase of revenue.

### Gross profit

Gross profit increased by approximately 31.2% to approximately HK\$45,736,000 for the Year from approximately HK\$34,873,000 for the Prior Year. The gross profit margin increased to approximately 19.4% for the Year from approximately 16.1% for the Prior Year. The increase of gross profit was mainly because of the significant increase in the distribution of imported toys and related products which is the highest in profit margin among the business segments.

### 工程項目相關代理服務

本集團於二零二二年八月八日開始有來自工程項目相關代理服務的新收益來源，主要來自香港火炭的項目。該項目有三項工程範疇，包括典型大堂、升降機及大堂，於本年度貢獻收益約3,384,000港元(二零二二年：無)。

### 財務分析 收益

收益於客戶收到及同意接收產品時確認。收益已扣除任何貿易折扣。

收益由去年約216,485,000港元增加約9.0%至本年度約235,963,000港元。收益增加主要由於銷售以及分銷進口玩具及相關產品以及銷售ODM玩具快速增長所致。

### 銷售成本

本集團ODM玩具、分銷進口玩具及相關產品以及自家特許玩具及相關產品的銷售成本包括：(i) 相關產品的生產成本；(ii) 特許費用；(iii) 模具折舊；及(iv) 其他。

銷售成本由去年約181,612,000港元增加約4.7%至本年度約190,227,000港元。銷售成本增長與收益增長是一致的。

### 毛利

毛利由去年約34,873,000港元增加約31.2%至本年度約45,736,000港元。毛利率由去年約16.1%上升至本年度約19.4%。毛利增加主要由於分銷進口玩具及相關產品大幅增加，而分銷進口玩具及相關產品的利潤率在一眾業務分部中相對較高。

### Other income, net

Other income, net decreased by approximately 83.3% to approximately HK\$651,000 for the Year from approximately HK\$3,898,000 for the Prior Year.

The decrease was mainly due to the sharp rebound of the US dollar during the Year. The foreign currency held on hand during the Year results in a foreign exchange loss being written off from other incomes.

### Selling expenses

Our selling expenses comprises (i) advertising; (ii) staff costs which mainly represents the expenses in salary of staff; (iii) freight, postage and delivery; (iv) commission expense for our consignment sales; and (v) other selling and distribution expenses. Selling expenses increased by approximately 12.0% from approximately HK\$8,200,000 for the Prior Year to approximately HK\$9,187,000 for the Year, mainly due to the increase in the online marketing expenses on social media platforms; and the expenses on Ani-Com & Games Hong Kong incurred in the Year.

### Administrative expenses

Our administrative expenses mainly consists of (i) staff costs which mainly represents the expenses in salary and staff benefit payable to our administrative department including our Directors; (ii) operating lease charges for land and building; (iii) travelling and entertainment expenses; (iv) audit fee; (v) depreciation expenses; (vi) legal and professional fee; (vii) insurance expenses mainly in relation to product liability insurance; and (viii) other administrative expenses.

Administrative expenses increased by approximately 3.5% from approximately HK\$27,036,000 for the Prior Year to approximately HK\$27,993,000 for the Year.

### Finance costs

The finance costs arose from our bank loans and fees for electronic payment transactions. Finance costs increased by approximately 116.7% to approximately HK\$234,000 for the Year from approximately HK\$108,000 for the Prior Year. The increase was mainly due to the increase in (i) the mortgage interest; (ii) interest on lease liabilities.

### 其他收入淨額

其他收入淨額由去年約3,898,000港元減少約83.3%至本年度約651,000港元。

該減少乃主要由於本年度美元大幅反彈所致。於本年度持有的外幣導致從其他收入中撇銷外匯匯兌虧損。

### 銷售開支

銷售開支包括(i)廣告；(ii)員工成本(主要為員工薪金開支)；(iii)運費、郵費及送貨；(iv)寄售佣金開支；及(v)其他銷售及分銷開支。銷售開支由去年約8,200,000港元增加約12.0%至本年度約9,187,000港元，主要由於社交媒體平台產生的線上營銷開支增加；及本年度產生有關香港動漫電玩節的開支。

### 行政開支

行政開支主要包括(i)員工成本(主要指應付行政部門(包括董事)的薪金及員工福利開支)；(ii)土地及樓宇經營租賃費用；(iii)差旅及酬酢開支；(iv)審核費用；(v)折舊開支；(vi)法律及專業費用；(vii)保險開支(主要關於產品責任保險)；及(viii)其他行政開支。

行政開支由去年約27,036,000港元增加約3.5%至本年度約27,993,000港元。

### 融資成本

融資成本源於銀行貸款及電子支付交易費用。融資成本由去年約108,000港元增加約116.7%至本年度約234,000港元。成本增加主要由於(i)按揭利率；(ii)租賃負債利息增加所致。

### Income tax expenses

Income tax expenses were increased by approximately 13.8% to approximately HK\$1,861,000 for the Year, as compared to approximately HK\$1,636,000 for the Prior Year.

### Future plans for material investments and capital assets

Save as disclosed in the prospectus of the Company dated 18 May 2018 (the “Prospectus”), the Group had no definite future plans for material investments and capital assets.

### Significant investments held

As at 31 March 2023, the Group is holding an investment of joint venture which was formed in accordance with the joint venture agreement entered into between Amuse Luck and Grand View Protective Products Limited (“Grand View”) (the “Joint Venture Agreement”) pursuant to which Amuse Luck and Grand View agreed to jointly establish a joint venture (the “Joint Venture”) in Hong Kong owned as to 30% by Amuse Luck and 70% by Grand View, which principally engages in manufacturing and sale of protective products (including medical face masks, infrared thermometer, disinfectant spray, protective clothing, etc.) in Hong Kong and PRC markets.

In accordance with the Joint Venture Agreement, Amuse Luck and Grand View have invested in aggregate amount of HK\$10 million to the Joint Venture for setting up the medical face masks production lines in proportion to their respective shareholdings, in which Amuse Luck contributed HK\$3 million to the Joint Venture and Grand View is responsible for the costs of medical face masks production equipment, its installation and the plant renovation which amount to approximately HK\$7 million.

於二零二三年三月三十一日，本集團持有一項合資公司投資，該合資公司乃根據佰好與康鴻防護用品有限公司(「康鴻」)訂立的合資協議(「合資協議」)成立，根據合資協議，佰好及康鴻同意在香港共同成立合資公司(「合資公司」)，分別由佰好及康鴻擁有30%和70%，合資公司主要在香港及中國市場從事製造及銷售防護產品(包括醫用口罩、紅外線探熱器、消毒噴霧、防護衣等)。

根據合資協議，佰好與康鴻已按照其各自的股權比例向合資公司投資，總金額為10,000,000港元，用途為設立醫用口罩生產線，其中佰好向合資公司出資3,000,000港元，而康鴻負責醫用口罩生產設備、安裝及廠房維修的成本，金額相當於約7,000,000港元。

### **重大收購及出售附屬公司及聯屬公司**

#### **(i) Acquisition 30% of DongYiQuan**

On 25 April 2022, the Group entered into the Sale and Purchase Agreement with Chu Guigui (褚桂桂) and Zhu Rongzheng (朱榮政) to purchase 30% of DongYiQuan Network Technology Co., Ltd., (“DongYiQuan”). The Consideration is HK\$10,000,000 which was fully settled and discharged by the allotment and issue of 192,307,692 Consideration Shares that under General Mandate, at the Issue Price of HK\$0.052 per Consideration Share to the Vendors at Completion.

DongYiQuan is a high-tech enterprise focusing on the development and application of smart healthcare industry solutions. It is principally engaged in the provision of smart health care products and service systems with a vision of “cloud platform, smart hardware and smart service”. DongYiQuan has cumulated solid clientele including local government agencies, hospitals, wellness centres, as well as individual households. It is in line with the Group’s investment objective by riding on the up side potential of the smart elderly care service sector and investing in DongYiQuan.

#### **(ii) Acquisition 100% of Forever Profits**

Pursuant to the sale and purchase agreement dated 8 August 2022 (the “Sale and Purchase Agreement”), Mr. Tse Chun Yiu (“Mr. Tse”) sold to the Company the entire issued share capital in Forever Profits Development Limited (“Forever Profits”) with a consideration of HK\$7,000,000, which was settled in cash. Pursuant to the Sale and Purchase Agreement, the Mr. Tse irrevocable and unconditionally guarantees to the Company that the net profit of each of the three years (“Profit Guarantee Period”) shall not be less than HK\$2,500,000. Otherwise, Mr. Tse shall pay the differences to the Company, and the maximum amount payable by Mr. Tse to the Company is HK\$2,500,000 per year.

#### **(i) 收購動醫圈的30%**

於二零二二年四月二十五日，本集團與褚桂桂及朱榮政訂立買賣協議，以購買 DongYiQuan Network Technology Co., Ltd. (「動醫圈」) 的30%。代價為 10,000,000 港元，已透過於完成時根據一般授權按發行價每股代價股份 0.052 港元向賣方配發及發行 192,307,692 股代價股份的方式悉數清償及支付。

動醫圈為專注於開發及應用智慧健康護理行業解決方案的高新技術企業，主要從事提供智慧健康護理產品及服務系統，公司願景為「雲平台、智慧硬件及智慧服務」。動醫圈已積累厚實的客戶基礎，包括地方政府機關、醫院、健康中心及個別家庭。其與本集團投資目標一致，即利用智慧養老服務領域的上升潛力，投資於動醫圈。

#### **(ii) 收購皆盈的100%**

根據日期為二零二二年八月八日的買賣協議(「買賣協議」)，謝俊曜先生(「謝先生」)向本公司出售皆盈發展有限公司(「皆盈」)的全部已發行股本，代價為 7,000,000 港元，以現金結算。根據買賣協議，謝先生不可撤回及無條件地向本公司保證三年各年(「利潤保證期」)之純利不少於 2,500,000 港元。否則，謝先生將向本公司支付差額，而謝先生每年應付本公司的最高金額為 2,500,000 港元。

As the first year of the Profit Guarantee Period will only end on 30 June 2023, it remains to be confirmed whether the profit guarantee in respect of the first year could be satisfied. The Company will disclose in its first quarterly report for the three months ending 30 June 2023 whether such guarantee in respect of the first year is satisfied and whether Mr. Tse is required to make any payment to the Company or not.

Forever Profits is a company incorporated in Hong Kong with limited liability. It is principally engaged in the provision of agency services related to engineering projects in Hong Kong, including (i) commercial building repair, maintenance, renovation; (ii) office renovation, design and (iii) other large-scale engineering projects.

### **(iii) Acquisition 45% of M.I.P.**

An indirect wholly-owned subsidiary of the Company, Amuse Development Limited (the “Amuse Development”) and Ms. Cheng Pui Ling (the “Ms. Cheng”) entered into an agreement for the sale and purchase of approximately 45.00% of the issued share capital (the “Sale Shares”) M.I.P. International Limited (the “M.I.P.”), pursuant to which the Ms. Cheng conditionally agreed to sell and the Amuse Development conditionally agreed to acquire the Sale Shares (the “M.I.P. Acquisition”) at a consideration of HK\$7,950,000 which shall be payable by the Amuse Development to the Ms. Cheng by cash. The M.I.P. Acquisition was completed on 26 October 2022.

The M.I.P. is a company incorporated in Hong Kong with limited liability. It is principally engaged in the provision of information technology solutions to customers, including (i) infrastructure solution such as network and data center; (ii) system and security solution such as application server and system security; and (iii) equipment reselling service. The M.I.P. has a diversified customer base, including renowned hotels, property developers and the government of Hong Kong.

由於利潤保證期的首年於二零二三年六月三十日才結束，因此首年的利潤保證是否能夠達成仍有待確認。本公司將於截至二零二三年六月三十日止三個月的第一季度報告中披露首年的該保證是否獲達成，以及謝先生是否須向本公司支付任何款項。

皆盈為於香港註冊成立之有限公司。其主要於香港從事提供工程項目相關代理服務，包括(i)商業大廈維修、保養、翻新；(ii)辦公室翻新、設計；及(iii)其他大型工程項目。

### **(iii) 收購萬普的45%**

本公司一間間接全資附屬公司佰悅發展有限公司(「佰悅發展」)與鄭佩玲女士(「鄭女士」)就買賣萬普國際有限公司(「萬普」)約45.00%已發行股本(「銷售股份」)訂立協議，據此，鄭女士有條件同意出售而佰悅發展有條件同意購買銷售股份(「萬普收購事項」)，代價為7,950,000港元，將由鄭女士以現金支付予佰悅發展。萬普收購事項已於二零二二年十月二十六日完成。

萬普為於香港註冊成立之有限公司。其主要從事向客戶提供資訊科技解決方案，包括(i)網絡及數據中心等基礎設施解決方案；(ii)系統及安全解決方案(如應用程式伺服器及系統安全)；及(iii)設備轉售服務。萬普擁有多元化的客戶基礎，包括知名酒店、物業發展商及香港政府。

### Gearing Ratio

Gearing ratio is calculated based on the total loans and borrowings divided by total equity at the respective reporting date. As at 31 March 2023, the Group's gearing ratio was approximately 0.02 times, while it was 0.02 times as at 31 March 2022. The Group's financial position is sound and strong. With available bank balances and cash, the Group has sufficient liquidity to satisfy its funding requirements.

### Foreign Exchange Exposure

Certain trade receivables, bank balances and trade payables are denominated in foreign currency of the respective group entities which are exposed to foreign currency risk. Although part of the Group's revenue and cost are in U.S. Dollar ("USD") and Japanese Yen, the Group does not expect any significant movement in the USD and Japanese Yen exchange rate. The Group currently does not have a foreign currency hedging policy. However, management monitors foreign exchange exposure closely and will consider hedging significant foreign currency exposure should the need arise.

### Charge on the Group's assets

At 31 March 2023, the Group's building with an aggregate carrying value of HK\$5,892,000 were mortgaged to secure banking facilities granted to the Group (31 March 2022: HK\$6,069,000).

### Information on employees

As at 31 March 2023, the Group had 40 employees (31 March 2022: 41) working in Hong Kong. Employees are remunerated according to their performance and work experience. On top of basic salary, commission, discretionary bonus and share option may be granted to eligible staff by reference to the Group's performance as well as individual's performance. The total staff cost (including remuneration of the Directors and mandatory provident funds contributions) for the Year amounted to approximately HK\$17,266,000 (2022: approximately HK\$15,884,000).

### 資產負債比率

The Company is committed in maintaining high standards of corporate governance (“CG”). The Board believes that commitment in CG practices will definitely benefit the Shareholders in long term. During the Year, the Company has applied the principles and complied with all the applicable code provisions of the Corporate Governance Code (the “CG Code”) as set out in Appendix 15 to the GEM Listing Rules in force at that time.

The Board considers that good CG is central to safeguarding the interests of the Shareholders and enhancing the performance of the Group. The Board will continuously review and improve the CG practices and standards of the Company to ensure that business activities and decision making processes are regulated in a proper and prudent manner.

With a view to further improving the Company’s CG practices, the following actions were taken in 2023:

- Appointment of non-executive Directors with appropriate management experience to further broaden the collective knowledge, perspective and skill of the Board.
- Appointment of Independent Non-executive Directors (“INEDs”) with appropriate professional accounting qualifications and financial management experience with regulatory entitles to further broaden the collective knowledge, perspective and skill of the Board.
- All members of the audit committee of the Company (“Audit Committee”) are INEDs and at least one of them has appropriate professional accounting qualifications and financial management experience.
- To adopt Board diversity policy to recognise and embrace the benefits of having a diverse Board to enhance the quality of its performance. In designing the Board’s composition, Board diversity has been considered from a number of aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service.

### Code of Conduct Regarding Securities Transactions by Directors

The Company has adopted the required standard of dealing, as set out in Rules 5.48 to 5.67 of the GEM Listing Rules (“the Model Code”) as the code of conduct regarding securities transactions by Directors. Following specific enquiry by the Company, all the Directors have confirmed that they have complied with the required standard as set out in the Model Code and its code of conduct regarding directors’ securities transactions during the Year.

With a wide range of expertise and a balance of skills, the INEDs bring independent judgement on issues of strategic direction, development, performance and risk management through their contribution at Board meetings and committees work.

The Group is keen to strengthen its market position and generate value for its investors while constantly looking out for its stakeholders to attain sustainable development. The Group formulates and implements the following strategies and plans to achieve its objectives and value.

- The Board encourages its members to discuss the underlying value of its culture at board meetings to align and improve its strategies;
- The Group provides sufficient resources to execute its strategies;
- The management teams report to the Board at least every quarter so that the Board can regularly evaluate the core value of its culture;
- Open communication is always available between the Board and the Company's workforce;
- The Board periodically monitors the Company's conduct and encourages holding the responsible individuals accountable where any misalignment occurs;
- Share option scheme is available for the Board to provide incentives for any relevant parties in future;

### Appointment and re-election of Directors

All of the Directors have service agreements or letters of appointment and the details of their terms are set out in the Report of the Directors on pages 36 to 47 of this annual report. All Directors are subject to re-election by shareholders at the annual general meeting. Retiring Directors are eligible for re-election and re-election of retiring Directors at annual general meetings is dealt with by separate individual resolutions. Where vacancies arise at the Board, candidates are proposed and put forward to the Board by the nomination committee of the Company (the "Nomination Committee") as more fully explained below under the section on Nomination Committee of this annual report.

### Board Composition

As at the date of this report, the Board has three executive Directors; three Non-executive Directors; and three INEDs, as shown on pages 26 to 31 of this annual report. Biographies of the Company's Directors are shown on pages 14 to 21 of this annual report.

INEDs ensure the Board accounts for the interest of all shareholders and subject matters are considered objectively. The Board considers all of the INEDs to be independent. INEDs have accounted for 33% of the full Board.

The Board established the following mechanisms to increase the credibility of independents views.

- Directors are entitled to seek external independent legal and other professional advice for performing their duties. Separate independent professional advice is always available upon their request;
- The Board (led by an INED) has conducted evaluation of the directors' (including INEDs) performance every half year through questionnaires, interviews and/or observations. Criteria for evaluation include (i) board meeting attendance; (ii) whether they actively participated in discussion; (iii) whether they had the motivation and integrity required; (iv) whether they had or were capable to devote sufficient time to make contributions to the Group; (v) whether they had the business experience and skills to effectively oversee the management; and (vi) whether they were independent. The aforementioned criteria are for by no means exhaustive or decisive. Management, external advisers and key stakeholders such as shareholders are also encouraged to provide useful feedback;
- The composition of the Board consisted of three INEDs, which accounted for one-third of the Board;

### 董事會組成

獨立非執行董事確保董事會為全體股東的利益行事，並已客觀考慮標的事項。董事會認為全體獨立非執行董事均屬獨立。獨立非執行董事佔董事會全體成員的33%。

董事會已建立以下機制，以提高獨立意見的可信度。

- 董事有權就履行其職責尋求外部獨立法律及其他專業意見。如有需要可尋求獨立專業意見；
- 董事會（由一名獨立非執行董事領導）每半年透過問卷、面談及／或觀察對董事（包括獨立非執行董事）的表現進行評估。評估標準包括(i)董事會會議出席率；(ii)是否積極參與討論；(iii)是否具有所需的動機及誠信；(iv)彼等是否已經或能夠投入足夠時間為本集團作出貢獻；(v)彼等是否具備有效監督管理層的業務經驗及技能；及(vi)彼等是否獨立。上述標準並非詳盡無遺，亦不具決定性作用。我們亦鼓勵管理層、外部顧問及主要持份者（如股東）提供有用的反饋；

- The Chairman welcomes any nomination of directors. The Board deploys multiple channels for identifying suitable candidates, including directors' referrals, management, advisors of the Group and external executive search firms. Candidates will be shortlisted by the Nomination Committee and the Nomination Committee will evaluate the candidate based on the aforementioned criteria. The Board has the final authority to determine suitable candidates to be elected as directors; and
- The Group has received annual written confirmation from each of the INEDs in respect of their independence in accordance with the independence guidelines set out in Rule 5.09 of the Listing Rules.

During the Year and up to the date of this report, the Group has complied with the CG Code, except for the deviation from the code provision A.2.1 of the CG Code. Mr. Li is the Chairman and the Chief Executive Officer and he has been managing the Group's business and supervising the overall operations of the Group since 2004. The Directors consider that vesting the roles of the Chairman and the Chief Executive Officer in Mr. Li is beneficial to the management and business development of the Group and will provide a strong and consistent leadership to the Group. The Board will continue to review and consider splitting the roles of the Chairman and the Chief Executive Officer at a time when it is appropriate and suitable by taking into account the circumstances of the Group as a whole.

### Induction, Information and ongoing Development

All the Directors were kept informed on a timely basis of major changes that may have affected the Group's business, including relevant rules and regulations. During the Year, all Directors have participated in continuous professional development to develop and refresh their knowledge and skills in accordance with code provision A.6.5 contained in the CG Code.

### Role and Responsibilities of the Board

The Board delegated appropriate aspects of its management and administrative functions to management. It also give clear directions as to the powers of management, in particular, with respect to the matters that management must report back and obtain prior approval from the Board before making decisions or entering into any commitments on behalf of the Company.

To assist in fulfilling its duties and responsibilities, the Board established three committees, namely Audit Committee, Remuneration Committee and Nomination Committee.

### Board Process

All the Directors are regularly updated on the governance and regulatory matters. There is an established procedure for Directors to obtain independent professional advice at the expense of the Company in the furtherance of their duties. The Company has also arranged appropriate director and officer liability insurance to cover any potential legal actions that might be taken against its Directors.

The Board meets regularly throughout the Year to review the overall strategies and monitor the operations as well as the financial performance of the Group. Notice of at least 14 days has been given to all Directors for all regular Board meetings and the Directors can include matters for discussion in the agenda whenever they consider appropriate and necessary. Agenda and accompanying Board paper in respect of regular Board meetings are despatched in full to all Directors within a reasonable time before the meeting. Directors have to declare their direct or indirect interests, if any, in any proposals or transactions to be considered by the Board at Board meetings and abstain from voting as appropriate. Draft minutes of all Board meetings are circulated to Directors for comment within a reasonable time prior to confirmation.

### Audit Committee

The Audit Committee was established in compliance with Rules 5.28 to 5.33 of the GEM Listing Rules and code provision C.3.3 of the CG Code. The main duties of the Audit Committee are to assist the Board in reviewing the Company's financial information, overseeing the Group's financial reporting system, risk management and internal control systems, reviewing and monitoring the effectiveness of the scope of audit and making recommendation to the Board on the appointment of external auditors.

The Audit Committee currently consists of three members, namely Ms. Chow Chi Ling Janice (the Chairlady of the Audit Committee), Mr. Yu Pui Hang and Mr. Tung Man, all being independent non-executive Directors. No member of the Audit Committee is a member of the former or existing independent auditor of the Company. The Audit Committee has reviewed this annual report, including the audited consolidated results of the Group for the year ended 31 March 2023.

According to the current terms of reference, the Audit Committee shall meet at least four times for a financial year. The Audit Committee held a meeting 30 June 2023 (i) review and approve the annual financial results in respect of the year ended 31 March 2023; (ii) discuss and consider the significant issues on the financial reporting, operational and compliance controls, the effectiveness of the risk management and internal control systems; and (iii) review the appointment of external auditors and relevant scope of works. ### Risk Management and Internal Control

The Company conducts an annual review on whether there is a need for an internal audit department. Given the Group's simple operating structure, as opposed to a separate internal audit department, the Board is directly responsible for the establishment, maintenance and review of the Group's system of internal controls and risk management throughout the Year and their effectiveness. The Company has engaged an external independent professional advisory firm (the "Independent Advisor") to review the effectiveness and adequacy of risk management and internal control systems in Year 2023 so as to ensure the effectiveness and adequacy of risk management and internal controls system. The Independent Advisor had reviewed and analysed all material controls of the Group, including financial, operational and compliance controls and their associated risks. The relevant reports from the Independent Advisor were presented to and reviewed by the Audit Committee and the Board.

In compliance with code provision D.2.6 of the CG Code, the Board adopted a whistleblowing policy. It provides employees and the relevant third parties who deal with the Group (e.g. customers, suppliers, creditors and debtors) with guidance and reporting channels on reporting any suspected improprieties in any matters related to the Group directly addressed to the designated person.

The chairman of the Audit Committee is designated to receive the relevant complaints for this purpose. All reported matters will be investigated independently and, in the meantime, all information received from a whistleblower and its identity will be kept confidential. The Board and the Audit Committee will periodically review the whistleblowing policy and mechanism to improve its effectiveness.

The Board considered the risk management and internal control systems of the Group to be adequate and effective for the Year. The Board also conducted a review of the adequacy of resources, qualifications and experience of staff of the Group's accounting and financial reporting function, and their training programs and budget which are considered to be adequate for the Year.

### Dividend Policy

The Company formulated the Dividend Policy to set out the principles for the Board to consider before making any dividend distribution. In deciding whether to propose a dividend and in determining the dividend amount, the Board shall take into account, included but not limited to: (i) the general financial condition of the Group; (ii) working capital and debt level of the Group; (iii) future cash requirements and availability for business operations, business strategies and future development needs; and (iv) any other factors that the Board deems appropriate.

### 風險管理及內部監控

本公司就是否需要內部審核部門進行年度檢討。鑒於本集團之簡單營運架構，與獨立內部審核部門相反，董事會於本年度內直接負責制定、維護及檢討本集團之內部監控及風險管理系統及其效用。本公司已於二零二三年委聘外部獨立專業顧問公司（「獨立顧問」）檢討風險管理及內部監控系統是否有效及充足，以確保風險管理及內部監控系統之效用及充足性。獨立顧問已檢討及分析本集團之所有重大控制，包括財務、營運及合規控制以及其相關風險。獨立顧問之相關報告已提呈予審核委員會及董事會並獲其審閱。

董事會認為，於本年度，本集團之風險管理及內部監控系統屬充足及有效。董事會亦已檢討於本年度本集團會計及財務申報職能部門之資源、員工資歷及經驗以及其培訓計劃及預算之充足性，並認為上述各項均充足。

### 股息政策

### Auditor's Remuneration

During the year, the remuneration paid to the external auditors of the Company, Grant Thornton Hong Kong Limited, in respect of audit services for the Year amounted to HK\$800,000.

### Respective Responsibilities of Directors and Auditors

The Directors are responsible for the preparation of the financial statements, which give a true and fair view of the state of affairs of the Company and comply with the requirement of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong) ("Hong Kong Companies Ordinance") and the applicable disclosure provisions of the GEM Listing Rules. The auditors are responsible for forming an independent opinion, based on the audit, on the financial statements prepared by the Directors and reporting the opinion solely to the Shareholders. The Independent Auditor's Report is set out on pages 48 to 56 of this annual report.

### Investor and Shareholder Relation

The Company endeavors to continue maintaining a high level of transparency in communicating with Shareholders and the investment community at large. Briefings and meetings with institutional investors and analysts are conducted regularly. The Company is committed to maintaining an open and effective investor communication policy and to update investors on relevant regulatory requirements.

Financial information and all shareholder corporate communications of the Company are made available on the Company's website at <http://www.amusegroupholding.com> and updated regularly on a timely basis.

The Board and management shall ensure shareholders' right and all shareholders are treated equally and fairly. The Company will announce and publish its quarterly, interim and annual results in a timely manner, which is well before the time limits set out in the GEM Listing Rules. Separate resolutions will be proposed at the general meetings on each substantially separate issue, including the re-election of individual Directors, if any.

The annual general meeting will provide an opportunity for direct communication between the Board and the Shareholders.

The Company regards the annual general meeting as an important event in which the Chairman and all Directors will make an effort to attend. External auditors shall also be invited to attend the Company's annual general meeting and are also available to assist the Directors in addressing queries from Shareholders relating to the conduct of the audit and the preparation and content of the auditors' report. All Shareholders are given prior notice on a timely basis together with a detailed agenda. The Board, according to the GEM Listing Rules, will conduct voting at the forthcoming annual general meeting ("AGM") by poll. The results of the Company will be declared at the meeting, and announced timely on the Stock Exchange's website and the Company's website.

### Shareholders' Rights

Procedures for convening an extraordinary general meeting and putting forward proposals at Shareholders' meeting.

Any Shareholder(s) individually or collectively holding 10% or more of the Company's total issued share capital shall be entitled to request the Board in writing to convene an extraordinary general meeting. Upon receiving such request, the Board shall issue a notice of extraordinary general meeting within 21 days and hold an extraordinary general meeting within two months from the receipt of such request. If within 21 days of the receipt of such request the Board fails to proceed to convene such meeting, the Shareholder(s) proposing to convene an extraordinary general meeting in writing may himself/herself (themselves) convene an extraordinary general meeting in the same manner.

### Procedures for Shareholders to put enquires to the Board

As informed by Ample Capital, neither Ample Capital nor any of its directors or employees or close associates, has or may have, any interest in the share capital of the Company or any member of the Group (including options or rights to subscribe for such securities), which is required to be notified to the Company pursuant to Rule 6A.32 of the GEM Listing Rules, except for the compliance adviser agreement entered into between the Company and Ample Capital dated 10 May 2018 and as supplemented dated 26 August 2019, 15 April 2021 and 30 June 2022 (the "Compliance Adviser Agreement"). The Company and Ample Capital have mutually agreed to terminate the Compliance Adviser Agreement on 1 October 2022.

### Directors' Indemnities and Insurance

As permitted by the Articles, a director of the Company may be indemnified out of the assets and profits of the Company from and against all actions, costs, charges, losses, damages and expenses which the director shall or may incur or sustain by or by reason of any act done, concurred in or omitted in or about the execution of his or her duty as a director of the Company, to the extent permitted by law. 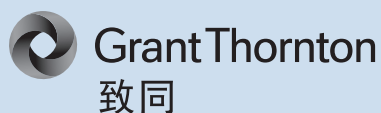

### 1. GENERAL INFORMATION

Amuse Group Holding Limited (the “Company”) is a company incorporated in the Cayman Islands with limited liability under the Companies Law, Chapter 22 (Law 3 of 1961 as consolidated and revised) of the Cayman Islands. The address of the Company’s registered office is P.O. Box 1350, Clifton House, 75 Fort Street, Grand Cayman, KY1-1108, Cayman Islands and the principal place of business of the Company is at Flat B-E, 33/F, Plaza 88, No. 88 Yeung UK Road, Tsuen Wan, New Territories.

The Company is an investment holding company. The Company and its subsidiaries (together referred to as the “Group”) are principally engaged in design, marketing, distribution and retail sales of toys and related products, and provision of agency services. The principal activities of the subsidiaries are set out in note 26 to the consolidated financial statements.

### 2. SIGNIFICANT ACCOUNTING POLICIES

#### 2.1 Statement of compliance

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”) which collective term includes all applicable individual HKFRSs, Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”) and accounting principles generally accepted in Hong Kong.

These financial statements also comply with the applicable requirements of the Hong Kong Companies Ordinance and include the applicable disclosure requirements of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”). Significant accounting policies adopted by the Group are disclosed below.

### 1. 一般資料

佰悅集團控股有限公司(「本公司」)乃根據開曼群島公司法第22章(一九六一年第三號法例，經綜合及修訂)於開曼群島註冊成立的有限公司。本公司的註冊辦事處地址位於P.O. Box 1350, Clifton House, 75 Fort Street, Grand Cayman, KY1-1108, Cayman Islands，本公司的主要營業地點位於香港新界荃灣楊屋道88號Plaza 88 33樓B-E室。

本公司為投資控股公司。本公司及其附屬公司(統稱「本集團」)主要從事設計、營銷、分銷及零售玩具及相關產品以及提供代理服務。附屬公司的主要業務載於綜合財務報表附註26。

### 2. 主要會計政策

#### 2.1 合規聲明

該等財務報表已根據香港財務報告準則(「香港財務報告準則」)編製，香港財務報告準則包括香港會計師公會(「香港會計師公會」)頒佈的所有適用個別香港財務報告準則、香港會計準則(「香港會計準則」)及詮釋以及香港普遍採納的會計準則。

該等財務報表亦符合香港公司條例的適用規定及包括香港聯合交易所有限公司GEM證券上市規則(「GEM上市規則」)的適用披露規定。本集團採納的主要會計政策於下文披露。

### 2.1 Statement of compliance (Continued)

The HKICPA has issued certain new and amended HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 2.3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

### 2.2 Basis of preparation of the consolidated financial statements

The consolidated financial statements for the year ended 31 March 2023 comprise the Company and its subsidiaries.

The measurement basis used in the preparation of the consolidated financial statements is the historical cost basis except that the investment properties as explained in note 2.7 and certain financial assets are stated at their fair value.

The preparation of financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

編製符合香港財務報告準則之財務報表需要管理層作出判斷、估計及假設，而該等判斷、估計及假設會影響政策之應用及所申報之資產、負債、收入及開支等金額。該等估計及有關假設乃根據過往經驗及管理層相信於該等情況下乃屬合理之各項其他因素而作出，所得結果構成管理層在無法依循其他來源得知資產及負債之賬面值時作出判斷之基準。實際結果或會有別於該等估計。

The directors anticipate that all of the pronouncements will be adopted in the Group's accounting policy for the first period beginning on or after the effective date of the pronouncement. Information on new and amended HKFRSs that are expected to have impact on the Group's accounting policies is provided below. Other new and amended HKFRSs are not expected to have a material impact on the Group's consolidated financial statements.

#### **Amendments to HKAS 1 and HKFRS Practice Statement 2 "Disclosure of Accounting Policies"**

The amendments to HKAS 1 require entities to disclose material accounting policy information instead of significant accounting policies in its financial statements. The amendments also provide some guidance on how material policy information are being identified and provide some examples of when accounting policy information is likely to be material.

In March 2021, HKICPA issued HKFRS Practice Statement 2 "Making Materiality Judgements" to provide entities with non-mandatory guidance on how to make materiality judgements when preparing their general purpose financial statements in accordance with HKFRS. HKFRS Practice Statement 2 was subsequently revised to provide guidance and examples on how to apply the concept of materiality to accounting policy disclosures.

The amendments to HKAS 1 are effective for annual reporting period beginning on or after 1 April 2023 and are applied prospectively. Earlier application is permitted. Except for the disclosure of accounting policies in note 2 may need to be revised to cope with the above changes, the directors of the Group expect that the amendments have no material impact on the consolidated financial statements.

### 2.4 Basis of consolidation

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

The Group includes income and expenses of a subsidiary in the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests.

In the Company's statement of financial position, subsidiaries are carried at cost less any impairment loss unless the subsidiary is held for sale or included in a disposal group. Cost is adjusted to reflect changes in consideration arising from contingent consideration amendments. Cost also includes direct attributable costs of investment.

The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable at the end of the reporting period. All dividends whether received out of the investee's pre or post-acquisition profits are recognised in the Company's profit or loss.

#### **Business combinations**

Business combinations are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are recognised in profit or loss as incurred.

Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity in the acquiree (if any) over the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed. If, after reassessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value on the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as bargain purchase gain.

業務合併使用收購法入賬。於業務合併轉撥之代價按公平值計量，而計算方法為本集團所轉讓之資產、本集團向被收購方原擁有人產生之負債及本集團於交換被收購方之控制權發行之股權於收購日期之公平值總和。收購相關成本於產生時在損益確認。

Where the consideration the Group transferred in a business combination includes assets or liabilities resulting from a contingent consideration arrangement, the contingent consideration is measured at its acquisition-date fair value and considered as part of the consideration transferred in a business combination. Changes in the fair value of the contingent consideration that qualify as measurement period adjustments are adjusted retrospectively, with the corresponding adjustments being made against goodwill or gain on bargain purchase. Measurement period adjustments are adjustments that arise from additional information obtained during the measurement period about facts and circumstances that existed as of the acquisition date. Measurement period does not exceed one year from the acquisition date.

The subsequent accounting for changes in the fair value of the contingent consideration that do not qualify as measurement period adjustments depends on how the contingent consideration is classified. Contingent consideration classified as equity is not subsequently remeasured and its subsequent settlement is accounted for within equity. Contingent consideration classified as a financial asset or liability is subsequently remeasured at each reporting dates at fair value with changes in fair value recognised in profit or loss.

Set out below are the accounting policies on goodwill arising on acquisition of a subsidiary. Accounting for goodwill arising on acquisition of interest in an associate or a joint venture is set out in note 2.9.

Goodwill arising in a business combination is recognised as an asset at the date that control is acquired (the acquisition date). Goodwill is measured as the excess of the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the Group's interest in the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

If, after reassessment, the Group's interest in the fair value of the acquiree's identifiable net assets exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held equity interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Goodwill is stated at cost less accumulated impairment losses. Goodwill is allocated to cash-generating units and is tested annually for impairment (see note 2.17).

On subsequent disposal of a subsidiary, the attributable amount of goodwill capitalised is included in the determination of the amount of gain or loss on disposal.

### 2.7 Investment properties

Investment properties are buildings which are owned or held under a leasehold interest to earn rental income and/or for capital appreciation.

On initial recognition, investment property is measured at cost, and subsequently at fair value.

Cost includes expenditure that is directly attributable to the acquisition of the investment properties.

The carrying amounts recognised at the end of the reporting period reflect the prevailing market conditions at the end of the reporting period.

Any gain or loss arising from a change in fair value or from the retirement or disposal of an investment property is recognised in profit or loss.

### 2.8 Property, plant and equipment

Property, plant and equipment (including right-of-use assets) are stated at cost less accumulated depreciation and any impairment losses (other than cost of right-of-use assets as described in note 2.10). Depreciation is calculated to write-off the cost of items of property, plant and equipment less their residual value (if any) using the straight-line method over their estimated useful lives as follows:

Gain or loss arising from disposal or retirement of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other costs, such as repairs and maintenance, are charged to profit or loss during the financial period in which they are incurred.

#### 2.9 Associates and joint ventures

An associate is an entity over which the Group has significant influence, which is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control of those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions relating about relevant activities require the unanimous consent of the parties sharing control.

In consolidated financial statements, interest in an associate or a joint venture is initially recognised at cost and subsequently accounted for using the equity method.

Under the equity method, the Group's interest in the associate or joint venture is carried at cost and adjusted for the post-acquisition changes in the Group's share of the associate or joint venture's net assets less any identified impairment loss, unless it is classified as held for sale (or included in a disposal group that is classified as held for sale). The profit or loss for the year includes the Group's share of the post-acquisition, post-tax results of the associate or joint venture for the year, including any impairment loss on the investment in associate or joint venture recognised for the year.

Where the associate or joint venture uses accounting policies other than those of the Group for like transactions and events in similar circumstances, adjustments are made, where necessary, to conform the associate or joint venture's accounting policies to those of the Group when the associate or joint venture's financial statements are used by the Group in applying the equity method.

When the Group's share of losses in an associate or a joint venture equals or exceeds its interest in the associate or joint ventures, the Group does not recognise further losses, unless it has incurred legal or constructive obligations or made payments on behalf of the associate or joint venture. For this purpose, the Group's interest in the associate or joint venture is the carrying amount of the investment under the equity method together with the Group's long-term interests that in substance form part of the Group's net investment in the associate or joint venture.

If such indications are identified, the Group calculates the amount of impairment as being the difference between the recoverable amount (i.e. higher of value in use and fair value less costs of disposal) of the associate or joint venture and its carrying amount. In determining the value in use of the investment, the Group estimates its share of the present value of the estimated future cash flows expected to be generated by the associate or joint venture, including cash flows arising from the operations of the associate or joint venture and the proceeds on ultimate disposal of the investment.

### 2.10 Leases

At inception of a contract, the Group considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an identified asset (the underlying asset) for a period of time in exchange for consideration'. - the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Group;

For contracts that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease and non-lease component on the basis of their relative stand-alone prices.

At lease commencement date, the Group recognises a right-of-use asset and a lease liability on the consolidated statement of financial position. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Group, an estimate of any costs to dismantle and remove the underlying asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any lease incentives received).

The Group also assesses the right-of-use asset for impairment when such indicator exists.

At the commencement date, the Group measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Group's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable payments based on an index or rate, and amounts expected to be payable under a residual value guarantee.

Subsequent to initial measurement, the liability will be reduced for lease payments made and increased for interest cost on the lease liability. It is remeasured to reflect any reassessment or lease modification, or if there are changes in in-substance fixed payments. The variable lease payments that do not depend on an index or a rate are recognised as expense in the period on which the event or condition that triggers the payment occurs.

For lease modification that is not accounted for as a separate lease, the Group remeasures the lease liability based on the lease term of the modified lease by discounting the revised lease payments using a revised discount rate at the effective date of modification. The only exception is any rent concessions which arose as a direct consequence of the COVID-19 pandemic and which satisfied the conditions set out in paragraph 46B of HKFRS 16 "Leases". In such cases, the Group took advantage of the practical expedient set out in paragraph 46A of HKFRS 16 and recognised the change in consideration as if it were not a lease modification.

When the lease is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit or loss if the right-of-use asset is already reduced to zero.

On the consolidated statement of financial position, right-of-use assets have been included in "property, plant and equipment".

Refundable rental deposits paid are accounted for under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

As a lessor, the Group classifies its leases as either operating or finance leases.

A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset, and classified as an operating lease if it does not.

The Group also earns rental income from operating leases of its investment properties. Rental income is recognised on a straight-line basis over the term of the lease.

### 2.11 Financial instruments

#### Recognition and derecognition

Financial assets and financial liabilities are recognised when the Group becomes a party to the contractual provisions of the financial instruments.

A financial asset is derecognised when the contractual right to the cash flows from the financial asset expire, or when the financial asset and substantially all of its risks and rewards are transferred. A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

#### Financial assets

##### Classification and initial measurement of financial assets

Except for those trade and bills receivables that do not contain a significant financing component and are measured at the transaction price in accordance with HKFRS 15, all financial assets are initially measured at fair value, in case of a financial asset not at fair value through profit or loss ("FVTPL"), plus transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at FVTPL are expensed in profit or loss.

##### **Bank loan**

Bank loan is recognised initially at fair value less attributable transaction costs. Subsequent to initial recognition, bank loan is stated at amortised cost with any difference between the amount initially recognised and redemption value being recognised in profit or loss over the period of the borrowings, together with any interest and fees payable, using the effective interest method.

Bank loan is classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least twelve months after the end of the reporting period.

##### **Trade and other payables and amount due to a joint venture**

They are initially recognised at fair value, and are subsequently stated at amortised cost using the effective interest method.

The Group recognises a loss allowance for expected credit losses (“ECL”) on the financial assets measured at amortised cost (including bank deposits and cash, trade and bills receivables and other receivables).

#### **Measurement of ECL**

ECL are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all expected cash shortfalls (i.e. the difference between the cash flows due to the Group in accordance with the contract and the cash flows that the Group expects to receive).

The expected cash shortfalls are discounted using the following discount rates where the effect of discounting is material:

- bank deposits and cash, trade and bills receivables and other receivables: effective interest rate determined at initial recognition or an approximation thereof.

The maximum period considered when estimating ECL is the maximum contractual period over which the Group is exposed to credit risk.

In measuring ECL, the Group takes into account reasonable and supportable information that is available without undue cost or effort. This includes information about past events, current conditions and forecasts of future economic conditions.

ECL are measured on either of the following bases:

- 12-month ECL: these are losses that are expected to result from possible default events within the 12 months after the reporting date; and
- lifetime ECL: these are losses that are expected to result from all possible default events over the expected lives of the items to which the ECL model applies.

#### **Trade and bills receivables**

For trade and bills receivables, the Group applies a simplified approach in calculating ECL and recognises a loss allowance based on lifetime ECL at the end of reporting period. These are the expected shortfalls in contractual cash flows, considering the potential for default at any point during the life of the financial assets. Bills receivables are assessed individually. In calculating the ECL of trade receivables, the Group has established a provision matrix that is based on its historical credit loss experience and external indicators, adjusted for forward-looking factors specific to the debtors and the economic environment.

To measure the ECL, trade receivables have been grouped based on shared credit risk characteristics and the days past due.

#### **Other financial assets measured at amortised cost**

The Group measures the loss allowance for other receivables equal to 12-month ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increase in the likelihood or risk of default occurring since initial recognition.

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial assets at the reporting date with the risk of default occurring on the financial assets at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

就貿易應收款項及應收票據而言，本集團應用簡化法計算預期信貸虧損，並於報告期末根據全期預期信貸虧損確認虧損撥備。考慮到金融資產年內任何時間點均可能出現違約事件，該等虧損為合約現金流量的預期落差。應收票據乃按個別基準進行評估。於計算貿易應收款項的預期信貸虧損時，本集團根據其過往信貸虧損經驗及外部指標建立撥備矩陣，並就債務人及經濟環境的特定前瞻性因素作出調整。

為計量預期信貸虧損，貿易應收款項按共同信貸風險特徵及逾期日數進行分組。

#### **按攤銷成本計量的其他金融資產**

本集團按相當於12個月預期信貸虧損計量其他應收款項的虧損撥備，除非自初步確認起信貸風險顯著增加，則本集團確認全期預期信貸虧損。評估是否確認全期預期信貸虧損乃根據自初步確認以來違約的可能性或風險有否顯著增加。

本集團於評估信貸風險自初步確認以來是否顯著增加時，會比較金融資產於報告日期與於初步確認日期發生違約的風險。於作出該評估時，本集團會考慮合理和有依據的定量和定性資料，包括過往經驗及毋須付出過多成本或努力即可獲得的前瞻性資料。

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;
- existing or forecast adverse changes in regulatory business, financial, economic conditions or technological environment that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations; and
- an actual or expected significant deterioration in the operating results of the debtor.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 30 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the end of each reporting period. A debt instrument is determined to have low credit risk if it has a low risk of default, the borrower has strong capacity to meet its contractual cash flow obligations in the near term and adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfill its contractual cash flow obligations.

For internal credit risk management, the Group considers an event of default occurs when (i) information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collateral held by the Group); or (ii) the financial asset is 90 days past due.

Detailed analysis of the ECL assessment of financial assets measured at amortised cost are set out in note 28.2.

### 2.13 Impairment of other non-financial assets

Internal and external sources of information are reviewed at the end of each reporting period to identify indications that the Company's investments in subsidiaries, interests in joint ventures and property, plant and equipment may be impaired or an impairment loss previously recognised no longer exists or may have decreased.

If any such indication exists, the asset's recoverable amount is estimated.

就內部信貸風險管理而言，本集團認為，倘(i)內部產生或自外部來源取得的資料顯示債務人不大可能向其債權人(包括本集團)悉數還款(不計及本集團持有的任何抵押品)；或(ii)金融資產已逾期90日，則視其為違約事件。

#### — Calculation of recoverable amount

The recoverable amount of an asset is the higher of its fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit ("CGU")). Corporate assets are allocated to individual CGUs, when a reasonable and consistent basis of allocation can be identified, or otherwise they are allocated to the smallest group of CGUs for which a reasonable and consistent allocation basis can be identified.

#### — Recognition of impairment losses

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the CGU to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of CGUs are allocated to reduce the carrying amount of the assets in the unit (or group of units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs of disposal (if measurable) or value in use (if determinable).

### 2.14 Inventories

Inventories are assets which are held for sales in the ordinary course of business.

Inventories are carried at the lower of cost and net realisable value.

Cost is calculated using the weighted average cost formula and comprises all costs of purchase and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs necessary to make the sales.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

### 2.15 Contract liabilities

A contract liability is recognised when the customer pays trade deposit before the delivery of goods at the inception of a contract, until the revenue recognised (see note 2.21) exceeds the amount of the deposit. A contract liability would also be recognised if the Group has an unconditional right to receive consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (see note 2.11).

### 2.14 存貨

存貨為於一般業務過程中持作銷售之資產。

存貨乃按成本及可變現淨值之較低者列賬。

成本乃按加權平均成本法計算，並包括所有採購成本及其他使存貨達致現時所在地點及保持現有狀況所涉及之成本。

可變現淨值是在日常業務過程中的估計售價減去銷售之估計所需成本。

在售出存貨後，該等存貨之賬面值會於確認相關收入之期間確認為銷售成本。將存貨減值至可變現淨值之減值金額和所有存貨虧損均在進行減值或虧損的期內確認為銷售成本。任何存貨減值撥回金額應在撥回發生期間沖減銷售成本。

### 2.15 合約負債

若客戶於合約開始時貨物交付前支付貿易按金，則確認合約負債，直至所確認收益(見附註2.21)超出按金額為止。倘本集團於確認相關收入前有無條件權利收取代價亦確認合約負債。在該等情況下，相應應收款項亦將一併予以確認(見附註2.11)。

### 2.16 Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated cash flow statement. Cash and cash equivalents are assessed for ECL in accordance with the policy set out in note 2.11.

### 2.17 Impairment of non-financial assets

The following assets are subject to impairment testing:

- Goodwill arising on acquisition of a subsidiary;
- Property, plant and equipment (including right-of-use assets)

Goodwill with indefinite useful life or those not yet available for use are tested for impairment at least annually, irrespective of whether there is any indication that they are impaired. All other assets are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable.

An impairment loss is recognised as an expense immediately for the amount by which the asset's carrying amount exceeds its recoverable amount. Recoverable amount is the higher of fair value, reflecting market conditions less costs of disposal, and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessment of time value of money and the risk specific to the asset.

現金及現金等價物包括銀行及手頭現金、於購入後三個月內到期的存於銀行活期存款。就綜合現金流量表而言，按要求償還及構成本集團現金管理不可分割部分的銀行透支亦計入現金及現金等價物。現金及現金等價物根據載於附註2.11的政策就預期信貸虧損進行評估。

### 2.17 非金融資產減值

以下資產須進行減值測試：

- 收購一間附屬公司產生之商譽；

不論是否有任何減值跡象，具有無限可使用年期或尚未可供使用的商譽至少每年進行減值測試。所有其他資產於有跡象顯示資產賬面值可能無法收回時進行減值測試。

For the purposes of assessing impairment, where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e. a cash-generating unit). As a result, some assets are tested individually for impairment and some are tested at cash-generating unit level. Goodwill in particular is allocated to those cash-generating units that are expected to benefit from synergies of the related business combination and represent the lowest level within the Group at which the goodwill is monitored for internal management purpose and not be larger than an operating segment.

Impairment losses recognised for cash-generating units, to which goodwill has been allocated, are credited initially to the carrying amount of goodwill. Any remaining impairment loss is charged pro rata to the other assets in the cash generating unit, except that the carrying value of an asset will not be reduced below its individual fair value less cost of disposal, or value in use, if determinable.

An impairment loss on goodwill is not reversed in subsequent periods. In respect of other assets, an impairment loss is reversed if there has been a favourable change in the estimates used to determine the asset's recoverable amount and only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

Impairment losses recognised in an interim period in respect of goodwill are not reversed in a subsequent period. This is the case even if no loss, or a smaller loss, would have been recognised had the impairment been assessed only at the end of the financial year to which the interim period relates.

### 2.18 Employee benefits

#### Retirement benefits

Retirement benefits to employees are provided through defined contribution plans.

The Group operates a defined contribution retirement benefits plan (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance, for all of its employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries.

Contributions are recognised as an expense in profit or loss as employees render services during the year. The Group's obligations under these plans are limited to the fixed percentage contributions payable.

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

### 2.19 Accounting for income taxes

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or directly in equity, respectively.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the end of the reporting period, and any adjustment to tax payable in respect of previous years.

#### 退休福利

僱員之退休福利乃透過定額供款計劃提供。

根據強制性公積金計劃條例，本集團為其所有合資格參與定額供款退休福利計劃（「強積金計劃」）之僱員經營一項強積金計劃。供款按僱員基本薪金之某一百分比作出。

供款於年內隨僱員提供服務於損益確認為開支。本集團根據該等計劃的責任僅限於應付固定百分比供款。

薪金、年度花紅、有薪年假、定額供款退休計劃的供款及非貨幣福利的成本於僱員提供相關服務的年度內產生。當付款或結付獲遞延及影響屬重大，該等金額按其現值列賬。

### 2.19 所得稅會計處理

年內所得稅包括即期稅項及遞延稅項資產及負債的變動。即期稅項及遞延稅項資產及負債的變動乃於損益中確認，但在其他全面收益或直接在權益中確認的相關項目，則相關稅項金額分別在其他全面收益或直接在權益中確認。

即期稅項指採用於報告期末已生效或大致上已生效的稅率就年內應課稅收入計算的預期應繳稅項，以及就過往年度應繳稅項作出的任何調整。

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits.

Apart from certain limited exceptions, all deferred tax liabilities and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary difference or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

The limited exceptions to recognition of deferred tax assets and liabilities are those temporary differences arising from the initial recognition of assets or liabilities that affect neither accounting nor taxable profit (provided they are not part of a business combination), and temporary differences relating to investments in subsidiaries to the extent that, in the case of taxable differences, the Group controls the timing of the reversal and it is probable that the differences will not reverse in the foreseeable future, or in the case of deductible differences, unless it is probable that they will reverse in the future.

Where investment properties are carried at their fair value in accordance with the accounting policy set out in note 2.7, the amount of deferred tax recognised is measured using the tax rates that would apply on sales of those assets at their carrying value at the reporting date unless the property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the property over time, rather than through sales. In all other cases, the amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the end of the reporting period. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at the end of each reporting period and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

Current tax balances and deferred tax balances, and movements therein, are presented separately from each other and are not offset. Current tax assets are offset against current tax liabilities, and deferred tax assets against deferred tax liabilities if the Group has the legally enforceable right to set off current tax assets against current tax liabilities and the following additional conditions are met:

- in the case of current tax assets and liabilities, the Group intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously; or

- in the case of deferred tax assets and liabilities, if they relate to income taxes levied by the same taxation authority on either:
  - (i) the same taxable entity; or
  - (ii) different taxable entities, which, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered, intend to realise the current tax assets and settle the current tax liabilities on a net basis or realise and settle simultaneously.

### 2.20 Provisions and contingent liabilities

Provisions are recognised when the Group has a legal or constructive present obligation arising as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate of the amount of the obligation can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

Any provision are reviewed at each reporting date and adjusted to reflect the current best estimate.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow of economic benefits is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events not wholly within the control of the Group, are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

### 2.21 Revenue recognition

Revenue arises mainly from the sales of toys and related products and provision of agency services.

To determine whether to recognise revenue, the Group follows a 5-step process:

1. Identifying the contract with a customer
2. Identifying the performance obligations
3. Determining the transaction price
4. Allocating the transaction price to the performance obligations
5. Recognising revenue when/as performance obligation(s) are satisfied

In all cases, the total transaction price for a contract is allocated amongst the various performance obligations based on their relative stand-alone selling prices. The transaction price for a contract excludes any amounts collected on behalf of third parties.

Revenue is recognised either at a point in time or over time, when (or as) the Group satisfies performance obligations by transferring the promised goods or services to its customers.

Income is classified by the Group as revenue when it arises from the sales of toys and related products and provision of agency services.

#### **Sales of toys and related products**

Revenue from sales of toys and related products is recognised when control over a product is transferred to the customer, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue is after deduction of any trade discounts.

#### **Principal versus agent**

When another party is involved in providing goods or services to a customer, the Group determines whether the nature of its promise is a performance obligation to provide the specified goods or services itself (i.e. the Group is a principal) or to arrange for those goods or services to be provided by the other party (i.e. the Group is an agent).

The Group is a principal if it controls the specified good or service before that good or service is transferred to a customer.

The Group is an agent if its performance obligation is to arrange for the provision of the specified good or service by another party. In this case, the Group does not control the specified good or service provided by another party before that good or service is transferred to the customer. When the Group acts as an agent, it recognises revenue in the amount of any fee or commission to which it expects to be entitled in exchange for arranging for the specified goods or services to be provided by the other party.

#### **Sales of toys and related products**

Revenue is recognised at a point in time when the customer takes possession of and accepts the products.

#### **Provision of agency services**

Agency services income is recognised over time because the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs.

#### **Rental income**

Accounting policies for rental income are set out in note 2.10.

#### **Interest income**

Interest income is recognised as it accrues under the effective interest method using the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the gross carrying amount of the financial asset. For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset.

#### **Management fee income**

Revenue is recognised at a point in time when the Group has provided its management service to the customers.

### 2.22 Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions. Government grants are deferred and recognised in profit or loss over the period necessary to match them with the costs that the grants are intended to compensate.

Government grants relating to income is presented in gross under "other income, net" in the consolidated statement of profit or loss and other comprehensive income.

### 2.23 Translation of foreign currencies

The consolidated financial statements are presented in Hong Kong Dollars (HK\$), which is also the functional currency of the Group.

In the individual financial statements of the consolidated entities, foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies and non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. The transaction date is the date on which the Company initially recognises such non-monetary assets or liabilities.

In the consolidated financial statements, the results of foreign operations are translated into Hong Kong dollars at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Statement of financial position items are translated into Hong Kong dollars at the closing foreign exchange rates at the end of the reporting period. The resulting exchange differences are recognised in other comprehensive income and accumulated separately in equity in the exchange reserve.

On disposal of a foreign operation, the cumulative amount of the exchange differences relating to that foreign operation is reclassified from equity to profit or loss when the profit or loss on disposal is recognised.

### 2.24 Borrowing costs

Borrowing costs are expensed in the period in which they are incurred.

In the application of the Group's accounting policies, which are described in note 2, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates are revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities, are described below.

#### 3.1 Estimated useful lives of property, plant and equipment

The Group estimates the useful lives of its property, plant and equipment based on the periods cover which the assets are expected to be available for use. The Group reviews annually their estimated useful lives, based on factors that include asset utilisation, the expected physical wear and tear, environmental factors and anticipated use of the assets tempered by related industry benchmark information. It is possible that future results of operation could be materially affected by changes in these estimates brought about by changes in factors mentioned. A reduction in the estimated useful lives of property, plant and equipment would increase depreciation charges and decrease the carrying amount of property, plant and equipment. At as 31 March 2023, the carrying amount of property, plant and equipment was HK\$29,619,000 (2022: HK\$16,735,000).

應用在附註2所敘述的本集團會計政策時，本公司董事須就未能即時輕易從其他來源得知的資產及負債賬面值作出判斷、估計及假設。有關估計及相關假設乃根據過往經驗及被視為有關的其他因素作出。實際結果可能有別於該等估計。

有關估計及相關假設將持續進行審閱。倘修訂僅影響修訂估計的期間，則於該期間確認會計估計的修訂，或倘修訂同時影響現時及未來期間，則於修訂期間及未來期間確認會計估計的修訂。

以下為於報告期間末有關未來的主要假設及估計不明朗因素的其他主要來源，對資產及負債的賬面值出現重大調整的重大風險。

#### 3.1 物業、廠房及設備估計可使用年期

本集團根據資產預期可供使用的涵蓋期間估計其物業、廠房及設備的可使用年期。本集團每年檢討其估計可使用年期，所根據的因素包括資產使用率、預期物理損耗、環境因素及基於相關行業基準所定資產的預期用途。倘上述因素出現任何變化而使有關估計改變，則可能對未來營運業績產生重大影響。扣減物業、廠房及設備的估計可使用年期將會增加折舊開支及減少物業、廠房及設備賬面值。於二零二三年三月三十一日，物業、廠房及設備之賬面值為29,619,000港元(二零二二年：16,735,000港元)。

#### 3.2 Impairment of trade and bills receivables and other receivables

The Group estimates the loss allowances for trade and bills receivables and other receivables by assessing the ECL. This requires the use of estimates and judgements. ECL are based on the Group's historical credit loss experience, adjusted for factors that are specific to the debtors, and an assessment of both the current and forecast general economic conditions at the end of reporting period. As at 31 March 2023, the aggregate carrying amounts of trade and bills receivables and other receivables amounted to HK\$25,720,000 (net of ECL allowance of HK\$239,000) (2022: HK\$12,826,000 (net of ECL allowance of HK\$21,000)). Where the estimation is different from the original estimate, such difference will affect the carrying amounts of trade and bills receivables and other receivables and thus the impairment loss in the period in which such estimate is changed (note 15 and note 16).

#### 3.3 Current and deferred income taxes

There are many transactions and events for which the ultimate tax determination is uncertain during the ordinary course of business. Significant judgement is required from the Group in determining the provision for income taxes. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made. As at 31 March 2023, the Group had current tax payable and current tax recoverable of HK\$Nil (2022: HK\$579,000) and HK\$1,233,000 (2022: HK\$3,452,000), respectively. The details of the deferred tax assets and liabilities are set out in note 23.

#### 3.2 貿易應收款項及應收票據以及其他應收款項減值

本集團透過評估預期信貸虧損估計貿易應收款項及應收票據以及其他應收款項的虧損撥備。這需要使用估計及判斷。預期信貸虧損乃基於本集團的過往信貸虧損經驗，就債務人的特定因素，以及於報告期末對當前及預測整體經濟環境的評估作出調整。於二零二三年三月三十一日，貿易應收款項及應收票據以及其他應收款項的賬面總值為25,720,000港元(扣除預期信貸虧損撥備239,000港元)(二零二二年：12,826,000港元(扣除預期信貸虧損撥備21,000港元))。倘估計有別於原先估計，則該差額將影響貿易應收款項及應收票據以及其他應收款項的賬面值，從而影響該估計變化期間的減值虧損(附註15及附註16)。

#### 3.3 即期及遞延所得稅

在日常業務過程中，許多交易和事項的最終稅務釐定存在不確定性。本集團在釐定所得稅撥備時需要作出重大判斷。倘該等事項的最終稅務結果有別於初始記錄的金額，相關差額將對釐定期間的所得稅及遞延稅項撥備產生影響。於二零二三年三月三十一日，本集團的即期應付稅項及可收回即期稅項分別為零港元(二零二二年：579,000港元)及1,233,000港元(二零二二年：3,452,000港元)。有關遞延稅項資產及負債的詳情載於附註23。

#### 3.4 Fair value of contingent consideration receivable

The fair value of contingent consideration receivable was determined by using valuation techniques. The Group's management uses its judgement to select a variety of methods and make assumptions, including the discount rates and estimation of future performance. Changes in assumptions used could materially affect the fair value of the balances and, as a result, affect the Group's financial condition and results of operation. At 31 March 2023, the carrying amount of contingent consideration receivable amounted to HK\$4,300,000 (2022: HK\$Nil).

#### 3.5 Estimation of goodwill impairment

The Group tests annually whether goodwill has suffered any impairment in accordance with the accounting policy stated in note 2.13. The recoverable amounts of cash-generating units have been determined based on value-in-use calculations. These calculations require the use of estimates about future cash flows and discount rates. In the process of estimating expected future cash flows, management makes assumptions about future revenues and profits. These assumptions relate to future events and circumstances. The actual results may vary and may cause a material adjustment to the carrying amount of goodwill within the next financial year. Determining the appropriate discount rate involves estimating the appropriate adjustment for market risk and for asset specific risk factors. Details of the estimates of the recoverable amounts of cash-generating units containing goodwill are disclosed in note 12.

#### 3.4 應收或然代價的公平值

應收或然代價的公平值乃採用估值技術釐定。本集團管理層運用判斷以選擇多種方法並作出假設，包括貼現率及未來表現估計。所用的假設變動可能對結餘的公平值產生重大影響，因而影響本集團的財務狀況及經營業績。於二零二三年三月三十一日，應收或然代價的賬面值約為4,300,000港元(二零二二年：零港元)。

#### 3.5 估計商譽減值

本集團按照附註2.13所述會計政策每年測試商譽有否出現任何減值。現金產生單位的可收回金額乃基於使用價值計算釐定。該等計算要求使用有關未來現金流量及貼現率的估計。於估計預期未來現金流量的過程中，管理層就未來收益及溢利作出假設。該等假設與未來事件及情況有關。實際結果可能存在差異，且可能導致須對下個財政年度內商譽的賬面金額作出重大調整。釐定適當貼現率涉及估計就市場風險及資產特定風險因素作出的適當調整。現金產生單位(包含商譽)的可收回金額估計詳情於附註12披露。

##### Fair value hierarchy

The fair value measurement of the Group's investment properties at the end of the reporting period on a recurring basis is categorised into the three-level fair value hierarchy as defined in HKFRS 13, "Fair Value Measurement". The level into which a fair value measurement is classified is determined with reference to the observability and significance of the inputs used in the valuation technique as follows:

- Level 1: quoted prices (unadjusted) in active markets for identical assets and liabilities.
- Level 2: inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices), and not using significant unobservable inputs.
- Level 3: significant inputs for the asset or liability that are not based on observable market data (significant unobservable inputs).

During the year ended 31 March 2022, the investment properties of the Group were revalued at the date of disposal, i.e. 28 January 2022 by AA Property Services Limited, an independent qualified professional valuer, who has appropriate qualifications and experience in the valuation of similar properties in the relevant locations. The Group's management had discussion with the valuer on the valuation assumptions and valuation results.

At 28 January 2022, the Group's investment properties fall into Level 2 of the fair value hierarchy as described above.

The recoverable amount of the cash-generating unit was determined based on a value-in-use calculation with reference to a professional valuation performed by Ravia Global Appraisal Advisory Limited (“Ravia”), an independent firm of professionally qualified valuer, as at 31 March 2023. The calculation uses cash flow projections based on financial budgets approved by the management covering a five-year period with the estimated gross profit margin ratio ranged from 11% to 13%. Cash flows beyond the projection period are extrapolated using an estimated growth rate of 3%. The pre-tax rate used to discount the forecast cash flows is 19%.

Based on the result of the above impairment testing, the estimated recoverable amount exceeded the carrying amount of the cash-generating unit by approximately 39% as at 31 March 2023. The Group’s management is not currently aware of any other probable changes that would necessitate changes in its key estimates and could cause the cash generating units’ carrying amounts to exceed their recoverable amounts. However, the estimate of recoverable amount of the Group’s cash-generating unit is particularly sensitive to the pre-tax discount rate applied. As at 31 March 2023, if the pre-tax discount rate increased by 1%, the estimated recoverable amount would exceed the carrying amount of the cash-generating unit by approximately 27%.

The Group actively and regularly reviews and manages its capital structure to maintain a balance between the higher shareholders returns that might be possible with higher levels of borrowings and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions affecting the Group.

During the year, the Group's strategy in monitoring its capital structure, which was unchanged from 2022, was to maintain a sufficient cash level to meet its liquidity requirements.

Neither the Company nor any of its subsidiaries are subject to externally imposed capital requirements.

#### 28.2 Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group. The Group's credit risk is primarily attributable to trade receivables.

#### *Trade receivables*

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry or country in which the customers operate and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers. At the end of the reporting period, 57% (2022: 45%) and 96% (2022: 93%) of the total trade receivables was due from the Group's largest customer and the five largest customers respectively.

Individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade receivables are due within 0 to 60 days from the date of billing. Normally, the Group does not obtain collateral from customers.

The Group measures loss allowances for trade receivables at an amount equal to lifetime ECL, which is calculated using a provision matrix. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases.

我們就所有要求超過若干信貸金額的客戶進行個別信貸評估。該等評估主要針對客戶過往到期付款的記錄及目前的付款能力，並考慮到有關特定客戶及客戶經營業務所在之經營環境的資料。貿易應收款項須於發票日期起計0至60日內支付。一般而言，本集團不會向客戶索取抵押品。

本集團按等於全期預期信貸虧損的金額，使用撥備矩陣計算貿易應收款項的虧損撥備。由於本集團的過往信貸虧損經驗並無顯示不同客戶分部的虧損模式存在重大差異，故此本集團並無就不同客戶基礎進一步區分基於逾期狀態而劃分的虧損撥備。

Results of the analysis as presented in the above table represent an aggregation of the instantaneous effects on each of the group entities' profit after tax and equity measured in the respective functional currencies, translated to the HK\$ at the exchange rate ruling at the end of the reporting period for presentation purposes.

The sensitivity analysis assumes that the change in foreign exchange rates had been applied to re-measure those financial instruments held by the Group which expose the Group to foreign currency risk at the end of the reporting period. The analysis is performed on the same basis for 2022.

#### 28.6 Equity price risk

The Group is exposed to equity price risk through its investment in listed equity securities. The Group's equity price risk is mainly concentrated on equity instruments quoted in the Stock Exchange of Hong Kong Limited. The management manages this exposure by maintaining a portfolio of investments with different risk and return profiles.

##### **Sensitivity analysis**

The sensitivity analyses below have been determined based on the exposure to equity price risks at the reporting date.

If the prices of the respective equity instruments had been 10% (2022: 10%) higher/lower, the post-tax profit for the year ended 31 March 2023 would increase/decrease by approximately HK\$280,000 (2022: HK\$323,000) as a result of the changes in fair value of equity securities listed in Hong Kong.
