granting of the proposed Issue Mandate and the proposed Repurchase Mandate and the extension of Issue Mandate by addition thereto of the number of Shares repurchased pursuant to the Repurchase Mandate; and (ii) the re-election of retiring Directors.

GENERAL MANDATE TO ISSUE SHARES

The Company's existing mandate to issue Shares was approved by its then Shareholders on 23 September 2022. In recommending Ms. Shen to stand for re-election as executive Director and Ms. Wang and Mr. Shen to stand for re-election as independent non-executive Directors, the Nomination Committee has considered the following backgrounds and attributes of the nominees concerned:

- (a) Ms. Shen has extensive experience in enterprise strategic management, mergers and acquisitions and risk management in the renewable energy industry. Ms. Shen holds a Master's degree in Business Administration and is a qualified senior accountant in PRC.
- (b) Ms. Wang is an experienced certified public accountant, certified tax agent and senior accountant in PRC.
- (c) Mr. Shen possesses extensive experience in the renewable energy industry.

The Nomination Committee considered that in view of their past performance, diverse and different educational backgrounds and professional qualifications and experience in the respective fields of management, corporate governance and accounting as mentioned above and as set out in Appendix II to this circular. 1. SHARE CAPITAL

Subject to the passing of the relevant resolution to approve the Repurchase Mandate and on the basis that no further Shares are allotted and issued or repurchased between the Latest Practicable Date and the date of AGM, the Company will be allowed to repurchase a maximum of 81,800,000 Shares, representing 10% of the aggregate number of issued shares of the Company as at the date of the AGM.

2. SOURCE OF FUNDS

The Directors propose that the repurchase of Shares under the Repurchase Mandate would be made out of profits or out of the proceeds of a fresh issue of Shares made for the purpose of the repurchase.

In repurchasing the Shares, the Company may only apply funds which are legally available for such purposes in accordance with the constitutive documents of the Company, the GEM Listing Rules and the applicable laws and regulations of the Cayman Islands. 5. UNDERTAKING

Ms. Shen, aged 47, was appointed as an executive Director on 3 August 2015. She was appointed as the compliance officer of the Company on 18 October 2016. Ms. Shen is responsible for the strategic development and management of the Group's business and operations.

Ms. Shen has a very rich operating experience in the field of enterprise strategic management, mergers and acquisitions, initial public offering and risk management. Ms. Shen was engaged in the compact fluorescent lamp industry and renewable energy industry and had accumulated a wealth of experience in financial management. She obtained an MBA from the Hong Kong Finance and Economics College in 2008, and is a qualified PRC senior accountant.
