FURTHER EXTENSION OF LONG STOP DATE IN RELATION TO PLACING OF CONVERTIBLE BONDS UNDER GENERAL MANDATE

Reference is made to the announcement of hmvod Limited (the “**Company**”) dated 28 June 2023, 4 July 2023 and 19 July 2023 in relation to the placing of convertible bonds under general mandate (collectively referred to as the “**Announcements**”). Capitalized terms used herein shall have the same meanings as those defined in the Announcements unless the context otherwise requires.

Pursuant to the CB Placing Agreement and the supplemental agreement dated 19 July 2023 (the “**First Supplemental Agreement**”), the Completion of the CB Placing shall take place on the date on which all the conditions precedent of the CB Placing (the “**Conditions**”) having been satisfied or waived. If the Conditions shall not have been fulfilled by 2 August 2023, the CB Placing Agreement shall be terminated and of no effect.

As additional time is required for the fulfillment of certain Conditions under the CB Placing Agreement, the Company and the Placing Agent entered into the second supplemental agreement (the “**Second Supplemental Agreement**”) on 2 August 2023 to extend the Long Stop Date to 16 August 2023.

Save as disclosed above, all other terms and conditions of the CB Placing Agreement remain unchanged and in full force and effect in all respects.

As the CB Placing may or may not proceed, Shareholders and potential investors of the Company are reminded to exercise caution when dealing in the securities of the Company.
